ADJOURNED MEETING

Wilmington, N. C., June 2nd, 1931.

The Presbytery of Wilmington met in adjourned session in St. Andrew's Presbyterian church, Wilmington, on this date at 11 a. m.

Rev. J. W. Miller, Moderator, was in the chair, and the following members were enrolled:

Ministers: J. E. L. Winecoff, W. P. M. Currie, A. J. Howell, A. D. P. Gilmour, D. D., R. C. Clontz, W. L. Wilson, W. E. West, A. V. Gibson, J. H. Whitmore, D. D., J. W. Miller, F. L. Goodman, P. C. Adams, L. I. Stell, C. C. Myers (14);

Ruling Elders: W. C. Scoggins, Delgado; Jonathan Reid, New Hope; W. K. Walker, St. Andrews; B. P. Smith, Graves Memorial; John Hall, Wilmington First, (5).

The meeting was constituted with prayer by Rev. J. E. L. Winecoff.

The Stated Clerk read a communication from the pastor of the White Plains church, with expression from the congregation as to its inability to entertain Presbytery at its fall meeting; and also one from the pastor of Mt. Zion church, Rose Hill, extending an invitation for the meeting to be held there. Upon motion, the White Plains church was relieved of responsibility in the matter, and the invitation from Mt. Zion church accepted.

Reports were read from the commission appointed to install Rev. W. C. Smith as pastor of the churches of Chinquapin, Beulaville and Bethel, the same showing that the exercises were observed in accordance with the Book of Church Order, and as follows:

Beulaville, May 3, 1931.

Present: Revs. R. C. Clontz and F. L. Goodman, and Ruling Elder J. L. Miller, of Hallsville. Rev. R. C. Clontz presided; Rev. F. L. Goodman preached; Ruling Elder Miller charged the pastor, and Rev. R. C. Clontz the congregation.

Bethel, May 3, 1931.

Present: Revs. P. L. Clark and R. C. Clontz, and Ruling Elder J. L. Miller, Rev. P. L. Clark presided; Rev. R. C. Clontz preached; Ruling Elder Miller charged the pastor and Rev. P. L. Clark the congregation.

Chinquapin, May 10, 1931.

Present: Revs. W. P. M. Currie and S. G. Harness, and Ruling Elder G. R. Ward, Wallace. Rev. W. P. M. Currie presided and preached; ruling elder Ward charged the pastor, and Rev. S. G. Harness the congregation.

The reports were duly adopted.

Report was also read from the commission appointed to ordain licentiate William Harlee Bordeaux to the Gospel ministry, as follows:

The commission met at 3 p. m. Saturday, May 30th, 1931, in the First Presbyterian church, Wilmington. Present: Revs. A. D. P. Gilmour, D. D., J. H. Whitmore, D. D., C. H. Storey, D. D., A. J. Howell and P. C. Adams; and ruling elders W. K. Walker, Thomas McDonald and John Hall. In view of the satisfactory examination of the licentiate on December 29, 1930, further examination was omitted, save the ascertaining that there had been no changes in his theological views since that date. The commission then made the following arrangements for his ordination as an evangelist in the First Presbyterian church, his home church, on Sunday evening, May 31st, 1931, viz.:

Rev. A. D. P. Gilmour, D. D., to preside, preach and perform other required parts; Rev. J. H. Whitmore, D. D., to make the ordination prayer; and Rev. C. H. Storey, D. D., to deliver the charge to the evangelist.

Thereupon, the commission took recess until Sunday evening, 31st, when the exercises arranged were conducted in accordance with the Book of Church Order.

A sermon was also heard, by invitation, from Rev. J. Gresham Machen, D. D., of the Westminster Theological Seminary, Philadelphia; and the exercises concluded with the benediction by Rev. W. H. Bordeaux.

The report was adopted, and Mr. Bordeaux enrolled as a member of Presbytery upon his signing the required obligation.

Rev. R. C. Clontz, chairman of the permanent committee on Evangelism, offered the following report, which was adopted:

We are glad to report an ever increasing interest in Evangelism in the Presbytery. Meetings were held in most of the churches last year and the number of churches reporting "No additions on Confessions" were decreased. Many of the pastors held meetings during the year and the results were most gratifying. The Superintendent and Evangelist for the Presbytery held 20 meetings with 253 confessions; 230 were added to the Presbyterian Church on confession and 25 by letter, making a total of 255 additions to our church. However, evangelistic meetings are not to be judged by

the number of souls added, but the keeping of the spiritual life of the church. Some of our best meetings resulted in only a few additions but new life came into the church and church members were reclaimed for the Lord Jesus Christ and His Church.

With these facts before us, and feeling that the rich mine from which the above were extracted is by no means exhausted and with 60,000 people above 12 years of age outside any church, we make the following recommendations:

1. That the month of October be designated as the month of evangelism in the Presbytery.
2. That each church outside of Wilmington hold a two weeks meeting, with both morning and night services where practical, during October.
3. That the Sessions of the Wilmington churches be respectively requested to release their pastor for at least one meeting during October.
4. That a survey be made by each church of the community which it serves and that the "over-looked and non-church people" be listed as prospects for church membership in the October campaign.
5. That prayer bands and personal work groups be organized in each church.
6. That we as ministers and elders now re-dedicate ourselves and churches to this great task of soul-winning.
7. That all organizations of the church, Sunday school, young people, men and women be enlisted.
8. That Pastor and Session secure evangelist for their respective meeting and report same to the Chairman, Rev. R. C. Clontz.
9. That an offering be taken on each Sunday during the meeting and turned over to Mr. W. D. McCaig, who will pay traveling and other expenses of the meeting.
10. That no honorariums be given and that after all expenses are paid, the balance, if there be one, be turned into the general fund for Presbytery's Home Missions.
11. That we begin now praying for God's blessings on these meetings in public and private prayer, and especially around our family altars.

Rev. A. D. P. Gilmour, D. D., chairman of the permanent committee on Presbytery's Home Missions, made request that the allotments out of Home Mission funds made to the pastors serving in various fields be continued until the fall meeting unless it should be found necessary to reduce them; in which case the Home Missions committee to have authority to make the necessary reductions. The request was duly granted by vote of Presbytery.

Rev. W. E. West made request that he be allowed to labor without the bounds of the Presbytery until the fall meeting. The same was granted.

By motion, Mr. West was recommended to the executive committee of Ministerial Relief to receive aid from its funds to the extent of \$50 per month until October 1st, 1931.

The Stated Clerk read a paper, signed by a large number of the members of the congregation of New Hope church, expressing their appreciation of the ministry of Mr. West and their prayerful interest in his welfare.

Rev. W. P. M. Currie, chairman of the permanent committee on Christian Education and Ministerial Relief, offered a request from Raymond C. Butler that his name be restored to Presbytery's list of candidates for the ministry. Upon motion, Presbytery declared that it did not see its way clear at this time to comply with this request.

Rev. W. H. Bordeaux asked that he be granted a letter of dismissal to the Presbytery of Connecticut Valley, of the Presbyterian church, U. S. A., that he might accept a call extended to him to serve as pastor of the Community Presbyterian Church, Old Greenwich, Conn. The Stated Clerk was directed to furnish such letter.

Rev. M. O. Sommers, of East Hanover Presbytery, was introduced to Presbytery, and a certificate was read transferring him to Wilmington Presbytery. Motion was made that he be received, pending the required examination, and that his name be enrolled as a member of Wilmington Presbytery. He was examined according to the Book of Church Order; and, the examination being sustained as satisfactory, his name was ordered to be enrolled upon his signing the required obligation.

Calls were read for the pastoral services of Mr. Sommers from the churches of Graves Memorial and Warsaw; and the same, being found in order, were placed in his hands. Upon his signifying his acceptance, the following commission was named to install him: Revs. R. C. Clontz, M. J. Murray, J. I. Knight and F. L. Goodman, and ruling elders J. E. Kelly, F. B. Johnson, H. E. Faison and J. W. Farrow; any two ministers and one ruling elder

to constitute a quorum. The time for the exercises and parts to be taken were left to the pleasure of the commission.

By motion, Mr. Sommers was also assigned to serve as stated supply of the Holly Grove church until the fall meeting.

The minutes were read and approved; and, after prayer by Rev. A. V. Gibson, the meeting adjourned.

Rose Hill, N. C., Tuesday, Sept. 22, 1931.

The Presbytery of Wilmington met in the one hundred and twenty-fourth stated session in the Mt. Zion Presbyterian church, Rose Hill, N. C., at 11 a. m.

The retiring Moderator, Rev. J. W. Miller, preached the opening sermon from the text, Gen. 42:36.

Presbytery was constituted with prayer by Rev. R. C. Clontz.

Rev. S. G. Harness was elected Moderator, and Rev. J. A. Boyd and Ruling Elder Gardner Edwards temporary clerks.

The printed docket offered by the Stated Clerk was adopted.

The list of ministers absent at the last stated meeting was read and absences excused.

The minutes of the adjourned meeting of June 2, 1931, were read.

Report of the commission to install Rev. M. O. Sommers as pastor of the Warsaw and Graves Memorial churches was read and adopted as follows:

Warsaw, Sunday, July 19, 1931, 11 a. m. Members present: Revs. R. C. Clontz, M. J. Murray and F. L. Goodman, and Ruling Elders H. E. Faison and J. W. Farrior. Rev. F. L. Goodman presided and Rev. M. J. Murray preached the sermon. Rev. R. C. Clontz charged the pastor and Ruling Elder Faison the congregation.

Clinton, Graves Memorial church, Sunday, July 26, 1931, 11 a. m. Members present: Revs. R. C. Clontz and J. I. Knight, and Ruling Elders F. B. Johnson, H. E. Faison, J. E. Kelly and J. W. Farrior. Rev. R. C. Clontz presided; Rev. J. I. Knight preached the sermon; Ruling Elder J. E. Kelly charged the pastor, and Ruling Elder Farrior the congregation.

The proceedings were conducted in accordance with the Book of Church Order, and Rev. Mr. Sommers declared duly elected and installed pastor of each church.

Communications were read by the Stated Clerk and action taken as follows:

From Curator of the Historical Foundation, Montreat, acknowledging receipt of books and records of Wilmington Presbytery. Received as information and ordered filed by the Stated Clerk.

From Revs. W. E. West and W. B. Knox, requesting to be excused from attendance and asking leave to labor without the bounds of the Presbytery until the spring meeting. Excuse and leave granted.

From Rev. K. B. McCutchen, residing in Bridgewater, Va. Stated Clerk directed to advise him to request certificate of dismission to the Presbytery within whose bounds he is working.

From Dr. E. E. Gillespie, Greensboro, and Dr. Homer McMillan, Atlanta, in re proposed evangelistic plans. Referred to Presbytery's committee on Evangelism.

From Stated Clerk of General Assembly regarding Bureau of Vacancy and Supply. Referred to Presbytery's member of Synod's committee on that subject.

From Dr. W. T. Thompson, Union Theological Seminary, relative to proposed correspondence course of study, etc. Referred to special committee consisting of Revs. C. H. Storey, D. D., R. H. Poole and A. V. Gibson.

From Dr. H. H. Sweets, Secretary, in re Christian Education and Ministerial Relief and Ministers' Annuity Plan. Referred to committees of Presbytery on the subjects.

From Dr. W. L. Lingle, President, regarding status of Davidson College. Referred to committee on Synod's Schools and Colleges.

From the Moderator of Transylvania Presbytery as to an overture regarding proposed representation of Deacons in church courts. Referred to committee on Bills and Overtures.

From Stated Clerk of General Assembly in regard to proposed amendment of the Book of Church Order allowing election of Ruling Elders and Deacons for limited terms. Referred to committee on Bills and Overtures.

From publishers of "Christian Observer" regarding "Church Paper Week," November 1st to 8th. Received as information, and plan commended by Presbytery.

From Dr. H. W. McLaughlin, Director, Country Church Work. Referred to special ad interim committee to consider the suggestions made and report at spring meeting. Following committee appointed: Revs. P. L. Clark, J. A. Boyd, F. L. Goodman.

The following statistical report to the Synod of North Carolina was presented by the Stated Clerk and adopted:

The Presbytery of Wilmington consists of 38 ministers, no licentiates and 7,463 communicants, 68 churches valued at \$1,421,100, and 23 manses valued at \$157,750. It has under its care 7 candidates for the ministry.

The following changes have been made during the year:

Ministers received—J. I. Knight, October 28, 1930, from Holston Presbytery, L. E. Wells, December 29, 1930, from Fayetteville Presbytery, and M. O. Sommers, June 2, 1931, from East Hanover Presbytery.

Ministers dismissed—G. M. Matthis, October 28, 1930, to Granville Presbytery, and W. H. Bordeaux, June 2, 1931, to Connecticut Valley Presbytery, U. S. A.

No ministers deceased. No churches organized.

Pastorial relations established—M. O. Sommers, Warsaw, July 19, 1931, M. O. Sommers, Graves Memorial, July 26, 1931.

Pastorial relations dissolved—G. M. Matthis, Warsaw, Graves Memorial, and Holly Grove, October 28, 1930.

No candidates received. Candidate W. H. Bordeaux ordained May 31, 1931.

Upon written request, Rev. C. B. Heller was excused from attendance at this meeting.

After prayer by Rev. J. A. Boyd, recess was taken for luncheon.

TUESDAY, 2 P. M.

Presbytery was called to order and opened with prayer by Rev. F. S. Johnston.

Time and Place of Next Meeting—Rev. F. L. Goodman and Ruling Elder Gardner Edwards.

Resolution of Thanks—Revs. J. W. Miller and W. L. Wilson and Ruling Elder J. C. McMillan.

Call for the pastoral services of Rev. M. O. Sommers from the Holly Grove church was read, found in order and placed in his hands. Upon his signifying his acceptance, the following commission was appointed to install him: Revs. R. C. Clontz, M. J. Murray, J. I. Knight and F. L. Goodman, and Ruling Elders J. E. Kelly, F. B. Johnson, H. E. Faison and J. W. Farrior. The time and parts to be taken were left to the pleasure of the commission.

Rev. A. V. Gibson, chairman, presented report of the permanent committee on Assembly's Home Missions, which was duly approved and the following recommendations adopted:

1. That all pastors and home missionaries be called again to a recognition of the primary place of evangelism in all their work.
2. That Tex-Mex. Industrial Institute, Kingsville, Texas, and Presbyterian School for Mexican Girls be assigned the young people's societies as the objectives of their home mission offerings.
3. That November be designated as the month for home mission study in all churches of the Presbytery, and that November 8th to 15th be designated as the week of prayer and self-denial for Assembly's Home Missions.
4. That all pastors be urged to preach on Assembly's Home Missions during November, and that home mission topics be used at prayer meeting services during that month.
5. That all sessions be urged to arrange for a generous offering to Assembly's Home Missions in the churches in November.

Rev. S. G. Harness, chairman, made report for the permanent committee on Women's Work, which was approved.

Report of the permanent committee on History was made by Rev. Andrew J. Howell, chairman, and Ruling Elder Henry E. Faison.

Mr. Faison made reference to plans for a celebration on Sunday, September 27th, 1931, of the one hundredth anniversary of the organization of the Graves Memorial (originally Goshen) church. Invitation was given to members of Presbytery to attend, and, upon motion, Presbytery extended, through Mr. Faison, its greetings to the church.

Revs. M. J. Murray and W. C. Smith and Ruling Elder R. L. Carr made report as to their attendance on the General Assembly in May, 1931, at Montreat. The reports were approved and their diligence commended.

The standing committee on the Minutes of the General Assembly, through Revs. M. J. Murray and W. C. Smith, reported no matters requiring special action of Presbytery other than one already presented.

Rev. J. W. Miller, chairman, offered report for the permanent committee on Orphans' Home, which was approved.

Rev. P. L. Clark, chairman, made report for the permanent committee on Synod's Home Missions. The same was approved.

Upon motion, Presbytery took recess for a half-hour to allow for meeting of committees.

4 p. m.—Presbytery reconvened and entered into a popular meeting in the interest of Religious Education. Report of the permanent committee was presented by Rev. C. H. Storey, D. D., chairman; and, pending its adoption, an address was delivered by him on the subject of the dignity and importance of the work of teaching. The report was duly approved and adopted as follows:

Since the last meeting of Presbytery the work of Religious Education has been aggressively promoted throughout the Presbytery. Working under the direction of Rev. R. C. Clontz, Misses Anderson, Bowden and Herring from the Assembly Training School conducted fifteen Daily Vacation Bible Schools with a total attendance of 750 children or an average of 50 in each school. We are indebted to these young ladies as they served without salary, merely receiving their expenses.

The fourth annual young people's conference for the Presbytery was held at White Lake June 22-26, with 90 young people and 10 adults in attendance. The same fine spirit that has characterized the former conferences was maintained and many felt that it was the best conference we have yet held. Sixty-five of our young people attended the Synodical conference at Davidson College. Thus a total of 915 children and young people were reached with some part of our program during the summer.

A careful study of the churches, large and small, throughout the Assembly indicates that the greatest difficulty faced in the work of Religious Education is the lack of trained teachers and leaders. Appreciating this great need the General Assembly has placed upon the Executive Committee of Religious Education the responsibility of giving to the Church a sane, practical and spiritual program of religious education and Leadership Training. We feel that great progress has been made in the type of program offered and would heartily commend the various features of it to all of our churches. The section of Leadership Training is offering a program for training leaders that will greatly help in solving our problems. Nine ways of training leaders is suggested. We sincerely believe that every pastor will find that one of them will meet his need. The Standard Leadership School is the ideal. If he cannot have a school, perhaps he can have a standard class; if not a standard class then a local class; if not a local class then he can get his teachers to take the work by correspondence. Lead-

ers may also be trained through workers' conferences, reading courses, departmental conferences, or, perhaps just personal conferences. If there are instructors who can teach leadership classes but who are not accredited, the Committee can help them to become accredited by guiding them in forming course plans and lending them books for reading. They can also furnish programs for workers' conferences, if desired. A program is of little value until used. Let us remember that the providing of an adequate program places definite responsibility upon Presbyteries and Synods to use it. Ultimately this responsibility devolves upon the pastor as the leader in the local church. Every pastor should acquaint himself with the entire program provided by the Assembly's agency and then make use of it so far as practical in the local church.

It is obvious to all that these agencies of the church cannot operate with the highest efficiency without adequate financial support. Funds contributed last year to the support of the work of this Committee, including Sunday School extension and the support of field workers, represent the smallest amount received in eleven years. The amounts received since April 1st are 12 per cent less than for the same period last year. At the same time the earnings of the Committee from the sales department have also greatly decreased. We therefore recommend:

1. That our churches put forth every effort to meet their apportionment for this cause.
2. That Rally Day, October 4th, be observed in all our Church Schools and that a liberal offering be made for the cause of Sunday School Extension. If that date cannot be observed then observe the nearest date convenient.
3. That during the fall and winter we concentrate upon the definite objective of developing our Church School and trained leaders for the school.
4. That, where possible, pastors of neighboring churches cooperate in putting on a Leadership Training School which will serve a group of churches.
5. That where other courses are not available, the pastor teach one of the Bible units.
6. That Rev. R. C. Clontz, Superintendent of Home Missions, be requested to write the young ladies who conducted the D. V. B. S. in our Presbytery, and the other agencies cooperating, expressing our hearty appreciation of their splendid service.
7. That the White Lake conference for young people be held again this year under the direction of Rev. R. C. Clontz and the Presbytery's committee on Young People's Work.
8. That the Presbytery express its appreciation of the support given this work by the executive committee of Religious Education and Publication, and that we respectfully request that the appropriation of \$900 be continued another year.

Rev. J. H. Whitmore, D. D., chairman of the standing committee on Bills and Overtures, offered the following

report which was adopted, action being taken separately as to the subjects:

1. Touching the matter of the proposed amendment of the Book of Church Order to make the offices of Ruling Elder and Deacon for limited terms, we recommend that this amendment be adopted.

The proposed amendment is as follows:

"The Assembly, in accordance with the provisions made therefor in the Book of Church Order, paragraph 160, hereby approves of, recommends to the Presbyteries, and submits to the Presbyteries for their advice and consent, the following amendment to the Book of Church Order, paragraph 149, viz., that there be added the following subparagraph to said paragraph 149:

'If any particular church, by a majority vote at a congregational meeting, shall prefer to elect Ruling Elders and Deacons for a limited term in the exercise of their functions, this may be done; provided that the time of such active services be not less than three years, and that the Session and Board of Deacons be made to consist of three classes, one of which classes shall be elected each year; and provided further that the Ruling Elders and Deacons, once ordained, shall not be divested of their office when they are not re-elected for active service, and if re-elected shall not be re-ordained; and provided further that a congregation voting to make such terms of office limited may also determine for how long a period of time, if any, such retired officers shall be ineligible for re-election. Elders thus retired shall be entitled to represent their church in the higher courts of the church when appointed by the session or by the Presbytery.'

Adopted by the General Assembly at Montreat, N. C., June 1, 1931."

2. In the matter of the communication from Transylvania Presbytery, Synod of Kentucky, requesting that this Presbytery concur in an overture to the General Assembly to change the Book of Church Order so as to permit deacons to be sent as representatives to church courts along with ruling elders, we recommend that Wilmington Presbytery do not concur.

Recess was taken until the evening session at 7:30, after prayer by Rev. R. C. Clontz.

TUESDAY, 7:30 P. M.

Presbytery re-assembled, and exercises were conducted by Rev. M. J. Murray, chairman of the permanent committee of Foreign Missions.

Rev. W. F. Junkin, of the Southern Presbyterian China mission, was introduced and delivered an informing address on the subject of the ability and moral sense of the Chinese people.

Mr. Murray offered reports for the committee, with recommendations which were adopted as follows:

That this Presbytery acknowledge to the Great Head of the Church our thanks for the manifest token of His blessing upon the Foreign work for the past year.

We hereby recommend that the Presbytery enjoin all pastors to proclaim boldly the unqualifiedly lost condition and estate of non-Christian peoples without Christ, lost relationships, lost life-motive, lost hope, lost righteousness, and lost power of moral and spiritual recovery, that they proclaim directly and through missionary witnesses the actual power of the gospel of Christ in the regeneration and salvation of the peoples of His world-wide Kingdom in direct proportion to the opportunity given your representatives to conduct active evangelistic work; that we reiterate the Lordship of Jesus and the present preeminence of His Great Commission as the great task of His Church.

That a Church School of Missions be held in every church in our Assembly during January, 1932, in an effort to bring to every man, woman, and child in our Church the reports and findings of the Chattanooga Missionary Congress as set forth in the book "The Church Faces Foreign Missions."

That our Young People's Societies be asked to shoulder this year, as their specific Foreign Mission responsibility, the \$6,000 necessary to operate the Jennie Speer Girls' School, Kwangju, Korea.

That every church in the Presbytery be asked to observe January 24-31, 1932, as the Week of Prayer and Self-Denial for Foreign Missions.

That all sessions be urged to arrange for a supplemental offering for Foreign Missions in the churches in January.

Presbytery adjourned until 9 a. m. Wednesday, after prayer by Rev. J. R. Phipps.

WEDNESDAY, SEPTEMBER 23

Devotional exercises were conducted at 9:15 a. m. by Rev. M. O. Sommers, with exposition of Psalm 118.

The following members were enrolled: Rev. A. D. P. Gilmour, D. D., and Ruling Elders H. C. Brogden, Stanford, and R. C. Moore, Bowden.

Minutes of Tuesday's sessions were read and approved.

Rev. C. C. Myers, chairman of the permanent committee on Bible Cause, presented report, which was received as information.

Rev. A. V. Gibson, chairman of the permanent committee on Stewardship, offered report with the following recommendations, which were adopted:

MINUTES OF WILMINGTON PRESBYTERY

1. That the date of the Every-Member Canvass be March 13, 1932.
2. That the theme of the canvass be "Every Member Enlisted."
3. That our Secretary of Stewardship be asked to arrange for a special day of prayer preparatory to the canvass.
4. That the Presbytery accept the Synod's benevolent asking of \$74,600.00.
5. That this amount be apportioned among the churches in accordance with table prepared.

Rev. R. C. Clontz, chairman, offered report for the permanent committee on Evangelism, which was adopted as follows:

Your committee on Evangelism would respectfully call attention to the plans adopted in June for an Evangelistic campaign for the whole Presbytery to be conducted in the month of October. We are glad to report a hearty response from our pastors and congregations on the subject. In view of this approaching campaign, and feeling our dependence upon the Great Head of the Church and our Divine Teacher, the Holy Spirit, we make the following recommendations:

1. That the Presbytery designate Friday, October 2nd, 1931, as a day of fasting and prayer, and that our people be urged to observe the day by an humble confession of sin and prayer for God's blessing and guidance.
2. That the fourth Sunday in September (27th) be named as the day for completing the suggested survey in our respective communities.
3. That churches finding it impossible to have evangelistic meetings in October be urged to hold such meetings in the month of November.
4. That the Presbytery co-operate with the Synod and General Assembly in evangelistic campaigns now being planned.
5. That the agency through which such co-operation shall be given be the Presbytery's committee on Evangelism.
6. That Rev. C. H. Storey, D. D., be added to this committee.

Rev. H. G. Bedinger, of the Presbytery of Fayetteville, and Rev. Daniel Lane, of the Methodist Episcopal church of Rose Hill, were introduced to Presbytery and invited to sit as visiting brethren.

10 a. m. Rev. J. H. Whitmore, D. D., chairman, presided at a special period devoted to the interests of Synod's Schools and Colleges.

Addresses relative to their respective institutions were delivered by Dr. W. C. Pressly, President of Peace Junior College, and Rev. H. G. Bedinger, President, Flora Macdonald College.

11 a. m. A doctrinal sermon was preached by Rev. J. E. L. Winecoff from the text, II Tim. 4:2.

The Presbyterial communion service was conducted by Rev. A. V. Gibson, assisted by Rev. M. J. Murray.

Rev. Andrew J. Howell addressed Presbytery on the subject of the Presbyterian Junior College for Men, and Dr. Whitmore, chairman, presented information relative to Davidson College.

The chairman also offered a paper with the following recommendations, which were adopted:

1. That the presidents of the colleges to which trustees are appointed from this Presbytery be asked to report to the chairman of the Presbytery's committee on Schools and Colleges, before the Spring meeting of Presbytery, concerning the diligence of these trustees in attending the meetings of the boards of trustees, and also to make suggestions as to reappointments or new appointments to their boards.
2. That the attention of the boards of the colleges partly owned by this Presbytery be called to the seriousness of operating their institutions at a loss each year, and so accumulating debts which will eventually overbalance their assets, and endanger their continued work and the whole benevolent work of the Presbytery.

Upon motion, Presbytery took the following action: That it endorse the plan of the board of trustees of Flora Macdonald College to collect, through committees of the alumnae, pledges made to the endowment fund of the college.

Upon suggestion of President Bedinger, Presbytery, upon motion, requested the churches to give him the privilege of their pulpits in the interest of Flora Macdonald College, if the way be clear.

After prayer by Rev. J. E. L. Winecoff, recess was taken for luncheon.

WEDNESDAY, 2 P. M.

Presbytery reconvened and was led in prayer by Rev. A. D. P. Gilmour, D. D.

MINUTES OF WILMINGTON PRESBYTERY

Dr. Gilmour, chairman of special committee on Ministers' Annuity Fund, brought to the attention of Presbytery the plans made for "Mobilization Day," October 18, 1931; and, upon motion, the churches were requested to give proper notice of the same, provide opportunity for receiving gifts or pledges which may be made toward the fund, and to offer prayer for Dr. H. H. Sweets, Secretary, and his efforts to bring the plan to success.

Dr. Gilmour, chairman of the permanent committee on Presbytery's Home Missions, made report for his committee, and presented the following statement of Ruling Elder W. D. McCaig, treasurer of home mission funds:

I give below a statement of the receipts and disbursements of the Home Missions Committee of the Wilmington Presbytery for the five months ended August 31, 1931:

The total apportionment to the Churches covering Presbytery's Home Missions amounted to \$12,553.48 and it will be noted from our receipts that the Churches during the first five months of the year have contributed only 13.5% of that amount.

It will be further noted that the cash balance on hand at the beginning of the church year, April 1st, amounting to \$1,827.75 has been depleted \$1,290.01; or in other words our expenditures for the first five months of the present church year have exceeded our receipts from all sources \$1,290.01.

It is needless for me to say that if this trend continues during the balance of the church year that the Home Missions Committee will close the year in debt.

Rev. A. D. P. Gilmour, D. D., chairman of the permanent committee on Men's Work, made report urging the ministers to continue their interest in the work. Upon motion, Presbytery re-affirmed its endorsement of the plan.

Rev. W. P. M. Currie, chairman of the permanent committee on Christian Education and Ministerial Relief, made report giving in detail information regarding candidates for the ministry and beneficiaries of student aid and ministerial relief funds. In connection with the report, Presbytery voted to defer further consideration of the matter of Raymond C. Butler, formerly of its list of candidates, until the spring meeting.

Rev. W. L. Wilson, chairman, made report for the permanent committee on the Sabbath and Family Religion, which was approved.

The special committee appointed to consider the communication from the Union Theological Seminary relating to proposed correspondence course of study and summer school of theology, reported, through Rev. C. H. Storey, D. D., chairman, that the ministers present had been canvassed and the proposition seemed to be favorably regarded by them.

Rev. R. C. Clontz made report concerning the subject of Vacancy and Supply, mentioning his activities as a member of Synod's committee on this subject. The report was approved.

Rev. F. S. Johnston, chairman of the standing committee on the records of Presbytery, reported approval and commendation of the minutes published. The report was approved.

The standing committee on Nominations, through Rev. W. P. M. Currie, chairman, made the following report, which was adopted:

1. That the trustees of Presbytery, J. O. Carr, W. H. Sprunt and R. C. Carson, be re-appointed for three years.
2. That the trustees of Davidson College, Rev. J. R. Phipps and W. P. Sprunt, be re-appointed for three years.

The report of the permanent Auditing committee was offered, showing approval of the accounts of the treasurer of the contingent fund.

The report of the treasurer of the contingent fund, Rev. Andrew J. Howell, showed a balance in bank of \$115.09. An appeal was made for the settlement of their accounts by delinquent churches.

The standing Devotional committee reported that all periods of worship had been provided for.

Rev. F. L. Goodman, chairman, offered report for the standing committee on the Time and Place of Next Meeting. An invitation from Flora Macdonald College for the spring meeting to be held in Red Springs, simultaneously with the Presbyteries of Orange and Fayetteville, was presented. The same was, upon motion, accepted, the date of meeting to be fixed by the Stated Clerk in conference with the President of the college.

Rev. L. I. Stell, chairman, offered the following report for the standing committee on Leave of Absence, and the same was adopted, viz.:
