

Dear brethren, the call of mission is knocking at our door—to my mind, we should heed this great call. There is a call for us from Liberia and from Haiti, a call to us from South America, Northern India and All Africa. Shall we answer these calls?

Our educational project has ceased to say, I need your help any longer. Since this is true, suppose we heed the Macedonian cry, "Come over and help us". Suppose that we, as an association, take active steps in sending the Gospel into all the world since mission is the work of the Christian Church.

#### Hodges' Institution

I feel brethren, that the building and land of Hodges' Institution should be rented for some amount, and that the proceeds should be reported to the Association annually, and that such proceeds be given to mission. I wish, too, my brethren, that each member of our Churches could see the wisdom of giving to mission —if so God would get glory out of our lives. We should choose Jesus Christ as our teacher and guide, and as he direct, let us follow.

#### The Folly of Self-Confidence

The object of our trust and confidence must necessarily be of the greatest importance. It is the foundation of the building, which if not strong and secure, must involve the edifice in ruin; it is the ground into which the anchor of the mariner is cast, and on which the safety of the vessel depends. Being so confessedly important, we meet with a variety of directions concerning it in the divine Word.

We are warned repeatedly against false objects of trust; we are especially admonished not to trust in man, whose breath is in his nostrils; not even in princes, for men of high degree, as well as men of low degree are vanity. We are cautioned not to trust in riches—not make gold our confidence. Not even to trust in our own hearts—trusting our hearts means to rest on its sufficiency;

Therefore, let us put on the whole armor of faith. The present condition of Christians are one of trais and perils. He is a mariner crossing the sea of life, exposed to storms and tempests, wherein, many have made ship-wreck of faith and a good conscience.

He is a spiritual racer, and is running the Christan course, eagerly stretching forth his hand to seize the wreath of glory and eternal life. Let us have grace to sustain us and glory to animate us having done all than we will be able to stand.

Dear co-workers, I dare not close without saying a word for the Theological Department of Shaw. This Association should go on record as a prime feeder of Shaw, and the education of young men who are studying for the ministry.

## PROCEEDINGS

## St. Paul, N. C., Oct. 25, 1923.

The Union Missionary Baptist Association convened in its thirty-ninth annual session at 10:30 a.m. with the Shitoh Baptist Church. In the absence of Moderator Dr. E. E. Smith, who was reported sick by Rev. H. G. Pope, pastor of the First Baptist Church, Fayetteville, and L. A. Raeford, Clerk of the Association, Rev. S. W. Smith, Vice-Moderator, called the house to order and asked Bro. M. D. Bery to lead the opening devotion, assisted by H. B. Barnhill, who lined hymn No. 483. Prayer by W. M. Patterson. Second hymn No. 516. Prayer by Bro. A. J. McDonald.

Among those present at this service were: Dr. A. W. Pegues, Revs. J. J. Scarlett, N. B. Dunham, F. D. Bandy, H. Adams, Geo. Williams, I. P. Pearsal, A. A. Morssey, D. J. Devane, J. M. Smith, W. T. Currie, Bros. J. W. Council, A. L. Johnson, E. S. Melvin, and others. After some brief remarks by the Vice Moderator, the programmes were adopted as a guide for the session. Rev. Wm. Allen, pastor of the Church, came forward and delivered the address of welcome. Rev. Allen, among the many good things, said, "All things are ready, enjoy yourselves as men of God."

Response by Rev. N. B. Dunham, Field Secretary of the Association. The time having arrived for the opening sermon, Rev. J. F. Freeman and Rev. E. J. F. Melvin took seats on the rostrum. Rev. Melvin lined hymn No. 710. This hymn was chaunted with uplifted voices.

## Thursday Afternoon Session

The Association reconvened at 2:30 p. m. Vice Moderator presiding. Bro. C. H. Hall and King Cromartie led devotions. After a few brief remarks by the moderator the body began the regular order. Minutes of the morning session were read and approved. Rev. H. W. Hall of the L. R. Association came forward and was introduced. Rev. Hall made some timely remarks. Rev. Geo. Billops of Wilmington was present with greetings.

3:30 Vice Moderator S. W. Smith suspended business for 15 minutes in honor of Dr. E. E. Smith, who by affliction was not able to attend his Association. Rev. Smith led in music, Blest Be the Tide That Binds Our Hearts in Christian Love. Rev. N. B. Dunham led in fervent prayer. The Moderator led in singing Near My God to Thee. Report of officers were called for and the following reported: Corresponding Secretary, Treasurer, Missionary, Field Secretary, Auditor. On motion reports were adopted. (See reports.) Sister Fairley was present and reported favorably. A collection was then taken to the amount of \$5.05. The Association then adjourned to meet at 7:30. Benediction by Rev. D. J. Devane.

## Thursday Evening Session

7:30. The opening devotion was conducted by Bros. J. B. Burns and E. D. L. Council. Bro. Burnes lined hymn No. 620. Bro. Council offered invocation. At the close of this service the Moderator called for echoes. Rev. J. J. Scarlett, pastor of First Church, Greensboro, opened with words of encouragement. Rev. A. A. Morssey made timely remarks. Rev. Geo. Williams, principal of Whites Creek Consolidated School, came forward with greetings from Bladen County. Music led by Mrs. S. H. Howard.

Time having arrived for the doctrinal sermon, Rev. Geo. Williams, Acting Moderator, business was suspended and Rev. S. W. Smith with Rev. W. T. Currie ascended the pulpit. Rev. Currie lined hymn No. 800. Rev. Smith read the 16th chapter of Mark 1-15. Bro. Kelly Whitted offered prayer. After another selection, Rev. Smith arose and used for a text Mark 16-15, Go ye into all the world and preach the Gospel. First the man of God said this charge was given to Christ's first disciples and it was before they were fully prepared for service, because they had not yet received the promises of the Father. Now you go and preach one Lord, one faith, one baptism, and tell all you come in contact with they must be born again. Though the new birth we learn of the doctrine of grace, where as we accept the New Testament teaching as the only safe way. Sister Thompson, representative of the orphanage home at Winston-Salem, came before the brethren and spoke of her work at the children's home. Rev. H. I. Quick in response spoke highly of the work carried on at Winston-Salem, and a map prepared and explained, by Sister Thomp-A motion then prevailed that Sister Thompson son have an opportunity of presenting her work at the Friday evening session. On motion committee on obituary reported. (See report.)

11:00. By orders of the chair the pending question was considered. Topic "For what purpose should young ministers prepare themselves for the Gospel ministry." Opened by Rev. W. T. Currie, followed by Rev. N. B. Dunham. In discussing this question it was clearly shown that preparation fits us to meet others and stand with firmness. Think of Moses prepared in all the ways of the Egyptians. What for? To meet the King's guests.

The preparation in Egypt fitted him for the King's service, and his surrender at the burning bush, after years of vacation, qualified him as missionary back to Egypt. Remember, young men, we must be prepared to deliver the message given to those when he said go and as ye go preach. The height of a young minister should be to help some one, and God will help him. Think of Washington's monument, five hundred feet high, made of stone and granite, yet each had to be prepared to fit. Now if the builders of Washington's monument used prepared material, let us prepare ourselves and God will use us in His service. This subject was followed with an able response by Rev. I. P. Pearsal, pastor of Good Hope Church, East Fayetteville.

By a carried motion, committee on reception of new churches reported, recommending that the New Bethlehem Church be enrolled as a member of Union Missionary Baptist Association. Motion was carried, and Bro. G. L. Butler, messenger, came forward and received the right hand of fellowship as a member of the body. After some brief remarks by the Moderator 10 minutes were given Deacon A. E. Manuel, chairman of Deacons' Council, to present their work, and encourage a co-operation of all the deacons. Rev. E. L. Thompson of the Lumber Association was presented to the brethren. Rev. Thompson was Moderator of his Association for many years. At this point Rev. H. I. Quick, president of the Pee Dee Union, came to the table and litted a collection to amount of \$12.20. The body took a recess for one hour and thirty minutes. ## Friday Afternoon Session

"Moses was trained in all the ways of the Egyptians. The speaker emphasized the importance of an education, of the heart, head and hand. It was clearly shown that the early training of Moses did not gualify him fully for God's service, but after years of experience, and the test at Mt. Sinai, he saw the place awaiting him. Rev. Scarlett in his closing remarks said, above all, we must be born again, change from nature to grace. The sermon was enjoyed by all pres-

ent. Rev. W. J. McNeill offered prayer. On motion, committee sent to negotiate with the Educational Board of Bladen County reported.

Dear Bro. Moderator and brethren of the Association. We Secretary of the above committee submit the following. After so long we came in touch with the Board, taken up the matter with careful consideration, the county agreed to take the school (ground and building) and operate it in the interest of the colored people. With this we agreed.

We further beg to say, Bro. Moderate, that the report alleged against us, saying that the property was sold for \$1.00 was untrue.

Rev. Geo. Williams, Sect. of Committee.

Bro. W. S. Smith was present and spoke of the educational work at Shannon, N. C. Rev. M. G. Crumpler was present and introduced. Rev. Crumpler, among the many good things, said "I always love to attend the Union Missionary Baptist Association, for the great Headlight, and the unity among the brethren." After some brief remarks by the Vice Moderator the body took a recess. Benediction by Rev. J. M. Smith.

## Friday Night Session

7:30. The session was opened with devotion conducted by Rev. S. M. Eagle and Bro. W. J. McAlister. The Moderator then called up the order of the afternoon session. Minutes were read and approved. The Moderator after some brief remarks regarding a motion that prevailed at the Friday session, presented a representative of the Children's Home, Winston-Salem. Sister came before the body with a map showing the difference in giving. It was clearly shown that our giving has much to do with our growth. Sister Thompson said the cause for so many small churches was because of what they give. This was a wonderful scenery and enjoyed by all present. Among those who responded were Revs. Geo. Williams, A. A. Morssey, D. J. Devane. Sister Washington (a blind lady) was presented with a most excellent group of hand-made articles (sewing, etc.).

The time having arrived for the sermon, Rev. H. I. Quick, with Rev. H. G. Pope, ascended the pulpit. Rev. Pope lined hymn No. 482. Rev. Quick read 139 Ps.

Prayer by Rev. J. F. Freeman. After another selection, Rev. Quick arose and used for a text the 23rd verse of the 139 Ps. Subject, Search me. First the speaker said man was nationally inclined to enjoy worship, regardless of its kind. So David said search me, O God, and know my heart. Try me, and know my thoughts. The sermon was a clear and practical one, was enjoyed by his hearers. At the close of the sermon Rev. Quick lead in music, "I Am Working for a Crown," followed with solo by Miss L. Roberts. 'A collection was lifted to the amount of \$14.00. Benediction by Rev. Pope.

## Saturday Morning Closing Session

The Association reconvened at 9:30 with devotion lead by Rev. D. J. Devane and Bro. A. McDonald. The Vice Moderator called the house to order and called the special order. Minutes were read and approved. The Vice Moderator called the attention of the brethren to their forgetfulness of those who labored with us but has been called from labor to reward. The Association suspended business for twenty minutes and held a touching memorial service in memory of the deceased. Rev. S. W. Smith lined hymn Oh Where Shall Rest Be Found. Prayer by Rev. F. D. Bandy. Music lead by Rev. D. J. Devane, "Abide With Me."

The business was then taken up. A motion prevailed that whereas the ministers of the Union Missionary Baptist Association has organized a ministers' conference, to better understand themselves, we recommend that the officers' names, and constitution, appear on the face of minutes. Rev. I. P. Pearsal was granted leave of absence.

Bandy, Second Vice President; Rev. L. A. Raeford, Recording Secretary; Rev. Geo. Williams, Corresponding Secretary; Rev. N. B. Dunham, Field Secretary; Rev. W. T. Currie, Auditor; Hon. A. L. Johnson, Treasurer. Committee on new churches reported. (See report.) Committee on Constitution. (See report). Committee on resolution reported. (See report). Committee on place reported

recommending that the next annual session of the Union Missionary Baptist Association convene with Second New Light Baptist Church commencing Thursday after the third Sunday in October, 1924. Rev. D. J. Devane, Rev. B. F. McAnhan, E. Z. Melvin, Geo. W. Hall, Geo. Carver, Miles Smith, J. W. Council, A. J. Burnes, E. L. Whitted, P. Dixon, W. W. Evans, A. S. Currie.

12:00. The closing service of the session was the missionary sermon, delivered by Rev. Geo. Williams, text 6th verse of the 126 Ps. Subject, "The ministerial sower. First in his labor. Second in his success." Rev. Williams handled his subject with care and put forth strong efforts, to have his hearers understand him. At the close of this wonderful sermon a collection was taken to the amount of \$33.31. The Finance Committee then made a financial report. (See report.) The Moderator after thanking the people for their hospitality closed the Association. Benediction by Rev. Geo. Williams.

## PREAMBLE AND CONSTITUTION

Whereas, the people of God are commanded to strive together in union of interest and effect, element of success for the advancement of Christ's Kingdom: therefore, the Missionary Baptists of his section of North Carolina, agree to form ourselves into an Association for mutual help, having in view the following objects: lst. The establishment of union among our churches upon principles embracing discipline, government and organization to encourage among our brethren by all Christian means, industry, sluceation, self reliance, general improvement and spiritual advancement, and to preach the gospel as far as our ability will permit. To secure these ends we pledge ourselves to God and to each other to sustain the principles embedded in our Constitution.

### CONSTITUTION

Art. 1 This Association shall be known as the Union Missionary Baptist Association. The object shall be substantially as enumerated in the above preamble.

Art. 2. The officers shall consist of a President. 1st Vice-President, 2nd Vice-President Secretary, Treasurer, Corresponding Secretary, Audittr, and an Executive Board of seven members. These officers shall be elected annually by the Association.

Art. 3. It shall be the duty of the president to preside at all meetings of the Association, decide points of order and sign all orders drawn on the treasurer of the Association. He is also exificit president of the executive board. He shall not vote only in case of a tie.

Art. 4. The Vice-President shall assume the duties of the Presifent in his absence.

Art. 5. The Secretary shall keep a correct record of all proceedings of the Association and prepare the same for publication. superintend the printing and distribution of the minutes. He shall acep all books and stationery belonging to the Association.

Art. 6. The treasurer shall receive all moneys belonging to and collect during the sitting of the Association and to pay out the same upon the order of the Association, all orders being signsid by the President and counter-signed by the Corresponding Sectetary.

Art. 7. The Corresponding Secretary shall conduct the correspondence, he shall be Secretary of the Executive Board of the Association and shall counter-sign all orders on the treasurer.

Art. 5. The auditor shall examine the accounts of the treasirer and make annual report of its condition to this body.

Art. 10. This body shall be composed of ordained ministers belonging to the churches connected with the Association and messengers chosen from the same, each church being entitled to three messengers, and must send to the Association 15 cents for each member represented in this Association; 10 cents for Christian Education and 5 cents for Associated purposes.

Art. 11. Any church desiring to join the Association may do so by letter and messengers, the same being regularly organized. All messengers to the Association must be armed with properly predited credentials. No church will be fellowshipped in this Association which neglects to maintain gospel order.

Art. 12. The annual session of this Association shall be held on Thursday after the third Sunday in October of each year at such places as may be selected.

Art. 13. By appointment of the Association there may be preached at each annual session an introductory, missionary, educational and doctrinal sermon.

Art. 14. This Constitution may be amended at any annual session by a two-thirds vote.

#### BY-LAWS

Art. 1. This Association shall not recognize or receive any church having as members any person excluded from any other church.

Art. 2. All churches of this body are especially requested to take special care of their pastors and use all efforts to help them gain instruction into the ministry.

Art. 3. From this time forward, no church within the jurisdiction of this Association shall ordain any ministers to preach unless he can read the Bible intelligently.

Art. 4. Any elder or minister found intoxicated or who shall visit places of ill repute, such as bar rooms or knowingly infulge in any immorality, such as living in cohabitation without being lawfully married, or acting in any manner such as will bring reproach upon the Baptist faith and profession, shall be called before a Council of Elders and dealt with for breach of good behavier.

## RULES OF DECORUM

Art. 1. The President and Clerk shall hold their offices from their election at one session until the election of officers at the next session and it shall be their duty to occupy their respective stations and proceed regularly to organization.

Art. 2. The President shall call the Association to order or in his absence the Vice-President shall act, and if he is absent the Secretary must open the session.

Art. 3. There shall be singing and prayer at the opening of each day's session.

Art. 4. Delegates shall enroll their names by letter or other evidence of election. Letters real and other statistical matter read.

Art. 5. Visiting brethren from other Associations may be invited to seats by a majority vote of that body.

Art. 6. The Association shall proceed to organize by electing a President. Vice-President, Secretary and Treasurer who, when elected, shall take their seats.

### ARTICLES OF FAITH

1. We believe in one living God, and that there are three persons in the Godhead, the Father, Son and Holy Ghost.

2. We believe that the scriptures of the Old and New Testaments are the words of God, and the only rule of faith and practice.

Gen. 13:26; 2 Cor. 13:14.

3. We believe in the doctrine of eternal particular election. Acts 3:46; Romans 8:28-30; 11:5-7; II Timothy 2:10; I Peter 7:17; II John 6:37-44.

4. We believe in the doctrine of original sin. Psalms 1:5.

5. We believe in the doctrine of man's impotency to recover himself from the fall he is in by nature of his own free will and ability. Eph. 11:1-19.

6. We believe that sinners are justified in the sight of God only by the imputed righteousness of Christ. Gal. 11:16. Rom. 8:24. 5-9.

7. We believe that God's elect shall be called converted and sanctified by the Holy Ghost. Eph. 1:4-7. Thess. 1:13-14.

8. We believe that the Saints shall preserve in grace, and never fall finally away. John 10:28-30. 3-1. I Peter 1-9.
9. We believe that Baptism and the Lord's supper are ordin-

9. We believe that Baptism and the Lord's supper are ordinances of Christ, and that the true believers are the only subjects of these ordinances and that the true method of Baptism is immersion. Matt. 3:16. Acts 8:38-9; Romans 6:4; Eph. 4:12.

10. We believe that the punishment of the wicked is everlasting, and that the joys of the righteous are eternal. Matt. 15:43. Rev. 20:12-15.

11. We believe in the resurrection of the dead and general judgment. I Cor. 15.

12. We believe that ordained ministers of such as have come under the imposition of hands by a regular authorized presbytery only, have a right to administer the ordinance, I. Tim, 4:14; II Tim. 1:6.

13. We believe that only regular baptized members in good standing have a right to take the Lord's Supper.

#### CONSTITUTION OF THE UNION

Art. 1. This body shall be known as the church union of the Union Baptist Association.

Art. 2. The object shall be to supply ourselves with better houses of worship and to foster the spirit of union and missions in our churches among our ministers and deacons on principles of righteousness as contained in the Bible.

Art. 3. Its officers shall be a President, Vice-President, Secretary and Treasurer, who shall be elected annually, and a Home Mission Board, consisting of life members by payment of five dollars each and it shall be presided over by the same officers of the Union, and make all appropriations and have charge of all home mission work. Art. 4. There shall be devotional services at the opening of each day's session.

Art. 5. The Union shall meet Saturday before the fifth Sunday of each month having five Sundays at such places as may be chosen.

Art. 6. There shall be preached an introductory, Doctrinal, and a Missionary sermon at each Union.

Art. 7. The Cnion shall be composed of messengers chosen of the churches and deacons and ministers belonging to the same.

Art. 8. Each church may be represented by a letter and messengers by payment of two cents for each member represented. 1 cent for building funds and one cent for expenses and mission. Each church is entitled to two messengers.

Art. 9. This constitution may be amended at any annual meeting of the union by a vote of two thirds majority of those present.

### CONSTITUTION OF THE MINISTERIAL CONFERENCE OF UNION EAPTIST ASS<sup>O</sup>CIATION

Art. I. This body shall be known as the Ministerial Conference of the Union Baptist Association.

Art. II. Its object shall be to better understand ourselves as a body of ministers, and to assist worthy supernuated ministers, (Retired).

Art. 3. Its officers shall be a President, Vice-President, Secretary, and Treasurer, who shall be elected annually, and a Home Mission Board consisting of seven Deacons, and it shall be presided over by the same officers of the Union and make all appropriations and have charge of all finance, and Home Mission work.

Art. IV. It shall meet quarterly; Friday before the 4th Sundays in September, December, March, and June.

Art. V. Each meeting shall be opened by devotional services followed by a sermon. Also a topic.

Art. VI. Its membership shall consist of all ordained elders in our association, who shall pay twenty five cents per quarter.

Art. VII. The money shall be used as follows: 50 per cent for of superanuated ministers. (Retired).
