SECOND DAY - MORNING SESSION.

Convention met at 9:30 a.m. Song No. 75, in Living Water Songs, No. 2. Prayer by Rev. J. H. Sutton.

Rev. A. B. Crumpler, having withdrawn from the Convention on yesterday, the duties of the President fall on the Vice President, Rev. A. H. Butler. Rev. C. F. Taylor was elected Vice President.

Rev. C. B. Strickland was elected Secretary, Rev. W. J. S. Walker having resigned.

On motion the President is empowered to appoint all the committees needed to transact the business of this Convention.

Convention adjourns to meet at 2:30 p.m.

SECOND DAY - EVENING SESSION.

Opening song No. 77, in Living Water Songs, No.

2. Prayer by Rev. C. F. Taylor.

Reports from the preachers continued.

Brother G. B. Cashwell spoke of the Rescue Work at Wilmington and asked for help. \$12.80 and one Teacher's Bible were given.

Brother T. J. McIntosh spoke of the paper the Lord laid on his heart in China, and \$12.75, one Testament and one Bible were given for its circulation.

The Committee on Examination of Applicants for t Ministry recommended the following brethren for ordination, viz: H. E. Oxendine, Wm. R. Paul Ham, W. H. Wellons and J. C. Daniels.

The ordination services followed:

Religious services were conducted by Revs. T. J. McIntosh and R. B. Jackson. The glory of God filled the sanctuary and many were made to rejoice.

THIRD DAY

Convention met at 9:30 a.m. Song No. 94, in Living Water Songs, No. 2. Prayer by Brother Cashwell.

Minutes of yesterday read and approved.

The Committee on "Revision of Discipline reported as follows:

We, the Committee on Revision of Discipline, beg leave to recommend the change of Article X in our Articles of Faith as follows:

X-a. -Our own hearts as well as the Scriptures teach us that even in the hearts of those who are justified and regenerated there remains something that "is not subject to the law of God, neither indeed can be." That something is variously termed in Scripture the "carnal mind", "our old man", "the sin which doth so easily beset us", and "the flesh that lusteth against the spirit". The christian finding himself in this condition and desiring to escape the corruption of the "old man", consecrates himself definitely and wholly to God (Rom. 12:1) with all he has or ever expects to have or be; and then he is able to exercise sanctifying faith in Jesus, who sanctifies him with the blood (Heb. 13:12) thru the Spirit (I Pet. 1:2) witnessed by the Holy Ghost (Heb. 10:14-15).

X-b. -The Scriptures teach us that after we are cleansed (John 15:3; Acts 10:15, 44) with the blood we then need to receive the filling of the Spirit, the baptism with the Holy Ghost, the abiding Comforter, that was promised by John the Baptist (Matt. 3:11) and corroborated by Jesus Christ (Jn. 14:16-17); that on receiving the baptism with the Holy Ghost we have the same evidence which followed in the Acts 2nd, 10th and 19th chapters, to wit: The speaking with other tongues as the Spirit gave utterance.
