RULES OF DECORUM

Art. I—The association shall open and close by prayer.

Art. 2—The moderator and clerk shall be chosen by the sufferages of the members present.

Art. 3—Only one person shall speak at a time who shall rise from his seat and address the moderator when he is about to make his speech

Art. 4—The person thus speaking shall not be interrupted in his

speech by any but the moderator until he is done speaking.

Art. 5. He shall strictly adhere to the subject and in no wise reflect on the person who spoke before, so as to make remarks on his life, feelings or imperfections, but shall fairly state the case and matter as near as he can so as to convey his light and ideas.

Art. 6—No person shall abruptly break or absent himself from the

association without first liberty being obtaining from it.

Art. 7—No person shall rise or speak more than three times on one

subject without first obtaining liberty from the association.

Art 8—No member of this association shall have liberty of laughing during the sitting of the same, nor whispering in the time of speech.

Art. 9—No member of this association shall address another mem-

ber in the term or appellation other than brother.

Art. 10—The moderator shall not interrupt any member in or prohibit him from speaking until he gives his light on the subject, except he break the rules of decorum.

Art. 11—The names of the several members of this association shall be enrolled by the clerk and called as often as this association requires.

Art. 12—The moderator shall be the last person who shall speak on the subject, who may give his opinion if he choose, unless the association is equally devided.

Art. 13—No member of this association shall join any secret order, and such shall be a violation of our faith and order, and shall be dealt

with by their churches.

Art. 14—Any member who shall willingly and knowingly break any of these rules may be reproved by the association as it may think proper.



- Art. 14. Any member who shall willingly and knowingly break any of these rules may be reproved by the Association as it may think proper.





subject without first obtaining liberty from the Association.

Article 8. No member of this Association shall have the liberty of laughing during the sitting of same, nor whispering in time of speech.

Article 9. No member of this Association shall address another mem-

ber in the term or appellation other than that of Brother.

Article 10. The Moderator shall not interrupt any Brother in or prohibit him from speaking until he gives his light on the subject, except he break the rules of decorum.

Article 11. The names of the several members of this Association shall be enrolled by the Clerk and called as often as this Association requires.

Article 12. The Moderator shall be the last person who shall speak on

the subject, who may give his opinion if he chooses, unless the Association is equally divided.

Article 13. No member of this Association shall join any secret order,

and such shall be a violation of our faith and order, and shall be dealt

with by their churches.

Article 14. Any member who shall willingly and knowingly break any of these rules may be reproved by the Association as it may deem proper.

9. We believe in the resurrection of the dead. We believe that the punishment of the wicked will be everlasting and the joys of the right-eous shall be eternal.

10. We believe that no minister has the right to administer the ordinance of baptism and the Lord's Supper except such as are regularly

ordained by the presbytery.

- 16. If any minister, deacon, or Clerk transgress these rules, the church shall have power to call help from other churches to aid in settling it.
- 17. We agree not to commune with any persons unless they are baptized in our faith and order.
- 18. We agree to commune with Predestinarian Baptists who are in good standing.
- 19. If any member sees another transgressing the rules of the church and does not bring it to the church after applying the eighteenth chapter of Matthew, they are liable to be tried before the church themselves. Each church shall have a Moderator and be governed by the voice of the church.
 - 20. No ordination shall be done only in a Union or an Association.
- 21. No traffic or trade shall be nearer than 150 yards of the church grounds.
- 22. No minister or members shall have a right to carry any of the Corresponding Association property to any Association.
- 23. No members who have been withdrawn from fellowship will be allowed to come into the Association. He first shall get right at his own church.
- 24. No member of this Association shall join any secret order and such shall be a violation of our faith and order and shall be dealt with by their churches.
