## FIRST DAY—MORNING SESSION.

HOLLY SPRINGS, N. C., Aug. 12, 1885.

The Wake Baptist Association met in its nineteenth annual session, with the Holly Springs Baptist Church, August 12, 1885.

The Moderator, Rev. J. Perry, conducted the devotional exercises. Prayer was offered by Rev. G. W. Harris. In the absence of the pastor, Rev. L. H. Hackney, Bro. Robert Fuquay extended a hearty welcome to the large number of delegates and visitors present, to which the Moderator responded in fitting and instructive words. Rev. William A. Green, who was appointed to preach the Introductory Sermon, being absent, on motion the sermon was postponed till evening.

The Constitution of the Association was read.

The committee on hours of meeting made the following report:

Meet at 9 A. M. and adjourn at 12 M.; meet at 2 P. M. and adjourn at 5 P. M.; meet at 8 P. M., and adjourn at pleasure.

The report was adopted.

The Association adjourned with prayer by Rev. S. H. Weatherspoon.

#### AFTERNOON SESSION.

The Association met at the hour designated.

Prayer was offered by Rev. H. C. Crosby.

Minutes of the morning session were read and approved.

The Moderator announced that letters and reports from churches was the next business in order.

Messengers from the different churches presented their reports. These reports were encouraging. They showed that most of the churches had received additions since the last annual meeting of the association. Many have commenced to erect new houses of worship; others are repairing their old ones. Most of the churches have prosperous Sunday Schools. Many of the pastors and messengers report that revivals were in progress when they left their respective churches, and that God was greatly blessing them with an out-pouring of the Holy Spirit.

Revs. H. M. Maloy and P. T. Young were appointed to conduct services at the Christian Church at 4 o'clock.

Two letters from the Sisters' Societies at Rolesville, containing \$2 each, for the Orphan Asylum and the Foreign Mission work, was read before the Association.

The hour having arrived, the Association adjourned with prayer by Rev. E. Rice.

#### EVENING SESSION.

Before the hour of service had arrived the people began to gather in large numbers to listen to the Annual Sermon by Rev. Wm. A. Green.

The exercises were opened by singing Hymn 522, Church Hymn book,

"Oh for a thousand tongues to sing," &c.

Prayer was offered by Rev. P. F. Maloy.

The speaker took for his text 1 Cor. 3: 9, "Ye are God's building." The following is the theme of the discourse:

1. The description of the church of God—A building.
2. This building has an architect which is Christ—It reflects His glory, transcends the temple of Solomon.
3. This building has a good foundation—A tried stone—Has been tried by every nation.
4. Its structure—Material prepared by Christ—It was once unfit for God's building—Had to be made living stones.
5. Who are employed to build this house?—Ministers, teachers in the Sunday School, Missionaries and each member of the church in some capacity.
6. The principles by which the material is held together—Faith and love.
7. The design of this building—The dwelling place of God—God delights to dwell in his church.
8. The beauty of this building—Bears God's image and reflects his glory.

These points were presented in a clear and forcible manner, and must have made a deep impression upon the mind of every person whose privilege it was to listen to this excellent discourse.

At the conclusion of the sermon a collection of \$4.40 was taken up for the Association.

Adjourned with benediction.

---

#### SECOND DAY—MORNING SESSION.

The Association met at 9 A. M.

Devotional exercises were conducted by Rev. Daniel Tucker.

Minutes of the previous afternoon and evening sessions were adopted.

Reading letters and reports from churches were continued.

The following were appointed a committee to examine candidates for ordination: Revs. G. W. Perry, William A. Green, Samuel Fulwider, T. B. Edwards and Daniel Tucker.

A motion was made that the Zoar church be received and the amount due the Association be donated to said church. Referred to the Committee on Reception of Churches.

A letter from the Sisters' Missionary Society at Franklinton, containing \$3 for Foreign Missions, was read before the Association.

An amendment to the Constitution was offered by Prof. H. C. Crosby and referred to the Committee on the Constitution.

Rev. G. W. Perry, Prof. H. C. Crosby and N. F. Roberts were appointed a Committee on the Revision of the Constitution.

The Treasurer made his report for the year ending August 12, 1885.

On motion a committee of three was appointed to examine the Treasurer's report. The following constituted the committee; Bros. James H. Young, P. F. Maloy and A. J. Edwards.

On motion, a letter of dismissal was granted Mt. Olive Baptist church to unite with the New Hope Association.

An amendment to the Constitution was offered by Bro. W. H. Patterson and referred to the Committee on the Constitution.

The Association adjourned with prayer by Rev. C. Johnson.

#### AFTERNOON SESSION.

Met according to adjournment.

The Moderator, Rev. J. Perry, in the Chair.

Rev. P. T. Young led in prayer.

Minutes of morning session were read and adopted.

The committee appointed to examine the Treasurer's report reported that they had carefully examined the Treasurer's report and found it correct. The report was adopted.

On the recommendation of the Committee on Reception of Churches, Zoar church was admitted.

The Home Mission Board made its annual report, which was adopted.

The following were appointed to select the place of the next annual meeting of the Association: Bros. M. Collins, A. Thomas, Isaac Chessor, John Tomlinson, W. Y. Mials, E. Perry and S. H. Harris.



A letter from Rev. E. B. Blake was read.

A motion prevailed that the union meetings and plans of raising money adopted in 1883, be continued.

The following were appointed a committee on officers : Bros. T. B. Edwards, J. T. Thompson, A. L. Sanders, P. T. Young and William Williams.

The committee on the place of the next meeting of the Association made their report, which was adopted.

The session adjourned with prayer by Rev. T. B. Edwards.

#### EVENING SESSION.

The exercises were opened at 8:30 o'clock with singing Hymn 698 in Church Hymn Book, "Sow in the morn thy seed," &c.

Selections of Scripture was read and prayer offered by Rev. J. Perry.

Bro. Perry then addressed the audience upon the necessity of establishing an Orphan Asylum for the colored orphans of North Carolina.

N. F. Roberts made some remarks upon the same subject. After which a collection was taken for the Asylum amounting to \$3.04.

Adjourned with benediction.

---

#### THIRD DAY—MORNING SESSION.

Association met at 9 o'clock.

Devotional exercises were conducted by the Moderator.

Minutes of the previous afternoon and evening sessions were adopted.

The Committee on the Revision of the Constitution made their report. The report was adopted by sections.

Bro. B. B. Goins, of the A. M. E. Church, appeared upon the floor and was welcomed to a seat in the Association.

The Committee on Officers made their report and the following were elected: Rev. J. Perry, Moderator; N. F. Roberts, Clerk; Rev. G. W. Harris, Treasurer; Rev. William A. Green, Auditor.

On motion, the Association donated the Orphan Asylum \$50.

A motion prevailed that no other donations be made to churches till those that were promised aid last year receive their money.

On motion, each minister and messenger was requested

to subscribe the amount he was willing to give to the Orphan Asylum, to be paid by November 15, 1885.

The following pledges were taken :

Bros. E. B. Blake, \$1, paid 50 cents cash ; A. B. Fleming, H. M. Maloy, R. B. Haywood, P. T. Young, D. S. Saulter, William Debnam, C. H. Williamson, M. C. Betts, H. T. Cook, J. N. Perry, G. L. Rand, Henry Smith, J. S. Saunders, C. Johnson, \$1 each ; Samuel Harris \$2 for himself and \$6 for his church ; Juniper Level Church \$5, by Rev. P. F. Maloy ; Alexander Blalock \$5 ; J. T. Thompson \$3 ; Macedonia Church \$2, by W. Watkins ; Rev. G. W. Harris \$2.

A motion prevailed that 1,200 copies of the minutes be printed and distributed among the churches of the Association. The Clerk, Moderator and Auditor were appointed a Committee on Printing.

Adjourned with prayer by Bro. Amos Perry.

#### AFTERNOON SESSION.

Met at 2 o'clock.

The house was called to order by the Moderator, who conducted the devotional exercises. Prayer was offered by Rev. E. Rice.

The minutes of the morning session were read and adopted.

A motion prevailed that the names of the licensed ministers be enrolled.

A motion prevailed that the Clerk have \$12 for his services and the traveling expenses of the Moderator and Treasurer be paid by the Association.

Voted that the general collection, \$4.40, be donated to the Orphan Asylum.

The Finance Committee made their report. Adopted.

The Committee on Letters reported. Adopted.

The Committee on Ordination made their report.

Rev. C. H. Bynum and Rev. Henry Stewart were welcomed to seats in the Association.

The following appointments were made for the next annual meeting :

*Introductory Sermon*—Rev. Henry M. Maloy.

*Doctrinal Sermon*—Rev. G. W. Perry.

A resolution offered by Bro. P. F. Maloy, thanking the church and citizens of Holly Springs for the hospitality extended to the Association, was adopted.

The work of the Association having been completed, the Association adjourned to meet with the Liberty Baptist Church on Wednesday before the third Sunday in August, 1886.

### REPORT OF HOME MISSION BOARD.

DEAR BRETHREN :—Your Board, to which the Home Mission work of the Association was entrusted, submit the following report for the year ending August 12, 1885 :

The Board endeavored to carry out the plan of work adopted by the Association at its last annual Meeting. That is, instead of employing a regular missionary, use the funds in aiding the most needy churches within the bounds of the Association, in building houses of worship or defraying the expenses of a pastor where a church is not able to have preaching once a month.

At the first meeting of the Board four churches were mentioned as being in need of aid : St. Mary's, Adam's Chapel, Rock Spring, and Mt. Moriah. Rev. G. W. Perry was appointed to ascertain whether or not these churches had or could secure a warrantee deed for their site, the prospect of building up a good church and the extent of their ability to help themselves. After receiving Bro. Perry's report, the Board donated to Mt. Moriah church \$15, and appointed Rev. G. W. Harris as missionary to St. Mary's, at Wilson's Mills, with the understanding that he also visit Adam's Chapel.

Some other applications for aid were received, but your Board deemed it best to defer action till the meeting of the Association.

## CONSTITUTION.

ARTICLE I. This body shall be denominated and known as the "WAKE BAPTIST ASSOCIATION."

ART. II. The Object of this Association shall be the promotion of Christ's kingdom among men ; and the means of accomplishing this shall be in strict conformity to the New Testament.

ART. III. This Association shall be composed of delegates chosen by the churches connected with it—each church being entitled to two or more delegates. Ministers who are members of the churches connected with this body shall be considered members of the Association *ex officio*. And ministers who are not in charge of, or connected by membership with churches within the bounds of this Association, and who present testimonials of good standing in the Baptist denomination, may become members of this Association by the payment of one dollar annually : *Provided*, Ministers who aided in the organization of this Association shall be considered members so long as they are in good standing in the Baptist denomination.

ART. IV. The delegates from each church shall bear a letter certifying their appointment, giving an account of the condition of the church, and a statement of all funds contributed for benevolent purposes during the year.

ART. V. The officers of this Association shall be Moderator, Clerk, Treasurer and Auditor, who shall be elected annually by the Association. In addition to these, there shall be appointed annually by the Moderator, an Executive Board of seven, an Educational Board of five, a Home Mission Board of five, and a Foreign Mission Board of five members.

ART. VI. It shall be the duty of the Moderator to preside during the deliberations of the body, to enforce an observance of the Constitution, preserve decorum, appoint committees, decide all questions of order, give his opinion concerning any subject under discussion after others have spoken, or when called upon, and give the casting vote in case of a tie.

ART. VII. It shall be the duty of the Clerk to record the proceedings of each annual session, and superintend the printing and distribution of the minutes among the churches.

ART. VIII. It shall be the duty of the Treasurer to receive all funds sent up by the churches, or collected during the session of this body, and disburse the same for the purposes for which they were sent or collected. He shall make an annual report to the Association. He shall not pay any order drawn on the Treasury except it is signed by the Moderator and the Clerk of the Association, subject to the provisions in the By-Laws.

ART. IX. Any church desiring to become a member of this body shall present her petition at an annual session of the Association, through delegates appointed for that purpose, and if the Association shall consent to receive her, the moderator shall extend to the delegates the right hand of fellowship.

ART. X. The Association shall not maintain fellowship with any church or churches that neglect to preserve gospel order.

ART. XI. The Association may invite visiting brethren to seats, and extend to them all the privileges of the body save that of voting.

ART. XII. The annual session of this body shall commence on Wednesday before the third Sabbath in August, at such place as the Association may select.

ART. XIII. The ministers composing the Association shall hold three ministerial meetings a year, in such places as brethren may designate.

ART. XIV. We will receive no minister into this Association but those who have a good moral character.

ART. XV. We will withdraw the right hand of fellowship from every minister who walks disorderly and contrary to the Gospel rule.

ART. XVI. Each church connected with this Association may continue its membership by paying three cents annually upon the head of each of its members. This fund shall be known as a Minute Fund. In addition to this, each



church shall be asked annually to pledge certain amounts for missionary work and such other benevolent objects as the Association may undertake to carry forward.

ART. XVII. By appointment of the Association, there shall be preached during each annual session an Introductory Sermon.

ART. XVIII. This Constitution may be amended at any annual session by a vote of two-thirds of the members present.

---

## BY-LAWS.

SECTION 1. All moneys sent from churches, societies and individuals shall be acknowledged in the minutes of the Association.

SEC. 2. Before the final adjournment of the Association all the funds, notes, &c., shall be counted by the Finance Committee and Treasurer. The Treasurer shall give the Finance Committee a receipt for the amount placed in his hands.

SEC. 3. The Treasurer, before receiving any funds from the Association, shall give a justified bond for a sum double the amount of that which may come into his hands, for the faithful performance of the duties of his office.

SEC. 4. No missionary or agent of the Association shall be Treasurer.

SEC. 5. The Treasurer shall refund all money paid out otherwise than specified in the Constitution.

SEC. 6. After the expenses of the Association shall have been paid, the remaining associational funds shall be applied to such purpose as the Association shall direct. The Home Mission Board shall execute the plans adopted by the Association.

SEC. 7. The Treasurer shall turn over to his successor all funds, notes, books and papers belonging to the Association, as soon as his successor shall give a bond as specified in the above sections.

SEC. 8. Should the newly elected Treasurer in any case fail to qualify, the Finance Committee shall retain the funds and be held responsible for the same till a Treasurer elected by the Association or the Executive Board shall qualify.

SEC. 9. The Auditor shall audit the accounts of the Treasurer and make annual reports to the Association.

SEC. 10. The duties of the boards provided for in the Constitution shall be such as are usually performed by such boards in other similar bodies.
