PROCEEDINGS

Shady Hill, Person County, July 24, 1912.

The East Cedar Grove Missionary Baptist Association con vened with the above named church at ten a. m. in its seventeenth annual session. Moderator Rev. H. G. Tilley presiding. Praise Service by Rev. J. T. Thorp, Rev. T. L. Bobbett, forty-five minutes, during that time many of the brethren took an active part, expressing praise and thanksgiving to the Lord, for his presence and guidance. Moderator then called for welcome address, the pastor Rev. A. B. J. Wyche came foward, and in well choosen words, bade a hearty welcome to the delegation, he spoke of the responsibility resting upon us as ministers, leaders and workers, the importance of prepairing ourselves to meet the outstanding world of critics. in a way to defend the Master's cause. Response by Rev. J. M. Taylor. Rev. Taylor responded in an able way, concluding his short response; by calling attention of the ministers and workers to the importance of attending the ministers conference, which meets at the N. R. T. School each summer, Durham, N. C. Next Moderator Rev. H. G. On motion by Rev. J. T. Peace, we adjourned until two p. m. Benediction by Rev. S. Wade.

FIRST DAY—AFTERNOON SESSION

The East Cedar Grove Association met pursuant to adjournment Moderator Rev. H. G. Tilley in the choir. Devotional exercises conducted by Rev. J. C. Lyon, Rev. Ambros Allen. Rev Allen Sung 987 Baptist Hymn Book, "A few more years etc." Rev. J. C. Lyon read i Cor. 13 Chapter, prayer by Rev. J. T Thorpe. Moderator continued praise service fifteen minutes, and many of the brethren took part and expressed thanks for the many favors the Lord had shown them. Moderator then called for minutes of the morning session were adopted. The committee on Hours of Meeting and Adjournment reported (See report.) On motion by Rev. J. H. Lyon, report of committee on Hours of Meeting and Adjournment was received and adopted. Committee on devotional exercise report. (See report.) Report adopted.

The corresponding Secretary introduced the following visitors: Rev. C. J. Springfield, Rev. S. Wade, Rev. R. E. Foster, Rev. Robert Street and Rev. L. H. Powell, the delegation greeted them by standing.

The Moderator then called for introductory sermon, Rev. J. T. Peace went upon the pulpit, accompanied by Rev. T. H. Jeffers. Rev. Peace read Exo. 4th Chapter, from 1-15, Prayer by Rev. Jeffers, after singing a selection, Rev. Peace came forward and announced his Text, from Exo. 4:2-17, Subject, "Call to Ministery." Prayer by Rev. C. J. Springfield. Collection taken by Rev. J. H. Lyon and Rev. J. M. Taylor, amount of collection \$6.05, it being time to close, the Association adjourned. Benediction by Rev. J. C. Lyon.

WEDNESDAY NIGHT SESSION,

Service opened by singing and reading scripture, by Rev. T. L. Bobbitt and Rev. Walter Hawkins, Text Acts 27:31. Collection \$1.35.

SECOND DAY-Morning Session

Association called to order at nine-thirty, by Moderator, Rev. H. G. Tilley. Praise Meeting conducted by Rev. T. J. Wagstaff and Rev. J. W. Sanford, twenty minutes, during which time the brethern spoke in loving terms of praise and thanksgivings. Moderator then read out the various committees and names. The Moderator by common consent suspended the rule and gave ten minutes for Mrs. Cora Thomas, our missionary from Africa, By request of Mrs. Thomas, Rev. J. H. Lyon sang "Sometime We'll Stand Before the Judgment Bar." While singing the last verse, Mrs. Thomas, came forward and the delegation stood greeting her, and in very striking, clear and plain words Mrs. Thomas put her work before us so that we felt Africa's condition more appearantly and present than ever before in our lives. After expressions from a few of the brethren regarding our work in Africa, a collection was taken by Rev. J. H. Lyon and Rev. J. M. Taylor for the building in Africa; the amount \$21.00.

Rev. L. J. Alexander who was on for the Doctrinal Sermon being absent the rule was suspended and the sermon omitted. Rev. T.L. Bobbitt payed over one dollar and thiry five cents collected at Wednesday night's service, Moderator adjourned to meet at two P. M. Benediction by Rev. L. H. Powell.

SECOND DAY-FATERNOON SESSION

The Moderator, Rev. H.G. Tilley, presided. Praise meeting conducted by Rev. S. T. Thomas, and Rev. J. H. Street read one hundredth's Psalm. After expression of thanks by many of the brethren, Moderator announced house opened for business, called for reading of minutes of morning session. On motion by Rev. Ambrose Allen, the minutes were received and adopted. Committee on Ministerial Education reported, (see report.) On motion by Rev. W. H. Standfield the report was adopted. Dr. N. F. Roberts, Dean of Theological Department, Shaw University, was asked to speak on this report. Dr. Roberts (defined the resolutions of

the report with good instruction and wholesome advice, and the need of trained ministers and leaders was touched on by him, concluded his very helpful talk and offered pledge cards to those who wished to help in the work of a building for theologs at Shaw. On motion by Rev. J. M. Taylor, the rules were suspended and Rev. J. W. Day excused from leading topic on program.

Adopted on motion by Bro. Jacob Tanner. Motion by Rev. J. M. Taylor to amend report of Committee on Sermons, by striking out "closing sermon," as we are accustomed to have no closing sermon. Committee on New Churches reported, (see report). Adopted on motion by Jacob Tanner. Committee on Sunday School reported, (see report).

Rev. C.H. Mayes reported from the stand collection, \$6.00. Committee on Credentials reported, (see report). Adopted. Committee on Appropriation reported, (see report). Adopted. Adjourned to meet Friday morning, twenty-sixth at 9:30 o'clock. Benediction by N. F. Roberts, D. D.

Collection reported from Thursday night service, amount, five dollars (\$5.05) five cents.

THIRD DAY-MORNING SESSION

Moderator, Rev. H. G. Tilley, presided, called to order 9:30 o'clock. Praise Meeting by Rev. J. W. Sanford and Rev. J. H Street. Rev. Sanford read Psalms 37; prayer by Bro. Street. Moderator announced that Praise Meeting continue. Fifteen minutes after expression from the brothren, Moderator announced the Association ready for business. The minutes of the second day afternoon session were read. By motion the minutes were adopted, after correction. On

motion by Rev. J. C. Lyon that the Association offer an apology to Rev. J. W. Sanford.

Rev. L. H. Powell came forward and represented his work to the Association. Committee on Temperance which had been brought over from Thursday evening in order to give more time to discuss its resolutions was reported and well discussed; led by Rev. W. F. Young, one of our strongest men on the question of morals and temperance. Many followed him, closing with a vote to sustain and defend the resolutions of the report.

Middle Baptist Association.

On motion by Rev J. C. Lyon, we send Rev. S. T. Taylor and Rev. J. W. Bradsher to the Roam Association On motion by Rev J.T. Peace, we send to State Convention at Lumberton, N. C, Bro. R. B. Bolton, Lee Jeffres. On motion by Rev. C. H. Mayes, we send Rev. W. D. Smith, Rev. T. J. Wagstaff to Wake Baptist Association. Resolution of thanks: Whereas, the Shady Hill Baptist Church and Pastor in the person of Rev. A. B. J. Wyche has been very hospitable to us in giving us a good time. and making it pleasant for us in every respect, every delegate and preacher has been royally intertained. Therefore: Be it resolved, that we the East Cedar Grove Association turn a vote of thanks to this Church, Pastor and Vicinity for the kind hospitality that has been extended during our stay.

REPORT OF TEMPERANCE COMMITTEE

Your committee beg leave to report the following:

Considering the evidences of death and destruction around us, caused by the evil of intemperance in various forms, especially the drink habit, the time has come when the church should make special effort to battle with this death dealing influence.

The death rate among our young people has become alarming, which death rate is caused by intemperate habits such as the use of narcotics which poison the human system and renders it unable to resist the germs of various diseases.

Whereas, intemperance is the monster evil in the land, the chief hindering cause of the church of Christ, the author of confusion and the destroyer of souls, we recommend that this Association request its ministers and churches to renew their effort in the hattle against intemperance and the drink habit, that the influence of the church be more felt and effective in the warfare against this deadly enemy.

Resolved 1st. That East Cedar Grove Association condemu in unmeasured terms the use of intoxicating liquors, the blightening enemy of the church, agent of the devil

Resolved 2nd That in the future this Association will refuse to license or ordain to preach the gospel, men who cannot furnish satisfactory proof that they are out and out against the use of intoxicating liquors and are themselves abstainers from its use.

Resolved 3rd. That it shall be the duty of each pasto: in charge of churches of this Association to preach at least two temperance sermons during the year and report the number of temperance sermons preached and text used in same to the next sitting of this Association.

RULES OF ORDER

r. The meeting of the Association shall be opened with singing, reading the scriptures and prayer by the Moderator or whoever he may appoint. There may be religious talks made by various brethren at each praise meeting. No one

one shall consume more than five minutes at these times, except the Moderator, who, on opening the first morning, may use as much time time as decency will allow.

- 2. The minutes of the previous meeting shall be read, corrected and approved.
- 3. No brother shall interrupt while he is speaking unless his remarks are foreign to the subject under debate. Any brother may then arise to a point of order or the Moderator call him to the proposition under consideration. When a brother is called to order by the Moderator he shall take his seat until it shall be determined by the Moderator whether or not he is in order. The said brother may appeal from the decision of the chair. The decision of the Association shall be final.
- 4. No brother shall use personal reflections during discussions nor speak more than twice to a motion, nor longer than ten minutes.
- 5. The Corresponding Secretary shall introduce all correspondence, corresponding delegates, notes, and report unfinished business, and read the Constitution and Rules of Order at the opening of each annual session, and enroll the hames of the delegates.
- 6. Delegates sent to this Association shall remain until the business of the Association is completed unless they be excused by the Association
- 7. No delegate shall leave the house during the process of business without leave of the Moderator.
- 8. Hours of meeting and adjournment shall be determined by a committee, except the first morning. Then the Moderator shall call the house to order at ten o'clock a. m.
- 9. No committee shall meet during the hours of business except a committee to whom a report has been recommitted,
- 10. These Rules of Order may be suspended or amended at any annual meeting by a two-thirds vote.
- 11. That the Clerk shall have but ten dollars for his service for superintending printing minutes and distribution.

CONSTITUTION

- ARTICLE 1. This Association shall be styled the East Cedar Grove Missionary Baptist Association of North Carolina.
- ART. 2. This Association shall be composed of regular Baptist churches in good standing and full practice of doctrines, faith, discipline, ordinances and efficacy of the regular Baptist denomination.
- ART. 3. The officers of the Association shall be a Moderator, Vice-Moderator, Clerk, Corresponding Secretary and Treasurer, and a Statistician, whose duties shall be as is common to such officers, who shall be elected annually, and hold their offices until their successors are appointed viva voice. The Moderator and Clerk shall not be eligible to hold their offices more than two consecutive sessions,
- ART. 4. The sole object of this Association shall be for fraternal intercourse, mutual council to stimulate the union of churches, to promote among ourselves the interest of education and the spreading of God's word. Any church, a member of this Association, neglecting to be represented by letter or delegate at two successive annual meetings shall be visited by a worthy admonitor from this body, and if she neglects to attend the third annual session she shall be cut off from the Association.
- ART. 5. This Association shall meet annually, composed of not more than two delegates from each church, with a letter stating the condition of the church. Said meeting shall convene on Wednesday after the third Sunday in July, with introductory sermon, and continue until the business of the Association is completed on the following Friday at 5 p. m. The rules of order in Hiscock's Baptist Church Directory shall govern the deliberations of this body.
- ART. 6. Membership in this Association shall be confined to the delegates and preachers who hold membership within these bounds.
