## Proceedings

The East Cedar Grove Missionary Baptist Association convened with the Vernon Hill Baptist Church at 10:00 a. m. in its Nineteenth Annual Session, Rev. T. H. Jeffres called the Association to order. Praise service was conducted by Rev. T. L. Bobbitt and S. T. Taylor sang hymn No. 622, Baptist hymn book. Rev. T. L. Bobbitt read the 51st Psalm. Prayer was offered by Deacon J. T. Beard. During the forty-five minutes of prayer service the brethren spoke many words of encouragement and praised God for the many blessings bestowed upon us. At the conclusion of the praise service the Pastor, Rev. J. C. Lyons, came forward and bid the brethren a hearty welcome to the church and community.

Rev. W. D. Smith, in a very able manner responded to the Address of Welcome of the pastor.

The Moderator, Rev. T. H. Jeffres, came forward and in an impressive and modest way made his annual address to the delight of all the brethren. In this address he pointed out the great work that lies before us and the necessity of a united force and greater zeal to accomplish the great work for the Master.

Rev. S. T. Thomas responded in a very forceable way to the address of the Moderator. The constitution was then read by Rev. J. M. Taylor.

On motion that the rules be suspended and Rev. J. M. Taylor be allowed to address the Association, as he was made late in meeting the Association, in which time he spoke many strong words of encouragement to the brethren of the convention.

### FIRST DAY—AFTERNOON SESSION

Moderator, Rev. T. H. Jeffres presiding, called the Association to order. Prayer services, conducted by Revs. H. Skinner and G. T. Street. Scripture reading, 6th chapter of Galatians. Prayer was offered by Rev. G. T. Street.

On motion the minutes of the first day's forenoon session was read and approved.

At this time the Corresponding Secretary introduced to the Association Rev. D. Smith, of Shilo Association, and Miss Rosa B. Ligon, general agent for the Virginia Orphanage.

The hour having arrived for the introductory sermon Rev. J. H. Lyons ascended the rostrum, accompanied by E. B. Thompson, who sang, "Go Preach My Gospel." Rev. J. H. Lyons read Acts 24. Prayer was offered by Rev. Thompson. Hymn No. 251 was rendered.

Rev. J. H. Lyons then took for a text: Acts, 24th chapter and 25th verse. "As he reasoned of righteousness, temperance and judgment to come, Felix trembled and answered, go thy way for this time, when I have a more convenient season I will call for thee." Theme—The power of the Gospel.

Rev. Lyon said in part: "A few evenings ago I presented a few facts concerning the life of Paul to the Y. M. C. A., and the steadfastness he had in Christ, even when he was subjected to terrible persecutions, and sorrow. How great and

powerful that Gospel must be when it had once gained an entrance into Paul's heart. There was no power on earth to drive it out, for it he suffered the loss of all things, and as he viewed them as they fled from him he counted them but dross that he might win Christ."

Rev. Lyon was at his best and made us all to feel glad.

Prayer was then offered by Rev. J. A. Lewis.

A collection of \$5.10 was lifted.

On motion that the pastors and deacons be a committee on devotional exercises.

The committee reported, Rev J. A. Lewis to preach at the stand.

On motion of Rev. J. M. Taylor, the act of the incorporation be printed in pamphlet form for the benefit of all.

On motion the rule be suspended for twenty minutes that the different committees be appointed.

The twenty minutes having expired, by unanimous consent, the time was extended for the completion of the committees.

On motion Brother S. Chandler, W. O. Harris and H. T. Brooks be excused for the remainder of the day.

On motion the report of the Committee on Devotional Exercises be received. [See report.]

Motion to adjourn.

## SECOND DAY—MORNING SESSION

The Association met pursuant to adjournment. Moderator, Rev. T. H. Jeffres called the Association to order.

Praise services were conducted by Rev. E. S. Chandler and Rev. J. M. Taylor. Rev. J. M. Taylor read Isa. 61. Prayer by Rev. D. Smith.

During the praise services the brethren spoke many words for the Master and our hearts did burn within us. At the conclusion of the praise meeting the Moderator ordered that the minutes of the first day afternoon session be read.

On motion the minutes were received and adopted. On motion we reconsider the motion that was tabled the previous day relative to the appointment of a certain committeeman. At this time the Corresponding Secretary came forward and introduced Brother Henry Peace, a member of the Executive Board of the Middle Baptist Association.

The Committee on Foreign Missions made their report. [See report.]

The hour having arrived for adjournment the rules were suspended and Miss Rosa Liggon addressed the Association on the behalf of the Orphanage of Virginia, after which a collection of \$7.01 was taken. Also a collection from the stand by Rev. D. Smith of \$2.10.

The Association then adjourned forty-five minutes for dinner.

Rev. J. T. Peace lodged a motion to change a part of Article 6, of the Constitution.

Committee on New Churches made their report. On motion the report of the committee was received and adopted. [See report.]

On motion Brother M. Tate, R. Goss and Brother Pettiford be excused.

On motion the report of the Committee on Appropriations was received and adopted. [See report.]

On motion of Brother H. T. Brooks a vote of thanks be tendered this church and people.

On motion that all moneys for foreign missions be sent to Dr. C. S. Brown by the Secretary. Collection from stand \$2.57.

On motion of Rev. J. A. Lewis that Rev. J. H. Lyons be a delegate to the State Convention.

On motion of Rev. J. H. Lyon, that Rev. J. T. Peace and J. M. Taylor be delegates to the Lott Cary Convention.

On motion that Rev. J. W. Day and J. C. Lyons be delegates to the Middle Baptist Association.

On motion that Rev. W. D. Smith be a delegate to the National Baptist Convention.

On motion that H. G. Tilley be a delegate to Shilo Association.

On motion that Rev. S. T. Thomas be a delegate to the Cedar Grove Association.

On motion that the resolution of Rev. H. G. Tilley be printed in the minutes.

On motion that the rule be suspended until the business of the Association is finished.

On motion that Rev. A. K. Cousin be a delegate to the Wake Baptist Association.

On motion the Association adjourned to meet with the Olive Grove Baptist Church, Granville County.

## RULES OF ORDER

1. The meetings of the Association shall be opened with singing, reading the Scripture and prayer by the Moderator or whosoever he may appoint. There may be religious talks made by various brethren at each praise meeting. No one shall consume more than five minutes at these times, except the Moderator, who, on opening the first morning, may use as much time as decency will allow.

2. The minutes of the previous meeting shall be read, corrected and approved.

3. No brother shall interrupt while he is speaking unless his remarks are foreign to the subject under debate. Any brother may then arise to a point of order or the Moderator call him to the proposition under consideration. When a brother is called to order by a Moderator he shall take his seat until it shall be determined by the Moderator whether or not he is in order. The said brother may appeal from the decision of the chair. The decision of the Association shall be final.

4. No brother shall use personal reflections during the discussions nor speak more than twice to a motion, nor longer than ten minutes.

5. The Corresponding Secretary shall introduce all correspondence, corresponding delegates, notes and report unfinished business and read the Constitution and Rules of Order at the opening of each annual session, and enroll the names of the delegates.

6. Delegates sent to this Association shall remain until the busi-

ness of the Association is completed unless they be excused by the Association.

7. No delegate shall leave the house during the process of business without leave of the Moderator.

8. Hours of meeting and adjournment shall be determined by a committee, except the first morning. Then the Moderator shall call the house to order at ten o'clock a. m.

9. No committee shall meet during the hours of business except a committee to whom a report has been recommitted.

10. These Rules of Order may be suspended or amended at any annual meeting by a two-thirds vote.

11. That the clerk shall have but ten dollars for his service for superintendent printing minutes and distribution.

## CONSTITUTION

ARTICLE 1. This Association shall be styled the East Cedar Grove Missionary Baptist Association of North Carolina.

ART. 2. This Association shall be composed of regular Baptist churches in good standing and full practice of doctrines, faith, discipline, ordinance and efficacy of the regular Baptist denomination.

ART. 3. The officers of the Association shall be a Moderator, Vice-Moderator, Clerk, Corresponding Secretary and Treasurer and a Statistician, whose duties shall be as is common to such officers, who shall be elected annually, and hold their offices until their successors are appointed viva voce. The Moderator and Clerk shall not be eligible to hold their offices more than two consecutive sessions.

ART. 4. The sole object of this Association shall be for fraternal intercourse, mutual council to stimulate the union of churches, to promote among ourselves the interest of education and the spreading of God's word. Any church a member of this Association, neglecting to be represented by letter or delegate at two successive annual meetings shall be visited by a worthy admonitor from this body, and if she neglects to attend the third annual session she shall be cut off from the Association.

ART. 5. This Association shall meet annually, composed of not more than two delegates from each church, with a letter stating the condition of the church. Said meeting shall convene on Wednesday after the third Sunday in July, with introductory sermon, and continue until the business of the Association is completed on the following Friday at 5 p. m. The rules of order in Hiscock's Baptist Church Directory shall govern the deliberations of this body.

ART. 6. Membership in this Association shall be confined to the delegates and preachers who hold membership within these bounds.

ART. 7. Pastors and deacons are recommended to be very accurate in the government of their churches, as we will recognize no church that is corrupt in practice or doctrine, according to the Holy Scripture, which is our rule of faith, practice and doctrine.

ART. 8. No difficulties arising between churches shall be heard by the Association until Gospel steps have been taken outside of this to settle the difficulty.

ART. 9. Members of other Associations, pastoring churches within the bounds of the Association, may be members of this Association, giving counsel but not allowed to vote. [See Article 6.]

ART. 10. Letters from churches shall state the number of members in full fellowship, baptized, received by letter, dismissed by letter, restored, expelled, died.

ART. 11. This Association will furnish the churches with the minutes of its proceedings and in order to do so, it is requested that the churches having more than one hundred members contribute three dollars, those having one hundred or less members contribute two cents per capita, and the money shall be sent by the delegates or in their letters to the Association, which, when received, shall be put in the hands of the Treasurer, and shall be disbursed as the Association may direct.

ART. 12. The following committees shall be appointed after the opening of the session: 1. Committee on Devotional Exercises. 2. Committee on Finance. 3. Committee on Place of Next Meeting. 4. Committee on Admission of New Churches. 5. Committee on Order of Business. 6. Committee on Publication of Minutes and such others as may be needful.

ART. 13. Any church belonging to this Association, wishing to leave and join another Association of the same faith and order, shall have a letter of dismissal from this Association to be and remain in order with us.

ART. 14. This Constitution may be amended or changed at any annual meeting by a two-third's vote, provided twelve months notice has been given.
