CONSTITUTION

of the

EAST CEDAR GROVE MISSIONARY BAPTIST ASSOCIATION OF NORTH CAROLINA

ARTICLE I

This Association shall be styled the East Cedar Grove Missionary Baptist Association of North Carolina.

ARTICLE II

This Association shall be composed of regular Baptist churches in good standing and full practice of doctrine, faith, discipline, ordinances, and efficacy of the regular Baptist denomination.

ARTICLE III

The officers of this Association shall be a Moderator, Vice-Moderator, a Statistician, whose duties shall be as is common to such officers, who are appointed viva voce. The Moderator and Clerk shall not be eligible to hold their offices more than two consecutive sessions.

ARTICLE IV

The sole object of this Association shall be for fraternal intercourse, mutual counsel, to stimulate the union of churches, to promote among ourselves the interest of education and the spreading of God's word. Any church, a member of this Association, neglecting to be represented by letter or delegate at two successive annual meetings shall be visited by a worthy admonitor from this body, and if she neglects to attend the third annual session she shall be cut from the Association.

ARTICLE V

This Association shall meet annually, composed of not more than two delegates from each church, with a letter stating the condition of the church. Said meeting shall convene on Wednesday after the third Sunday in July, with introductory sermon, and continue until the business of the Association is completed. The rules of order in Hiscock's Baptist Directory shall govern the deliberations of this body.

ARTICLE VI

Membership in this Association shall be confined to the delegates and preachers who hold membership within these bounds.

A'RTICLE VII

Pastors and deacons are recommended to be very accurate in the government of their churches, as we will recognize no church that is corrupt in practice or doctrine, according to the Holy Scriptures, which is our rule of faith, practice, and doctrine.

ARTICLE VIII.

No difficulties arising between churches shall be heard by the Association until gospel steps have been taken outside of this body to settle the difficulty.

ARTICLE IX

Members of other Associations pastoring churches within the bounds of the Association may be members of this Association, giving counsel, but not allowed to vote. (See Article VI.)

ARTICLE X

Letters from churches shall state the number of members in full fellowship, baptized, received by letter, dismissed by letter, restored, expelled, or died.

ARTICLE XI

This Association will furnish the churches with the minutes of its proceedings, and, in order to do so it is requested that all churches pay two cents per capita. The money shall be sent by the delegates or in the church letter to the Association, which, when received, shall be put in the hands of the treasurer, and shall be disbursed as the Association may direct.

ARTICLE XII

The following committees shall be appointed after the opening of the session: (1) Committee on Devotional Exercises, (2) Committee on Finance, (3) Committee on Place of Next Meeting, (4) Committee on Admission of New Churches, (5) Committee on Order of Business, (6) Committee on Publication of Minutes, and such other as may be needful.

ARTICLE XIII

Any church belonging to the Association, wishing to leave and join another association of the same faith and order, shall have a letter of dismissal from the Association to be and remain in order with us.

ARTICLE XIV

This Constitution may be amended or changed at any annual meeting by a two-thirds vote, provided twelve months notice has been given,

CONSTITUTION

of the

WOMAN'S AUXILIARY OF THE EAST CEDAR GROVE ASSOCIATION

ARTICLE I-NAME

This organization shall be known as the Woman's Auxiliary of the East Cedar Grove Association.

ARTICLE II—OBJECT

The object of the Auxiliary shall be to assist the brethren in Home and Foreign Missionary work, especially along the lines of Ministerial Education.

ARTICLE III-OFFICERS

- Section 1. The officers of theh Auxiliary shall be a President, three Vice-Presidents, a Recording Secretary, and a Treasurer. Their duties being such as are common to the offices they hold.
- Sec. 2. All officers to be elected annually and continue in office until their successors are elected.
- Sec. 3. The Executive Board of the Woman's East Cedar Grove Union shall act as Executive Board for Auxiliary, whose duty it shall be to carry out the purpose and work of the Auxiliary at its absence.
- Sec. 4. The officers of the Auxiliary are members of the Executive Board by virtue of their office. Five members shall constitute a quorum to do business for the body.

ARTICLE IV

- Section 1. The Woman's Auxiliary shall meet with the East Cedar Grove Association on Thursday morning of the same week said Association meets on Wednesday.
- Sec. 2. Any Missionary Baptist church, Sunday school, missionary circle, or educational organization may be represented in the Auxiliary by the annual payment of 50 cents. Any member of a Missionary Baptist church may become an annual member by the payment of 25 cents.
 - Sec. 3. Visitors may be invited to seats, but not to vote.
 - Sec. 4. The meetings shall be opened with devotional exercises.

RULES OF ORDER

- 1. The meetings of the Association shall be opened with singing, reading the Scriptures and prayer by the Moderator or whoever he may appoint. There may be religious talks made by various brethren at each praise meeting. No one shall consume more than five minutes at a time, except the Moderator, who, on opening the first morning, may use as much time as decency will allow.
- 2. The minutes of the previous meeting shall be read, corrected, and approved.
- 3. No brother shall be interrupted while he is speaking unless his remarks are foreign to the subject under debate. Any brother may then arise to a point of order, or the Moderator call him to the proposition under consideration. When a brother is called to order by a Moderator he shall take his seat until it is determined by the Moderator whether or not he is in order. The said brother may appeal from the decision of the chair. The decision of the Association shall be final.
- 4. No brother shall use personal reflections during the discussions; nor speak more than twice to a motion, nor longer than ten minutes.
- 5. The Corresponding Secretary shall introduce all correspondence, corresponding secretaries, notes, and report unfinished business, and read the Constitution and Rules of Order at the opening of each annual session, and enroll the names of the delegates.
- 6. Delegates sent to this Association shall remain until the business of the Association is completed, unless they be excused by the Association.
- 7. No delegate shall leave the house during the process of business without leave of the Moderator.
- 8. Hours of meeting and adjournment shall be determined by a committee, except the first morning. Then the Moderator shall call the house to order at 10 o'clock a. m.
- 9. No committee shall meet during hours of business except a committee to whom a report has been recommended.
- 10. The Rules of Order may be suspended or amended at any annual meeting by a two-thirds vote.
- 11. That the Clerk shall have \$15.00 for his services of superintending printing of Minutes and their distribution.

PROCEEDINGS

Berea, N. C., July 18, 1928.

The Thirty-Third Annual Session of the East Cedar Grove Association met with the New Hope Granville Church on the date mentioned above to engage in its annual meeting. The meeting was called to order by the Moderator, Rev. S. T. Thomas. The devotional exercises were led by Rev. G. T. Street and Brother Max Johnson. Hymn No. 110. Psalms 133 was read for Scripture lesson; then Rev. G. T. Street invoked God's blessings upon the delegation through prayer. Twenty minutes were given for praise service, in which time many heartfelt expressions were made.

After the devotionals, the Moderator declared the meeting open for business. He then announced that the welcome address would be delivered. After the pastor of the church, Rev. J. T. Peace, was presented by the Moderator, he came forward and with very uplifting words he caused the delegation to feel welcome. Among many other things, Rev. Peace said that the present day is calling for prepared ministers who are prepared both in head and in heart. He said further, that God has not called talking-machines to preach the Gospel, but He has called living men to preach the Gospel. He made us welcome on the part of the church, the Sunday School and the Home Mission Circle. He asked that the brethren strive to give to the people here the most wholesome instruction while in session.

A motion carried that in the absence of Rev. E. W. Walker, who was to have made the response to the welcome address, that Rev. J. H. A. Jenkins would respond to the welcome address. Rev. Jenkins came forward and delivered a very impressive response on the part of the Association.

Brother J. C. Jones introduced and presented the moderator, Rev. S. T. Thomas, to deliver his annual address. Rev. Thomas came forward and began his address by saying: "I thank God for having brought us together in this thirty-third annual meeting of the East Cedar Grove Association. He gave for his subject "The Value of Men." In setting forth the value of men, he referred to the 8th chapter and 4th verse of the Psalms, which reads as follows: "What is man that thou art mindful of him." In discussing God's love for man he said that God has many agents in the world in man's behalf. He also said that God's care for man denotes the value of man. He said that God's love for man was so great that despite the disobedience of man, He

arranged that man might be saved if he would believe. In closing, Rev. Thomas stressed the importance of pointing out continually the value of man.

After the moderator's address, a motion carried that Dr. A. S. Croom respond because of the absence of Rev. P. E. Green, who was to have responded. In Dr. Croom's response, he said that the value of man laid on us a tremendous responsibility to give to the world valuable service. He said further that another big task of valuable men is to help Jesus Christ to redeem the world to Himself. He urged that religion be lived out rather than talked out.

The moderator ruled regarding the constitutional matter of last year, that the report of the Committee on Revising the Constitution be accepted as the right amount of money to represent each church as required by the Association, which was two cents per capita.

Motion carried to adjourn for one hour. Benediction by Rev.

J. L. Tilly.

AFTERNOON SESSION

The devotional exercises were conducted by Revs. Samuel Harris and S. T. Taylor. Hymn, "'Tis Jesus Christ I Long to Find," etc. A part of the 12th chapter of Heb. was read for Scripture lesson. Then prayer was offered by Brother J. H. Wilson. After a very inspiring prayer meeting the moderator declared the house ready for business. With moderator in chair, the minutes of the forenoon session were read and approved. Then the moderator announced that because the time had arrived for the introductory sermon the visitors would be given a chance to express themselves later. After singing "Since Jesus Came Into My Heart," led by Rev. P. E. Green, Rev. G. W. Thomas read a part of 3rd chapter of the First Corinthians; then prayer was offered by Brother Phelix Walker. Then the delegation joined in singing "The Old Time Religion." After being presented Rev. W. D. Smith arose and announced for his text 1 Timothy, 4:12, 13, "Let no man despise thy youth, but be thou an example of the believers, in word, in conversation, in charity, in spirit in faith in purity. Till I come, give attendance to reading, to exhortation, to doctrine." Subject, "The Minister an Example." Rev. Smith referred to the youth of the minister as a very dangerous period of his life. He said, "He may go into the right way, or he may be shifted into the wrong way." He said the young minister should safeguard the dangerous period of his life by associating safe advisers and by invoking the very presence of Him, the Holy Spirit, to guide him. He said that a man who

is a minister should put his whole life and time in the ministry if he is to serve acceptably. Rev. Smith said, "I have not fully understood the full meaning of the sacredness of the office of the ministry, but I learn as I go on in the cause of the Master." Rev. Smith urged that the ministers value their word—value it so much that the people everywere who know them can say that whatever they say is true. At the close of the sermon he emphasized the need of preachers seeking to know the worth of being a good example as a minister. He advised the ministers never to refer to any congregation as being worthless, but instead, give them a chance by being a good example in all that the text includes. At the close of the sermon Brothers L. J. Jeffers and R. D. Rogers took a collection to the amount of \$6.18. The moderator then introduced the following brethren: Rev. W. M. Harris of the Harmony Association, Skippsmith, Va.; Deacon G. H. Harris of the Bluestone Association; Rev. M. Milligan of the Lumber River Association; Rev. J. C. Lyon of the County Line Association, Rev. P. E. Green delivered a sermon in the grove, accompanied by Rev. S. W. Keith. His text was taken from Psalms 17:4, "Concerning the works of men, by the word of thy lips I have kept me from the paths of the destroyer." His subject: "Preservation from the Destroyer." A collection was taken to the amount of \$2.11. Motion carried to adjourn until tomorrow morning. Benediction by Rev. J. C. Lyon.

THURSDAY—MORNING SESSION

The devotional exercises were conducted by Rev. S. W. Keith and Brother J. W. Velines. Hymn, "I am not Ashamed to Own my Lord," etc. A part of the 10th chapter of John was read for Scripture lesson. Prayer was offered by Brother J. W. Velines.

After the praise service, the moderator announced the house ready for business. He then called for the minutes of the yesterday afternoon session. The minutes were read and approved. Then the moderator presented Rev. J. L. Tilley, a professor of theology of Shaw University. Rev. Tilly arose and began his remarks by saying to the body, "I am flesh of your flesh and bone of your bone, and whatever I have done or whatever I may do for the Kingdom of Christ, you have a share in it." He gave as his subject, "Cooperation." He said that one of the great duties of the Baptist is to make the necessary sacrifice to live up with our leading brethren to put over the program of the Master. He said the big job of the Baptists is to stick together, and that the educators among Baptists should do their work among Bap-

tists, that those who do not have education may have it. It is our job to cooperate in our associational work and in our Baptist State work, he continued. He said further that the pastor should cooperate with every auxiliary of his church, and if he does not he is not a worthy pastor. Rev. Tilley made an earnest appeal to the ministers of the association to attend the great All-Baptist Celebration and be inspired by some of the greatest men of the world.

After the address by Rev. Tilly, Dr. C. C. Somerville of Portsmouth, Va., the field agent of the Lott-Cary Baptist Foreign Mission Convention, was introduced. "Rev. Somerville said, "The Lott-Cary Baptist Foreign Mission Convention is one of the greatest organizations in the world. It is the only organization which does Foreign Mission work exclusively." He spoke of the need of bringing in our lost brethren,—he quoted this passage of Scripture, "Except your brother be with you, ye shall not see my face." He said that Jesus enjoined the duty of doing mission work, at home, in the state and throughout the world, quoting these words of Jesus, "Ye shall be witnesses unto me both in Jerusalem, and in all Judea, and in Samaria, and unto the uttermost parts of the earth." Then he made a strong appeal to the Association to help our brother in Africa. After the message by Dr. Somerville, a collection for foreign missions was taken to the amount of \$17.50.

The following cimmittees were enlarged from 3 to 5 by motion: Committee on Credentials and Committee on Education. A motion carried that Rev. J. W. Day's resignation as chairman of the Committee on Obituaries be accepted, and Brother Samuel Harris serve instead. After the appointment of various committees the moderator announced that the Woman's Auxiliary would take charge for their work. The meeting adjourned.

THURSDAY—AFTERNOON SESSION

The delegation reassembled for business. The devotional exercises were conducted by Rev. J. T. Pierce and Brothr D. A. Toran. Hymn, "My Soul, Be on Thy Guard," etc. A part of the 10th chapter of Romans was read and prayer offered by Brother D. A. Toran. The moderator announced that Rev. Samuel Harris and Rev. J. E. Thorpe would go to the school house and preach. At the service at the school house a collection was taken to the amount of \$3.16. Next, the minutes of the forenoon session were read and adopted. Next, the following committees made their reports, which were approved: Committee on Ministerial Education, Committee on Foreign Missions, Committee on Time

and Place, Committee on Officers, Committee on Obituaries, Committee on Sunday Schools, Committee on Home Missions, Committee on New Churches, Committee on Temperance (with an amendment of all intoxicants); the statistician made his report, which was approved. Motion carried that Brother R. D. Rogers be continued as Statistician. The Treasurer made his report, which was adopted.

After much business was transacted the moderator announced that Rev. A. S. Croom, D.D., would preach the Doctrinal Sermon. Rev. J. L. Tilley led the congregation in singing, "I Know the Lord Has Laid His Hands on me." Then prayer was offered by Rev. J. W. Standfield. After being introduced and presented by Rev. Tilley, Rev. Croom arose and gave for his text 1 John 1:8, "If we say we have no sin, we deceive ourselves and the truth is not in us." Subject, "Holiness and Sanctification." The preacher asked, "What is holiness or sanctification?" The answer is found in the word of God (Phil. 1:6). It is a continuous and progressive work. It is a continuous warfare. (Rom. 7:14-25) How shall we get out of this dilemma regarding this all important question? Here it is, "With my mind I serve the Lord." The Christian has two natures. Sanctification does not free us from sin only in proportion as it develops us into the new life. Sanctification begins in regeneration and ends nowhere." Rev Croom gave to the audience a well prepared and heartfelt message. At the close of the sermon a collection was taken which amounted to \$10.02.

A motion carried that a rising vote of thanks be given to the New Hope Granville church and community for their hospitality toward the delegation. Reports on Finance and Appropriation were made and approved.

Sister Lucenda Parish, Vice-President of Woman's Auxiliary, requested that we continue in prayer until we can follow the Holy Spirit in doing more work for the Master.

Mrs. Charlotte Webb, President of the Woman's Auxiliary, turned over to the Association treasury from the Woman's Auxiliary \$5.00 to assist in printing minutes and \$1.00 to pay to sexton.

After the contribution of the ministers there were notices served on certain articles of the Constitution as follows:

Because the moderators and clerks of our Association are prevented from remaining in office long enough to become sufficiently familiar with the doings of the Association to do their best work for the Association, I wish to serve notice that the part of Article 3 in the Constitution be changed, which reads: "The moderator and clerk shall not be eligible to hold their offices more than two consecutive years."
