Mount Olive, N. C., October 8th, 1931

ANNUAL ADDRESS OF REV. A. A. SMITH, MODERATOR OF  
THE ASSOCIATION

---

WHEN WE LEARN TO LIVE TOGETHER

How true it is that life has been given us that we may learn how to live. How to live as individuals having relationships with others and with the unseen and eternal life of world order.

To so live as to insure health, prosperity, progress and happiness for each and for all. T

As the transition is made from the arts of war to those of peace, the emphasis is shifting from the ideals of independence to those of interdependence. The ideals and challenges of interdependence are more exacting and mean more to mankind than those of independence.

As life became more complicated and diversified, personal freedom will more and more be interpreted in terms of social justice and well being.

We must now learn to see and live life steadily and see and live life whole.

It is impossible to accomplish much or get far in this vast undertaking without having some great and all commanding purpose by which to steer our course, and a philosophy of that purpose, such as set forth supremely in the faith, life and teachings of the humble Nazarene. Running all through the Gospel of Christ like a theme, running through a musical composition, there occurs only to recur with ever deepening intensity, the theme of our interdependence, based upon our inter-relationships, human and divine.

What ever else we ought to expect the Christian faith to do for us we must demand that it do for us at least three things.

First: The faith that man is a child of the living god ought and does make human life sacred.

Second: This faith ought and does make human relationships sacred.

Third: This faith ought and does make human conduct, the fruitage of faith sacred.

We do not have to read far into the New Testament to find many illustrations in the parables, discourses and examples of Jesus to prove that human life, human relationships and human conduct meant much to the Master.

These three-fold expressions of his faith were all summed up in the two Commandments of love to God and man; in how one should worship and obey God, how one should judge and treat and serve another, how one can injure another in thoughts, words and deeds.

According to Jesus for a man to injure or wrong any one it were better that a mill stone be hanged about his neck and he be cast into the sea.

I came not to be ministered unto but to minister. He who must be greatest among you, let him be servant of all.

Paul left the inspiration of this Gospel of love and service in his great chapter on faith, hope and love, and elsewhere when he said, Love worketh no ill to any one's neighbor, therefore love is the fulfillment of the law.

It is true as the poet sings,  
 There is a destiny that makes us brothers;  
 None goes his way alone;  
 All that we send into the life of others  
 Comes back into our own.

There is a mystery and a majesty about this, gospel of our interdependence, based upon our interrelationships, human and divine, that we cannot get away from and that we will not let us go.

We simply cannot get away from this faith and its obligations and compusions in our lives any more than the child could get away from his home and parents. The late Dr. Burton at the time, president of Smith College, speaking of how closely human lives are interwoven told this charming story about his eight-year-old son:

One evening the little fellow ran to him and said, Papa, I don't see why I must stay at home all the time and do what you and mama tell me to do. Why can't I go out into the city and do what I want to do?

Dr. Burton, while surprised and amused, being a wise educator as well as a fond parent, thought it best to encourage the lad and see what would come of it.

So he said to him—well, neither do I understand why you must stay here and do what your mama and I tell you to do. Here is my pocket book with some money in it that you may need.

The child, while showing signs of astonishment, took his father at his word. He ran upstairs, put some things into his small traveling bag and came back carrying it in one hand, his hat in the other and with his overcoat over his arm. As he approached his father, he said nothing, but looked up into his face with his round, wide-open eyes, full of unanswered questions. Finally, his father remarked, Why don't you want to go out into the city and do just what you want to do and not stay here all the time and do what papa and mama tell you to do. Still there was the look of unanswered questions in those wide-open eyes, and even when the question was repeated there was no response. After another silence a slight moisture appeared in his eyes and tears were about to fall, only then did he speak and relieve his pent-up feelings. And this is what he said, "Papa, I want to take mama with me."

Our Christian faith, and our experience and knowledge growing out of this faith, reveal and establish for us our relationships to God and to each other. In this Christian Gospel of our interdependence, based upon our inter-relationships, human and divine, as nowhere else, we find our vision and our task and we may be sure that the power of our faith will make our strength equal to our task; it is always so.

This gospel explains why we are bound together by such sacred strong and insoluble ties of kinship and friendship; it gives us a working philosophy of the Christian faith itself and furnishes us with a practical program for every day living. This gospel helps us to see and live life steadily and to see and live life whole, and also saves us from a meaningless and hopeless existence.

Learning to live is the greatest art in the world and its sublimest lessons are written out for us in the Gospel of Christ.

Man only learns some of the arts of how to live after he has spent his best days. This is a gospel of faith in God that makes human life, human relationships, and human conduct sacred.

When we become more proficient in this great art of learning how to live as individuals and as nations we shall discover for ourselves the hidden treasures that prevent human understanding, we shall find our approach to the deepest and most abiding realities of life and like-

wise ours shall also be its divine compensations and unfilled rewards.

As an architect looks well to the laws of heat and cold and moisture and stress and strain in the work of construction, we have to do the same in character building. In doing so we have found that the same fundamental laws and principles that apply to individuals apply equally to communities and nations.

The individual is the unit of power and influence in the world of mankind. Social life is individual life written larger. International life is individual life written still larger. The Golden Rule, truth, justice, fidelity, love, peace, good will and service are just as indispensable in the conduct and affairs of nations as they are indispensable in the conduct and affairs of individuals.

### CONSTITUTION OF THE BEAR CREEK MISSIONARY BAPTIST ASSOCIATION

Article 1. This body shall be known as the Bear Creek Missionary Baptist Association.

Art. 2. The object of the Association shall be to promote Christ's Kingdom among men, and the means of accomplishing this shall be in strict conformity to the New Testament. Pastors should encourage Christian Education to assist in the Home and Foreign Missions and to do all in their power for the support of an active prayer meeting and Sunday School in all churches and in every way possible strive to conform to the teaching of the word of God.

Art. 3. This Association shall be composed of Messengers, Pastors and Deacons chosen by the churches they represent. Each church is entitled to three delegates who shall be in good standing in the churches they represent. All ordained ministers belonging to this Association shall pay \$2.00 annually. Licentiate ministers \$1.00 annually. Ordained deacons 50 cents annually, to maintain their membership. Ministers who are not members of this Association may become members by bringing a letter of recommendation from the Association from whence they came and the payment of \$2 down and \$2.00 annually thereafter; said monies to maintain a superannuated fund. All disabled ministers and deacons shall be paid annually.

Art. 4. The delegates from each church shall present a letter certi-

fying their appointments, and also stating the condition of their church.

Art. 5. The officers of this Association shall be a Moderator, Assistant Moderator, a Clerk, a Corresponding Secretary and Treasurer, and an Executive Board of seven members, and shall continue in office until their successors are elected.

Art. 6. It shall be the duty of the Moderator to preside during the deliberation of this body; in observance of the Constitution preserve order, decide all questions, give his opinion concerning any subject under discussion, after those wishing to speak shall have spoken, or when called upon to give the casting vote in case of a tie.

Art. 7. It shall be the duty of the Assistant Moderator to assume the duties of the Moderator in his absence.

Art. 8. It shall be the duty of the Clerk to record the proceedings of each annual session. The Clerk, corresponding Secretary and Moderator to compose the printing committee and to superintend the printing of the Minutes and distribute them among the churches in ninety days.

Art. 9. It shall be the duty of the Corresponding Secretary to keep correspondence with the various bodies representing the object of the Association, and shall keep a faithful register of all ordained ministers and historical events of the Association, and make report to each annual session, and assist the Clerk.

Art. 10. It shall be the duty of the Treasurer to receive all funds sent up from the churches or collected during the session of this body and disburse the same as ordered by the Association, when drawn by the Clerk and signed by the Moderator. He shall also make to the Association an annual report of the condition of the treasury. He shall give good security.

Art. 11. The Executive Board may meet when it is necessary and do business for the Association of any of its churches, and the church or Association calling for the Board shall defray the expenses of the Board and in no wise attempt to interfere with the business of any church unless called for by the church.

Art. 12. Any church desiring to connect herself with this body shall present a petition at an annual session, through a delegate appointed for that purpose and if received the presiding officer shall extend the right hand of fellowship.

Art. 13. This Association shall not maintain fellowship with any of the churches that neglect to preserve Gospel order. Churches may continue their fellowship by contributing twenty-five (25c) cents per member as representative fee in the Association.

Art. 14. The Association may invite brethren to seats, and extend to them all the privileges of this body, except that of voting.

Art. 15. This body shall hold its session annually and at such time and place as it may select.

Art. 16. By appointment of the Association there shall be preached at each annual session an Introductory, Missionary, Doctrinal, and Sunday School sermon during the session, directed by the Choir.

Art. 17. Messengers to the Association shall bring 25 cents for Educational purposes.

Art. 18. The Association will not recognize the ordination of any minister in its bounds unless done by the Association while in session or the Executive Board.

Art. 19. This Constitution may be amended at any annual session by a vote of two-thirds of the members present.

Art. 20. It shall be the duty of the Trustees of the Association and Directory Board of the Sunday School Convention to have full control

of the legal business of the Association coming under their supervision.

Section 2. The Board of Trustees shall consist of seven members whose term of office shall be fixed by the Association and they shall meet as often as they find it necessary.

### AMENDMENT

Resolved that Shaw University be the Objective of this Association. All monies raised during the year between the sittings of the Association by the Sunday School Convention, Home Mission Convention, Eastern and Western Unions, and from various sources, be represented at the Association and turned in to Associational Treasurer.

Art. 21. That there be an amendment to the effect that all churches be urged to give each fifth Sunday in the interest of the Unions. Fees of Deacons shall be 25 cts quarterly to the Union.

### RULES OF ORDER

1. Each session of the Association shall be opened with religious exercises, to be conducted by the Moderator, or such other person as he may designate.

2. At each daily session the names of delegates, shall be called and the proceedings of the previous session read before entering upon the business of the day.

3. The members shall exhibit towards the officers and each other that courtesy which belongs to Christians.

4. No member shall speak more than twice on the same subject, nor longer than five minutes at a time, without permission from the body.

5. Any member desiring to speak shall arise and address the Moderator.

6. All motions which meet a second shall be definitely stated by the Moderator before being discussed.

7. When a subject is under discussion no motion or proposition

shall be in order except to adjourn, to lay on the table, to amend or postpone indefinitely.

8. Reports of standing committees.

9. Reports may move to reconsider.

9. The Association shall reserve the right to determine what questions shall be admitted to its consideration.

10. No member shall present himself during the session without permission from the Moderator.

11. These rules may be amended at any regular session by a majority of the members present.
