## PROCEEDINGS OF BUSINESS SESSION

The Original Bear Creek Primitive Baptist Association convened in annual session with Lawyer's Springs Church, Anson County, North Carolina, Friday, September 19, 1952 and continued Saturday and Sunday following.

Brethren, sisters and friends assembled in the house at 10:30. After engaging in songs of praise, Elder J. A. Monsees introduced services by prayer followed with introductory discourse by Elder V. V. Willard of High Point, pastor of Lawyer's Springs Church, from Romans 5:19.

Following the introductory sermon about one hour was taken for refreshments, after which the Association met in the house and engaged in songs of praise followed in prayer by Elder A. L. Land.

Lawyer's Springs Church, with Ministers, Messengers and Brethren composing the Association, proceeded to business as follows:

Elder V. V. Willard, pastor of Lawyer's Springs Church served as Moderator, and Brother Tommy Horne, Clerk of Lawyer's Springs Church served as Clerk and called Preston L. Helms as Assistant Clerk.

5. Called on Presbyteries to report:

By request of Liberty Hill Church, Stanly County, N. C., a Presbytery was organized by the following Ministers and Deacons, Elders C. M. Mills, V. V. Willard and Homer Poplin and Deacons W. L. Solomon, T. B. Polk, W. R. Coley, G. P. Burris, Sanford Medlin, F. L. Baucom, R. M. Hatley, A. E. Broom, C. W. Griffin, Cletus Marsh, J. M. Taylor, E. F. Lambert, J. W. Harwood, F. L. Honeycutt, N. D. Hathcock and Lloyd Outen and ordained Brother Craven Furr to the office of a deacon.

According to previous arrangement Elders C. M. Mills, V. V. Willard, J. W. Bullard, W. E. Snyder, Fred Clayton, D. B. Willard and J. S. Stephenson and Deacons C. C. Willard, E. M. Morefield and others met in the edge of Winston-Salem at a place where the Primitive Baptists have been having services for quite a period of time and organized a Presbytery and constituted a church, consisting of members lettered from High Point and also ordained the following brethren: F. C. Willard, H. L. Willard and W. H. Minter to office of deacons.

Pursuant to adjournment the Association met in the house Saturday, 20th at 9:15 A. M. After singing songs of praise and prayer by Elder E. H. Simpson of Concord, N. C., continued with business as follows:

13. Unanimously agreed to distribute minutes to corresponding associations as usual.

On motion it was unanimously agreed that we hold the 1953 session of the Original Bear Creek Primitive Baptist Association with High Point Church, Guilford County, North Carolina, beginning Friday before the fifth Sunday in August and continuing through Saturday and Sunday following, and that the pastor of High Point Church preach the introductory sermon.

16. On motion unanimously agreed that we have 1000 copies of this minute printed and distributed to churches and associations as usual and that Preston L. Helms superintend the printing and distribution of same and that he be allowed \$80.00 for printing, mailing and services.

17. By motion unanimously agreed to distribute all funds above that allowed for printing, mailing and clerks services, to ministers as the finance committee may deem proper.

18. By unanimous agreement the Association returns thanks to God for His mercy and to the brethren, sisters and friends of Lawyer's Springs Church and vicinity for their kind hospitality and entertainment afforded during this session of the Association.

19. Agreed to adjourn to time and place above mentioned. Benediction by Elder E. H. Simpson.

## ARTICLES OF FAITH

Article 1. We believe in one living and true God; the Father, the Word and The Holy Ghost.

Article 2. We believe in the man Jesus being the first of all God's creation and the pattern of all God's perfection in nature, grace and glory, and in relative union with the Divine Word, and thus united with the whole Trinity.

Article 3. We believe that the scirpture of the Old and New Testament contain the only written revealed word of God and the perfect rule of faith and practice for God's Church in her militant state while here on earth.

Article 4. We believe in the doctrine of election; that God chose His Church in Christ Jesus before the world began.

Article 5. We believe in all mankind's apostacy by transgression in Adam, the federal head.

Article 6. We believe in the doctrine of original sin.

Article 7. We believe in the impotency of man to recover himself from his fallen state by his own free will and ability.

Article 8. We believe that sinners are justified freely by grace and before God by faith in Christ and His righteousness only.



Article 9. We believe that God's elect or Church shall be called, converted, regenerated and sanctified by the Holy Spirit in due time.

Article 10. We believe that the saints shall persevere in grace and never really fall away.

Article 11. We believe that baptism and the Lord's Supper are ordinances of Christ's appointment, and that believers alone are the subjects of baptism and the only proper communicants of the Supper; that the mode of baptism is immersion, and that neither of the ordinances is to be altered or changed by the inventions or opinions of men. We believe in feet washing as taught by our Saviour in St. John 13:4-17.

Article 12. We believe that no man as a minister has any right to the administration of any of the ordinances of the gospel except such as are sound in the faith of the gospel, regularly baptized, called of God and have come under the imposition of hands by a regular presbytery.

Article 13. We believe in the resurrection of the dead, both the just and unjust, and a general judgment.

Article 14. We believe that the punishment of the wicked will be everlasting and the joys of the righteous eternal.

#### **RULES GOVERNING THE ORIGINAL BEAR CREEK PRIMITIVE BAPTIST ASSOCIATION**

1st. We understand that at whatever church this Association is being held, that it is being held solely under the authority of that church, just as any other regular or monthly conference.

2nd. That the officers and suffrages of that church shall be the officers and voice of the Association, except as that church may deem prudent to request any member of another church to assist in the business transactions of the Association.

3rd. This Association shall have no authority to pass upon any question of a disciplinary nature except it has first been passed upon by the local churches composing this Association; then the work of the churches shall be recognized by the Association.

4th. Any member who endeavors to bring in or inject a disciplinary question that involves fellowship, before it has been passed upon by the local churches, shall be considered out of order by the church with whom the Association is being held, and by the messengers present from the sister churches.

5th. The Association shall be conducted for no purpose other than song, prayer, and preaching services, and no business shall be transacted by the Association except that which is necessary or sets forth the status of each church composing this body in the form of a minute.
