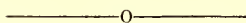

CONSTITUTION

ARTICLE I. This body shall be known as the Wake Baptist Association.

ARTICLE II. The object of this Association shall be the promotion of Christ's Kingdom among men, and the means of accomplishing this shall be in strict conformity with the New Testament.

ARTICLE III. This Association shall be composed of Delegates chosen by the Churches connected with it, each Church being entitled to at least one delegate, and one delegate for each hundred members or fraction thereof. Ministers who are members of the Churches connected with this body shall be considered members of this Association. Ex-officers and ministers who are not in charge of or connected with Churches within the bounds of this Association who present testimonials of good standing in the Baptist Denomination and any layman in good standing may become annual members by the payment of \$1.00.

ARTICLE IV. The delegates from each church shall bear a letter certifying their appointment giving an account of the condition of the church, and a statement of all funds contributed for benevolent purposes during the year.

ARTICLE V. The officers of this Association shall be a Moderator, Vice Moderator, Clerk, Corresponding Secretary, Treasurer, Auditor and Historian.

Section 1. The Boards of this Association shall be an Executive, consisting of twelve members; including the officers of the Association, a Ministerial Board; also, such committees as may be authorized by the Association.

ARTICLE VI. The officers and Board Members shall be elected at the Annual meeting of the Association.

Section 1. The Members of the Executive Board shall assume their duties at the close of the Annual Meeting.

Section II. The Ministerial Board Members shall serve as occasion may require.

ARTICLE VII. The Moderator shall open all meetings punctually, and preside during the deliberations of the Body; enforce the observance of the constitution; decide all questions of order; give his opinion concerning any subject under discussion after others have spoken or when called upon, and give the casting vote in the event of a tie.

ARTICLE VIII. The Vice Moderator shall discharge the duties of the Moderator in his absence.

ARTICLE IX. The Clerk shall keep a record of the proceedings of the Association; superintend the printing and distribution of the minutes; keep on file the printed minutes and other important papers of the Association, and shall serve as the Secretary of the Executive Board.

ARTICLE X. The Treasurer shall receive all money contributed by the member churches, make disbursements as authorized by the Association. He shall not pay any order on the Treasury except it be signed by the Modera-

tor and Clerk. He shall make his annual report to the Association.

ARTICLE XI. The auditor shall audit the Treasurer's book and attest his annual report to the Association.

ARTICLE XI. The Auditor shall audit the Treasurer's books and attest his annual report to the Association.

ARTICLE XII. The Corresponding Secretary, as directed by the Moderator, shall communicate with the churches and serve as the Secretary of the Ministerial Board.

ARTICLE XIII. The Historian shall collect facts of interest of the Association and member Churches and shall make a report to each annual meeting of the Association.

ARTICLE XIV. Any Baptist Church or organization seeking membership in this Association must present a petition to the Association in session through delegates appointed for that purpose.

Section 1. Upon the reception of such Church or organization the Moderator shall extend to the delegate the right hand of fellowship, on behalf of the Association. This Association shall not maintain the fellowship with any Church or organization that is not in Gospel order.

ARTICLE XV. The Association shall meet on Wednesday and Thursday before the Third Sunday in August each year the Church or Institution which invites it unless otherwise designated by the Executive Board.

ARTICLE XVI. We shall withdraw the right hand of fellowship from any minister who walks disorderly or contrary to the Gospel rule.

ARTICLE XVII. Each Church connected with this Association may continue its membership by supporting this Constitution.

ARTICLE XVIII. The Wake Baptist Sunday School Convention, The Wake Baptist Missionary Union, The Woman's Auxiliary and the Ministers' and Deacon's Union are Auxiliaries of the Association.

ARTICLE XIX. There shall be a Ministers' and Deacons' Union as an Auxiliary of the Parent Body of the Wake Baptist Association.

Section 1. The object of the Ministers' and Deacons' Union shall be primarily to better acquaint Ministers and Deacons, also other members of the Baptist Denomination with the Christian Way of Life.

Section 2. The officers of the Ministers' and Deacons' Union shall be a President, Vice President, Secretary and Treasurer.

Section 3. The Officers of said Ministers' and Deacons' Union shall be elected at each annual session of the Wake Association.

Section 4. Ministers, Deacons and members of Churches of the Association in good and regular standing, and supporting the objectives of the Association, shall be counted members of the Union.

Section 5. A free will offering will be given in the Ministers' and Deacons' Union by each member to help spread the gospel and its teachings.

Section 6. The Ministers' and Deacons' Union shall submit a written report to each Annual Session, of all its programs, activities, and funds.

Section 7. The Association shall provide necessary funds to lawfully and reasonably support the said Union Programs as directed by the Parent Body.

Section 8. The Ministers' and Deacons Union shall meet each fifth Saturday and Sunday unless otherwise advised by the Association.

ARTICLE X. The Object of the Auxiliary shall be to aid the Association in the extension of Christ's Kingdom.

Section 1. The Officers of the Auxiliary shall be President, Vice President, Recording Secretary and Treasurer of each department.

Section 2. All officers of the Auxiliary shall be elected annually.

Section 3. All moneys collected by the Auxiliary shall be turned over to the Finance Committee of the Association in session and a receipt taken for same.

Section 4. All the reasonable expenses of the Auxiliary shall be paid by the Association.

Section 5. The time of meeting of the Auxiliary shall be simultaneous with the meeting of the Association.

BY-LAWS

ARTICLE XXI. This Constitution may be amended at any Annual Session of the Association by a vote of two-thirds of the members present.

Section 1. Schools, Societies and Individuals shall be acknowledged in the minutes of the Association.

Section 2. Before the final adjournment of the Association all the funds, notes, etc., shall be counted by the Financial Committee and Treasurer. The Treasurer shall give the Finance Committee a receipt for the amount placed in his hands.

Section 3. The Treasurer shall pay out no money except on order written by the Clerk and signed by the Moderator and Clerk.

Section 4. After the expense of the Association shall have been paid the remaining funds shall be applied to such purposes as the Association may direct. The Executive Board shall execute plans adopted by the Association.

Section 5. The Auditor shall audit the accounts of the Treasurer and make annual reports to the Association.

Section 6. The duties of the Boards provided for in the Constitution shall be such as are usually performed by such boards in other similar bodies.

PROCEEDINGS OF THE MID-YEAR SESSION OF THE WAKE BAPTIST ASSOCIATION

Held With the Baptist Grove Baptist Church
Near Raleigh, North Carolina

The Mid-Year Session of the Wake Baptist Association met with the Baptist Grove Baptist Church, The Reverend William A. Perry, Pastor, on Sunday, March 30, 1952. A short devotional was lead by Mrs. I. H. Leathers and Mrs. Odessa Turner. "Since Jesus Came into My Heart" was sung for the opening selection, nine verses of the 18th Chapter of Matthew was read for the Scripture. Mrs. Mollie Dunston offered the prayer. After the devotionals, Mrs. Dunston stated that she was thankful to be present for the Mid-Year session, for she was unable to attend the session at Fuquay Springs because of illness.

Mrs. Ellen Powell was asked to present the speaker of the hour, in the person of Mrs. Ellen Austin, the Executive Secretary of the Woman's Convention of North Carolina. Mrs. Austin came forward and thanked the women for their support for missions and Christian Education through the past years.

Mrs. Austin then gave a brief summary of her trip to Africa. She first described her trip, she stated that the group left New York by plane, one of the largest in the world, weighing 17 tons and traveling at a speed of 370 miles per hour. In thirty hours the group had landed in Monrovia where the party was presented to President Tubman, President of the Republic. The speaker then went on to point out some of the opportunities for missionary work in Africa. She stated that there were large sections of Africa which still believe in superstition. (2) Large lepor colonies were to be found in abundance. (3) Some Chiefs had as many as fifty wives. These situations just mention was a real challenge to missionary minded men and women.

The body adjourned for dinner.

The afternoon session was opened by music by the Olive Branch Choir. The Reverend Clyde B. Walton read 14 verses

of the 10th Chapter of John for the Scripture. The prayer was offered by Reverend John Parks. "O Master Let Me Walk with Thee," was the next selection sung by the Choir. The speaker for the occasion, Rev. S. L. Suitt, came forward and announced his text from Titus 1:9 "Holding fast the faith word as he has been taught." The speaker suggested the following: Paul was taught at home, so must we be taught at home. Paul was taught in the traditions of the Fathers, we must be taught in race appreciation. Finally we need to stick to Christ. Paul met Christ on his way to Damascus. The choir sang, "Lift Him Up."

An offering was taken following the sermon. See Financial Report.

The Reverend A. A. Crum was presented to the Association as the new pastor of Malaby's Cross Road Baptist Church.

At this time the Moderator, Reverend Stokes presented all officers of the United Association: Rev. Horton of Minister's Deacon's Union, Mrs. Mollie Dunston of Woman's Auxiliary and Mr. Leroy Burton of the B. T. U. Convention, who also spoke in behalf of the allied bodies.

The Committee on hospitality made its report:

Proceedings of the Eighty-Sixth Annual Session
of the
WAKE BAPTIST ASSOCIATION

The Vice Moderator, the Reverend C. H. Heath, called the Eighty-Sixth Annual Session of the Wake Baptist Association to order at 10:30 A. M. Rev. A. A. Anderson let the opening selection and read twelve verses of the 16th chapter of Luke for the Scripture. The prayer was offered by Reverend Millard Jones. Reverend Jones also sang, "My God That Springs from all My Joy." After brief remarks by Reverend Anderson, and Reverend Heath, The Reverend Mr. W. W. Faulcon made the welcome address. He stated that the members and friends of New Providence has been looking forward to time when the Association would be their guest, and that they were welcome to every facility which the church had provided for their comfort.

The Reverend Alexander Terrell responded to the welcome on behalf of the Association. The next item to claim our attention was a topic, "Christianizing the World Through the Home," led by Reverend C. C. Jones. He stated that the home was the foundation of our Christian work. Above every other institution, the home should be Christian, parents and children alike.

The congregation sang, "Amazing Grace," after which Reverend G. W. Watkins read the 24th Psalm. Reverend Suitt offered prayer. Reverend T. A. Watkins of the First Baptist Church, Wilson came to bring us the message of the hour. His subject was, "How May We Succeed in Christianizing the World?" The speaker's text was taken from John 1:34, "And I saw, and bare record that this is the Son of God." and John 3:30, "He must increase, but I must decrease." The speaker pointed out the fact that we must have a conviction that Jesus is the Christ the Son of God. We are but instruments through which God works, therefore, we must decrease as did John the Baptist but, Christ will increase. The speaker delivered a very thoughtful and forceful message.

After the sermon Brother Robert Haskin and B. W. Lane lifted the offering.

Adjournment.

WEDNESDAY AFTERNOON

The afternoon Session was opened by the Reverend O. H. Broadie who led in singing, "Leaning on the Everlasting Arms." Reverend Clyde B. Walton read twelve verses of the 14th Chapter of John. Brother L. Bridges offered the prayer. Hymn 286, 'My Hope is Built on Nothing Less,' in the Baptist Standard Hymnal, was sung as the next selection. Reverend Heath presented Reverend Stokes who came forward to bring his annual message. He. stated that it was at New Providence Baptist Church that the late Reverend Dr. N. F. Roberts resigned and the association elected him as the new clerk. The Moderator advised us to commit ourselves to the following: (1) Each Christian help win souls for Christ. (2) We should set a standard of Christian Giving. (3) That all pastors teach our Covenant to our members. (4) Stress the importance of getting our children in Sunday School. (5) Support our Baptist School (6) Support General Baptist Convention (7) The Association meet in an extra session.

After the Moderator's Address was delivered, Dr. Bullock motioned that the Moderator's address be adopted as a whole. This motion was carried.

The Sisters came forward to take over for the remainder of the time Wednesday afternoon. After the selection, "Jesus Keep Me Near the Cross." Brief remarks were voiced by Mrs. Corinna Dunn and Mrs. F. B. Holt on the Place of Mothers in Christianizing the World. Mrs. Mollie Dunston made her address to the Association. Others who made remarks were Mrs. Odessa Lane, Miss Penny Perry and Mrs. Trice.

Because Dr. Strassner, President of Shaw University, could not be present on Thursday, he delivered his message at this time on the program. He emphasized "The Place of the Christian College in Christianizing the World." The speaker suggested that there is no singleness of purpose in the world, that there is a great clash between two ideologies,

Russia and America. In a situation like this the Christian College must educate boys and girls for leadership. Dr. Strassner's remarks were very, very stimulating.

The Committee on officers made its report at this time. It was motioned by Brother S. M. McCullers that the report will be adopted. The motion prevailed. Another motion prevailed that the Executive Committee succeed itself and that Brother H. C. High be added to the Committee. This was passed also.

An offering was taken to the amount of \$13.85.
