CONSTITUTION

ARTICLE I This body shall be known as the Wake Baptist Association.

ARTICLE II The object of this Association shall be the promotion of Christ's Kingdom among men, and the means of accomplishing this shall be in strict conformity with the New Testament.

ARTICLE III This Association shall be composed of Delegates chosen by the Churches connected with it, each church being entitled to at least one delegate, and one delegate for each hundred members of the churches connected with this body shall be considered members of this Association. Ex-officers and members who are not in charge of or connected with churches within the bounds of this Association who present testimonials of good standing may become annual members by the payment of \$1.00.

ARTICLE IV The delegates of each church shall bear a letter certifying their appointment giving an account of the condition of the church, and a statement of all funds contributed for benevolent purposes during the year.

ARTICLE V The Officers of this Association shall be a Moderator, Vice Moderator, Clerk, Corresponding Secretary, Treasurer, Auditor and Historian.

Section 1. The Board of this Association shall be an Executive, consisting of twelve members; including the officers of the Association, a Ministerial Board; also such committees as may be authorized by the Association.

ARTICLE VI The Officers and the Board Members shall be elected at the Annual meeting of the Association.

Section 1. The Members of the Executive Board shall assume their duties at the close of the Annual Meeting.

Section 2. The Ministerial Board Members shall serve as occasion may require.

ARTICLE VII The Moderator shall open all meetings punctually, and preside during the deliberation of the body; enforce the observance of the constitution, decide all questions of order; giving his opinion concerning any subject under discussion after others have spoken or when called upon, and give the casting vote in the event of a tie.

ARTICLE VIII. The Vice Moderator shall discharge the duties of the Moderator in his absence.

ARTICLE IX The Clerk shall keep a record of the Proceedings of the Association; superintend the printing and distribution of the minutes; keep on file the printed minutes and other important papers of the Association.

ARTICLE X The Treasurer shall receive all money contributed by the member churches, make disbursements as authorized by the Association. He shall not pay any order on the Treasurer except it be signed by the Moderator and Clerk. He shall make his annual report to the Association.

ARTICLE XI The Auditor shall audit the Treasurer's book and attest his annual report to the Association.

ARTICLE XII The Corresponding Secretary, as directed by the Moderator shall communicate with the churches and serve as the secretary of the Ministerial Board.

ARTICLE XIII The Historian shall collect facts of interest of the Association and member churches and make a report to each annual meeting of the Association.

ARTICLE XIV Any Baptist Church or organization seeking membership in this Association must present a petition to the Association in session through delegates appointed for that purpose.

Section 1. Upon reception of such Church or organization the Moderator shall extend to the delegate the right hand of fellowship, on behalf of the Association. This Association shall not maintain the fellowship with any Church or organization that is not in **Gospel order**.

ARTICLE XV The Association shall meet on Wednesday and Thursday before the Third Sunday in August each year with the Church or Institute which invites it unless otherwise designated by the Executive Board.

ARTICLE XVI We shall withdraw the right hand of fellowship from any minister who walks disorderly or contrary to the Gospel rule.

ARTICLE XVII Each Church connected with the Association may continue its membership by supporting this Constitution.

ARTICLE XVIII The Wake Baptist Sunday School Convention, The Wake Baptist Missionary Union, the Woman's Auxiliary and the Ministers' and Deacons' Union are auxiliaries of the Association.

ARTICLE XIX There shall be a Ministers' and Deacons' Union as an Auxiliary of the Parent Body of the Wake Baptist Association.

Section 1. The object of the Ministers' and Deacons' Union shall be primarily to better acquaint Ministers and Deacons also other members of the Baptist Denomination with the Christian Way of Life.

Section 2. The Officers of the Ministers' and Deacons' Union shall be a President, Vice President, Secretary and Treasurer.

Section 3. The officers of the said Ministers' and Deacons' Union shall be elected at each annual session of the Wake Association.

Section 4. Ministers, Deacons and Members of the Churches of the Association in good and regular standing, and supporting the objectives of the Association, shall be counted members of the Union.

Section 5. A free will offering will be given in the Ministers' and Deacons' Union by each member to help spread the gospel and its teachings.

Section 6. The Ministers' and Deacons' Union shall submit a written report to each Annual Session, of all its programs, activities and funds.

Section 7. The Association shall provide necessary funds to lawfully and reasonably support the said Union Programs as directed by the Parent Body.

Section 8. The Ministers' and Deacons' Union shall meet each **fifth** Saturday and Sunday unless otherwise advised by the Association.

ARTICLE XX The object of the Auxiliary shall be to aid the Association in the extension of Christ's Kingdom.

Section 1. The Officers of the Auxiliary shall be President, Vice President, Recording Secretary and Treasurer of each department..

Section 2. All officers of the Auxiliary shall be elected annually.

Section 3. All moneys collected by the Auxiliary shall be turned over to the Finance Committee of the Association in session and a receipt taken for the same.

Section 4. All reasonable expenses of the Auxiliary shall be paid by the Association.

Section 5. The time of meeting of the Auxiliary shall be simultaneous with the meeting of the Association.

BY-LAWS

ARTICLE XXI This Constitution may be amended at any Session of the Association by a vote of two-thirds of the members present.

Section 1. Schools, Societies and Individuals shall be acknowledged in the minutes of the Association.

Section 2. Before the final adjournment of the Association all the funds, notes, and etc., shall be counted by the Finance Committee and Treasurer. The Treasurer shall give the Finance Committee a receipt for the amount placed in his hands.

Section 3. The Treasurer shall pay out no money except on order written by the Clerk and signed by the Moderator and Clerk.

Section 4. After the expense of the Association shall have been paid the remaining funds shall be applied to such purposes as the Association may direct. The Executive Board shall execute plans adopted by the Association.

Section 5. The Auditor shall audit the accounts of the Treasurer and make annual report to the Association.

Section 6. The duties of the Board provided for the Constitution shall be such as are usually performed by such boards in other similar bodies.

PROCEEDINGS

The Ninety-First Annual Session of the Wake Baptist Association met with the Wake Chapel Baptist Church, Millbrook, North Carolina, August 15th and 16th, 1957. The Reverend B. H. Closs was the host minister.

The Session opened with singing led by the Reverend C. H. Heath, "Leaning on the Everlasting Arm." The Reverend Morgan read the 24th Psalm for our Scripture lesson. The Reverend Walton offered the prayer. "Tis the Promise of God" closed the devotionals.

The Reverend B. H. Closs made brief words of welcome. He stated that Wake Chapel had gone all out for the comfort of this body, and as pastor he wanted the Association to enjoy themselves. The sacrifices of the church would make it possible for the body to be enriched and thereby making the lives of all the members of the Association better. The Response was made by Dr. C. E. Askew.

The next item to claim our attention was the discussion of the theme led by the Reverend T. A. Watkins. The theme was "The Christian Church and Some Present Day Problems." The speaker stated that man is so designed by his Creator to constantly meet problems. This is a normal course of life. It is the place of Christianity and the Christian Church to help man overcome his problems. It is through problems man is brought closer to God. After a general discussion on the Theme, Reverend Watkins suggested that he would treat the theme under three heads: 1 The Problem of Human Existence; 2. The Problem of Human Relationship; 3. The Problem of Human Destiny.

Brother Watkins pointed out that as human beings, we face a big problem of earning a living. We are living in an age of "Go Getters." We should learn how to give and take." The speaker used the illustration of the Rich Farmer who tore down old barns to build new ones. One big problem we face is where does my share begin and where does God's share begin? Reverend Watkins brought us a very penetrating message.

A song, "Blessed Assurance," followed next by the choir. The Reverend A. A. Anderson and Dr. J. D. Roberts were asked to accompany the Reverend C. R. Trotter who was scheduled to bring the message. The presentation of the speaker was made by Dr. Roberts. Reverend Trotter came forward and announced his subject: "The Church Speaks to

the Times." In his introduction, the speaker recognized the fact that this was the Ninety-First Session of this body. He said: "For almost a century this Association has been sending out rays of truth and beauty in our bounds. The speaker gave a brief background of the situation in the Corinthian Church, as far as its composition was concerned, and the problem of eating meat that had been sacrificed to idols.

The speaker summed his message up under three heads: 1. The Church finds itself in a world out of Balance. This is true as far as human relations are concerned. Every force of nature seem to work with God, but Man seems not to work with Him. We must get the right focus to be used in God's program. "There must be proper relationship between the head and heart." Many people are letting their heads run away with their hearts.

The speaker mentioned some problems which are disturbing the world. The problem of Production and Distribution. the problem of Governmental regimentation, and the problem of racial tension.

Finally said the speaker, in the face of great problems the church must be the first to speak. The Church must prick the dull conscience of men; the church must set the hearts of men right. Reverend Trotter brought to the body a very thoughtful message.

The morning offering was lifted by Deacon Aikens and Deacon Wilder.

Our visitors were presented to the Association. Dr. Grady Davis presented Reverend A. L. West, who pastored Union Grove for a short time, but he is at present studying at Boston University. The Reverend Aaron Johnson was presented also.

Our morning session closed with the selection of "What A Friend."

WEDNESDAY AFTERNOON

The evening devotionals were conducted by the Reverend Millard Jones. He led in singing "Take the Name of Jesus with You." A portion of the 13th Chapter of 1st Corinthian was read by Reverend Jones. Reverend W. A. Morgan offered the prayer. "More Love To Thee O Christ" was sung. A few minutes were devoted to expressions from the various delegates.

Reverend Watkins again came before the body and discussed the Problem of Human Relationships. He emphasized racial tension, but this must be solved, and, the only way it can be solved is through Christ. Dr. Askew along with several others expressed personally their thanks to Reverend Watkins for such a thoughtful presentation.

The Vice Moderator presided and presented the Reverend Stokes who came forward and gave his Annual Message. Please note Recommendation. A motion prevailed that the address be placed in the hands of a Committee, composed of Reverends T. A. Watkins, U. G. Jones and R. D. Wilder. They reported that the Address be printed. This passed.

We had other reports. Reverend C. C. Jones made the report from the Lott Carey Convention which was held in the city of Winston-Salem. Reverend Jones emphasized two things that took place at the convention. He said the convention had a clinic on voting and it stressed the issue of reaching the rural churches.

We had reports from the Treasurer and the Auditor, both were adopted. After these reports, we had the report of the Committee on Organization. This report was adopted with all officers elected for another year.

Remarks were made by Brothers Haskins and Jones of Wilson. The Benediction was pronounced by Reverend B. F. Auston.

3. We recommend Article 12 of the Moderator's Recommendation:
"That the pastors and churches strive to continue to conduct a Daily Vacation School during each year at their churches."
4. We recommend Article 13 of the Address: That we support Leadership Training Courses.
5. We recommend Article 14, of the Address: "That we help deserving members of this Association who need aid to study at Shaw University School of Religion."

We have carefully taken under consideration the Moderator's Address and have found the message very inspiring and far reaching. It is much needed in our times, therefore, we your committee recommend that the Moderator's Address be adopted in its entirety.

RECOMMENDATIONS

1. That all Christians strive to obtain more of the riches of God's Grace through daily Bible study and prayer.

2. That winning souls to Christ, and a life consecrated and dedicated to His service will be the ceaseless practice of the church.

3. The pastor will stress, or make available to his church members a training course that will teach the Baptist church covenant and urge its practice.

4. That the officials and Executive Board members of the Wake County Sunday School and B. T. U. conventions; the Wake County Missionary Union; the Wake Ministers and Deacons Union; the Woman's Home and Foreign Missionary Union of Wake County; the Woman's Auxiliary to the Wake Association and the Executive Board of the Wake Association, all will meet at an appointed place within the next sixty days, work out and unite methods for one Leadership Training Program within the bounds of this Association.

5. Shaw University is teaching courses to help the pastors and all members of the church, we urge you therefore, Brethren, to raise more money in your churches for Mission and Christian Education, then send those deserving persons of our churches who want training and will go to Shaw for instruction in broader ways.

6. That the church will teach its membership to purchase homes, live more economically, and ever strive to be law abiding citizens.

7. The churches of this body are largely rural, the pastor is not there each Sunday in the month, in order to stimulate more interest and realize more money for the objectives and the expanding problem of this Association, where it is workable, a "\$1.00 Club," be organized in each church. Appoint a leader of the movement, with committee to help, and urge all church members to join the Club. Let the campaign for joining cover a period and break up the payments of the dollar into small parts within the ability of all the church members.

8. God is not pleased at the commercial practices on Sunday at the meeting place of our great Wake County Sunday School Convention. I pray that something may be done to avoid that practice even if the time of meeting has to be changed from Sunday to another day.

9. Let us support Shaw University to the strength of our ability and earnestly strive to ever keep going a Christian College to train our youth.

10. The Woman's Auxiliary is doing a good work in reaching back to the local church through the mission circle. May I urge each pastor and official staff of each church to see that a mission circle is in your church and at work. Then represent into the Woman's Auxiliary of this Association. To encourage the Mission Circle, let the local church honor them by giving full credit to the circles for all money that the members pay in for missions and Christian Education.

11. That this Body, and all Christians, in these perilous times will exercise steadfast faith in Jesus Christ, pray earnestly and stay humbly before the Almighty God for Divine guidance in all things. This will solve many problems.

12. That the pastors and churches strive to conduct a Daily Vacation Bible School during each year at their church.

13. The Leadership Training Institute conducted by your Association since the last meeting, in only three areas of the Association, namely: Riley Hill, Oberlin (West Raleigh), and Holly Springs, greatly helped the large attendance. I urge therefore, the continuance of the long range course with a faculty to instruct separately, the officials and all other workers in the Church.

14. To help deserving members of this Association, who need aid to study at Shaw University School of Religion, I recommend that \$250.00 be ear-marked for that purpose.

15. That the payment of \$1.00 per year for Missions and Christian Education, by each member of every church of this Association be regularly stressed by the pastors, deacons and all concerned so that the Lord's work may go forward more progressively through your Association.

16. That all Auxiliary bodies of this Association submit a full written report at each annual session of this Association.

17. That we meet in Extra Session and that the Committee on place of meeting will recommend a church for that meeting if there is one inviting the Association.

18. In order to more fully understand each other and the program of the Association, we therefore, kindly ask your approval of calling a special conference meeting, of all pastors, ministers and deacons and all other interested laymen and mission sisters to be held at the Bethlehem Baptist Church, the Fifth Saturday in September, 1957 at 11:00 A.M. That being a part of the Ministers and Deacons Union program that day.

(b) That each church will send its pastor and a delegation along with him, probably two deacons and a sister, to that conference, to get information and inspection.

19. That each individual church member, the church, and the Association, increase our giving of money for State, and Foreign Missions, Christian Education and all the supported objectives of this Association to strengthen the forces of God's Kingdom.

20. That this Body represent into the Lott Carey Convention this year in Orange, New Jersey by delegation. That the delegate take advantage of the special bus rates offered through the office of Dr. O. L. Sherrill, and all others who may find it convenient to do so.

EXTRA-SESSION OF THE WAKE BAPTIST ASSOCIATION

Garner, North Carolina
March 30, 1958

The Extra-Session of the Wake Baptist Association was held with the Wake Baptist Grove as host church. Instead of meeting in the church auditorium, we met in the Garner Consolidated School Building, Mr. C. A. Marriott, principal.

After the local Sunday School was concluded, Mrs. Mammie N. Perry, the President of the Woman's Auxiliary, presided. She read for the Scripture, sixteen verses of the 24th Chapter of Luke. The Reverend T. B. Smith offered the prayer. In her introductory remarks, Mrs. Perry stated that this had been a long hard winter but she was thankful to God for meeting the various circles in our bounds. She said this was not only a fifth Sunday, but it was also Palm Sunday which should have added meaning to us. "The Old Rugged Cross" was sung and expressions from several of the sisters. Mrs. L. W.
