PROCEEDINGS.

FRIDAY, SEPTEMBER 30th, 1910.

The Radicue Primitive Baptist Association met in session with the Pilgrim Rest Church, Wilson, N. C. Elder A Wooten sang hymn on page 591 and Elder Wm. Burnam offered prayer, after which Elder A. Wooten preached the introductory sermon from 2nd Kings 4:20. Elder J. H. Davis, alternate, sang hymn on page 141 and preached from the same subject. The Moderator then dismissed the Association for a short recess.

After a short intermission the Association re-assembled with Elder A. Wooten presiding Moderator. Elder S. Akers sang hymn on page 305 and offered prayer. The Moderator then announced the house in order for business. Agreed on motion that Elder A. Wooten be chosen Moderator of the Association. Agreed on motion that Bro. H. C. Jones be chosen Clerk with Bro. H. Dick-

ens. Assistant Clerk.

Agreed on motion that visting brethren and messengers from sister Associations be invited to seats and form a part in Conference and feel themselves at home. Agreed on motion that Elder A. Wooten, Bros. T. Dupree and L. Coburn be appointed a Committee on Arrangement of preaching from day to day. The Committee appointed Elder A Outerbridge and Elder Noah Steward to

the hall to preach for the people.

Agreed on motion we send Bro. H. Howard to the stand to record the text of the ministers. Agreed on motion that Bros. S. Ward, T. Dupree and J. Jones be appointed a Committee on Finance. Agreed on motion that Corresponding Messengers from sister Associations be called for. Elder J. H. Davis with file of minutes represented the Mt. Calvary Association of Ga., and were received, on motion, by the Moderator extending right hand of fellowship to the messenger. Elder C. J. Roguemore with file of minutes represented the Mt. Ramah Association of Ga., and were received, on motion, by the Moderator extending right hand of fellowship to the messenger. Elder W. H. Bassett represented the Chestnut Knob Primitive Baptist Association of Va., and were received, on motion, by the Moderator extending right hand of fellowship to the messenger. Elder Wm. Burnam with file of minutes represented the Antioch Association of Ga., and were received by the Moderator extending right hand of fellowship to the messenger. Elder S. Akers and Elder C. Duncan with file of minutes represented the Cub Run Association of Va., and were received, on motion, by the moderator extending the right hand of fellowship to the messengers. Elder G. S. Schuler with file of minutes represented the Mt. Willow Association of Miss., and were received, on motion, by the Moderator extending the right hand of fellowship to the messenger. Elder B. F. Daniel appointed by the Union Association and for failure to come the Association was represented by Elder Wm. Burnam and were received by the

Moderator extending right hand of fellowship to the messenger. Elder R. Everette and Elder Noah Steward with file of minutes represented the Little River Association of Johnson County and were received by the Moderator extending right hand of fellowship to the messengers. Agreed on motion that Petitionary Letters be called for. Two letters were read by clerk desiring to join with the Radicue, viz:—Mt. Ararat of Texas and Mt. Calvary of Texas. Agreed on motion that the letters and churches be received into the Radicue Association. Elder R. Peele came forward from the Corresponding Association, acknowledged their sins and begged forgivness and restoration. Agreed on motion that the Corresponding Association be received into fellowship and correspondence by the Moderator extending right hand of fellowship to the messengers. The Big Harper and Mississippi River Associations not represented. Agreed on motion that letters from sister Churches be called for.

Agreed on motion we see where the next session of the Radicue Association shall sit. Art Willow Church and the Plymouth Church were applicants for the next session of the Association. It pleased the mind of the brethren to grant the next session of the Association to the Art Willow Church. Agreed on motion that the next session of the Radicue Primitive Baptist Association sit with the Art Willow Church, Pitt County, N. C. Agreed on motion that Elder A. Wooten preach the introductory sermon with

Elder Geo. Dickens, alternate.

Agreed on motion that Elder A. Wooten and Bro. H. C. Jones prepare the circular letter. Agreed on motion that the Association adjourn until tomorrow morning at 9:00 o'clock. Elder W. H. Bassett sang hymn on page 339. Benedictien by Elder S. Akers.

SATURDAY, OCTOBER 1st, 1910.

The Association met according to adjournment. The Moderator sang hymn on page 21. Prayer by Elder R. Everette after which the Moderator read the 1st Chapter of the Psalms of David

and announced the house in order for business.

Agreed on motion that the list of the churches be called. Agreed on motion that yesterday's proceedings and the circular letter be read. Agreed on motion that yesterday's proceedings and the circular letter be received. Agreed on motion that the Finance Committee make their report. Agreed on motion that the report of the Finance Committee be received. Agreed on motion we take up unfinished business. Agreed on motion that the Association withdraw fellowship from Elder N. Johnson and all who endorse or follow his disorderly conduct.

Agreed on motion the Association appoint delegates to visit sister Associations with whom she corresponds. Agreed on motion we send Elder H. Taylor to the Cub Run Association, 1911.

Agreed on motion we send to the Corresponding Association Elder A. Outerbridge and Bro. H. Black. Agreed on motion we send Elder Geo. Dickens, Elder H. Taylor and Elder Aaron Wooten to the Little River Association, of Johnson County. Agreed on motion we send Elder A. Wooten to Mt. Willow Association of Ark. Agreed on motion we send Elder A. Wooten to the Chestnut Knob Primitive Baptist Association of Va., 1911. Agreed on motion we send Elder A. Wooten and Bro. J. B. Hyman to the several Associations of Georgia. Agreed on motion we correspond with the Mississippi River, the Big Harper, and the Mt. Olive Associations by letter and minutes. Agreed on motion that the Moderator and Clerk prepare the correspondent letters for sister Associations. Agreed on motion the Association Treasurer make his report. Agreed on motion that the report of the Treasurer be received. Bro. Warren Coburn, Treasurer, Elder A. Wooten, S. Ward, Joseph Jones and H. C. Jones, Trustees for the Association.

Agreed on motion that the Association have 1,500 minutes printed under the supervision of Elder A. Wooten. Agreed on motion the Association adjourn until Sunday morning at 9 o'clock. The Moderator tendered the heart felt thanks of this Association to the people of this vicinity for their kind attention during their

assemblage at this place.

Circular Letter.

This the 30th Annual Session of the Radicue Primitive Baptist Association held with the Pilgrim Rest Church, Wilson, N. C., commencing on Friday before the 1st Sunday in October, 1910.

The Lord hath brought us through many dangers seen and unseen to us. Dear brethren let us stand fast in the liberty wherewith Christ has made us feel and be not entangled again with the yoke of bondage. Oh, how good and pleasant it is for brethren to dwell together in unity. It is like the precious ointment upon the head that ran down upon the head even Aaron's beard and down to the skirts of his garment as the dew of Hermon. And as the dew that decended from the mountain of Zion for there the Lord commanded the blessing . Dear Brethen we have received your Messengers and Ministers from the East and from the West. They have brought us good news from a far country.

We desire to keep up the friendly correspondence with all orderly Primitive Baptists. Dear Brethen pray for us that our faith fail not and that God's Righteousness may be spoken of.

Abstracts of Principles.

We believe in one true and living God the Father, the Word and the Holy Ghost.

We believe that the Scriptures of the Old and New Testaments are the

words of God and the only rule of faith and practice.

We believe in one Superior Eternal God the creator and upholder of all beings and the disposer of all events for there are three that bear record in heaven; the Father, the Word, and the Holy Ghost, and these three are one. 1 John 1:5.

We believe in the total depravity and just condemnation of all the fallen

race of Adam.

We believe in original sin and that the punishment of the wicked shall be everlasting and joys of the righteous eternal. We believe that God's elect shall be called, converted, regenerated, sanctified by the Holy Ghost.

We believe that the saints shall always preserve in grace and never finally

fall away.

We believe that baptism, the Lord's supper, and the washing of the Saint's feet are ordinances of Jesus Christ and that the true believers in Jesus Christ are the only subjects entitled to these privileges.

We believe the mode of baptism is by immersing in water.

We believe in the resurrection of the dead both of the just and unjust.

We believe that God chose his people in Christ Jesus before the world begun We believe that no minister has a right to the administration of ordinances only such as are regularly baptized, called and come under the imposition of the hands presbyter.

We believe that none but regularly baptized members have the right to

commune at the Lord's Table.

Rules of Decorum of Church Government.

Agreed to and Adopted by the Church of God at Radicue Meeting House, Friday Before the First Sunday in August, 1876.

Being dismissed by letters from Otter's Creek, Sparta, Tyson's Meeting House; having spent the day in fasting and prayer, give ourselves to Christ and to one another.

ARTICLE 1. That members comprising this church shall assemble themselves together at Radicue Meeting House the first Sunday in every month and the Saturday before, unless prevented by unavoidable necessity. Heb-10:10. "And not to forsake the assembling of ourselves together as the manner of some is."

2. The members of the church shall meet in conference on every Saturday before the first Sunday in each month. Acts 15:6. "And the Apostles and

Bilders come together to consider of this matter."

3. Conference shall be opened and closed with prayer, or praise to Almighty God. † Tim. 2:1. "I exhort, therefore, that first of all prayer and intercession and giving of thanks be made for all men." † Thes. 1:17, 18. "Pray without ceasing, and everything give thanks, for this is the will of God in Christ Jesus concerning you."

4. The pastor of the church shall be moderator or nominate one who is

present, when absent the conference shall appoint one, and after the conference shall be agreed, on motion, visiting brethren from sister churches may be invited to take seats with us. Psalm 138:1. "Behold how good and how

pleasant it is for brethren to dwell together in unity."

5. It shall be the duty of the Moderator to preserve order and harmony in the conference according to these rules or others which may be subsequently adopted. He shall fairly state every question, ascertain the majority and re-

port accordingly. 1 Cor. 14:40. "Let everything be done decently and in order.

6. The conference shall appoint a clerk whose duty it shall be to record faithfully in a well bound book (purchased by the conference) all of their proceedings and to do and to perform all such other things as usually de-

volves upon such officers.

The member's names shall be enrolled distinctly, called over and a significant mark attached to their names which may be absent. Acts 1:15. "The number of their names together were about 120." When any member shall be absent three conferences, it shall be the duty of the clerk to give notice thereof to the church who thereupon, shall order notice to be issued conference may take such measures as to them may appear consonant with brotherly love and Gospel order. Heb. 10:25. "Not forsake the assembling together." to the delinquent, to be served by one of the deacons, and upon which the

8. A door shall be opened for the admission of new members, who before admission shall verbally relate their experience and when unanimous satisfaction is offered the church in conference that God has wrought a work of grace in their souls, it shall be the duty of the Moderator to give them the right hand of fellowship in behalf of the church and said candidates, shall after being baptized by immersion become a member of the church and not before. Peter 3:15. "Be ready always to give an answer to every man that ask you the reason of the hope that is in you with meekness and fear." Mat. 28:19. "Baptizing them in the name of the Father, and of the Son and of the Holy Ghost.'

If any momber of this church shall bring a complaint of a private trespass having been committed upon him by one of his brethren, before he shall have complied with the requisition of the great head of the church, prescribed in the 8th chapter of Matthew, the church shall disregard it and shall be deemed disorder. "Whereof if thy brother trespass against thee," etc.

It shall be deemed disorder in any member of the church who shall speak illiberally of one of his brethren or otherwise than is laid down in the word before the recited chapter (18th of Matthew) and who may join the world calumniating or traducing their character. Rom. 1:39. "Let love be without dissimulation." Gal. 6:12. "Brethren if a man be overtaken in fault, ye which are spiritual, restore such a one in the spirit of meekness, considering thyself, less thou also be tempted." "Bear ye one another's burdens, and so fulfill the Law of Christ.'

All public offences against morality shall be noted by the church publicly and the offenders dealt with according to Gospel order. Matt. 5:16. "Let your light so shine before men, that they may see your good works and

glorify your Father which is in heaven.

12. Every motion made and seconded, shall be taken under consideration of the conference, unless withdrawn by the mover and making it open for discussion or debate, but one person shall speak at a time, who shall arise from his seat and address the Moderator by the appellation of Brother Moderator, and when two or more shall rise at the same time he shall decide without argument between them. 1 Cor. 14:40. "Let everything be done decently and in order.

13. Every query presented shall be thrice read before it is open for debate, and it shall not be received unless a majority of those present concur in its

reception and its decision a majority shall govern.

14. In all cases, except in the admission of members into the church a majority of those present shall govern whose decisions shall be final, except two-thirds of the members at the next conference agree to consider the matter and two-thirds shall so agree the subject matter shall again come before the conference and this decision shall be final.

15. Implicit obedience shall be yielded to the decision of the conference but every member that is dissatisfied with the proceedings of the conference shall express themselves before adjourning of the conference and not there-Rom. 13:1. "Let every soul be subject to the higher power."

The minutes of the conference shall be read before it adjourns and all

errors corrected.

17. The following are prohibited, whispering or laughing during time of public speaking, with the appearance of wrath, or in a degrading manner,

speaking more than three times without leave.

18. It shall be deemed disorderly in any member who openly and avowedly denies the fundamental doctrines contained in the church covenant and they shall be dealt with accordingly. Jude 1:3. "Earnestly contend for the faith which was once delivered unto the saints." Be of one mind. How can two

talk together except they be agreed?

19. As intemperance is one of the worst evils which can effect the members of any society, either civil or religious, and more especially the latter, it being in direct violation of the word of God, wounding the cause of Jesus Christ, hurting the feelings of the sober brethen and exposing the individual to commission of sin of the most abominable cast of character, we do declare and agree that when any member of this church shall so far forget what he owes to the great head of the church, to himself, the feeling of his brethren and to morals and to well being of society generally, as to get drunk and become known to the church, he shall be notified to attend our church conference, and on failing to render entire satisfaction, to be considered as an excommunicant and not entitled to any privilege thereafter until such offender shall bring forth fruits meet for repentance. Matt. 5:16. "Let your light so shine before men." etc. The following amendment to the above article was adopted in conference and read thus:-"And we further agree and declare to be the duty of every member of this church, that when he knows of a member of this church getting drunk as above stated in this article to make it known to the church.

20. If upon issuing a notice to any delinquent member as is required by the 7th Article of this Decorum, the Deacon returns, "not to be found within the limits of the church," that the conference shall then proceed as if the

notice had been served.

21. A majority of the members of this church in conference shall have the power to alter or to amend any of the rules of this Decorum, which they have adopted for their government or to add any new rules which said majority may deem necessary.

Motion made by Elder N. Johnson and seconded and agreed that any church of the Radicue Association shall not hold any member who will not

pay an honest debt.



Agreed on motion we send Bro. E. H. Howard to the stand to record the text of the ministers. Agreed on motion Bros. S. Ward, T. Dupree and Joseph Jones be chosen committee on finance. Agreed on motion that corresponding messengers from sister associations make their report. Elder J. D. Lightfoot with file of minutes represented the Antioch Association of Georgia and were received on motion by the moderator extending the right hand of fellowship to the messenger. Elder J. H. Davis represented the Mt. Calvary Association of Georgia and were received on motion by the moderator extending right hand of fellowship to the mes-Elder Randal Conoway with file of minutes represented the Cub Run Association of Virginia, and were received by the moderator extending the right hand of fellowship to the messenger. Elder E. K. Turner represented the Chestnut Knob Association of Virginia, and were received on motion by the moderator extending right hand of fellowship to the messenger. Bro. J. E. Everette represented the Little River Association of Johnson County, N. C. and were received on motion by the moderator extending the right hand of fellowship to the messenger. Elder R. C. Agreed on motion that letters from sister churches be called for fifteen letters were handed in and read by the clerk. on motion we see where the next session of the Radicue Association will convene. The Plymouth Church asked for the next session of the Radicue Primitive Baptist Association and as it pleased the mind of the brethren it was agreed on motion that the next session of the Radicue Primitive Baptist Association convene with the Plymouth Church, Washington County, situated 4 miles east of Plymouth. Agreed on motion Elder A. Wooten preach the introductory sermon with Elder H. Taylor, alternate. Agreed on motion Elder A. Wooten and Bro. H. C. Jones write the circular letter. Agreed on motion that the association adjourn until tomorrow morning at 9 o'clock. Elder J. D. Lightfoot sang hymn on page 73 and dismissed the association.

SATURDAY, SEPTEMBER 30th, 1911.

Ramah Association of Georgia represented by a file of minutes. Agreed that the above named associations be received. Agreed on motion we take up correspondence with the Pine Light Association of Missisippi. Agreed on motion we take up correspondence with the Piedmont Association of Va. Agreed on motion the association appoint delegates to visit sister association with whom she corresponds.

Agreed on motion we send Elder H. Taylor to the Chestnut Knob and Piedmont Associations of Virginia, A. D., 1912, to convene with Locust Grove Church, Patrick County, Virginia D. & W. R. R. at Stella, Va. Agreed on motion we send Elder A. Wooten to the Cub Run Association of Virginia, A. D., 1912. Agreed on motion we send Elder A. Wooten and Elder H. Taylor to the Associations of Georgia. Agreed on motion we send Elder J. B. Hyman and Elder A. Outerbridge to the Little River Association of Johnson County, N. C. Agreed on motion we send Elder H. P. Black and Bro. Wm. Howard to the Corresponding Association of Martin County, N. C. Agreed on motion we correspond with the Missis-

sippi River and the Big Harper Associations by letter and minutes. Agreed on motion we send Elder A. Wooten to the Mt. Willow Association, Arkansas. Agreed on motion that the moderator and clerk prepare the corresponding letters for sister associations.







Abstracts of Principles.

We believe in one true and living God the Father, the Word and the Holy

We believe that the Scriptures of the Old and New Testaments are the

words of God and the only rule of faith and practice.

We believe in one Superior Eternal God the creator and upholder of all beings and the disposer of all events for there are three that bear record in heaven; the Father, the Word, and the Holy Ghost, and these three are one. 1 John 1:5.

We believe in the total depravity and just condemnation of all the fallen

race of Adam.

We believe in original sin and that the punishment of the wicked shall be everlasting and joys of the righteous eternal. We believe that God's elect shall be called, converted, regenerated, sanctified by the Holy Ghost.

We believe that the saints shall always preserve in grace and never finally

fall away.

We believe that baptism, the Lord's supper, and the washing of the Saint's feet are ordinances of Jesus Christ and that the true believers in Jesus Christ are the only subjects entitled to these privileges.

We believe the mode of baptism is by immersing in water.

We believe in the resurrection of the dead both of the just and unjust. We believe that God chose his people in Christ Jesus before the world begun.

Rules of Decorum of Church Covernment.

Agreed to and Adopted by the Church of God at Radicue Meeting House, Friday Before the First Sunday in August, 1876.

Being dismissed by letters from Otter's Creek, Sparta, Tyson's Meeting House; having spent the day in fasting and prayer, give ourselves to Christ and to one another.

ARTICLE 1. That members comprising this church shall assemble themselves together at Radicue Meeting House the first Sunday in every month and the Saturday before, unless prevented by unavoidable necessity. Heb. 10:10. "And not to forsake the assembling of ourselves together as the manner of some is.'

The members of the church shall meet in conference on every Saturday, before the first Sunday in each month. Acts 15:6. "And the Apostles and Elders come together to consider of this matter."

3. Conference shall be opened and closed with prayer, or praise to Almighty

God. 1 Tim. 2:1. "I exhort, therefore, that first of all prayer and intercession and giving of thanks be made for all men." 1 Thes. 1:17, 18. "Pray without ceasing, and everything give thanks, for this is the will of God in Christ

Jesus concerning you

4. The pastor of the church shall be moderator or nominate one who is present, when absent the conference shall appoint one, and after the conference shall be agreed, on motion, visiting brethren from sister churches may be invited to take seats with us. Psalm 133:1. "Behold how good and how pleasant it is for brethren to dwell together in unity."

5. It shall be the duty of the Moderator to preserve order and harmony in the conference according to these rules or others which may be subsequently adopted. He shall fairly state every question, ascertain the majority and report accordingly. 1 Cor. 14:40. "Let everything be done decently and in

order."

6. The conference shall appoint a clerk whose duty it shall be to record faithfully in a well bound book (purchased by the conference) all of their proceedings and to do and to perform all such other things as usually devolves

upon such officers.

7. The member's names shall be enrolled distinctly, called over and a significant mark attached to their names which may be absent. Acts 1:15 "The number of their names together were about 120." When any member shall be absent three conferences, it shall be the duty of the clerk to give notice thereof to the church who thereupon, shall order notice to be issued to the delinquent, to be served by one of the deacons. and upon which the conference may take such measures as to them may appear consonant with brotherly love and Gospel

order. Heb. 10:25. "Not forsake the assembling together."

8. A door shall be opened for the admission of new members, who before admission shall verbally relate their experience and when unanimous satisfaction is offered the church in conference that God has wrought a work of grace in their souls, it shall be the duty of the Moderator to give them the right hand of fellowship in behalf of the church and said candidate, shall after being baptized by immersion become a member of the church and not before. Peter 3:15. "Be ready always to give an answer to every man that ask you the reason of the hope that is in you with meekness and fear." Mat. 28:19. "Baptizing them in the name of the Father, and of the Son and of the Holy Ghost."

9. If any member of this church shall bring a complaint of a private trespass having been committed upon him by one of his brethren, before he shall have complied with the requisition of the great head of the church, prescribed in the 8 chapter of Matthew, the church shall disregard it and shall be deemed

disorder. "Whereof if thy brother trespass against thee," etc.

10. It shall be deemed disorder in any member of the church who shall speak illiberally of one of his brethren or otherwise than is laid down in the word before the recited chapter (18th of Matthew) and who may join the world calumniating or traducing their character. Rom. 1:39. "Let love be without dissimulation." Gal. 6:12. "Brethren if a man be overtaken in fault, ye which are spiritual, restore such a one in the spirit of meekness, considering thyself, less thou also be tempted." "Bear ye one another's burdens, and so fulfill the Law of Christ."

11. All public offences against morality shall be noted by the church publicly and the offenders dealt with according to Gospel order. Matt. 5:16. "Let your light so shine before men, that they may see your good works and glorify

your Father which is in heaven.

12. Every motion made and seconded, shall be taken under consideration of the conference, unless withdrawn by the mover and making it open for discusion or debate; but one person shall speak at a time, who shall arise from his seat and address the Moderator by the appeleation of Brother Moderator, and when two or more shall rise at the same time he shall decide without argument between them. 1 Cor. 14:40. "Let everything be done decently and in order."

13. Every query presented shall be thrice read before it is open for debate.

and it shall not be received unless a majority of those present concur in its re-

ception and its decision a majority shall govern.

14. In all cases, except in the admission of members into the church a majority of those present shall govern whose decisions shall be final, except two-thirds of the members at the next conference agree to consider the matter and two-thirds shall so agree the subject matter shall again come before the conference and this decision shall be final.

15. Implicit obedience shall be yielded to the decision of the conference but every member that is dissatisfied with the proceedings of the conference shall express themselves before adjourning of the conference and not there-

after. Rom. 13:1. "Let every soul be subject to the higher power."

The minutes of the conference shall be read before it adjourns and all

errors corrected.

The following are prohibited, whispering or laughing during time of public speaking, with the appearance of wrath, or in a degrading manner.

speaking more than three times without leave.

It shall be deemed disorderly in any member who openly and avowedly denies the fundamental doctrine contained in the church covenant and they shall be dealt with accordingly. Jude 1:3. "Earnestly contend for the faith which was once delivered unto the saints." Be of one mind. How can two

talk together except they be agreed?

19. As intemperance is one of the worst evils which can effect the members of any society, either civil or religious, and more especially the latter, it being in direct violation of the word of God, wounding the cause of Jesus Christ, hurting the feelings of the sober brethren and exposing the individual to commission of sin of the most abominable cast of character, we do declare and agree that when any member of this church shall so far forget what he owes to the great head of the church, to himself, the feeling of his brethren and to morals and to well being of society generally, as to get drunk and be come known to the church, he shall be notified to attend our church conference, and on failing to render entire satisfaction, to be considered as an excommunicant and not entitled to any privilege thereafter until such offender shall bring forth fruits meet for repentance. Matt. 5:16. Let your light so shine before men," etc. The following amendment to the above article was adopted in conference and read thus:-"And we further agree and declare to be the duty of every member of this church, that when he knows of a member of this church getting drunk as above stated in this article to make it known to the church.'

If upon issuing a notice to any delinquent member as is required by the 7th Article of this Decorum, the Deacon returns, "not to be found within the limits of the church," that the conference shall then proceed as if the notice had been served.

21. A majority of the members of this church in conference shall have power to alter or to amend any of the rules of this Decorum, which they have adopted for their government or to add any new rules which said majority may deem necessary.

Motion made and seconded and agreed that no church shall hold any mem-

ber who will not pay an honest debt.

Motion made and seconded that we will not have nor hold members with us belonging to secret societies, Odd Fellows, Masons, or Sunday Schools.

RULES OF DECORUM OF CHURCH GOVERNMENT.

AGREED TO AND ADOPTED BY THE CHURCH OF GOD AT RADICUE MEETING HOUSE, FRIDAY BEFORE THE FIRST SUNDAY IN AUGUST, 1876.

Being dismissed by letters from Otter's Creek, Sparta, Tyson's Meeting House; having spent the day in fasting and prayer, give ourselves to Christ and to one another.

ARTICLE 1. That members comprising this church shall assemble themselves together at Radicue Meeting House the first Sunday in every month and the Saturday before, unless prevented by unavoidable necessity. Heb 10:10. "And not to forsake the assembling of ourselves together as the manner of some is."

The members of the church shall meet in conference on every Saturday before the first Sunday in each month Acts. 15:6. "And the Apostles and

Elders come together to consider of this matter."

3. Conference shall be opened and closed with prayer, or praise to Almighty God. 1 Tim. 2:1. "I exhort, therefore, that first of all prayer and intercession and giving of thanks be made for all men." 1 Thes. 1:17,18. "Pray without ceasing, and everything give thanks, for this the will of God in Christ Jesus concerning you "

The pastor of the church shall be moderator or nominate one who is present, 'when absent the conference shall appoint one, and after the conference shall be agreed, on motion, visiting brethren from sister churches may be invited to take seats with us. Psalm 133:1. "Behold how good and how pleasant it is for brethren to dwell together in unity."

5. It shall be the duty of the moderator to preserve order and harmony in

the conference according to these rules or others which may be subsequently adopted. He shall fairly state every question, ascertain the majority and report accordingly. 1 Cor. 14:40. "Let everything be done decently and in order."

6. The conference shall appoint a clerk whose duty it shall be to record faithfully in a well bound book (purchased by the conference) all of their proceedings and to do and to perform all such other things as usually devolves

upon such officers.

7. The members' names shall be enrolled distinctly, called over and a significant mark attached to their names which may be absent. Acts 1:15. "The number of their names together were about 120." When any member shall be absent three conferences, it shall be the duty of the clerk to give notice thereof to the church who thereupon, shall order notice to be issued to the delinquent, to be served by one of the deacons, and upon which the conference may take such measures as to them may appear consonant with brotherly love and Gospel

order. Heb. 10;25. "Not forsake the assembling together."

8. A door shall be opened for the admission of new members, who before admission shall verbally relate their experience and when unanimous satisfaction is offered the church in conference that God has wrought a work of grace in their souls, it shall be the duty of the moderator to give them the right hand of fellowship in behalf of the church, and said candidate, shall after being baptized by immersion become a member of the church and not before. Peter 3:15. "Be ready always to give an answer to every man that ask you the reason of the hope that is in you with meekness and fear," Mat. 28:19 "Baptizing them in the name of the Father, and of the Son and of the Holy Ghost."

9. If any member of this church shall bring a complaint of a private trespass having been committed upon him by one of his brethren, before he shall have complied with the requisition of the great head of the church, prescribed in the 8th chapter of Matthew, the church shall disregard it and shall be deemen

disorddr. "Whereof if thy brother trespass against thee," etc.

10. It shall be deemed disorder in any member of the church who shall speak illiberally of one of his brethren or otherwise than is laid down in the word before the recited chapter (18th of Matthew) and who may join the world calumniating or traducing their character. Rom 1:39. "Let love be without dissimulation." Gal. 6:12. "Brethren if a man be overtaken in fault, ye which are spiritual, restore such a one in the spirit of meekness, considering thyself, less thou also be tempted." "Bear ye one another's burdens, and so fulfill the Law of Christ."

11. All public offences against morality shall be noted by the chu ch publicly and the offenders dealt with according to Gospel order. Matt. 5:16. "Let your light so shine before men, that they may see your good works and glority

your Father which is in Heaven."

12. Every motion made and seconded, shall be taken under consideration of the conference, unless withdrawn by the mover and making it open for discusion or debate, but one person shall speak at a time, who shall arise from his seat and address the Moderator by the appeleation of Brother Moderator, and when two or more shall rise at the same time he shall decide without argument between them. 1 Cor. 14:40. "Let everything be done decently and in order."

13. Every query presented shall be thrice read before it is open for debate, and it shall not be received unless a majority of those present concur in its re-

ception and its decision a majority shall govern.

14. In all cases, except in the admission of members into the church a majority of those present shall govern whose decisions shall be final, except two-thirds of the members at the next conference agree to consider the matter and two-thirds shall so agree the subject matter shall again come before the conference and this decision shall be final.

15. Implicit obedience shall be yielded to the decision of the conference but every member that is dissatisfied with the proceedings of the conference shall express themselves before adjourning of the conference and not thereafter. Rom. 13:1. "Let every soul be subject to the higher power."

The minutes of the conference shall be read before it adjourns and all

errors corrected.

The following are prohibited, whispe ing or laughing during time of public speaking, with the appearance of wrath, or in a degrading manner,

speaking more than three times without leave.

18. It shall be deemed disorderly in any member who openly and avowedly denies the fundamental doctrine contained in the church covenant and they shall be dealt with accordingly. Jude 1:3. "Earnestly contend for the faith which was once delivered unto the saints." Be of one mind. How can two

- talk together except they be agreed?

 19. As intemperance is one of the worst evils which can effect the members of any society, either civil or religious, and more especially the latter, it being in direct violation of the word of God, wounding the cause of Jesus Christ, hurting the feelings of the sober brethren and exposing the individual to commission of sin of the most abominable cast of character, we do declare and agree that when any member of this church shall so far forget what he owes to the great head of the church, to himself, the feeling of his brethren and to mortals and to well being of society generally, as to get drunk and be come known to the church, he shall be notified to attend our church conference, and on failing to render entire satisfaction, to be considered as an excommunicant and not entitled to any privilege thereafter until such offender shall bring forth fruits meet for repentance. Matt. 5:16. "Let your light so shine before men," etc. The following amendment to the above article was adopted in conference and read thus:—"And we further agree and declare to be the duty of every member of this church, that when he knows of a member of this church getting drunk as above stated in this article to make it known to the church."
- If upon issuing a notice to any delinquent member as is required by the 7th Article of this Decorum, the Deacon returns, "not to be found within the limits of the church," that the conference shall then proceed as if the notice had been served.
- 21. A majority of the members of this church in conference shall have power to alter or to amend any of the rules of this Decorum, which they have adopted for their government or to add any new rules which said majority may deem nccessary.







RULES OF DECORUM OF CHURCH GOVERNMENT.

AGRED TO AND ADOPTED BY THE CHURCH OF GOD AT RADICUE MEETING HOUSE FRIDAY BEFORE THE FIRST SUNDAY IN AUGUST, 1876.

Being dismissed by letters from Otter's Creek, Sparta, Tyson's Meeting House having spent the day in fasting and prayer, give ourselves to Christ and to one another.

As intemperance is one of the worst evils which can effect the members of any society either civil or religious, and more especially the latter, it being in direct violation of the word of God, wounding the cause of Jesus Christ, hurting the feelings of the sober brethren and exposing the individual to commission of sin of the most abominable cast of character, we do declare and agree that when any member of this church shall so far forget what he owes to the great head of the church, to himself, the feeling of his brethren and to mortals and to well being of society generally, as to get drunk and become known to the church, he shall be notified to attend our church conference, and on failing to render entire satisfaction, to be considered as an excommunicant and not entitled to any privilege thereafter until such offender shall bring forth fruits meet for repentance. Matt. 5:16. "Let your light so shine before men," etc. The following amendment to the above article was adopted in conference and read thus:- "And we further agree and declare to be the duty of every member of this church, that when he knows of a member of this church getting drunk as above stated in this article to make it known to the church.

20. If upon issuing a notice to any delinquent member as is required by the 7th Article of this Decorum, the Deacon returns "not to be found within the limits of the church." that the conference shall then proceed as if the notice had been served.

21. A majority of the members of this church in conference shall have power to alter or to amend any of the rules of this Decorum, which they have adopted for their government or to add any new rules which said majority may deem necessary.



12. Every motion made and seconded, shall be taken under consideration of the conference, unless withdrawn by the mover and making it open for discussion or debate, but one person shall speak at a time, who shall arise from his seat and address the moderator by

the appealeation of brother moderator, and when two or more shall rise at the same time he shall decide without argument between them. 1 Cor. 14:40, Let everything be done decently and in order."

13. Every query presented shall be thrice read before it is open for debate, and it shall not be received unless a majority of those present concur in its reception and its decision a majority shall

govern.

14. In all cases, except in the admission of members into the church, a majority of those present shall govern whose decisions shall be final; except two-thirds of the members at the next conference agree to consider the matter and two-thirds shall so agree, the subject matter shall again come before the conference and this decision shall be final.

15. Implicit obedience shall be yielded to the decision of the conference, but every member that is dissatisfied with the proceedings of the conference shall express themselves before adjourning of the conference and not thereafter. Rom. 13:1, "Let every soul be sub-

ject to the higher power."

16. The minutes of the conference shall be read before it adjourns,

and all errors corrected.

17. The following are prohibited, whispering or laughing during time of public speaking, with the appearance of wrath, or in a degrading manner, speaking more than three times without leeave.

18. It shall be deemed disorderly in any member who openly and avowedly denies the fundamental doctrine contained in the church covenant and they shall be dealt with accordingly. Jude 1:3, "Earnestly contend for the faith which was once delivered unto the saints." Be of one mind. How can two talk together except they be agreed?

19. As intemperance is one of the worst evils which can effect the members of any society, either civil or religious, and more especially the latter, it being in direct violation of the word of God, wounding the cause of Jesus Christ, hurting the feelings of the sober brethren and exposing the individual to commission of sin of the most abominable cast of character, we do declare and agree that when any member of this church shall so far forget what he owes to the great head of the church, to himself, the feelings of his brethren and to mortals and to well being of society generally, as to get drunk and become known to the church, he shall be notified to attend our church conference, and on failing to render entire satisfaction, to be considered as an excommunicant and not entitled to any privilege thereafter until such offender shall bring forth fruits meet for repentance. Matt. 5:16, "Let your light so shine before men," etc. The following amendment to the above article was adopted in conference and read thus:-"And we further agree and declare to be the duty of every member of this church, that when he knows of a member of this church getting drunk as above stated in this article, to make it known to the church."

20. If upon issuing a notice to any delinquent member as is required by the 7th Article of this Decorum, the Deacon returns, "not to be found within the limits of the church," that the conference

shall then proceed as if the notice had been served.

21. A majority of the members of this church in conference shall have power to alter or amend any of the rules of this Decorum, which they have adopted for their government or to add any new rules which said majority may deem necessary.

Motion made, seconded and and agreed that no church shall hold

any member who will not pay an honest debt.

Motion made and seconded that we will not have nor hold members with us belonging to secret societies, Odd Fellows, Masons, or Sunday School.
