Dear Brother Harris:

There are several items about which I shall write you this evening.

First, I now have a concrete figure from the Pilgrim Press for the printing of the WTJ.

1. 72 pages (which I think will accommodate the papers we have) similar to last year's Journal, 1,000 copies for \$575.75 F.O.B. , plus author's change of copy on an hourly rate.

This is indeed a good price; even somewhat better than I had hoped for, and than what I estimated at ATS for 1,000 copies. This is only about \$150.00 higher than the 55 page bulletin in quantity of 500 last year.

2. The Pilgrim Press would not be able to do this job, that is begin it, before a month to six weeks- probably January 1 to 15. Then they estimate from one month to six weeks, probably the latter, to complete the job. Thus if they do this Journal it would likely be the middle of February to the first of March before it would be read for us. This is of course the rather disappointing feature of the proposition.

As far as the Editorial Committee is concerned we are practically ready to submit the copy to the press, but they cannot begin it for a month to six weeks. I am sure that we cannot hope to match this price anywhere. In fact I seriously doubt if we could get it done anywhere else for less than upward of \$1,000.00 , if not more, and we do not have that kind of money.

Please give me your decision in the above matter at once if at all possible. It will be necessary for us to let the contract at the earliest possible date so that the Pilgrim Press will hold the time open for our job. I wish it were possible to have it done sooner, but if we cannot then what is the answer?

Second, can you supply me with the correct titles of the positions and the degrees of each of the men whose papers we are to publish? Are the following listings correct as far as I know them?


J. L. Mercer, ?, Azusa Pacific College
