Dear Brethren:

On the instructions of Dr. Richard Taylor by phone from Kansas City, and by the approval of the members of the Editorial Board of the WTS I submitted the MSS to the Pilgrim Publishing House at Indianapolis for the printing of the Wesleyan Theological Journal. They bid \$396.70 for 500 copies of the journal. This was the best reliable bid that we were able to get.

Yesterday I received the galley proofs of the Journal from the Pilgrim Publishing House. I have read them carefully, made such corrections as were necessary, and am returning them to the printers at once. They promised delivery of the journal within sixty days from the time they received the MS. There were less than sixty days until the NHA Convention in April from the time the MS was submitted to them. However, they pomised to do their best to get the journal out by that time, but were not certain if this would be possible. It is evident that they are trying hard as they have already set the type. Since they are making this effort I thought it only fair to read these proofs at once and get them back to them immediately rather than sending them to each of the members of the Editorial Committee to read. This would have taken much longer and might delay the printers considerably. I trust this is satisfactory with you men under the circumstances.

Actually the proofs were unusually clean and free from excessive mistakes-very few mistakes in fact. Apparently, as nearly as I can figure from the proofs, the material will print out to just about 56 pages, which is the number of pages which they bid on at \$396.70. However, it could be off on this figure a little either way. It is not possible to figure accurately from the galley proofs. Should it run over, which I doubt, it will cost a little more than the quoted figure. I suppose the ye will be some way of paying for the extra in that event.
