I trust you received the Committee listings. I mailed them to you Monday, I think. Also, did you receive the letterhead and envelopes (300 of each)?

On the basis of your explanation with respect to the amendment to Dr. Harris' motion, I am letting the matter stand. I believe your explanation clears the matter.

With regard to the financial arrangement with respect to the journals which you distribute, I fear you misunderstood my motives. I am not meaning to suggest that your method is unethical. I do think, however, that without being able to give a strict account of just how many expenses you have had, that this manner of handling the journals exposes you to the possibility of being charged with unethical practices by some sleuth who may want to embarrass you some time. If that should happen, both you and I would be embarrassed. I was trying to prevent such a contingency from arist was on that basis that I used the word "acquiesce." The fact that you were given official permission to handle the journals as you do would not prevent an enemy within the Society from questioning your original motive for requesting this privilege. I know you well enough that I am raising no question personally. I was just trying to protect you from what I see as a possibly embarrassing situation in the future. I am willing to let the matter drop at this. I certainly do not want to add to your work by imposing technicalities on you.
