Dear friend Wayne,

Many thanks for the package of 25 copies of WTS Journals, Vol. 13, 1978, through the kindness of the Richeys. Blair Richey spoke to me about it this morning when he was waiting in the registration line, then delivered the package to my office later on. Your letter, attached to the package, is much appreciated. What a pleasant surprise to see my Dad's school picture in a recent issue of the C.C. Dispatch! I had seen the actual photo when we were going through my folk's things in preparation for the sale a year ago last October. Thank you for sending it to me.

I had to go to the ATS Information Files for some addresses that I needed, so I took your two inquiries along with me. JOEL S.
