Dear Larry,

I am enclosing a xeroxed copy of a letter from President Ray
A. Seilhamer, Evangelical School of Theology, Myerstown, Pa., in which
he extends an invitation to WTS to hold our annual meeting there on
Nevember 6-7, 1987. I thought you should know about this now, for you
will want to include this on the agenda for the Executive Committees
meeting in April.

You will also find enclosed a copy of a letter I addressed to Mrs. Evelyn Marston Mottweiler in which permission was granted to use Bishop Marston's paper that was first published in the WTS Journal in 1969. It will appear in a biography of Bishop Marston that will be coming from the press in the near future.

Ray Dunning called me this week about a couple of matters relating to WTS, one of which was about the reservations and trip to the CHA Convention in April. We are checking the possibility of making the trip together. His inquiry prompted me to check your letter of January 24, 1985, again. You wrote: "I will contact the Executive Committee and have them notify you of their motel needs." You suggested that reservations should be made at CROSSWINDS NORTHWEST, and I assume that I am responsible for making the reservations. I observe that the Convention is scheduled Tuesday through Thursday, April 23 - 25. I see there are "Special Events Tickets," but I assume those reservations would be made on an individual basis -- or, do I have some responsibility in that regard? I'll also need to know whether or not there should be "single" or "double" reservations. Ray mentioned the possibility of his wife going with him.

I have a recent letter from Dr. Alex. R.G. Deasley (Feb. 11, 1985). He had the misfortune of being in a car accident which put him in the hospital at the end of December and from which he is only now fully recovering. Regarding Vol. 19, No. 2 (Fall 1984 issue) he writes: "...I do not foresee that it will be forthcoming for six weeks or two months. That however, is only an estimate and does not take into account any delays that could occur with the printer."

I rejoice with you over the large endowment you have received for a chair in Wesley and the Church.
