We continue to receive excellent reports from those that were present in the recent CHA convention in Indianapolis. I feel our speakers in the plenary sessions did superbly. All the reports received from the commissions were very complimentary. Once again, I want to express our gratitude to each of you for helping make the commissions very successful.

This memo is being sent to the chairpersons of each commission. Hopefully, the head of each commission is receiving this memo. If, perchance, you receive this memo and you are no longer the head of your commission, please forward this memo to the newly elected chairperson. Also, advise our CHA office as to the current name and address of the newly elected chairperson.

The Executive Committee of the Christian Holiness Association will be convening in Chicago the latter part of August. By that time I trust we can have the major part of our program fairly well assembled. Therefore, on or before August 15th, I would like to know two things from each commission:

1. What is the theme to be discussed by your commission in the 1990 convention?
2. Who is the speaker or speakers to be featured in your commission?

August 15th is less than three months away. Therefore if the above questions are not as yet answered, you may want to call a phone conference, get out a letter, or call a meeting rather soon to complete the above assignment. If I can be of any assistance, please let me know.

In as much as some of our commission leaders may be new, let me reiterate that the commissions will meet on Wednesday and Thursday mornings of the convention. The Wednesday presentation will be repeated in identical fashion on Thursday. The subject is not to be continued from one day to the next so the people will return a second day. They should go to another seminar.



It should be a beautiful place for our future convention.
