Dear Howard,

The primary purpose of this letter is to mention the mid-year WTS financial report that is given to the WTS Executive Committee during the CHA Convention. It is most likely that you are already aware of this, but I do not want to be delinquent if you are not. It was not mentioned in the job description, and I do not recall that I had ever told you about it. Hence this precaution. I'm enclosing the reports I've made the past four years: Nov. 1, 1988 to April 11, 1989; Nov. 1, 1987 to March 31, 1988; Nov. 1, 1986 to March 20, 1987; I thought I had a fourth but evidently not. I'm sending these three also to PATRICA WALLS. Since she has the two ledgers I'm presuming that she will be responsible to make out the report, though I do not know your plans.

Here are a few other items that I'm also enclosing:

✓(1) Your other copy of the "Report of the Nominating Committee," I overlooked it and did not enclose it in my last letter.

✓(2) A copy of a letter written by Dr. R. Larry Shelton to Dr. John Oswalt, then President of Asbury College, acknowledging the latter's invitation to WTS to hold its 1989 Annual Conference at Asbury College. Please file this in the notebook for WTS Annual Conference Minutes, etc. It is important that this bit of evidence be recorded with the WTS records.

✓(3) The 3-page report of Shirley Hoffmann regarding WTS Office Expenses for August, September, and October 1989 -- and a page report of secretarial work that had been done by Jane Jarrett for WTS (hired by Shirley Hoffmann). We paid Shirley H. at the rate of \$9.99 per hour for overtime. My Christian business friends tell me that we do not talk about "overtime" until a 40 hour work week has been done. You may want to check on this, i.e. what constitutes "over-time" work.

A couple of agenda items (if you think it well, Howard): (1) the price per page of advertising in the WTS Journal. It has been \$50 per page for some time. Personally I think it should be more now. (2) Should the large double numbers of the Journal be sold for \$5.00 each when single copies are sold, which is the same price for other issues (single copies) -- or should it be more?

I saw Bishop Ole Borgen at the SPO today and learned that he has not yet received the extra Journal copies he has ordered. Why don't you send to me the yellow page (as I recall) on which he listed the copies he wants and I'll take care of it. I think it was with the papers for application of WTS membership.
