To All Members & Friends of the WTS:

My annual letter notifying all members and those with Standing Orders for the Journal of the WTS, that Dues for the new calendar year are now payable comes with a prayer that each of you will have the most meaningful and fruitful year of your life thus far.

Note the underlined categories of interest and concern:

1. Members/Standing Orders: If you are located where you can receive mail at a Seminary, University, College, Bible School or other educational institution, please send with your dues your Box No. or other Mailing address on campus. We can still mail the Journal, even to individuals, at Library Rate of 19¢ rather than 59¢ at 4th Class Book Rate, if the name of the School is included on the mailing label, thus saving us 40¢ for each Journal thus mailed.
2. Full Members: Please be on the watch for persons whom you may recommend for membership in the WTS. Only Full Members may recommend. An application is in the back of each Journal.
3. Student Members: When you are no longer a student, please notify the Secretary and take advantage of either Associate or Full Membership. See Vol. 15, No. 1, p. 103.
4. Honorary Members: Upon retirement any member who has been active for 3 or more years may notify the Secretary in writing and become a paid up member for life. See Vol. 15, No. 1, p. 103.
5. Journal Costs: The only change made at the annual meeting in November was to increase the single number rate from \$2.50 to \$3.00. This includes Standing Orders so that now it will be \$6.00 per year rather than \$5.00.
6. All Members: I implore, beseech, earnestly request that ALL CHANGES OF ADDRESS BE SENT TO ME PROMPTLY. We annually lose from 25 to 50 members by failure at this point. We added 188 new members last year - 1980 - which brings our total to 1,503 members and 252 Standing Orders. LET'S ADD MANY MORE AND SUBTRACT NONE IN 1981.
