

## STANDING RULES

### I. Pertaining To Membership

A. All new membership applications received at or following the annual meetings and subsequently approved by the Membership Committee prior to the publication of the new volume of the Journal shall receive the current issue of the Journal as well as the new volume.

B. Upon approval by the Membership Committee all new members shall be notified in writing of their acceptance by the Secretary, together with a letter of welcome and the current issue of the Journal.

C. Members who are deceased in any given fiscal year shall be included in the Secretary's annual report.

D. An honor roll of deceased charter members, active at the time of their death, shall be printed in the Journal each year with the date of their death.

### II. Relating To Officers And Committees

A. The expenses of the Officers and Committee Members shall be paid for everything relating to the Wesleyan Theological Society, except for the Annual Meeting expense of travel and entertainment, provided a written, itemized report is presented to the Treasurer.

B. The dates of the expiration of Committee Members' term of office on the various Standing Committees shall be carried in the Journal along with the Committee listings.

### III. Relating To Procedures

A. The advertizing rate in the Journal shall be reviewed periodically by the Executive Committee. It is currently \$50.00 per page or \$30.00 per half page.

B. Invitations to host an annual meeting of the Society shall be considered by the Executive Committee only if submitted in writing by the chief administrator of an institution or facility.

STAMPING RULES

I. Pertaining to Membership

II. Relating to Officers and Committees

A. The expenses of the Officers and Committees shall be paid for everything relating to the Western Theological Society except for the Annual Meeting expenses of travel and entertainment, provided a written itemized report is presented to the Treasurer.

B. The rates of the execution of Committee Members' work of office in the various Executive Committees shall be carried in the Journal along with the Committee Minutes.

III. Relating to Procedures

A. The advertising rate in the Journal shall be reviewed periodically by the Executive Committee. This is currently \$20.00 per page or \$10.00 per half page.

B. Invitations to host an annual meeting of the Society shall be considered by the Executive Committee only if invited in writing by the chief administrator of an institution or facility.
