The Auditing Committee composed of L. E. Graham, D. S. Mims, and J. F. Cousins has made an audit of the books of the Church Treasurer for the year ending October 31, 1948. We have done all of the work that we deemed necessary to satisfy ourselves that the Church Treasurer's books and the members accounts which were maintained by the Church Secretary were being kept in an acceptable manner.

The accompanying statement of Receipts and Disbursements (Exhibit A), in our opinion, properly reflects the financial activity of the funds handled by the Church Treassurer for the period under review. The bank reconciliation is shown as Exhibit B.

The following securities which are in the custody of Mr. C. J. Jones were examined:

- 1. U. S. Government Bonds, series G. issued November 1945 with a face value of \$2,000. This item is earried on the books as a Parsonage Building Fund.
- 2. Security Building & Loan certificate dated December 17. 1947 with a face value of \$1,100.00. This was purchased with money received from the balance of the Erwin Mills stock. The dividends are to be added to the Poor Fund.
- 3. Three series F government bonds each with a face value of \$25.00. One dated July 1944 was given by Mr. & Mrs. J. P. Breedlove. Another bearing the same date was given by Mr. & Mrs. G. P. Whitley Jr. The third, dated December 1944, was given by W. C. Whitley, Jr. who was killed in action about that time. The proceeds from all three was to go toward the cost of air conditioning the church.

The following building and losn certificates all made out in the name of the "Duke Memorial Church Trustees") which are in the custody of Judge Spears were examined.

With all respect for the able job being done by the two people now occupying these positions, it is recommended that these positions be bonded in an amount to be determined by the Finance Committee.
