

February 7, 1961

The Official Board of Duke Memorial Church held its regular meeting on Tuesday, February 7, at 7:45 p.m., in the Church Parlor. In the absence of the chairman and vice-chairman, Judge Spears presided.

Following prayer by the Pastor, the minutes of the previous meeting were read and approved.

Brief reports were made for the Commissions on Missions and Education. Mrs. Borland, on Missions, called attention to the need for trained workers at home and abroad; and Mrs. Dozier, on Education, gave highlights of the January meeting, including the fact that their budget was being set up and an evaluation of the church school program was being made.

Mr. Jones' financial report for seven months ending January 31 showed receipts as \$46,754.29 and disbursements as \$46,479.48. A copy of this report is attached.

Since Scout Week was being observed at the time of the Board meeting, Mr. Allen gave a review of scouting at Duke Memorial Church. This activity, he said, is governed by a Council on Scouting, which is composed of representatives of the three active groups -- cubs, troop and explorers -- and meets monthly. The duties of the Council include the planning of the yearly program, the selecting of the leaders for the units, and the assisting of the leaders in general. Mr. Allen paid special tribute to Professor R. N. Wilson, who started this work at Duke Memorial and remained active in its program until his death. The Board had a moment of silent prayer in Professor Wilson's memory.

Mr. Bradshaw had three items for special consideration: (1) reiteration of the need for workers in the mission fields; (2) the Durham District Lay Rally on Monday evening, February 13, which is open to both men and women; and (3) the Church program during the weeks prior to and during Easter. In connection with the last, Mr. Bradshaw asked the Board for thoughts and prayers on their own spiritual growth and that of the Pastor in order that he might be led rightly.

In behalf of the Survey Committee of which he is chairman, Judge Spears reported that it is at work and expects to have an early report so that plans for a new educational building may go forward. He stated that the finance committee, at its last meeting, voted to endorse this project, which he feels is important to the Church and the Church membership.

The meeting was dismissed with prayer by Mr. Whitford.
