4. Basis of membership

Membership and services are available to all residents of the Edgemont Community (an area in East Durham bounded by Ramseur Avenue and the Norfolk and Western Railway, Seaboard Street, Liberty Street and Alston Avenue and a four block area south of Alston Avenue). The Edgemont Community is a bi-racial (60% black and 40% white) low income community with a population of 5,000. Membership for school age children and teenagers is available by completing a membership card and paying a membership fee of 25¢ yearly. In other incidences, membership is based solely on participation, existing need or interest and referral of an Edgemont Community Center's program and/or services. person to the Edgemont Community

5. Purpose and objectives of the proposed project The Edgemont Community Center is a multi-purpose center that seeks to enable individuals, families, and groups in the Edgemont Community toward the development of their own unique abilities and strengths. The Edgemont Community Center sees itself as a decentralized, community project that exists in the midst of the low income community it works to serve and respond to. The Center strives to be flexible and responsive to the changing needs through sensitively assessing the priorities as felt by the Edgemont people. There is an attempt to work with the people where they are and to shape programs and services around priorities as seen by the people. A secondary purpose is to provide appropriate opportunities for volunteers to work and learn in this low income setting. The Center perceives its role as crossroads for the Edgemont and Durham Community interaction with individual churches having participated over the years.

The Edgemont Community Center has served persons in the Edgemont Community since 1942. The project has evolved and sought, progressively to serve in a more professional manner. A "Long Range Planning Proposal," representing the efforts and thinking of the Edgemont Community Center staff, board and community members, has been developed stating the ministerial means needed to run present program and stating what projected programs or services are needed according to priority. There are basic premises on which these Center programs or proposed projects

are based:

- The use of programs as tools for individual, family or 1. community development.
- The principle of community development and maximum 2. Edgemont Community involvement in program development.
- 3. Emphasis on involvement of the total family, thereby maximising the impact of planned, co-ordinated, sensitive intervention in the multi-problem family.
- Emphasis on the educational, physical, social, cultural 4. and intellectual development of the individual at this own pace.

Building renovation - \$18,000 total. The present building is 23 years old. During that time no basic renovation has occurred and only irregular maintenance. The building is 1,200 square feet. With 650 persons serviced by the Center and the facility being used sixteen hours daily, building deterioration is rapid. Heating and plumbing are substandard and could not service any expanded area. There are rotting door and window frames, worn floor tiles, as well as a critical need for repainting and landscaping. Equipment - \$7,000 total. There is the need for replacement of furnishings (chairs, tables, cabinets) that are sturdy, multi-purpose, less cumbersome and more generally adaptable. Such equipment is a necessity, whether activities remain confined to the present facility or expand to an adjacent facility.

- b. Improved recreation facilities, \$25,500 total. The Edgemont Community Center is presently the only recreational facility available to the 5,000 persons in the Edgemont area. Further, recreation is used as a tool in working with disadvantaged youth. Priorities in the improved recreation program include: additional recreation equipment (\$2,500); requisition of additional adjacent land immediately west of the Center (\$13,000); addition of a shelter over the existing basketball court (\$7,000) with an attached recreation storage area (this structure could include partitioning to allow for simultaneous activities such as basketball, shuffleboard, ping pong, etc.); the grading and landscaping of present property (\$3,000).
