The Administrative Board of Duke Memorial United Methodist Church held a Special meeting on Tuesday, February 9, 1971 at 7:45 p. m. in the Bradshaw Room. Mr. Marshall Spears, Jr., chairman, presided. There were 59 members present.

Rev. W. B. Petteway gave the devotion on Love using Dr. Moffet's translation of the 13th Chapter of I Corinthians.

The minutes of the January meeting were approved as submitted.

Mrs. Walter Seeley, president of W.S.C.S., reported that the proceeds from the Fall Festival was being divided between Home Missions and Foreign Missions in the amount of \$1100.00 each. \$950.00 of the latter will help support Rev. and Mrs. John W. Garrison, missionaries in Brazil, and \$150.00 to help with a water system in Rhodesia.

Mr. Robert Lyon, chairman of the Building Committee, stated "A recent review of the Sanctuary Renovation and New Organ Installation Program by the Building Committee with the Contractor (Mr. Jesse Cole) and the Architect (Mr. George Pyne) has resulted in the development of the following agreed schedule that is hereby submitted to the Official Board for approval." The work will start the week of April 12 (after Easter); August 15 - September 15, installation of carpet and pews; August 15 - September 15 begin installing Organ. Mr. E. W. Coffin moved that the schedule be accepted as presented by Mr. Lyon. Mr. Norwood Thomas, Jr. seconded the motion. The vote was carried in the affirmative.

Mr. Horace Mansfield, chairman of the Interim Committee on Use of Fellowship Hall for Worship Services, reported as follows:

Mrs. Alan Whanger, chairman on Commission on Missions expressed her desire for Duke Memorial to give full support for a missionary as soon as possible. At present the church does not pay anything toward one.

Mrs. Seeley asked that the facilities of the Educational Building be provided for approximately 30 children ages 3 - 7 in June and July for recreational and educational program staffed by personnel from the Y. W. C. A.; the W.S.C.S. to defray any church expenses such as janitorial services, etc. This request was granted.

Gen. Holsinger reported that he was getting information together as chairman of Personnel Committee.
