INFORMATION AND IGNORANCE!

At one time in our history, the business side of the Methodist Church was pretty much a closed affair. This was true from the "closed cabinet" of the bishop by which no one knew a firm word of appointments until the closing hour of the annual session of the Conference to the local church where a like curtain seemed to be designed as a test of faith of the member-ship. Few people seriously suspected skull-duggery; there were very few who did not now and then wish to know how decisions really were made.

The pendulum has made its swing and I, for one, rejoice in it. Even some of the meetings of the Council of Bishops are open to observers. I don't intend to go; it is nice to know that if one wishes, one can! All across the Church as in the political spectrum, the "right to know" syndrome makes itself felt. We are now placing a premium and a great effort that all in our connection may be well informed as to the decisions made, how they are made, and what they mean to us. Ignorance is being banished by information - yet, there is a possible break in the chain of the "right to know".

The old adage, "You can lead a horse to water but you can't make him drink; you can send a child to school but you can't make him think" applies in church life. Great effort and considerable expense go into an effort to inform the people. Our own failures in perusal of what comes to us, of ignoring the publications of the church, of non-attendance at meetings of great importance, can frustrate efforts to banish ignorance with information. Directly to the point is our Pensions Crusade which now is being organized and near to its intensive phase. Honest and therefore accurate statements of what is being done and undertaken will be placed by mail service in each local home in our congregation. The worship services and the whole range of meetings during the next three months will be a forum for this activity. Those who will read and/or hear will know. I have a deep conviction that in this Pension Crusade information will lead to joyful participation and with that conviction, the concern that many of us will fail to know simply because we don't put our minds to what is before our eyes and at the portal of our ears.

Can it be that many of us will prefer ignorance to information? I pray not. I will do in this connection, as every other, all that is in my power that ignorance be overcome. Join with your committee, church staff and fellow members that we may first of all, know, and that knowing, we shall then know how God will have us respond!
