Edith Toms reported that Ran Few and Oliver Upchurch had been appointed to update Church roll and progress was being made. Plans for a Revival in November are in the making.



Edith Toms reported that Ran Few and Oliver Upchurch had been appointed to update Church roll and progress was being made. Plans for a Revival in November are in the making.



Motion I

I move that a committee be named to compile a list of persons whose membership at Duke Memorial is in question according to 1 of 3 categories:

- 1. A member residing in the community, who is negligent of church vows and attendance
- 2. A member whose address is outside the local community and not participating in Duke Memorial
- A member whose address is no longer known to the pastor, membership secretary, and evangelism work area

that the persons listed will have their name read before the congregation, printed in the church newsletter, and letters will be sent where possible requesting activation of membership, transfer to another UMC, or transfer to a non-UMC.

that after three years with this review repeated each year, persons whose names remain on this list be removed by order of the Charge Conference.

Motion II

I move that all persons whose names now exist on the roll of DMUMC where there is a reasonable belief that these persons are deceased, that

- 1. The names be read before the congregation
- 2. The names be published in the church news letter
- 3. If there is no positive response that they be listed as removed by death immediately and removed from the church rolls.
