Minutes: The minutes of the December 6, 1988, meeting were approved as mailed.

Mrs. Toms welcomed the new members to the Board and asked each to stand to be recognized.

Finance Reports

Ed Hammond, Chairman of the Finance Committee:

- Congratulated Bill Martin for raising 96.63% of the 1989 budget
- Reported that the Finance Committee is not concerned about the missing 3.27% feeling very confident that new pledges will cover this deficit
- Todate \$293,247.00 has been pledged Past year and new pledges - \$11,200.00 Total projected budget - \$463,447.00

Dr. Hammond, on behalf of the Finance Committee, MOVED THAT WE ACCEPT THE BUDGET AS PRESENTED (see attached). The motion PASSED.

Dr. Hobbs MOVED THAT WE ADOPT A RESOLUTION (see attached) AUTHORIZING JAMES A. LONG, CHURCH TREASURER OR WILLIAM E. SELF, TRUSTEE TREASURER, TO SELL, ASSIGN AND ENDORSE OR TRANSFER CERTIFICATES REPRESENTING STOCKS, BONDS OR OTHER SECURITIES REGISTERED IN THE NAME OR FOR THE ACCOUNT OF DUKE MEMORIAL UNITED METHODIST CHURCH AND HELD BY WHEAT FIRST SECURITIES. The motion was seconded and PASSED.


Bill Self announced that we had received \$1,066 from the William Cleeves Estate and \$2,500 from the Lucille Parker Estate. He reminded the Board that 20% of these amounts can be spent immediately and 80% must go into the endowment. Subsequently, in the future, 80% of the income derived from these investments can be spent each year with the remaining 20% being reinvested in the endowment. Based on this formula, \$713.20 can be spent immediately.

Mrs. Toms announced that Shirley Few has agreed to chair the Capital Campaign. The intensive phase of the \$1.3M campaign will be held April 27th-May 10th. Philip and Bonnie Gardner, the professional fund raisers assigned to us, will be in residence for three weeks beginning around April 20th. They will also be here January 17th & 18th to interview members of the church and to lay the groundwork for the campaign.

Nominating Committee - the new members of the Nominating Commitee, Class of 1991, who were elected at the 1988 Charge Conference are Ann Marie Langford, Meta Metcalf and Louis Sasser, Jr.

Membership Roll Update - Oliver Upchurch reported:

- 265 names have been read three times and removed
- 72 names have been read two times and can be removed at Charge Conference 1989
- 10 names have been read once and can be removed at Charge Conference 1990
- As of December 31, 1988, our membership is 1250 (see full report attached)

The motion was seconded and PASSED.

Laney Funderburk moved THAT THE PROCESS OF MARKETING THESE BOOKS TO THE CONGREGATION BE TURNED OVER TO THE DISCRETION OF THE MUSIC COMMITTEE. The motion was seconded and PASSED.

There being no further business, the meeting was adjourned.
