Report to the 1981 Charge Conference:

CHURCH PLANT: The facilities of Duke Memorial are more than adequate for any program undertaking. They are well maintained through the efforts of the Trustees and the Committee on Properties, of which W. K. Howard is chairman. The insurance coverage is adequate and is periodically re-evaluated.

PROGRAM: The Council on Ministries and the church staff work together with suggestions from many persons as well as plans of their own devising. The intention is that there will be a well-rounded, diversified program activity throughout the year. Not always is the response to such endeavors what one would desire. In response to a questionnaire distributed to the congregation, one member wrote, "Duke Memorial's program offerings are simply excellent and if we don't always take advantage of it, it is our own fault." One might add, "and loss also."


FINANCIAL TASK: It is remarkable that without significant growth in numbers of members, we have moved our level of pledges from \$172,347 of a 1975 budget of \$183,997 to \$224,000 in pledges for a budget of \$249,000 for 1982. A few of us are tithers, far too few. Many give in a planned proportionate way. For many, the last consideration in the family budget is giving to God's work through this church. The giving potential of our membership is not yet being even approached, much less fulfilled.

LEADERSHIP: I am deeply grateful for all who have accepted places of leadership and who have faithfully and consistently done their best in these roles. The many organizations within the Church work well, consistently, and fruitfully in their areas of responsibility. The work of the Church staff continues to be a harmonious relationship and usually produces good results. With deep regret we record the resignation of Margaret Anne Biddle after six extraordinarily fine years at Duke Memorial. The Church hostess, Mrs. Shirley Bowman, who succeeds Eva Martin and Beth Neece, is doing her job in a splendid way.

MEMBERSHIP UPDATE: A supplementary report presented to this Charge Conference gives a listing of persons about whom we need information as to their membership/nonmembership in Duke Memorial. We are in the process of contacting persons on another list to determine their current status. This work of this Committee to update the Church roll will require three years in terms of the Discipline, at which time we will have a very clear and current membership roll.

SPIRITUAL LIFE: During the six and a half years we have been at Duke Memorial, I believe there are some evidences of spiritual growth and development. Even so, I must record the fact that we continue at a lamentably low percentage of membership present in the Sunday School and at the principal services of worship each week. Soul searching and much prayerful inquiry for all of us are needed if we are to turn the corner on these statistical measurements of our spiritual life. There is a mute but powerful testimony given to newcomers by the plethora of unfilled seats--and it is not a helpful testimony! Somewhere we have lost something of our resolution to support the Methodist Church by "our presence." Two prayer and sharing groups are meeting the needs of a few of our family; many seem to feel no need or concern for these areas of life. In this time of great Methodist emphasis on evangelism, Duke Memorial is a prime target for growth and strengthening.
