I am working with a long-term continuing support group system for survivors of incest and childhood sexual abuse. We are in the process of forming as a non-profit organization, and will offer support to both male and female survivors and "pro-survivors" (family members, spouses, and partners of trauma survivors). There is some short-term crisis help available (10-12 weeks) but the effects of this type of trauma cannot be dealt with in such a short time period. Long-term support is necessary and providing a safe place in which to do this healing work is a ministry that not only helps me in my own journey, but re-connects some survivors who have turned away from the organized church because of its seeming lack of assistance to the survivor, or because of situations involving clergy-abuse.

In beginning to tell my story (and no longer hide my history under a cloak of misguided shame) I am opening up doorways for regular people to reach out and effectively minister to survivors, for people to take a look at how we can do MORE to make the church a safe place for all people, and to let other survivors (who may not have made the decision to become public with their history) know there are people who understand and will stand by them through this long and difficult journey.
