Laney Funderburk, Chairman of the Steering Committee for the Campaign for Renewal presented the following items relating to church property. The area in which the Trustee Group has oversight. The proposals were accepted by the Board without dissent.

- Install an elevator in the location shown on the architect's drawings that have been and remain on display at the church for a number of months. Traverse will be from ground level to second floor and mechanism will be of hydraulic type A. Fairly firm estimate is \$103,000, a figure that has been in the Capital Fund budget for many months.
- 2. Modification and renovations of office library area in middle of building at an estimated cost of \$140,000. again a figure that has been in the Capital Fund budget for many months. This figure is not as firm as the elevator cost figure.
- 3. When final and last bids are in-hand these items will be again presented to the Board for final acceptance. I tried to contact each of you to inform you of the above proposals and was successful except for Ran Few and Elizabeth Bookhout. In my comments to the Board, I mentioned some of the concerns expressed by individual Trustees but did indicate that the consensus was to move ahead subject to availability of funds.

When final bids are in-hand and I am informed, I shall again inform you of the status of the matter, and receive any further comments you may care to make. We can have a meeting if that is requested.
