# MINUTES.

A

# WEDNESDAY MORNING, MAY 6TH.

The General Executive Committee of the Woman's Foreign Missionary Society of the Methodist Episcopal Church opened its fifth annual session at 1018 Arch street, Philadelphia, on Wednesday, May 6th, 1874, at 9.30 A. M.

Devotional exercises were conducted by Mrs. Keen, Corresponding Secretary of the Central Branch. Scripture was read, a hymn was sung, and prayer was offered by Mrs. Willing.

Mrs. Rev. Dr. Hibbard, of the New York Branch, was elected President of the Committee.

A motion was made and carried that the delegates of the Central Branch should nominate a Secretary and Assistant Secretary. In accordance with their nomination, Mrs. J. H. Knowles, of Newark, N. J., was chosen Secretary, with Mrs. Stevens, of Wilmington, Del., assistant.

The roll being called, the following representatives of the several branches responded:—

The seats of the delegations having been arranged, the regular order of business was taken up. First, reading reports of Corresponding Secretaries,—that of New England by Mrs. Latimer, New York by Mrs. Skidmore, St. Louis by Mrs. Prescott, Northwestern by Mrs. Willing, Central by Mrs. Keen, Cincinnati by Mrs. Doughty, Baltimore by Miss Hart. These reports were heard with deep interest, and after their reading the President proposed, as an expression of the sentiment of the meeting, that all present should unite in singing the first and last verses of the hymn: "All hail the power of Jesus' name."

The reports of Treasurers were then given, showing receipts as follows:—

A motion was made by Mrs. Willing that Mrs. Daggett be invited to a seat with the New England delegation. The motion was carried.

Mrs. Johnson, recently returned missionary from India, was introduced, and made a few remarks. Rev. Mr. Weatherby, of India, was also introduced, and briefly addressed the committee. The order of business was then resumed.

The following Standing Committees were appointed:—

Committee on Publication.—Mrs. Doughty, Mrs. Latimer, Mrs. Wright, Mrs. Steele, Mrs. Nind, Mrs. Johnson, Mrs. Hamilton.

COMMITTEE ON EXTENSION OF WORK.—Mrs. Skidmore, Mrs. Taplin, Mrs. Queal, Mrs. Wilson, Mrs. Rand, Mrs. Hagans, Miss Hart.

COMMITTEE ON MISSIONARY CANDIDATES.—Mrs. Keen, Mrs. Scott, Mrs. Skidmore, Mrs. Steele, Mrs. Prescott, Mrs. Ingham, Mrs. Cowen.

COMMITTEE ON MEMORIALS —Miss Hart, Mrs. Taplin, Mrs. Hibbard, Mrs. Queal, Mrs. Nind, Mrs. Keen, Mrs. Hagans.

COMMITTEE ON REVISION OF CONSTITUTION.—Mrs. Latimer, Mrs. Wright, Mrs. Willing, Mrs. Wilson, Mrs. Johnson, Mrs. Ingham, Mrs. Cowen.

FINANCE COMMITTEE.—Mrs. Willing, Mrs. Skidmore, Mrs. Latimer, Mrs. Prescott, Mrs. Doughty, Miss Hart, Mrs. Keen.

Mrs. Daggett presented the report of the Heathen Woman's Friend, which was accepted, and referred to the Committee on Publication.

Item 8 in order of business was then taken up, viz.: Reception of Memorials and Petitions. Communications from Mrs. Parker, of India were read, and referred to the Committee on Finance, they having power to refer as much as properly belonged to the Committee on Memorials to that Committee.

The order of business was suspended to give place to a few remarks from Mr. Weatherby upon Mrs. Parker's communications. On motion Mrs. Johnson was invited to be present with the Committee to which the above communications were referred.

The order of business was resumed.

A letter from Mrs. Dr. Butler was read and referred to the Committee on Memorials.

Dr. Butler's estimates were referred to the Committee on Finance. A paper from Dr. Eddy, and the estimates from Kiu Kiang, were referred to the same Committee.

A communication from Mrs. Ing of China, and one from Liberia, were referred to the Committee on Extension of Work.

The order of business was then suspended to give time before the close of the session for miscellaneous business.

Mrs. Willing presented a communication in reference to work in New Mexico, which was ruled out, as not within the province of the Woman's Foreign Missionary Society.

The place and time of meeting for the Standing Committees was announced.

Miss Hart offered the following resolution:-

Resolved, That the first half hour of each session be spent in devotional exercises, at which all delegates and returned missionaries are especially urged to be present.

The resolution was adopted, and Mrs. Steele was appointed to lead the devotions the following morning.

The Committee adjourned.

# THURSDAY MORNING, MAY 7TH.

After a half hour spent in devotional exercises the Committee was called to order by the President at 9.30 A. M.

The unfinished business of the previous day was resumed, viz.: Reception of Memorials and Petitions.

A communication from Dr. Maclay, Superintendent of Missions in Japan, was read, and referred to the Committee on Extension of Work.

A communication of Rev. S. L. Baldwin, with estimates for work in China, was referred to the Committee on Finance. An extract of a letter from M. H. Wood, relative to work in South America, was read and referred to the Committee on Finance.

Mrs. Sites, returned missionary from China, was introduced, also Mrs. Thomas, returned missionary from India.

Mrs. Skidmore moved that the Standing Committee have permission to invite the missionaries present to attend their sessions. The motion was carried.

The following resolution, offered by Mrs. Hagans, was adopted:-

Resolved, That the Corresponding Secretaries of the several branches be a committee to nominate the Standing Committees for the General Executive Committee meetings, and to plan work for its sessions and report the same at the opening of said committee.

A motion was made and carried, that the reports from Standing Committees be presented immediately after unfinished business at the commencement of the morning sessions.

An interesting letter was read from a converted Chinese woman, Wong Tingai, of Hung Moi, China, translated by Mrs. Baldwin. At the suggestion of the President amid deep feeling the following verses were sung:

He breaks the power of cancelled sin, He sets the prisoner free, His blood can make the foulest clean, His blood avails for me.

O! that the world might taste and see
The riches of his grace,
The arms of love that compass me
Would all mankind embrace.

Reports of Standing Committees were called for. A partial report of the Committee on Finance was presented by Mrs. Latimer, Secretary of Committee. (For report in full, see Appendix No. 5.)

On motion, the report was considered item by item. The first item, after a general discussion, was adopted. The second item was re-committed, the third adopted, the fourth returned to the committee for revision.

A motion was made and carried that Mrs. Bishop Simpson be requested to address the ladies upon the subject of her visit to Mexico.

Announcements of meetings of Committees were given. Also, a notice of the Anniversary to be held in the evening in Arch Street M. E. Church, the addresses to be made by Mrs. Steele of Wisconsin, Mrs. Hibbard of Clifton Springs, New York, Mrs. Johnson of India, and Mrs. Skidmore of New York.

On motion the Committee adjourned at 12.30.

## FRIDAY MORNING, MAY STH.

Devotional services were conducted by Mrs. Wright.

At 9.30 A. M. the regular order of business was commenced.

Reports of Standing Committees were called for and the Committee on Finance presented the items of their report, which had been re-committed the previous day.

The second item was adopted by a rising vote. The fourth item was adopted. (See Report in full in Appendix No. 5.)

The Committee on Extension of Work presented a partial report, the third item of which was adopted. (See Appendix No. 2.)

The following resolution was offered by Mrs. Willing, and adopted.

Resolved, That the Committee on Extension of Work be requested to consider the feasibility of further correspondence with the Superintendent of the Bulgarian Mission, with a view to sending thither two missionary teachers during the year, by the action of the Committee of Reference, if the condition of our finances will warrant a provisional appropriation for that purpose.

Item 2 of the Report on Extension of Work was recommitted with the same instructions as are contained in the foregoing resolution in reference to Bulgaria.

No other Committees being ready to report, miscellaneous business was called for.

A paper was presented from the St. Louis Branch petitioning for change of headquarters of that Branch.

On motion the petition was granted, and permission was given to the Branch officers to select a name for the Branch.

Mrs. Johnson offered the following resolution:-

Resolved, That the name of the Central Branch be changed to Philadelphia Branch.

Carried.

Mrs. Latimer offered the following resolution:-

Resolved, That the petition for a sanitarium in Foochow to be built in connection with the Parent Board, be referred to the Committee on Memorials.

Carried.

The time and place of meeting of Standing Committees was announced. The 628th hymn was sung, and the Committee adjourned at 11,30 A. M.

# SATURDAY MORNING, MAY 9TH.

Devotional services were conducted by Mrs. Nind. At the appointed hour the regular business of the Committee was commenced.

A letter from Mrs. Dr. Butler to Mrs. Bishop Simpson, respecting work in Mexico, was read; also a note from Mrs. Simpson's namesake in the Mexican Orphanage.

Reports of Standing Committees being called for, Mrs. Ingham, Secretary of Committee on Missionary Candidates gave a partial report which was adopted item by item.

A partial report of the Committee on Memorials and Petitions was presented by Mrs. Nind, and adopted.

A motion was made and carried, that item 11 in the published order of business be considered.

Miss Hart gave a cordial invitation to the Executive Committee to hold their next session in Baltimore.

The following resolution, offered by Mrs. Willing, was adopted:-

Resolved, That we accept the invitation of the Baltimore Branch to hold the next session of the General Executive Committee in that city; this decision, however, to be subject to the judgment of the Committee of Reference, said Committee being requested to report as early as possible.

The following motion was offered by Mrs. Queal:-

That we instruct the Committee of Reference on condition the General Executive Committee does not meet in Baltimore next year, that it shall meet in Evanston.

Pending the discussion of this motion the following substitute was offered by Mrs. Doughty, and accepted:—

Resolved, That if the Committee of Reference find it inexpedient to go to Baltimore, they shall appoint the next session of the General Executive Committee within the bounds of the Western Branch, if convenient for that Branch, or if not, at Evansion.

Adopted.

The following resolution was passed:-

Resolved, That the St. Louis Branch shall hereafter be known as the Western Branch.

On motion, the Committee adjourned at 11.30 A. M.

### MONDAY MORNING, MAY 11TH.

The Committee met at the residence of Mrs. Keen, 1209 Arch Street.

Devotional services were conducted by Mrs. Willing, from 9 to 9.30 A. M.

The regular business session commenced at the appointed time.

The Committee on Publication presented their report, which was adopted item by item. (See Appendix No. 1.)

A motion was made and carried that 500 copies of the Minutes be published.

The Committee on Finance made a partial report, which was adopted item by item.

A motion was made by Mrs. Skidmore that the part of Mrs. Parker's letter relating to Mrs. Buck be referred to the Committee on Memorials; also, that part relating to the Letter of Instructions. The motion prevailed.

The Committee on Extension of Work presented their report, which was adopted. (See Appendix No. 2.)

Announcements were made for evening services, and for Standing Committee meetings. The doxology was sung, and Committee adjourned.

# Tuesday Morning, May 12th.

Devotional services were conducted by Mrs. Hagans. The order of business was entered upon at the appointed time.

The Committee on Missionary Candidates presented their report, which was adopted. (See Appendix No. 3.)

Item 3 of this report occasioned discussion, the question arising whether the homeopathic school is excluded in the practice of the lady physicians of the W. F. M. S. It was decided that while a diploma from an allopathic college is required, the practice is left to the necessities arising in each case.

A motion was made by Mrs. Keen and carried, that the Corresponding Secretaries presenting the papers of these Missionary Candidates should give a short verbal sketch of those just accepted by this Board. In accordance with this motion a short account of each one was given, and letters from some of the young ladies were read. Upon motion, two minutes were spent in silent prayer for these young ladies, accompanied with thanksgiving to God for His gracious gifts to them and to this Society, followed by a short prayer led by Mrs. Skidmore.

Before entering upon this season of prayer, the following resolution was offered by Mrs. Willing:—

Resolved, That the Secretary is hereby instructed to write a letter of sympathy to the parents of Miss Josephine Copp, who, under appointment for India, has been transferred to the home above.

The resolution was carried.

After prayer these words were sung :-

His only righteousness I show,
His saving truth proclaim,
'Tis all my business here below,
To cry, Behold the Lamb!

Happy if with my latest breath
I may but gasp his name.
Preach him to all and cry in death,
Behold, behold the Lamb!

The following offered by Mrs. Willing was carried:—

Resolved. That we give place in our published minutes to a statement of of the birth-place, place of education, date of sailing, and present appointment of all missionaries in the employ of our Society, and also those accepted by the General Executive Committee for future work.

The Committee on Revision of Constitution made their report, which was not adopted.

The following resolution presented by Mrs. Taplin was adopted:-

Resolved, That the proposed amendment of article 5, section 2, paragraph 3, of the Constitution be plainly stated, and action upon it be referred to the next General Executive Committee Meeting of the Woman's Foreign Missionary Society.

The following notice of the proposed change was then given by Mrs. Ingham, Secretary of Committee on Revision:—

That article 5, section 2, paragraph 3, be so amended as to read, "To publish the missionary paper of the Society, appointing therefor the agent, the editor, and the editorial contributors; the publication of an annual report being left to a Special Committee."

Miscellaneous business being in order, Mrs. Bishop Simpson gave some interesting statements in relation to Mexico.

Mrs. Latimer moved that a vote of thanks be extended to Mrs. Simpson for the very interesting and instructive remarks relating to our mission in Mexico. Carried by a rising vote.

Miss Hart moved that the Committee now adjourn for Standing Committee sessions, to meet again in open session to-morrow morning at 9 o'clock. Motion prevailed. Adjourned.

### WEDNESDAY MORNING, MAY 13TH.

The regular business session was postponed in order to give time to complete the Report of the Finance Committee.

The morning was spent in prayer, followed by a Love Feast. The meeting was opened by Mrs. Hibbard by reading the 3d Chapter of Ephesians. The hymn, "Love divine, all love excelling," was sung, and after the opening prayer the time was fully occupied in voluntary prayers and testimonies. A full record of this meeting cannot be given, for it is beyond the power of pen to describe the heavenly influence which filled the place.

The secret springs of the power of the Woman's Foreign Missionary Society were revealed, and with the Psalmist every heart adoringly exclaimed, "All my springs are in Thee!"

Meeting adjourned at  $11\frac{1}{2}$  A. M.

### WEDNESDAY AFTERNOON.

Committee met at 2 P. M. in the Bishop's Room, at 1018 Arch Street. The session was opened with prayer by Mrs. Willing.

The Committee on Memorials and Petitions presented items 3, 4, 5 of their report, which were adopted. (See Appendix No. 4.)

Bishop Simpson entered the room, and spoke a few encouraging words, endorsing heartily the work of the Woman's Foreign Missionary Society.

The Committee on Finance presented their report, which was considered item by item, and adopted.

The estimates from foreign missions were considered, and the appropriations for the ensuing year were made as follows:—

Whereas, this Society has received from its Missionaries no intimation that a Sanitarium is a necessity, or desideratum, and whereas this Committee is not convinced that said Sanitarium is a necessity or desideratum for the Missionaries of the W. F. M. S., therefore,

Resolved, That this Committee deem it inexpedient to assume any part of the expense of a Sanitarium in Foochow.

- 3. Resolved, That the 3rd article in "Letter of Instructions" be amended so as to read "Every Missionary employed by this Society is required to give at least five years of continuous service as a single woman to the Mission work assigned her, and should she, for any reason (sickness excepted) withdraw from the work of the Society, before the expiration of that term, she will be required to refund to the Society the amount spent upon her outfit and passage.
- 4. Resolved, That we require our Missionaries to signify their acquiescence in the "Letter of Instructions" by subscribing their names thereto.

Whereas, a comunication referring to 'the case of Mrs. Buck, and the Letter of Instructions to our Missionaries has been received by the General Executive Committee, and by them referred to the Committee on Memorials, therefore

Resolved. That we recognize that Mrs. Buck has complied with the financial requirements demanded of her, and thus made all the reparation in her power.

#### REPORT OF COMMITTEE ON FINANCE.

1. Whereas, the question of salary for Missionaries in South America having been definitely fixed, therefore

Resolved. That the salaries of all our Missionaries be uniform, \$750 per annum, being the amount.

2. Resolved, That one personal teacher be supplied for our South American Missionaries for this year.

- 3. Resolved, That we apportion the sum of \$100 for two South American Bible women, who are described as possessing unusual qualification for the work.
- 4. Resolved, That \$1000 be appropriated to cover the rental of a suitable building for orphanage and home in South America.
- 5. Resolved, That we pay the estimated amount for the home in Pachuca, provided we are assured that the property can be secured by title to the W. F. M. S.
- 6. Resolved, That we suggest correspondence between the Committee of Reference and different localities of our mission fields, as follows, in order that thorough information may be obtained with regard to all parts of our workbulgaria and Kiu Kiang, Mrs. Skidmore; Japan. Mrs. Willing; Peking and Mexico, Mrs. Keen; Onde District, Mrs. Doughty; Foochow and Africa, Miss Hart; Kumaon and part of Rohilcund District, Mrs. Prescott; South America and the rest of Rohilcund District, Mrs Latimer.
- 7. Resolved, That the funds of the W. F. M. S. be entirely under the control of the General Executive Committee, to be used only for purposes designated at Executive Meetings—balances remaining with Treasurers in foreign fields to be reported to the General Executive Committee subject to its disposal.
- 8. Resolved, That when requisitions are made upon the General Executive Committee for money for building purposes, a statement shall be made of the whole amount that will probably be required for the purpose named.
- 9. Resolved, That we regret our inability to comply with the request of the India Conference to change the time of our financial year, such compliance involving Constitutional amendment.
- 10. Resolved, That we request Mrs. Parker to continue to act as our Treasurer in India, and if she is unable to serve that the Committee of Reference be empowered to appoint one in her place.
- 11. Resolved, That the fifth article of the Rules respecting Missionaries be so amended as to read, "A Medical Missionary shall be accountable to the Branch from which she is sent, giving an itemized account of receipts and disbursements of all fees received in medical service; such money shall be used for necessary expenses in her medical work, any surplus being credited to her Branch.
- 12. Resolved, That if the North Western Branch after making its first payments shall find its finances equal to added work, it shall have liberty to send a Medical Missionary or Missionary Teacher to Paori, India.
