"Fear not, for I am with you; Be not dismayed, for I am your God. I will strengthen you; yes, I will help you, I will uphold you with My righteous hand" (Isaiah 41:10 NKJV).

The Only Source of Confidence for the New Year (I John 5:14-15)

Greetings and a blessed New Year to all the subscribers and readers of the Baptist Informer. I am so grateful to

God for the privilege of sharing a value with you that I strongly believe is extremely important to having a prosperous New Year. The value I want to share is confidence.

In my encounters with people across this land and other parts of the world, I have yet to meet an extremely successful person who was not draped with confidence. The late Dr. Samuel Dewitt Proctor in his book, *The Substance of Things Hoped For*, tells of his initial encounter with the late Rev. Dr. Martin Luther King Jr., while Dr. King was a student at Crozer Theological Seminary, that to a degree bonafides my claim. Dr. Proctor wrote of that encounter, and I quote, "It was immediately clear to me I was talking to a prodigious candidate for leadership. He looked like a major event about to happen." There is no doubt that Dr. King was a man clothed with confidence.

In addition to the fruit of the Spirit, confidence is an attribute of the people of God. From Genesis to Revelation, it is clearly shown that confidence is one of the distinguishably profound attributes of the people of God. Remember when David went to King Saul to ask Saul for permission to fight Goliath? David convinced Saul with these words, "The Lord that delivered me out of the paw of the lion, and out of the paw of the bear, he will deliver me out of the hand of this Philistine" (I Samuel 17:37). That's confidence. You recall when Shadrach, Meshach, and Abed-nego refused to bow down and worship the golden image setup by King Nebuchadnezzar, and it had been decreed that those who did not worship the golden image were to be thrown in the fiery furnace? Well, Shadrach, Meshach, and Abed-nego said to King Nebuchadnezzar, "we are not careful to answer thee in this matter. If it be so, our God whom we serve is able to deliver us from the burning fiery furnace, and he will deliver us out of thine hand, O king. But if not, be it known unto thee, O King, that we will

not serve thy gods, nor worship the golden image which thou hast set up"(Daniel 3:16-18). My friends, that is the voice of confidence.

I am quite sure that this is not a surprise, but the scripture repeatedly reiterates the confidence of the people of God. Listen to a few of them: (1) when God is for you who can be against you; (2) though a host should encamp against me my heart shall not fear; (3) the Lord is at my right hand and I shall not be moved; (4) we are more than conquerors; (5) I can do all things through Christ that strengthens me. You would have to agree with me that the author and finisher of our faith, Jesus Christ, epitomized confidence. Of himself, Jesus said, I am the light of the world, the bread of life, the living water, the resurrection, the good shepherd, the first and the last, Alpha and Omega, the beginning and the end, and I am the way, the truth and the life. Jesus was a person endorsed with confidence.

I felt the need to share with us the importance of confidence because of the many unknowns that lie ahead for us in the New Year. With so many unknowns that lie ahead of us, a successful voyage through the New Year necessitates that we be draped with confidence. The word confidence comes from the Latin word *con-fidere*, which means to have full trust. Our success in the New Year is largely determined by that to which we will give or have given our full trust, the source of our confidence.

The writer of the First Epistle of John reminds us that the source of the believer's confidence is in God. John's entire objective in the epistle I John is certainty. John wrote this epistle so that we might know. Can you imagine the confidence that you gain to reach-out, to stretch-out, to embrace the impossible, and journey into the unknown when you know? How else can you explain the determination of African-American people during the Civil Rights Movement? In spite of being only 10% of the population, brutally beaten, hosed, bitten by dogs, bombed, and gunned down, they still looked their deterrence, detractors and demons straight in their eyes and said, "I ain't going to let nobody turn me around. I am going to keep on walking, keep on marching, walking up King's Highway." Their confidence was fueled with a belief that God was on their side. People who have God as the source of their confidence never seem to be intimidated by new adventures and difficult challenges. Nevertheless, for God to become the source of our confidence, there are three

things we need to consider.

I. The Source of Our Confidence in God Is Sanction in the Will of God.

When we speak of the will of God, we are actually taking about God's desire, God's pleasure. So the question we must ponder is, "What is God's desire for my life?" I say that, ultimately, God's desire for our lives is the manifestation of his glory upon our lives, which includes good things being bestowed upon our lives. Psalm 84:11 tells us that **For the Lord is a sun and shield: the Lord will give grace and glory: no good thing will he withhold from them that walk up rightly.** Confidence needed to embrace the New Year, is a confidence whose source lies in the will of God.

II. We Have to Know God's will.

To have the confidence that what we ask of God, God will do, we must first know the will of God. Many times our prayers are not answered according to the outcome we have formulated in our minds because the content of our prayers is not shaped by the will of God. The confidence of the people of God is built by the Word of God. The air that inflates our confidence is the Word of God. Our mind is constantly being shaped by what God has said. Our hope is standing on what God has said. Our boldness is fueled by what God has said. Our thoughts for thinking what we can do is based upon what God has said. Therefore, to have the confidence that John is talking about embracing, we must know the will of God.

III. The Content of God's Will Is a Sure Thing.

Whatever we ask, if it is in accordance to God's will, it is a sure thing. It is a sure thing because it is based upon the personification of God. Jesus said in John 15:7, "if ye abide in me, and my words abide in you, ye shall ask what ye will, and it shall be done unto you." It is a sure thing because God is. I

must admit there are something things that I am not quite sure about. I am not quite sure what lies ahead in 2005. However, I am sure that God is real for I can feel God within my soul. Subsequently, that gives me the confidence to journey into the unknown, the confidence to stand alone, the confidence do in spite of what the critics say cannot be done.

In a watch night service in 1999, a testimony was shared by a young lady who was home from school for the holidays that I will never forget. She testified how her mother had made unbelievable sacrifices for her to attend school. She was getting ready to go back to school in January, but she needed \$2,000 dollars in order to return back to school. She stated that she did not know where they were going to get the money for her to return to school. But then she said something that touched me. She said, with tears falling freely from her eyes, that her mamma told her that she was going to get it. Therefore, if mamma said it, I know that she is going to do it. So I am not going to worry.

What the young lady said is a small mirror reflection of how we ought to have confidence in God. We may not know how it is going to happen. We may not know how it is going to come about. We may not know how it will be derived. But if God has said it, that should be enough to have the confidence to believe it. The scripture has declared, "if you confess with your mouth and believe in your heart thou shall be saved." Why not trust that word? The hymn writer wrote, "It is so sweet to trust in Jesus just to take him at his word. Just to rest upon his promise. Just to know thus saith the Lord. Jesus, Jesus oh how I trust him! How I've proved Him o'rer and o'rer! Jesus, Jesus precious! O grace to trust him more." ■

Conflict of Interest Policy, Board Meeting Schedule

In anticipation of our upcoming meetings that will focus on board orientation and self-assessment, it may be helpful for General Board members to reflect on the Conflict of Interest policy below. The recent actions of certain General Board members, as reported by Convention Trustees in our January 7, 2005 meeting, illustrate in dramatic fashion why every board of directors needs to adopt a Conflict of Interest policy. The purpose of such a policy is to prevent the personal interests of board members from interfering with the performance of their duties to the Convention, or resulting in personal financial, professional, and/or political gain at the expense of the Convention or its member churches.

Conflict of Interest (also Conflict) means a conflict, or the appearance of a conflict between the private interests and official responsibilities of a person in a position of trust. A Convention General Board member holds a position of trust. Real or perceived (the appearance of) conflicts must be voided, since they can cause significant damage to the Convention's reputation and well-being. Some of the clearest and most serious conflicts of interest occur

- When a board member receives an inappropriate financial gain resulting from association with the organization. This type of conflict is known as *private inurement*. Examples include a board member renting space that he or she owns to the organization at more than fair market value.
- When a board member is

involved with a competing organization, either for profit or non-profit. It is a clear breach of fiduciary responsibility for a board member to promote the competing interest of such an organization, or to intentionally or accidentally convey confidential information to such an organization. If a situation presents the possibility that this might occur, the board member should resign from the General Board.

1. I shall identify areas of potential conflict and avoid any areas of impropriety, including making full disclosure of any potential conflict of interest, and adhering to this Conflict of Interest Statement by abstaining and physically removing myself from any and all discussions where such a conflict may arise.

2. I shall understand that confidentiality with respect to all aspects of the Convention's actions, the actions of the General Board and the actions of the staff, are necessary components for efficient and productive operation of the goals and objectives of the Convention; and further, that I shall refrain from any actions which may lead to the dissemination of such internal information, including but not limited to, seeking advice from a trusted colleague, gossip and the misplacement of board material.

3. I shall not accept any employment, perform any consulting duties, or engage in any activities (whether paid or unpaid) which conflict with the business interests of the Convention.

4. I understand that in the event the Convention has incurred costs or attorney fees as a result of legal action, litigation, or appeal brought by or on my behalf due to a conflict of interest and consequent sanctions and in the event that the Convention prevails in such legal action, litigation, or appeal, the Convention shall be entitled to recover all of its costs and attorney fees from me.

5. I understand that this Conflict of Interest and Confidentiality Statement is a condition of my board position with

the Convention, and that failure to comply with the same shall be just cause for sanctions or disciplinary action by the board, including but not limited to my termination/dismissal as a board member of the Convention.

A copy of this policy shall be given to all General Board members at the time of their selection whereupon they shall sign and date the policy and also

each year thereafter. Failure to sign does not nullify the policy.

The History of Martin Luther King Day

It took 15 years to create the federal Martin Luther King, Jr. holiday.

Congressman John Conyers, Democrat from Michigan, first introduced legislation for a commemorative holiday four days after King was assassinated in 1968. After the bill became

stalled, petitions endorsing the holiday containing six million names were submitted to Congress.

Conyers and Rep. Shirley Chisholm, Democrat of New York, submitted King holiday legislation each subsequent legislative session. Public pressure for the holiday mounted during the 1982 and 1983 civil rights marches in Washington.

Congress passed the holiday legislation in 1983, which was then signed into law by President Ronald Reagan. A compromise moving the holiday from January 15, King's birthday, which was considered too close to Christmas and New Year's, to the third Monday in January helped overcome opposition to the law.

National Consensus on the Holiday

A number of states resisted celebrating the holiday. Some opponents said King did not deserve his own holiday – contending that the entire civil rights movement rather than one individual, however instrumental, should be honored. Several southern states include celebrations for various Confederate generals on that day, while Utah calls it Human Rights Day. Legislation is now pending to change the name to Martin Luther King Day. Arizona voters approved the holiday in 1992 after a threatened tourist boycott. In 1999, New Hampshire changed the name of Civil Rights Day to Martin Luther King, Jr. Day.

Timeline of Events in Martin Luther King, Jr.'s Life

1929: Born at noon on January 15, 1929. Parents: The Reverend and Mrs. Martin Luther King, Sr. Home: 501

Auburn Avenue, N.E., Atlanta, Georgia.

1944: Graduated from Booker T. Washington High School and was admitted to Morehouse College at the age of 15.

1948: Graduates from Morehouse College and enters Crozer Theological Seminary. Ordained to the Baptist ministry, February 25, 1948, at the age of 19.

1951: Enters Boston University for graduate studies.

1953: Marries Coretta Scott and settles in Montgomery, Alabama.

1955: Received Doctorate of Philosophy in Systematic Theology from Boston University, Boston, Massachusetts on June 5, 1955. Dissertation Title: *A Comparison of God in the Thinking of Paul Tillich and Henry Wiseman.*

Joins the bus boycott after Rosa Parks was arrested on December 1. On December 5, he is elected president of the Montgomery Improvement Association, making him the official spokesman for the boycott.

1956: On November 13, the Supreme Court rules that bus segregation is illegal, ensuring victory for the boycott.

1957: King forms the Southern Christian Leadership Conference to fight segregation and achieve civil rights. On May 17, Dr. King speaks to a crowd of 15,000 in Washington, D. C.

1958: The U. S. Congress passed the first Civil Rights Act since restoration. King's first book, *Stride Toward Freedom*, is published. On a speaking tour, Martin Luther King, Jr. is nearly killed when stabbed by an assailant in Harlem. Met with President Dwight D. Eisenhower, along with Roy Wilkins, A. Philip Randolph, and Lester Grange on problems affecting black Americans.

1959: Visited India to study Mohandas Gandhi's philosophy of non-violence. Resigns from pastoring the Dexter Avenue Baptist Church to concentrate on civil rights full time. He moved to direct the activities of the Southern Christian Leadership Conference.

1960: Becomes co-pastor with his father at the Ebenezer Baptist Church in Atlanta, Georgia. Lunch counter sit-ins began in Greensboro, North Carolina. In Atlanta, King is arrested during a sit-in waiting to be served at a restaurant. He is sentenced to four months in jail, but after intervention by John Kennedy and Robert Kennedy, he is released. Student Non-Violent Coordinating Committee founded to coordinate protests at Shaw University, Raleigh, North Carolina.

1961: In November, the Interstate Commerce Commission bans segregation in interstate travel due to work of Martin Luther King, Jr. and the Freedom Riders. Congress on Racial Equality (CORE) began first *Freedom Ride* through the South, in a

Greyhound bus, after the U.S. Supreme Court outlawed segregation in interstate transportation.

1962: During the unsuccessful Albany, Georgia movement, King is arrested on July 27 and jailed.

1963: On Good Friday, April 12, King is arrested with

Ralph Abernathy by Police Commissioner Eugene "Bull" Connor for demonstrating without a permit. On April 13, the Birmingham campaign is launched. This would prove to be the turning point in the war to end desegregation in the South. During the eleven days he spent in jail, MLK writes his famous *Letter from Birmingham Jail*. On May 10, the Birmingham agreement is announced. The stores, restaurants, and schools will be desegregated, hiring of blacks implemented, and charges dropped.

On June 23, MLK leads 125,000 people on a Freedom Walk in Detroit. The March on Washington held August 28 is the largest civil rights demonstration in history with nearly 250,000 people in attendance. At the march, King makes his famous *I Have a Dream* speech. On November 22, President Kennedy is assassinated.

1964: On January 3, King appears on the cover of *Time* magazine as its

Man of the Year.

King attends the signing ceremony of the Civil Rights Act of 1964 at the White House on July 2. During the summer, King experiences his first hurtful rejection by black people when he is stoned by Black Muslims in Harlem. King is awarded the Nobel Peace Prize on December 10. Dr. King is the youngest person to be awarded the Nobel Peace Prize for Peace at age 35.

1965: On February 2, King is arrested in Selma, Alabama during a voting rights demonstration. After President Johnson signs the Voting Rights Act into law, Martin Luther King, Jr. turns to socioeconomic problems.

1966: On January 22, King moves into a Chicago slum tenement to attract attention to the living conditions of the poor. In June, King and others begin the March

Against Fear through the South. On July 10, King initiates a campaign to end discrimination in housing, employment, and schools in Chicago.

1967: The Supreme Court upholds a conviction of MLK by a Birmingham court for demonstrating without a permit. King spends four days in Birmingham jail. On November 27, King announces the inception of the Poor People's Campaign focusing on jobs and freedom for the poor of all races.

1968: King announces that the Poor People's Campaign will culminate in a March on Washington demanding a \$12 billion Economic Bill of Rights guaranteeing employment to the able-bodied, incomes to those unable to work, and an end to housing discrimination. Dr. King marches in support of sanitation workers on strike in Memphis, Tennessee. On March 28, King leads a march that turns violent. This was the first time one of his events had turned violent. Delivered

I've Been to the Mountaintop speech. At sunset on April 4, Martin Luther King, Jr. is fatally shot while standing on the balcony of the Lorraine Motel in Memphis, Tennessee. There are riots and disturbances in 120 American cities.

There were twenty thousand arrests. King's funeral on April 19 is an international event. Within a week of the assassination, the Open Housing Act is passed by Congress.

HISTORICAL OBSERVATION

After a Splendid Enterprise

When "A Splendid Enterprise" brought to closure the first one hundred plus years in the life of the General Baptist State Convention and its attendant auxiliaries our history did not cease. Especially is this true for the Woman's Baptist Home & Foreign Missionary Convention of North

Carolina, Inc. The founding purpose of the WBH&FMC is of a perpetual nature. There is always a need to organize and improve missionary activities in Baptist Churches across North Carolina, the Nation and the World.

Embedded in the final WBH&FMC described by "A Splendid Enterprise"

was a servant of God poised to take it to the next level in its growth in the person of Dr. Shirley W. Bullock. Dr. Bullock had been positioned by the Lord as first vice-president to lead this dedicated body to do a greater service for the kingdom. Psalm 37:34a, (TEV) "put your hope in the Lord and obey His commands; He will honor you by giving you the land." So this prepared servant, who is a native of Oxford, North Carolina, graduated from North Carolina Central University, Durham, NC with a B.S. degree, from East Carolina University, Greenville, NC with a Master of Education degree, and earned an Administrative Certification from North Carolina State University, Raleigh, NC. Subsequently she was awarded a Doctor of Humane Letters degree from Shaw University, Raleigh, NC.

Dr. Shirley Bullock was and still is an accomplished educator. She rose through the ranks from a High School Classroom Teacher with honors to become a Department Chairperson, to a Vocational Counselor and Director of Vocational and Technical Education Programs in the Rocky Mount City Schools. She served the State of North Carolina as a Vocational Administrator in the State Department of Public Instruction as well as Officer for the North Carolina Council of Local Vocational Administrators.

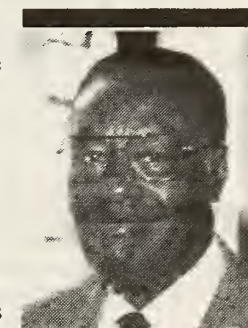
Dr. Bullock, blessed with an abundant supply of energy, was able to serve in other capacities. She provided leadership for the Wake County Board of Education, served the Wake Forest University Poteat Scholarship Selection Committee. Currently she serves as a

member of the North Carolina Internship Council – appointed by Governor Easley. She is recipient of the Governor's State of North Carolina

Long Leaf Pine Award, which is the highest State Award given to civilians. Dr. Bullock epitomizes a life dedicated to the Lord and she can see how He, the Lord, honors her and gives her the land or abundance of her endeavors.

These seem to be enough to fill a life time for most persons but not for our subject. She has found time and energy to do more. She taught and still teaches for the member churches of the General Baptist State Convention, the Woman's Baptist Home and Foreign Missionary Convention, and the Lott Carey Baptist Foreign Missionary Convention. She served the WBH&FMC as its State President. Beyond this she served Shaw University as a member of its Board of Trustees. Dr. Bullock is a consummate traveler. She also found time to raise four children, be a wife to a Pastor, and now to the President of the General Baptist State Convention of NC, Inc. This is truly a dedicated soul to Kingdom's work. Among many "ONE". ■

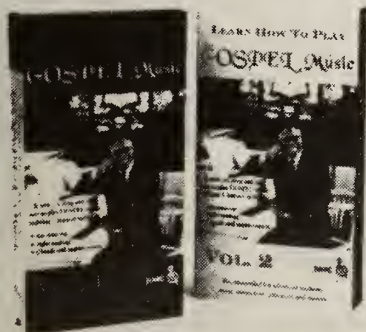

Picture Me Tobacco Free Photovoice Project

was one of the first churches to become a part of the Picture Me Tobacco Free Photovoice Project sponsored by the Center for Health and Healing, an affiliated non-profit entity of the General

Baptist State Convention of NC, and funded by the NC Health and Wellness Trust Fund. This project is part of a three year statewide campaign to help prevent North Carolina teens from using tobacco products. Youth between the ages of 11 and 16 are recruited and trained to serve as holistic health advocates within their local churches and communities.

One of the tasks that the Youth Action Team (YAT) had to perform was writing an action plan related to youth tobacco prevention or cessation. The YAT of Greater St. John chose to do several Action Plans. One of those was to write a NO SMOKING POLICY for their church. The YAT felt that this was

important because others should role model positive behavior for youth and smoking, especially on church grounds, is not a positive behavior. The YAT met and wrote the plan with some guidelines and assistance from their Adult Advisors, Rev. George McCormick and Bro. Clifton E. Bell, Jr. After a draft of the plan was written, it was taken to the Pastor, Rev. Joseph F. Kearns, Sr. Following discussions with the Pastor and Adult Advisors and revisions to the draft, a final copy was written and presented to Rev. Kearns.

We are happy to report that the Smoking Policy was presented to the congregation at the June church conference, voted on, and approved by the membership. At that time, the youth wanted to design a No Smoking sign to be placed outside in the parking lot. The Advisors met with the pastor and informed him of the youths' request. He was "elated" (at the least) with this idea. After the youth received permission to do the signs, each member of the them (Walter Rush, Tavia McCormick, Phillip Cheek, II, Brittany Coble, and Adrianna Bowden) was asked to draw four signs each. After the submission of the drawings, the Advisors met with Rev. Kearns to decide on a design. The Adult Advisors took the best drawing of each youth and combined elements of them to come up with the best design. That design was sent out to be produced. Everyone is pleased with the resulting signage. The signage will be placed in several visible

locations in the parking lot.

On November 13th, 2004, "PICTURE ME TOBACCO FREE" sponsored a Health Awareness Day at New Hope Baptist Church in Greensboro, North Carolina. During this forum, the new sign was presented as part of Greater St. John Missionary Baptist Church's YAT presentation. It was well received by others in attendance. A representative of Guilford County Health Department offered to work with Greensboro churches to produce duplicate signs at no cost to the churches.

A hearty well done to the YAT, their advisors, and Rev. Kearns for all of the support and hard work that made this Action Plan a success.

Second Chances

Greetings in the name of our Lord and Savior, Jesus Christ. On behalf of Vice President, Rev. Walter S. Taylor, Secretary, Rev. Larry Allen and the entire staff of The Ministers Council of The General Baptist State Convention of

North Carolina, Inc., we pray God's choice blessings upon you as we celebrate the comings of the soon coming King, who came born as a babe in Bethlehem and is come as Savior and Lord in the hearts of the born again

believers.

The following message was presented at the 2002 Congress of Christian Education during a seminar on Narrative Preaching by Dr. James H. Harris, pastor of Second Baptist Church in Richmond, Virginia.

It is my prayer that this message will speak to your hearts as it has spoken to mine.

SECOND CHANCES

"The word of the Lord came to Jonah a second time, saying 'Get up, go to Nineveh, that great city and proclaim to it the message that I tell you.' So Jonah set out and went to Nineveh, according to word of the Lord."
Jonah 3:1-10

Many of us today have wasted and squandered money and opportunities. We have faltered and failed in so many ways to do what God has called us to do, and yet we have had so little compassion for others. It seems that we are so quick to condemn the faults and failures of others; oftentimes, so eager to accuse, point a finger and judge someone else for their human weaknesses, and their failures, their slips of conscience and their acquiescence to the luring power of the flesh – the body. We have a condemning air about us, an arrogant spirit of superiority that suggests that we have never done anything wrong – that we have never lied, that we have never fornicated nor committed adultery, that we have never deceived or tricked or schemed, that we have never been homeless or poor or hungry. We act as if we are perfect and everybody else is in need of salvation – everybody except us.

Jonah teaches us that we are not perfect, that failure is a part of the human condition, that life includes failure and if we are going to be saved, we have to learn to cope with the ups and downs of life. Jonah has disobeyed God. He has ignored the call of God. He has gone in the wrong directions. He has been thrown overboard. He has been swallowed up by a whale. He has prayed to the Lord from the belly of the whale – Jonah has been to hell and back. He has been in the deep, dark, dungeons of sheol. But God was still there – you can run, but you cannot get away from God. And while folk in the church, folk in the pews and in the choir stands, folk in church school – deacons and trustees, may be slow to forgive and quick to judge their fellow brothers and sisters, God is a God of *Second Chances*. God does not write us off even if we go in the wrong directions. God does not abandon us even if we go down the wrong path, on the wrong boat, causing chaos and stormy weather for others. Yes, Jonah was disobedient. Yes, Jonah was hard-headed. Yes, Jonah was obstinate and ugly in his behavior and attitude. Yes, Jonah was determined to do what *he* wanted to do, so much like so many folk in the church determined to disobey God, determined to disregard the word of the Lord. But the sweetest, most gracious words of scripture are found in this text. The most loving and kindest words of prophetic literature are found in this text. The words of this text contain words that describe the essential nature of God – a God who gives us second chances.

Don't write people off. Don't be

unforgiving. Don't be mad and unkind, and don't be rigid and inflexible in your relationships with others. Give folk a second chance! God is a God of second chances. God is the God who gives us the opportunity to develop a new consciousness, a second time. Let's look at the text more closely to learn a few lessons from it this morning.

The first thing we glean from the text is that the message of the Lord is the same, the second time around. Second chances don't mean that the message has changed. The message is the same. The text says *"The word of the Lord came to Jonah a second time saying 'Get up, go to Nineveh that great city.'"* Jonah still has to get up and go to Nineveh – the assignment has not changed. The destination has not changed; the mission and the mandate are still the same – Go to Nineveh that great city. The destination is the same, the place that we ran from the first time and got into a whole lot of trouble – is still the place that God wants us to go to. Just because Jonah had taken a holiday, an excursion on the Mediterranean Sea and caused a lot of havoc in his life and the life of the sailors, doesn't mean that his orders had changed. Just because he had gone AWOL didn't mean that God had changed his orders. And although he had said, "NO!" the first time, when God came to him the second time He said the same thing, "Go to Nineveh!" God's orders are the same. Go to Nineveh! Do what I ask you to do. Go to the jails and prisons; go to the schools and street corners; go to those who are helpless; go to Nineveh, that great city, where the power brokers reside; go to Nineveh. Go where I send you. Second chances give us an opportunity to do what we didn't do the first time.

Secondly, not only are you to go to Nineveh, but you are to do the same thing I told you the first time. Going is not enough, but the purpose for your going is to preach! Proclaim the message that I tell you! The text says: *"The word of the Lord came to Jonah a second time, saying arise, get up, go to Nineveh, that great city, and proclaim, preach to it the message that I tell you."* God wanted Jonah to preach, not to philosophize or rationalize, but to preach! Not to sing or to testify, but to preach! Not to entertain or caress folk in their carnality, in their baneful and base behavior, but to preach! Not to come in timidity and in fear, but to preach! - Boldly proclaiming the word of God. Jonah wasn't sent to do anything but preach and to preach or proclaim the message that the Lord told him to preach.

As Jesus watched people place their offering into the temple treasury, He noticed a poor widow who put in

two coins valued at less than a penny.

Mark 12:43-44 – *“Calling His disciples to Him, Jesus said, ‘I tell you the truth, this poor widow has put more into the treasury than all the*

others. They all gave out of their wealth; but she, out of her poverty, put in everything, all she had to live on.’”

This passage gives us a wonderful example of faith and how God must be the Lord of our finances, but the real message actually goes much deeper.

We have all been blessed in so many ways; and we are called to be good stewards, or managers, of all our

blessings. As a good steward, we must present all we possess back to our Heavenly Father as an offering of love. Yes, this relates to our financial resources; but it also means we are to offer our gifts, abilities, talents, and time back to God through service and ministry to others. God created us (the complete package of who we are) for a purpose. We will need to spend good quality time with God to fully understand our purpose, but we can be absolutely sure that God has NOT blessed us so we can advance our own selfish agenda!

Every one of our blessings, no matter how small, is given so we can bless God in return. We often hold back from ministry opportunities because we feel our “offering” is insignificant. We feel inadequate to serve or unworthy to make a true contribution to the work of God’s Kingdom. But God is never concerned with the magnitude of a gift. He is, and always has been, concerned with the condition of our heart. *“Does the Lord delight in burnt offerings and sacrifices as much as in obeying the voice of the Lord? To obey is better*

than sacrifice, and to heed is better than the fat of rams” (1 Samuel 15:22). How we give is much more important than what we give.

God does not need our money, time, ability, or anything we accomplish or produce. He loves us dearly and desires to receive the complete love and devotion which is given with our offering. Jesus was blessed by a widow who gave from her heart, even though the actual gift carried very little

earthly value.

If we want our service or ministry to have significance in the eyes of God, we must focus on the One to whom we are giving rather than on the value of the gift in the eyes of man. With our eyes focused, we must then give with all the love in our heart. If our heart is pure in the giving, God will receive our offering as a true blessing. There are no worthless or insignificant gifts when the gift is given from a pure heart.

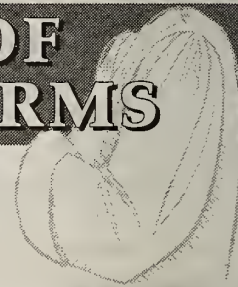

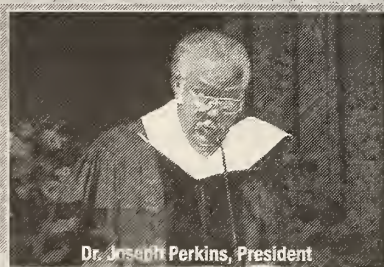

Bridging the Text

Continuing the discussion from the previous article, care should be given in the usage of titles as the "thing" that makes the sermon. **At no time should titles have ascendancy over the text, becoming the source relied upon to carry the point of the message.** The attention given to titles as strategic in the sermon document is not only misappropriation of significance but also deceptive and misleading. Turning the hearer's

focus to the portion on the plate that has the least amount of nutrients important for health and life will bring about unhealthy consequences in the formation of spiritual growth. Like a child whose diet has been that of sweets over vegetables and meats, congregations living off of sweets of titles, owing to cultural flavor of the times, suffers from malnourishment.

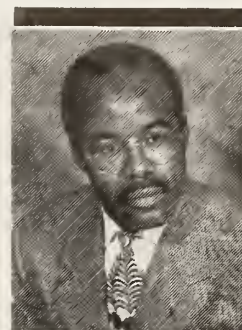
Titles should not be seen as having the same function of slogans used as a marketing tool or device to sell a product. Everything seems to hinge on getting the attention of the audience for whom the product is created. For the preacher, where should he/she search in the hopes of appropriating titles for sermon documents? Is the television appropriate for shaping titles? Are secular songs written and sung by talented artists

a rich reservoir? Are significant world events sufficient? What about personal experience or even sponsoring events of nature? How far or to what extent is the preacher willing to go in search of a title that resonates well with the pangs of the congregation, spurring cheers, laughter, and applause, giving assent to entertainment?

If the preaching-text is taken from the Scripture, likewise, the sermon from the text, then it does follow that the title should be an offspring of the text. Titles should be both biblical and theologically wrapped in universal truth for a particular audience. **Cross-fertilization of biblical sermon content with worldly or secular titles weakens the message desiring to play on the human whims of the listening audience.** Titles as a general homiletical rule should emerge out of and be made from the same textual fabric as the structure of the sermon,

avoiding the gospel preached as something else. Paul has given stern notice to not preach any other gospel than Christ Crucified, lest a curse infers.

Total trust in the principles of biblical truth in the sermon document will approximate conviction and conversion over use of the sermon as an entertainment and amusement enterprise. Sermons, if they are to remain gospel, must seek to be Christ and not culturally rooted. For questions or comments: RHBC@BellSouth.Net.

TELLING IT LIKE IT IS

"Resolving Grievances"

I receive calls on a regular basis concerning some conflict that is going on in our churches.

Church Conflict, if not handled properly, will eventually lead the church into court. So it would seem that a church would do well to establish a procedure for dealing with disputes, disagreements, or grievances, which are bound to develop in spite of the best of Christian intentions. It is tragic when such matters make it to the court system to be resolved. Every effort should be made to settle such matters within the framework of the church structure. A church with a number of employees may want to establish a written procedure for dealing with employee grievances. Such procedure may include the following ideas.

The immediate supervisor should be the first person involved when an employee has a problem. A written record should be made of the grievance and the attempt to deal with it. Several efforts may have to be made to resolve the issue. If the difficulty cannot be dealt with at this level, then the next level of supervision should be involved. All of the records of the attempts to solve the problem should be reviewed, and additional solutions explored.

If the supervisors cannot develop a

satisfactory solution, it is helpful to have some type of a committee (personnel, pastor relations) made up of qualified church members who relate to personnel matters. These persons should be brought into the discussion to give greater insight into possible solutions. Every effort should be made to deal with such matters in the church rather than securing an attorney and going to court. The above matters are things Bruce P. Powers talks about in his book, "Church Administration Handbook".

Now, there is nothing that I am aware of that can stop a church or church members from taking each other to court. But if a church would consider placing some type of language into her bylaws that would require the church or members to exhaust the church's remedy before going to court, such conflicts may be resolved prior to court. Language such as the following could be helpful.

"Neither the church nor her members shall bring a legal action against the church and members shall not bring a legal action against each other without first exhausting his/her administrative remedy. For this purpose, administrative remedy shall include: (1) allowing the moderator and/or independent council of the association of the church's membership or a designate of the General Baptist State Convention of NC (example, Moderator of Moderators' Council) to assist in mediating and resolving such issues; or (2) allowing an independent professional mediation or dispute resolution agency assist in resolving such issues."

It is believed that once these steps are taken, the parties are more likely to arrive at some solution and thereby eliminate the need to proceed to court.

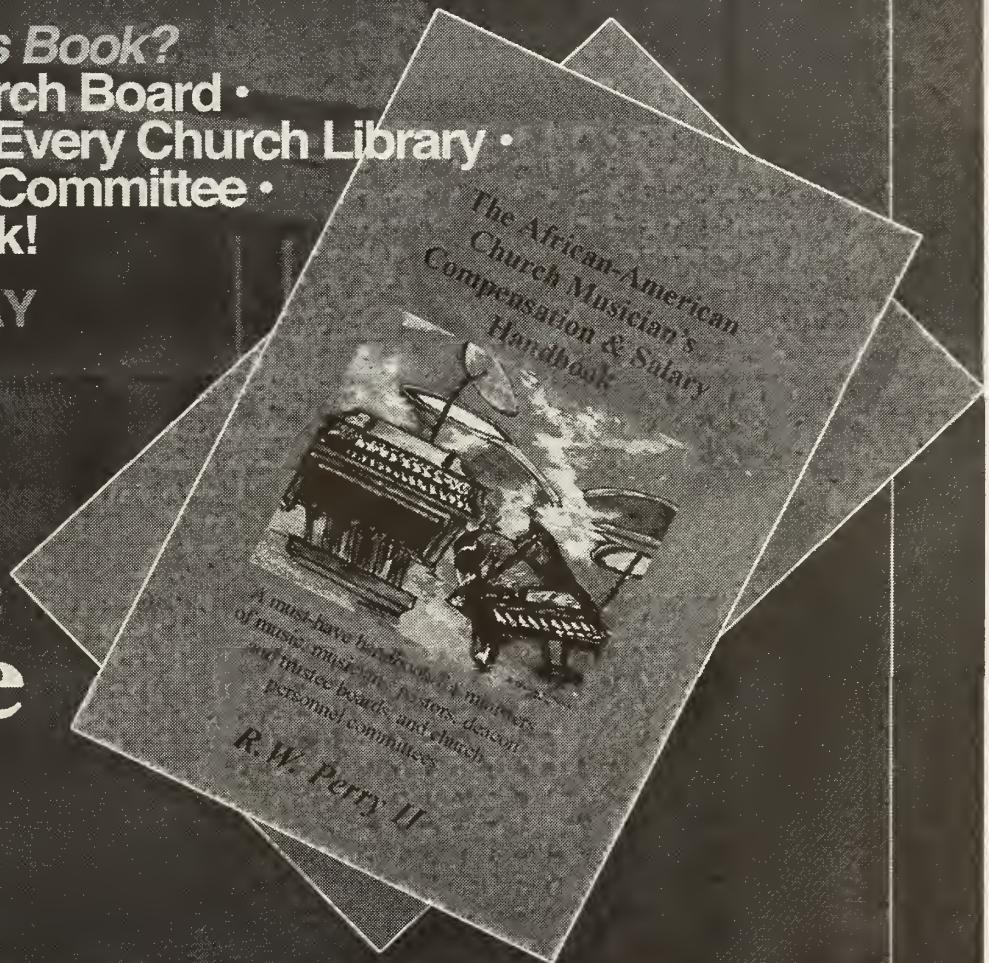

EXPLORING THE WONDERS OF GOD'S GRACE

Looking to God to Establish the Work of Our Hands

Reasons that are deeper than I can explain, but I am extremely grateful to have this opportunity to express to you hopes of a prosperous New Year. Can you believe that we have again embarked upon a new year? Perhaps that I am older, time for me appears to move so swiftly. Seemingly, I still have some more time to spend in the year that just ended. Yet, in spite of how things may appear to me, we are in the beginning of a new year.

To those to whom time also may appear to be moving extremely fast, let me just say that we are not experiencing an illusion. Recently, a rereading of the 90th Psalm helped me in my understanding of how quickly time passes by. If you have attended a Home Going Celebration of a person who lived to be at least 70 years old or older, there is a strong possibility that you are familiar with the 90th Psalm. It is common for the 90th Psalm to be read at the Home Going Celebration of someone who had lived to be at least 70 or older.

I know many would think differently, but I am not sure if a Home Going Celebration is the best utilization of the 90th Psalm. In your leisure time, reread the 90th Psalm closely. Check it out. The emphasis in the 90th Psalm is not death, but rather how quick and swift time is. Observe what the

Psalmist says about time, "For a thousand years in thy sight are but as a yesterday when it is past, and as a watch in the night (90:4)... For all our days are passed away in thy wrath: we spend our years as a tale that is told. The days of our years are threescore years and ten; and if by reason of strength they be fourscore years, yet is their strength labour and sorrow; for it is soon cut off, and we fly away (90:9-10)." How long we live is not the issue in 90th Psalm, but rather how long we live swiftly passes by. Our life in relation to time, asserts the Psalmist, is like the flower. In the morning, the flower flourishes and grows up, but in the evening it is cut down and withers away (Psalm 90:6).

The essential lesson in the 90th Psalm that Psalmist would have for us to learn is proper and wise usage of the time that we have to live. The length of time that we live is not the key to a fulfilled life, but rather it is that to which we have committed our lives to during the time that we have been given to live. Since the time in our lives passes by so swiftly and to avoid the mistake of mismanaging how we utilize our lives, the Psalmist suggests that we allow God to establish the work of our hands. In other words, to fully take advan-

tage of a very finite and swift time that we have to live, we want to accept the purpose that God has defined for our lives. We should never forget that we were made and created for God's purpose and glory. Therefore, regardless of how swift time passes by, if our lives are committed to the purpose that God has established for our lives, time then becomes a matter of a reflection and captivation of a moment. Dr. Martin Luther King, Jr. only lived for thirty-nine years, but oh how his time on earth is a moment that continues to have an impact on the lives of people all over the world.

So as the New Year already has begun to move swiftly let us go forth into the New Year clinging to the advice of the Psalmist. For the Psalmist advised, "Let thy work appear unto thy servants, an thy glory unto their children. And let the beauty of the Lord our God be upon us: and establish thou the work of our hands upon us; yea, the work of our hands establish thou it" (Psalm 90:16-17). Remember, our Lord and Savior, Jesus Christ, only lived thirty-three years. Yet those thirty-three years are a reflection and moment in time that will forever be remembered and utilized because Jesus allowed God to establish the work of his hands.

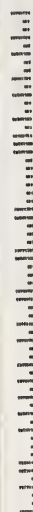

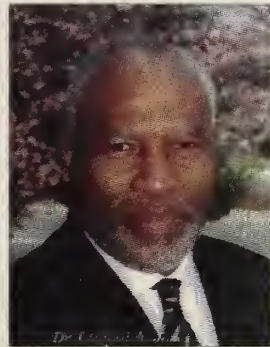
Jones Energizes crowd at Martin Luther King Banquet

A crowd approaching 1,000 people gathered in the Raleigh Civic and Convention Center on January 7 to hear The Reverend Dr. Clifford A. Jones, Sr.'s keynote address to this annual gathering of Baptists from across North Carolina. Jones (who is Senior Pastor of Charlotte's Friendship Missionary Baptist Church and a past president of the General Baptist State Convention) brought the packed room to its feet with his repeated hopeful promise of "someday."

In classic Jones style, the address began with reflections on the history of the *Brown v. Board of Education* decision that ultimately led to desegregation of the public schools. After the Supreme Court reached a decision in *Brown* in 1954, the Court turned its attention to how to implement the ruling in the following term. The NAACP pressed the Court to use the word "forthwith" in order to accelerate progress toward desegregation

of the public schools. The Court finally opted to use a phrase associated with Oliver Wendell Holmes, "with all deliberate speed."

Jones offered that the "with all deliberate speed" phrase was interpreted by many in the country as a means to delay or even prevent progress in the area of civil and human rights in the 1950's and 60's. "It pointed not to a timeframe for reaching a goal, but to a 'someday,'" Jones reasoned. Linking the phrase to the classic civil rights era song, "We Shall Overcome," Jones argued that the same phrase used by some to maintain the status quo is the same ideal that inspires Missionary Baptists to work for justice, support the cause of missions, and advance the causes of the Kingdom of Christ in the earth. The gathering was



inspired to keep believing in a better day to come while working to bring the powers of faith, hope and service to bear to meet the challenges of today.

An excited and energized Baptist family poured out of the Raleigh Civic Center following Jones' address. One Banquet attendee was quoted as saying, "I often come to these events and leave a little sad, but not tonight. I'm excited about doing much more in my Church and in our Convention. Dr. Jones was awesome."

Dr. Charles T. Bullock (GBSC President) presided over the gala evening that included participation from each of the Convention's Vice Presidents. First Vice President Howard W. Parker, Jr. introduced the keynote speaker. Second Vice President Nilous M. Avery, II

offered a welcome speech. Third Vice President Leonzo D. Lynch presented the head table dignitaries. Fourth Vice President Ricky Banks gave the invocation. Ms. Kenya Woods (a member of the Piney Wood Baptist Church in Ahoskie) gave music for the evening, accompanied by Mr. David Eggleston, the Convention's chief musician. Mrs. Colene B. Stanley, President of Lott Carey Baptist Foreign Missions Convention's Women's Auxiliary, was on hand to offer the evening dinner grace. The Banquet attendees were given a special treat when a liturgical dance team from Raleigh's Martin Street Baptist Church performed.

Vice President-at-Large John H. Grant assisted the President in recognizing the 2005 Martin Luther King, Jr. Presidential Award Recipients. Each year, the Convention recognizes persons

Gray named EST

The Reverend Haywood T. Gray has been named the seventh Executive Secretary-Treasurer in the one hundred thirty-eight years of the General Baptist State Convention of North Carolina, Inc.

The Executive Committee elected Gray on November 15, 2004. He began service on a part-time basis immediately and began full-time service on January 1, 2005. When announcing Reverend Gray's election, GBSC President Charles T. Bullock said that Gray "brings to this position new hope, new inspiration, and zeal to lead us to new heights. We are excited about what God will do through his leadership."

The Constitution of the General Baptist State Convention sets the parameters of the duties of the Executive Secretary-Treasurer. According to the Constitution, "The Executive

Secretary-Treasurer shall have administrative supervision over, and is responsible for the total promotion of the Convention's program. He shall be the chief executive officer of the General Board staff, the chief budget officer of the General Board staff, the

chief professional advisor of the Convention and its Committees, the secretary and treasurer of the General Board and the Convention, and a strong spiritual leader providing statewide guidance and inspiration." When asked of his reaction to such a broad job description, Gray responded, "I am amazed at how long God has been preparing me for this avenue of service.

I am overwhelmed, excited and very humbled by it all."

It is something of an understatement to say that God has brought our new Executive Secretary-Treasurer a long way from what he fondly refers to as "the backwoods of Southern Virginia." Raised in Southampton County, Virginia, just a few miles from

who have made important contributions to their respective fields of work and service. Dr. J. Donald Ballard (Pfafttown), Dr. Elbert Lee, Jr. (Rocky Mount) and Mrs. Zettie B. Williams (Magnolia) were this year's recipients. President Bullock presented an engraved plaque following Dr. Grant's moving presentation of each recipient. Dr. Ballard was honored for "demonstrated excellence in preaching and pastoral leadership." Dr. Lee's citation was for "acclaimed distinction in advocacy for seniors and gerontology research." Mrs. Williams' "exemplary leadership in education and community service" was recognized by the Convention.

The Banquet also marked a "changing of the guard" as Interim Executive Secretary-Treasurer Reginald A. Wells was honored for his service and new Executive Secretary-Treasurer Haywood T. Gray was formally presented to the Baptist family. In presenting Reverend Wells to the attendees, Gray said, "a strong wind forces some to retreat, to give up on their dreams, and to abandon their visions. But a select few — instead of giving into their fears — lift their heads, square their shoulders, and challenge life's gale force winds. Such is the case with The Reverend Reginald A. Wells." Following Gray's introduction, President Bullock offered praise and appreciation

to Wells for his service and presented Wells with an engraved plaque. Reverend Wells thanked the Convention for its support and cooperation during his tenure and expressed personal appreciation to his family, Church family, and friends across the state.

Dr. David C. Forbes, Sr. (Pastor of Christian Faith Baptist Church in Raleigh and Chairman of GBSC Board of Trustees) was tasked with the duty of presenting the new Executive Secretary-Treasurer. In presenting Gray (who is a member of Christian Faith), Forbes offered a hopeful vision of what the GBSC could do under Gray's administrative leadership. To celebrate and commemorate Gray's election as Executive Secretary-Treasurer, Dr. Forbes presented a contribution of \$3,000.00 from Christian Faith Baptist Church for state missions. Forbes challenged the pastors present to lead their congregations to make a special offering for state missions as a gesture of welcome to Gray and as a pledge of support for his new efforts as administrative head of the Convention.

Gray's remarks stirred the crowd as he spoke of the power of the word "shall." He provided an optimistic view of the Convention's future focused, not on what God might do, but what the Bible promises that He "shall" do.

the epicenter of the 1831 Nat Turner slave rebellion, Gray has very humble beginnings. His family never even owned a car. Reared by his late maternal grandmother, he remembers his family moving often during his youth. He was a teenager before his grandmother was able to purchase her first home. "I remember her being so proud of that little house and, until her death, she was obsessed about keeping it neat, clean and in good repair," says Gray. "She taught me how to stretch a dollar and to take care of what God blesses you with."

He answered the call to preach when he was fifteen years old. Though sure of God's call, he never imagined the idea of being involved in some form of full-time ministry. "All of the ministers in our community were part-time and non-resident. I didn't have a clue that a person could support themselves or even keep themselves busy doing ministry," Gray recalls. When accepted at Averett College (now Averett University) in Danville, Virginia, he decided on a double major in Social Work and English. "In the back of my naïve mind, I thought I would do social work to earn a living," Gray recalls, "and that the English background would be helpful if a Church needed me once or twice a month." Because he received a ministerial scholarship from the University, he was required to enroll in a course designed to help students in ministry understand their calling as a career. "I was shocked that someone could actually do ministry as a life's vocation and I knew instantly that this was what I wanted to do," he says. He did not change his major because his intentions were to go to graduate school after Averett. Back in those days, his goal was to earn a Ph.D. in Black Church studies and teach in a University.

It was at Averett that Gray's work ethic was honed. "I had more jobs than I could count: two work study jobs, babysitting, English tutor for Vietnamese refugees, and preaching whenever somebody wanted to hear me," he notes. He completed his four year degree in three years, not because "I was so smart, but because I was so poor." He could not afford to pay private school tuition for four years and continue to send money home to help support his then ailing grandmother.

His plans to enroll in seminary after graduating from Averett were put on hold by the call of Shady Grove Baptist Church in Pelham, North Carolina. He accepted the call to become their pastor in February 1981. "The deacons asked me to sign a contract for one year while they continued to search for the 'right man,'" says Gray with a broad smile. One year turned into seventeen years. He soon moved to Yanceyville, North Carolina and became active in Church, community and denominational affairs. "There is no doubt," he remarks, "that being at Shady Grove was the most meaningful time in my development as a minister. Much of who I am today, I owe to the good people of Shady Grove Church and of Caswell County."

He claimed the attention of Dr. E. B. Turner in the early 1980's and became active in the General Baptist State Convention. He served in several capacities in the Turner administration including Secretary of the General Board and a member of several Convention committees including Budget and Program. He sat a term as a Trustee of Shaw Divinity School and was a part of the early movement to seek accreditation for the seminary. In 1990, Gray ran for and was elected Fourth Vice President. "The election win came as something of a shock because so many people thought it would be impossible for a pastor of a

Whenever feasible, the Executive Secretary-Treasurer hopes to visit with our Associations. However, other staff stands ready to travel when the EST is unavailable. ■

GBSC Receives Technology Grant

The General Baptist State Convention has received a one-time grant from the Saint Paul Baptist Church of Charlotte to be used to upgrade the technology at the Baptist Headquarters. In announcing the grant, the Executive Secretary-Treasurer said that the improvements to operations at the Headquarters would be nothing short of "remarkable."

The Convention has contracted with G1Systems of Raleigh to implement the upgrades. The "Technology Refinement Plan" (jointly developed by G1Systems and the EST) will address several concerns. First, the grant will provide for an upgrade to the existing network. Upon completion, the computers in the Headquarters will be able to communicate with each other. This should reduce the amount of paperwork produced because staff members will be able to send forms and other documents to each other electronically.

A part of the network upgrade project will allow the Baptist Headquarters to become a "Wi-Fi Zone." "Wi-Fi" refers to wireless access to the Internet. By making the Headquarters a "Wi-Fi Zone," persons with wireless computer capability will be able to connect to the Internet while in the Baptist Headquarters without using any cable connections. Committee members are encouraged to bring their "Wi-Fi" laptops to meetings at the Headquarters and make use of the Internet access capabilities afforded by the technology upgrade taking place.

Secondly, the grant will provide funds to purchase two computers. One computer will be used by staff and will replace a very outdated computer. The other computer will be a "public" use computer. It will be available and accessible to visitors at the Baptist Headquarters. It will provide free access to the Internet.

Thirdly, the grant will provide the basis for a new digital document storage

and retrieval system. According to Gray, the Baptist Headquarters generates an enormous amount of paperwork. The new system will allow the Headquarters to keep digital copies of forms, documents and other paperwork. The staff will be able to retrieve these documents electronically through their computers instead of having to manually search for documents in paper files. Ultimately, the new system will allow persons with the proper clearances to access documents stored on the Baptist Headquarters computers by way of the Internet. "This feature," says EST Gray, "will be especially helpful to Moderators and Pastors who will not have to wait for published reports to be mailed to them. They will be able to go to the GBSC website and download the information as needed."

"The Technology Refinement Plan" will be implemented in stages. It is hoped that it will principally be in place by mid-summer. The St. Paul grant will lay the foundation for the technology needs of the Headquarters. Additional funds will be required to completely implement the Plan.

Charlotte's Saint Paul Baptist Church, the providers of the grant, has The Reverend Dr. Gregory K. Moss, Sr. as pastor.

Raleigh Area Volunteers Sought for Headquarters

The Baptist Headquarters has announced a search for members of Raleigh area Missionary Baptist Churches to sign up as Headquarters volunteers. A need for persons to volunteer (either on a one-time basis or on a continuing basis) has presented itself in the early days of the leadership of the new Executive Secretary-Treasurer.

"Unfortunately, we have a small staff," says EST Haywood T. Gray, "and there are not enough hours in the day to complete all the tasks set before us on a daily

basis."

Volunteers are needed in a wide range of services from typing and computer skills to painters and "clean up crews." The EST is developing a list of volunteer services needed. The list should be available in mid-March with hopes of volunteers being ready to start work in late March. Persons interested in volunteering should contact the Baptist Headquarters for a "Volunteers List" and application. Following review of the application and a recommendation from the volunteer's pastor, a brief orientation will take place and work can begin.

Preaching Statesman Joins Divinity School Faculty

The Shaw University Divinity School is pleased to welcome the world celebrated, and sought after, Dr. Gardner C. Taylor, Senior Pastor Emeritus of The Concord Baptist Church of Christ (Brooklyn, New York) as the Shaw University Divinity School Distinguished Professor of Homiletics. Dr. Taylor's presence at Shaw is a part of the Divinity School's two-fold commitment to train clergy for leadership while developing a school of excellence for preachers. Both objectives are expressed in the University's motto "Strides to Excellence: Only the Best!"

Named one of "The Fifteen Greatest Preachers" by *Ebony Magazine*, Dr. Taylor was presented the Presidential Medal of Freedom, the nation's highest civilian honor, by President William Jefferson Clinton, on August 9, 2000. His international honors include being named Knight Commander, Order of African Redemption by President William V.S. Tubman of the Republic of Liberia in 1969. Liberian President William R. Tolbert, Jr. later conferred the Order of Africa honor in 1973.

From 1948-1990, Dr. Taylor served as Pastor of The Concord Baptist Church of Christ in Brooklyn, New York. Within that span of time, over nine thousand members were added to the Church. He also served as Pastor of Bethany Baptist Church (Elyria, Ohio), Beulah Baptist Church (New Orleans, Louisiana), and Mount Zion Baptist Church (Baton Rouge, Louisiana). Dr. Taylor's leadership has brought forth the creation of The Concord Baptist Church Elementary School, Nursing Home, Clothing Exchange, Federal Credit Union, Seniors Resident, and the Concord Baptist Christ Fund

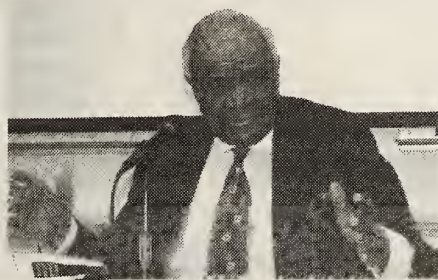
while at Concord Baptist Church of Christ.

Dr. Taylor, a premier lecturer on preaching, has committed to train, teach and impart excellence into the Shaw University Divinity School students. A special class, "*The Preaching of Gardner C. Taylor*," designed by Dr. Reginald Van Stephens (Assistant Professor of Homiletics) and Dr. J. T. Roberson (Dean of Shaw University Divinity School) allows Dr. Taylor to share his gifts and talents with the Divinity School students. Introduced in the current term, Dr. Taylor's focus in the class is on contemporary preaching. An emphasis of the

course, according to Dean Robertson, is studying "the hermeneutical DNA on the individual uniqueness of a sermon" by giving attention to exegesis, exposition, social needs, preparation and delivery of the sermon. "Through these lenses, students are capturing the methods of his excellence in preaching and his preaching methodology as he engages them in the classroom," says Dean Robertson. The classroom setting has been organized and is structured around a dialogical approach to the learner so that the students are able to ask questions designed to initiate dialogue on preaching.

Dr. Gardner C. Taylor puts the "power in preaching" and is considered by many to be the greatest living African American preacher. Dr. Clarence G. Newsome, President of Shaw University,

has welcomed Dr. Taylor's presence. "God is up to something! God has allowed greatness to be in the midst of us," says President Newsome. "We are eternally blessed that Dr. Taylor has agreed to grace us with his presence," says Doris Sanders, a Shaw University Divinity School student. "I'm so grateful that God ordered my steps to the Shaw Divinity School.

The anointing is so powerful in Dr. Taylor's class that I feel both humbled and inspired realizing that my ministerial development is profoundly enhanced by infusions of Dr. Taylor's wisdom. The opportunity to study the art of preaching with the 'Michelangelo of Homiletics,' is a divine appointment in the realms of education and impartation," says Sherri L. Arnold Graham, Graduate Student Government Association (GSGA) Vice-President.

As a preacher/teacher, Dr. Taylor's contributions span both national and international arenas. He is the author of many books and public writings including *Best Sermon* (1959); *Preaching Biblically*; *The Cry of Freedom*; *Presbyterian Journal* (Interpretation), "*Some Musings On A Nation Under God*"; and *Harvard Divinity Bulletin*, "*Climbing Jacob's Ladder*" (1993). He wrote *The Words of Gardner Taylor - Six Volumes* (Judson); *How Shall They Preach*, 1976 Lyman Beecher Lectures, Yale University; *The Scarlet Thread* 1981; *Chariots Aflame*, 1988; and *We Have This Ministry* (with

The Reverend Samuel Proctor) 1996.

Dr. Taylor has shared his greatness in preaching knowledge at some of the nation's most prominent universities and seminaries. He has lectured at Colgate-Rochester Divinity School, Harvard Divinity School, Union Theological Seminary, Louisville Presbyterian Seminary, Southern Baptist Seminary, Eastern Baptist Seminary, Southeastern Baptist Seminary, Louisville Presbyterian Seminary, Yale Divinity School, Atlantic Christian College, Southwester Baptist Seminary, and Princeton Theological Seminary. Shaw University Divinity School is now added to that list of hosting seminaries for Dr. Taylor's lectures. Additionally, the Gardner C. Taylor Lectures are an annual event at Duke Divinity School sponsored by the Office of Black Church Studies and the Black Seminarians Union.

Dr. Taylor is a former member of the General Council of the American Baptist Convention and a Past President, of the Progressive National Baptist Convention. He has been featured in the *New York Times*, *Ebony Magazine*, *Newsday*, and *Newsweek*. In a Baylor University survey in 1996, Dr. Taylor was named one of the "Twelve Most Effective Preachers In The English Speaking World".

In announcing Dr. Taylor's coming to Raleigh, Shaw University Divinity School heralded its pride and appreciation at having "the personification of excellence in preaching or, as some have referred to him, 'the prince of preachers,' to be a faculty member at our school. We believe his presence will steer us toward "Excellence in Preaching" as we are committed to "Only the Best!"

The God of Jacob

"The Lord of hosts is with us; the God of Jacob is our refuge." (Psalm 46:11).

It was not safe to be Jacob's friend, brother, or even his father. Jacob was a selfish, ambitious young man whose greedy mind was more active than his good conscience. He was clever at deception, an adroit actor, and a coward.

Quick to take a mean advantage of another person, he was also quick to run away when in danger. Then, in his fear and loneliness, he prayed, and even tried to make a bargain with God. "If he will do something special for me, I will be very generous with him" was the spirit of Jacob's prayer. Indeed, he seemed to believe trickery and dishonesty a good policy.

We cannot, however, with good grace be severe with Jacob. In fact, it is not quite safe for us to point an accusing finger at him. For while we are doing that, some neighbor, or perhaps some member of our family, might have a finger leveled at us. It becomes us to handle Jacob with sympathy, because he and

Then as we read the words "the God of Jacob," their meaning suddenly becomes clear. Weak cowardly, sinful Jacob — yet God claimed him, and changed him. God hated Jacob's ways, but he did not hate Jacob. Doubtless, he hates our foolish motives and sinful acts, yet he calls us to him and forgives us when we come. "The God of Jacob is our refuge."

small church in a small rural community to rise to such a high level in the state convention," Gray recalls. "There was strong support from all across the state and I made some lifelong friends in the months leading up to that election."

He chose not to seek higher office after his tenure as Fourth Vice President. "That was a tough decision for me," remembers Gray. "But the reality set in that it would be difficult for me to continue to ask our congregation to support me financially to meet the growing demands of holding statewide office. I literally had to choose between spending more money for missions and spending more money to support my presidential aspirations. I chose missions." After leaving the presidential line-up, he focused his attention on local issues. He was twice elected to the Caswell County Board of Education and served a term as Moderator of Cedar Grove Missionary Baptist Association. His tenure as Moderator was marked by growth and change. At the end of his term, 100% of the Churches were participating in and supporting the Association. He led the Association to build a new, state-of-the-art, \$800,000.00 childcare facility licensed to serve 150 children.

In 1998, he accepted the call of the Temple Memorial Baptist Church in High Point to become their fifth pastor.

About Temple Memorial, Gray says, "it was definitely a Church in crisis – struggling spiritually, in trouble financially, and in need of renewal and revival." When queried on why he felt such strong hope in the possibilities of what Temple Memorial could become, he says that he was touched by the good-

ness of the people there. "Good people plus a great God always spell success," Gray says.

Within two years, the Church's financial standing had been restored and new models for accountability had been instituted. More than three hundred people joined the Church in his seven-year tenure. By the time that he resigned in November 2004, the entire Church debt has been retired and Church budget had peaked at almost triple the budget the Church operated under when he arrived. Of his proudest accomplishments in High Point, Gray points to leading his Church to make missions central to who they were as a Church. "We actually became a Missionary Baptist Church in more than just name; we were Missionary Baptist because of what our beliefs called

us to do," he says. The Church's missions allocation grew from less than 2% of the Church budget in 1997 to almost 18% of the budget in 2004. Eight missionary groups were active with each having "hands on" involvement in a missions focus. "If my experience in Pelham taught me pastoral and community skills," Gray says, "then it is clear that God led me to High Point to sharpen my administrative skills and to heighten my passion for missions."

If you ask him of his proudest personal accomplishments, he is quick to respond, but his answer may surprise some. He does not point to any particular season of ministry, but to his pride in his four sons. He "adopted" three teenage boys in his Pelham congregation and provided for their support and growth into men. His oldest is a firefighter in High Point, his middle son is enlisted in the U. S.

Navy, and his youngest is a minister in Arkansas. "I'm so grateful to God for my sons, daughters-in-law and seven grandchildren," he says with a broad grin. "They have brought such special meaning to my life in wonderfully, extraordinary ways. I just hope that I've been as good a dad to them as they have

been sons, daughters, and grandkids to me." After coming to High Point, his family grew as he added a fourth son to his family circle who is now a graduate student in Durham.

When asked of his priorities for his new role of Executive Secretary-Treasurer, he lists stabilizing the

Convention's financial standing at the top of his list. "If we do not quickly bring our financial house in order, we will threaten our ability to do missions in this State." Beyond that, he wants to establish the necessary controls to insure that funds designated for objectives are forwarded in a timely manner. He realizes that increasing efficiency and widening accountability are high on his list of "things to do." Developing clear operational and administrative policies as well as updating the technology under which the Baptist Headquarters operates are high priority items. "Helping our Convention find new ways to do the old things of Christian education, missions and benevolence is going to be the bulk of my contribution as Executive Secretary-Treasurer," Gray indicates.

He moved to Raleigh just four days before the Martin Luther King, Jr. Memorial Banquet. On the Sunday before his first full-time day on the job, he united with Christian Faith Baptist Church in Raleigh. "I literally had a Church home before I had signed a lease on my house and before I had keys to my office in the Baptist Headquarters, but that's just how I wanted it to be," Gray states. Just before making the move from High Point, he realized that January would be the first time in almost

forty years that he was not connected to a Church. "That thought scared me – literally scared me – and I knew that I had to be in a Church quick, fast, and in a hurry." He reports that Dr. David C. Forbes, Sr. and Christian Faith have been a wonderfully welcoming and supportive Church family and that he is

benefiting greatly from being affiliated with that congregation.

When asked how his first month as full-time Executive Secretary-Treasurer has gone, he breaks into hearty laughter. "Outside the fact that I still have not completely unpacked and that I still get a little confused on some of the one way streets in downtown

Raleigh, I think I'm doing pretty well," he quips. "The good people of the Convention have been so warm and welcoming that I have to keep telling myself that this is not a dream. I am so looking forward to meeting them and working with them to make our Convention the strongest witness for Christ and missions in the nation." He is busy at doing just that. In his first month on the job, he has already logged almost 2,200 miles, traveling the state, meeting with General Baptists, and reflecting on how far he's come from the "backwoods of Southern Virginia."

(NOTE: The first two administrative leaders of the Convention (G. W. Watkins and J. H. Moore) had the title of General Secretary. W. C. Somerville was the first full-time Executive Secretary-Treasurer. C. E. Griffin, Thomas Kilgore, O. L. Sherrill (who was also known as "Mr. Baptist"), C. C. Craig (who was known as the first "million dollar Executive Secretary-Treasurer), and A. D. Logan, Jr. followed Sommerville in the office of Executive Secretary-Treasurer. O.S. Bullock and Reginald A. Wells have both served as Interim Executive Secretary-Treasurers; Bullock in 1940 and Wells in 2004.)

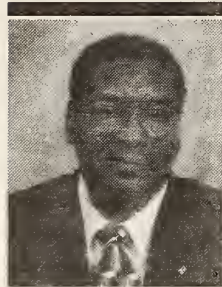

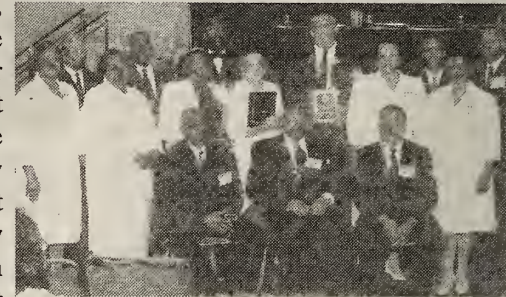

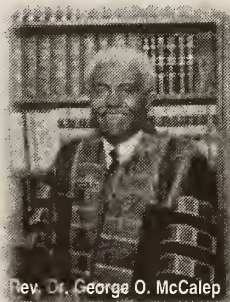

The Reverend Dr. George O. McCalep is the Distinguished Lecturer for the 2005 Leadership Summit sponsored by the Ministers Council, an auxiliary of the General Baptist State Convention. The Summit will be held in Goldsboro on March 3 and 4. Dr. McCalep, now in his twenty-sixth year as Senior Pastor of the Greenforest Community Baptist Church in Decatur, Georgia, is considered a leading authority on the subjects, of Church growth, stewardship, evangelism, Church economic empowerment, Sunday school growth, and Church leadership. Under his pastorate, Greenforest has grown from "mission" status with a membership of 25 to "mega-church" status with a membership exceeding 6,000 active persons. Greenforest operates the second largest predominately African-American Christian school in the nation. The Greenforest-McCalep Christian Academic Center enrolls 900 students in preschool through twelfth

grade. The Academic Center's offerings include an \$11,000,000.00 Early Learning Center providing early childhood development for 460 children aged from five weeks to five years old.

The Greenforest Community Development Corporation manages the Church's 161-unit apartment complex. The CDC has partnered with financial institutions to provide home ownership opportunities. Greenforest collaborates with neighboring Churches to operate the South DeKalb Church Federal Credit Union.

The 2005 Distinguished Lecturer holds a Ph.D. from Ohio State University. He has triple Masters degrees: a Master of Science from the University of Kansas, a Master of Divinity from Morehouse School of Religion at the Interdenominational Theological Center in Atlanta, a Masters degree in Educational Administration and Supervision from John

Carroll University. His undergraduate degree was earned at Alabama A & M University.

Dr. McCalep is an accomplished author. He has published twelve books including the immensely popular book, *Faithful Over A Few Things: Seven Critical Church Growth Principles*. This book has sold over 30,000 copies. He is owner of both Orman Press and Ormanpress.com. He also owns a stewardship and capital campaign consulting company, The McCalep Group.

Shaw Divinity Announces 32nd Annual Ministers Conference in March

A workshop on Bible Usage is slated for Wednesday morning, March 16. Dr. Joseph V. Crockett, Director of Research of Domestic Ministries with the American Bible Society in New York City is the workshop presenter. Rounding out the circle of participants is The Reverend

Phyllis Yvonne Murphy who will preach the Distinguished Alumni sermon on Tuesday morning, March 15. Reverend Murphy is pastor of New Metropolitan Faith Winners Baptist Church, Inc. in Durham.

In an effort to enhance preaching skills, the 2005 Ministers Conference will feature a Preaching Clinic featuring Dr. Gardner C. Taylor, Adjunct Professor of Homiletics at Shaw University Divinity School. Dr. Taylor will lead a two-part clinic on Tuesday afternoon and

Wednesday morning. Special certificates will be awarded to persons participating in the Preaching Clinic. In a unique offering, the Divinity School is offering this Preaching Clinic by video conferencing to CAPE sites across the state.

Early registration continues through March 10. Early registrations received by the cutoff date are \$85.00. Seminary students may register early for \$45.00. After March 10, registration is \$100.00 and seminary students who register after March 10 will pay \$50.00. (Persons seek-

ing registration as seminary students must provide proof of enrollment.) Individuals seeking only to participate by video conferencing at CAPE sites across the state will need to pay \$25.00 to register.

Continuing Education Units are being offered for participation in the Ministers Conference. The C.E.U. fee is \$25.00. An Alumni Luncheon will be held during the Conference and luncheon tickets may be purchased when registering. Luncheon tickets are \$15.00 each.

Lott Carey Reaches Farther

The reach of Lott Carey will touch sixteen countries by August 2005, according to Dr. David Emmanuel Goatley, Executive Secretary-Treasurer of Lott Carey Baptist Foreign Mission Convention. "By the time we gather for our Annual Session in August," says Goatley, "our missional work of evangelism, education and health will reach Australia, Jamaica, Sudan, Ghana, Kenya, Uganda, Guyana, Liberia, Zambia, Haiti, Mozambique, Zimbabwe, Italy, Nigeria, India, and South Africa"

Dr. Goatley has also announced that Lott Carey is collaborating for HIV/AIDS prevention, care and support through the All-Africa Conference of Churches based in Nairobi, Kenya. Through partnership

with the All-Africa Baptist Fellowship, headquartered in Kumasi, Ghana, Lott Carey is strengthening theological seminaries all across the African continent. Lott Carey continues to provide relief to families victimized by last year's Caribbean hurricanes in Haiti, Jamaica, and Grenada.

"We are helping survivors of the Indian Ocean tsunami through the Baptist World Alliance for Asian countries and through the All-Africa Conference of Churches for African countries," says Goatley. "In addition to our ongoing mission support around the world, Lott Carey is receiving funds to support tsunami survivors through the end of February. We are collaborating primarily with Baptist communities that are already providing essential medical, physical, and spiritual help. Our assistance will target people at the grassroots level. God is enlarging our field of work and scope of influence in a time of significant challenge and opportunity."

African-American Baptists who were committed to a substantial foreign mission thrust - especially on the African

continent founded the Lott Carey movement in 1897. They believed that nothing should distract the church from executing its primary objective of advancing God's mission throughout the world. Since the founding, Lott Carey Foreign Mission Convention has single-mindedly invested in Christian missions around the world.

North Carolina Missionary Baptists have long played a significant part in the work of Lott Carey. The North Carolina connections to Lott Carey are obvious: Dr. J. Michael Sanders, the current President of Lott Carey, is a North Carolina native and Mrs. Colene B. Stanley (of Lake Waccamaw) is the current President of Lott Carey Woman's Auxiliary. The 2005 Annual Session of Lott Carey will be held in Charlotte during the week of August 15-19. Dr. Clifford A. Jones, Sr. and Friendship Missionary Baptist Church are Lott Carey's hosts.

Contributions for foreign missions from General Baptist State Convention congregations are sent to the Baptist Headquarters in Raleigh to be forwarded to Lott Carey.

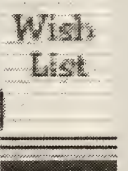

A Historical Observation: "From Barber to Preacher"

As I begin to read the biographical sketch of Dr. J. Ray Butler, I became fascinated with the potential leadership skills of his barber's training and his call to

serve the Lord. I was impressed as I began to draw a parallel between his call and the conversation that took place as the Lord talked with the prophet Isaiah (Isaiah 7:20). This passage deals with God's transmission of messages to that generation and us today.

When it was necessary for the Lord to send a message, He can use anything or anyone He wants to use. The Today's English Version of the Bible renders the passage as, "When that time comes, the Lord will hire a barber from across the Euphrates - the Emperor of Assyria, he will shave of your beard and the hair of your heads and your bodies." It appears that when the Lord was ready to send our generation a message, He called a barber from Roseboro, North Carolina.

This barber, Dr. J. Ray Butler, is a product of the local school district, and

the Harris Barber College of Raleigh. He was in Newport News, Virginia when he responded to the call to serve in the army of the Lord. Dr. Butler sought to prepare himself for the journey ahead while attending the First Baptist Church of East End in Newport News. He matriculated at Shaw University, Shaw Divinity School, Southeastern Theological Seminary, and Friendship College at Rock Hill, SC. For his academic pursuits, he received the Bachelor of Arts, Bachelor of Divinity, Master of Divinity and the Doctor of Divinity degrees. Along the way, McKinley Theological Seminary in Jackson, Mississippi honored him with an LL.D.

Dr. Butler is married to Mrs. Marion Lucas Butler and they are the proud parents of four sons. Two sons live in North Carolina while the other two sons live in Ohio. He has been the Pastor of Churches throughout North Carolina and in Baltimore, Maryland. Currently, he is the pastor of record for fourteen years plus at the United Cornerstone Baptist Church in Winston-Salem, North Carolina.

Dr. Butler is very active in the larger community. He has been involved with the Human Relations Commission, the Red Cross, Mental Health Association, United Way, and the Mayor's task forces all in the greater Winston-Salem commu-

nity.

Dr. Butler has served the General Baptist State Convention of North Carolina, Inc. in many capacities. He has served the Convention as its vice president-at-large, chairman of the General Board, chaired the Personnel Committee, and is currently the Convention's parliamentarian. He served as moderator of two General Baptist associations. Our subject also found energy and time to serve the National Baptist Convention, USA and the Lott Carey Baptist Foreign Convention in several capacities. He has

been on Lott Carey's Executive Committee and General Board. He was the featured preacher in the National Baptist Convention USA at least twice.

Dr. Butler still finds time to be a world traveler having visited fourteen countries, preaching in four of them. He has authored two books. During the administrations of North Carolina Governor Jim Hunt, Dr. Butler was appointed a member of the State Board for Licensed Contractors. The "Barber" is still preparing us for the kingdom. God bless him. ■

Black History Month

Americans have recognized black history annually since 1926, first as "Negro History Week" and later as "Black History Month".

What you might not know is that black history had barely begun to be studied – or even documented – when the tradition originated. Although blacks have been in America at least as far back as colonial times, it was not until

the 20th century that they gained a respectable presence in the history books.

Blacks Absent from History Books

We owe the celebration of Black History Month, and more importantly, the study of black history, to Dr. Carter G. Woodson. Born to parents who were former slaves, he spent his childhood working in the Kentucky coal mines and enrolled in high school at age twenty. He graduated within two years and later went on to earn a Ph.D. from Harvard. The scholar was disturbed to find in his studies that history books largely ignored the black American population – and when blacks did figure into the picture, it was generally in ways that reflected the inferior social position they were assigned at the time.

On February 1:

Feb. 1, 1926 – What is now known as Black History Month was first celebrated on this date as Negro History Week by Carter G. Woodson. It became a month long celebration in 1976.

Feb. 1, 1902 – Langston Hughes, a famous poet, was born this day in Joplin, MO.

Feb. 1, 1865 – The 13th Amendment to the U.S. Constitution, which abolished slavery, was adopted by the 38th Congress.

On February 2:

Feb. 2, 1948 – President Truman sent Congress a special message urging the adoption of a Civil Rights program, including the creation of a fair employment practices commission and anti-lynching and anti-poll tax measures.

On February 3:

Feb. 3, 1903 – Jack Johnson wins the Negro Heavyweight title.

Feb. 3, 1920 – The Negro Baseball League is founded.

On February 4:

Feb. 4, 1913 – Rosa Parks (born Rosa Louise McCauley) was born on this day.

Feb. 4, 1971 – National Guard mobilized to quell rioting in Wilmington, N.C. Two persons killed.

On February 5:

Feb. 5, 1866 – Congressman Thaddeus Stevens offered an amendment to Freedmen's Bureau Bill authorizing the distribution of public land and confiscated land to freedmen and loyal refugees in 40-acre lots.

Feb. 5, 1934 – Henry (Hank) "Home Run King" Aaron, baseball superstar, was born.

On February 6:

Feb. 6, 1820 – "Mayflower of Liberia" sailed from New York City with eighty six Blacks. Black population: 1,771,656 (18.4%).

Feb. 6, 1993 – Arthur Ashe dies. First African American tennis player to win at Wimbledon.

On February 7:

Feb. 7, 1926 – Negro History Week originated by Carter G. Woodson is observed for the first time.

On February 8:

Feb. 8, 1944 – Harry S. McAlphin, first African American to be accredited to attend the White House press conference.

Feb. 8, 1986 – Oprah Winfrey becomes the first African American woman to host a nationally syndicated talk show.

On February 9:

Feb. 9, 1944 – Novelist Alice Walker was born in Eatonton, GA.

Feb. 9, 1952 – Author Ralph Ellison's novel *Invisible Man* wins the National Book Award.

Feb. 9, 1971 – Leroy "Satchel" Paige is inducted into the Baseball Hall of Fame.

Feb. 9, 1995 – Bernard Harris, African-American astronaut, takes space walk.

On February 10:

Feb. 10, 1927 – Leontyne Price, who became an internationally acclaimed opera singer, was born in Laurel, Miss.

Feb. 10, 1964 – After 12 days of debate and voting on 125 amendments, the U.S. House of Representatives passed the Civil Rights Act of 1964 by a vote of 290 – 130.

On February 11:

Feb. 11, 1990 – Nelson Mandela is released from a South African prison after being detained for 27 years as a political prisoner.

On February 12:

Feb. 12, 1909 – The National

Association for the Advancement of Colored People (NAACP) was founded. The call for the organizational meeting was issued on 100th anniversary of Abraham Lincoln's birth by 47 whites and six blacks.

On February 13:

Feb. 13, 1923 – The first black professional basketball team, "The Renaissance", was organized.

Feb. 13, 1957 – Southern Christian Leadership Conference organized at New Orleans meeting with Martin Luther King, Jr., as president.

On February 14:

Feb. 14, 1817 – Frederick Douglass, "The Great Emancipator", is born.

Feb. 14, 1867 – Morehouse College organized in Augusta, GA. The institution was later moved to Atlanta. New registration law in Tennessee abolished racial distinctions in voting.

Feb. 14, 1936 – National Negro Congress organized at Chicago meeting attended by 817 delegates representing more than 500 organizations.

On February 15:

Feb. 15, 1851 – Black abolitionists invaded a Boston courtroom and rescued a fugitive slave.

Feb. 15, 1968 – Henry Lewis becomes the first black to lead a symphony orchestra in the United States.

On February 16:

Feb. 16, 1970 – Joe Frazier knocks out Jimmy Ellis in the second round of their New York fight and becomes the world heavyweight boxing champion.

On February 17:

Feb. 17, 1870 – Congress passed resolution readmitting Mississippi on condition that it would never change its constitution to disenfranchise blacks.

Feb. 17, 1963 – Michael Jeffrey Jordan, famed basketball player and former minor league baseball player, born in New York, N.Y.

On February 18:

Feb. 18, 1931 – Toni Morrison (born Chloe Anthony Wofford), who will win the Pulitzer Prize for her novel *Beloved*, was born on this day in Lorain, Ohio.

On February 19:

Feb. 19, 1919 – Pan-African Congress, organized by W.E.B. DuBois, met at the Grand Hotel, Paris. There were 57 delegates – 16 from the United States and 14 from Africa as well as others from 16 countries and colonies.

On February 20:

Feb. 20, 1895 – Death of Frederick Douglass. Douglass was the leading black spokesman for almost 50 years. He was a major abolitionist, lecturer, and editor.

On February 21:

Feb. 21, 1895 – North Carolina Legislature, dominated by black Republicans and white Populists, adjourned for the day to mark the death of Frederick Douglass.

Feb. 1, 1965 – Malcolm X assassinated at age 39 in the Audubon Ballroom at a rally of his organization. Three blacks were later convicted of the crime and sentenced to life imprisonment.

On February 22:

Feb. 22, 1898 – Black postmaster lynched and his wife and three daughters shot and maimed for life in Lake City, S.C.

On February 23:

Feb. 23, 1868 – Dr. William Edward Burghardt (W.E.B.) DuBois, educator and civil rights advocate, is born in Great Barrington, Mass.

Feb. 23, 1979 – Frank E. Peterson, Jr. named the first black general in the Marine Corps.

On February 24:

Feb. 24, 1868 – The House of Representatives voted, 126 to 47, to impeach President Andrew Johnson.

On February 25:

Feb. 25, 1870 – Hirman R. Revels of Mississippi was sworn in as first black U.S. Senator and first black Representative in Congress.

Feb. 25, 1948 – Martin Luther King was ordained as a Baptist minister.

Feb. 25, 1964 – Muhammad Ali defeated Sonny Liston for world heavyweight boxing title.

On February 26:

Feb. 28, 1984 – Musician and entertainer Michael Jackson won eight Grammy Awards. His album, "Thriller", broke all sales records to date and remains one of the top-grossing albums of all time. Eight ways to encourage your pastor simple acts that feed a shepherd

Sometimes pastors are the loneliest people in the church. Often their hours are long, the pay minimal, the criticism

considerable and constant. Feelings of disappointment, discouragement, and defeat may begin to plague the best of them. Paul's admonition to "serve one another in love" (Gal. 5:13) should encourage us to remember our shepherds. Here are eight ways to make their lives better.

1. Cut the criticism

A Pastor told his audience, "that the space between someone doing the best he or she can and someone in need is **holy ground**. The Holy Spirit had transformed that feeble sermon for her – and as it turned out, for me too." Unlike most workers who are evaluated once or twice a year, clergy are often critiqued weekly after each worship service. It's not unusual to hear people say "the music was poor", "the hymn selection was awful", or "the sermon was boring". We would do well to remember that most spiritual leaders work hard to make worship a unique celebration each week.

2. Pray regularly

Ask God to shower your pastor with an abundance of love, hope, joy, faith, peace, power, wisdom, and courage. Pray for your spiritual leader's maturity and growth in the faith. As you pray keep in mind this wisdom from German writer

Johann Wolfgang von Goethe: "If you treat a person as he is, he will stay as he is; but if you treat him as if he were what he ought to be, he will become what he ought to be and could be."

3. Express appreciation in writing

A spoken compliment is always welcome, but a written one can be read over and over again for years. So, when you hear or see something you like from your minister, write an appreciative note.

4. Use your skills to bless

Are you proficient with computers? Help your pastor master the church's new computer. Are you a mechanic? Offer to service the car free of charge or at a reduced fee. One pastor I know recalls: "I was pastoring my first church – a small congregation with limited resources. While there, I developed a series of dental problems and could not afford treatment. What a joy it was when a dentist in the church offered to treat me for free. Correcting my dental problem involved nearly a dozen visits. He treated me carefully and cheerfully each time. I have thought of that dentist many times since then and the memories of his kindness continue to bless my life."

5. Squelch gossip

If you hear a negative comment, respond with a positive one. If misinformation is being spread, correct it with the accurate information. Or, if people are gossiping, just walk away. Remember the Bible condemns gossip and careless speech. James 1:26 says, "If anyone considers himself religious and yet does not keep a tight rein on his tongue, he deceives himself and his

religion is worthless." And Psalm 34:13 reads, "Keep your tongue from evil and your lips from speaking lies."

6. Offer to meet a need

Some people make their spiritual leaders defensive and angry by saying, "You need to..." That approach is seldom welcome and almost always counterproductive. If you see a need, approach your spiritual leader by saying, "I'd like to help by..." If you see an area that can be improved, take responsibility for working on it. Be an active participant in your church. Get involved by teaching a class, leading a workshop, singing in the choir, feeding the hungry. Ask your spiritual leader where and how you can employ your gifts.

7. Be openly responsive

Nothing so animates and excites a spiritual leader as seeing people respond to the preaching and teaching. Imagine the surprise and delight of a pastor in your city, who, when greeting a visitor to our church, found he or she came because of the kindness of a church member who was a neighbor. One pastor's heart filled with joy when a group of women in Washington, D.C., responded to a sermon preached from the words of Jesus – "Do not judge, or you too will be judged"

(Matt. 7:1). After hearing the sermon, the women decided to give a baby shower for the young woman who provided childcare while they met for Bible study. She was unmarried, close to going on welfare, and without support from her family or the father-to-be. The young woman was moved to tears by the surprise baby shower. Later, the women explained to the pastor, "Your sermon taught us that it's possible to reach out to someone in need – in this case, an unwed mother – without judging or condoning the situation."

8. Throw away the measuring stick

Don't expect that your present spiritual leaders will do things the same way their predecessors did. Lay aside personal agendas and preferences. Instead, focus on how your leader is being used by God to do effective ministry now. By serving your shepherds, you will ensure that they will not only be encouraged but will feel appreciated and continue to minister with enthusiasm and energy.

A friend is someone who stays with you in the bad weather of life, guards you when you are off your guard, restrains your impetuosity, delights in your wholeness, forgives your failures, does not forsake you when others let you down.

The friendship of Jesus enables us to see others as he saw the apostles: flawed by good children of the Father.

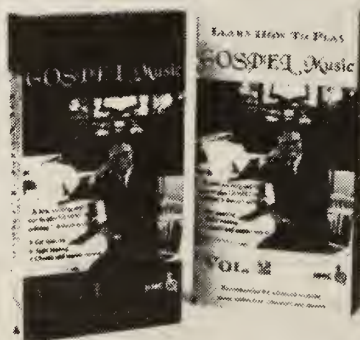

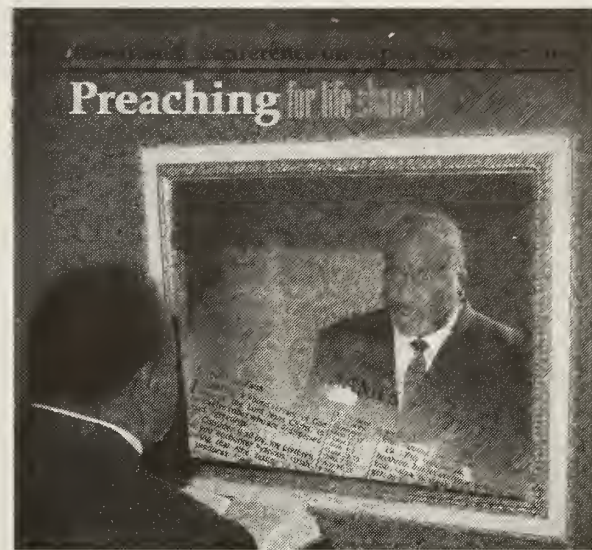
