PROCEEDINGS.

SHADY GROVE CHURCH, January 12th, 1912.

In pursuance to a call made the Church at Shady Grove, with others, assembled at said Church on Friday, the 12th day of January, A. D. 1912, at 12 o'clock M.

The assembly was called to order by Bro. W. A. Jackson who, after praise and prayer, stated in a few brief remarks the purpose of the meeting.

Bro. E. R. Wilson was called to act as Moderator, *pro tem.*, and Bro. W. A. Jackson as Secretary, *pro tem.*

On motion, there be a Committee from said Church appointed to draft resolutions as to the further action of the meeting. The following are appointed, *viz.* Bros. Ransom West, W. A. Jackson, E. R. Wilson.

The report of the committee on resolutions is made as follows :

REPORT.

Whereas, The Church at Shady Grove having been denied representation in the last session of the Annual Conference, without a charge; be it

Resolved, 1st. That in pursuance to a call made by said Church on the 27th day of Nov., 1911, notice being duly given, do hereby assemble ourselves at said Church on the 12th day of January, A. D. 1912, and pledge ourselves to the support of the doctrine of the Original Free Will Baptists.

Resolved, 2nd. Seeing that the so-called Cape Fear Conference has departed from the Faith of the aforesaid Original Doctrine of the Free Will Baptists on the subject of *Sanctification*, and the *Baptism of the Holy Ghost*, and the *Speaking in Tongues as the only Evidence*.

We therefore invite all Churches and Ministers who believe in the Original Doctrine as practiced by the Free Will Baptists, set forth in the Discipline of the Cape Fear Conference prior to the revision in 1899, to unite in the deliberations of this body.
