

#### RULES OF DECORUM

N. C. 27215—Phone 584-8380

The Association shall be opened and closed by prayer.
 Only one person shall speak at a time, who shall rise from his seat and address the Moderator in the beginning of his speech.

3. Every brother speaking shall adhere strictly to the subject under consideration, and shall in no way reflect on any brother.

4. No messenger shall absent himself from the Association while in

conference without permission.

5. No messenger shall speak more than three times on the same subject without permission from the Association.

6. Messengers shall keep strict order while the business of the

Association is being transacted.

7. No messenger shall be interrupted while speaking unless he violates the Rules of Decorum.

8. No messenger shall address another in any other term or ap-

pellation other than the title of brother.

9. The names of the members composing the Association shall be enrolled by the Clerk and called over as often as the Association requires.

10. The Moderator shall not speak on any question before the Assoction until all the other messengers are through speaking, he may give his views, after any messenger, having a right to speak, may reply to any new matter introduced by the Moderator.

11. Any member who shall violate any of the rules of the Associa-

tion shall be dealt with by the Association as it deems proper.

#### ARTICLES OF FAITH

1. We believe in only one true and living God, who rules all things after His own will, and that He, who created all things, is infinite in power, wisdom, knowledge, and goodness, eternal, immortal, invisible, and unchangeable and that this God has revealed Himself in His word under the character of Father, Son, and Holy Ghost, and that there are three that bear witness in earth: the Spirit, the water and the blood, and that these three agree in one.

2. We believe that the Holy Scriptures of the Old and New Testaments are the written word of God and are sufficient rule of faith and practice. They are given by inspiration of God and are profitable for doctrine, for reproof, for correction, and for instruction in righteousness that the man of God may be perfect, thoroughly furn-

ished unto all good works.

3. We believe that Christ died and made a complete atonement for all who ever did, do now, or ever will believe on His name and that all who are finally saved were given to Christ in covenant of the Father before the world was, that they should show forth His praise.

4. We believe that all whom God did foreknow He did also predestinate to be conformed to the image of His Son; that God elected according to His foreknowledge through the sanctification of the Spirit unto obedience and sprinkling of the blood of Jesus Christ, all who are finally saved to an inheritance incorruptible and unde-

filed and that fadeth not away, reserved in heaven for all true saints, and that none come to Christ only those whom He loved with an everlasting love and in due time calls to everlasting glory.

5. We believe in the doctrine of original sin.

6. We believe in man s impotency to recover himself from the fallen state he is in by his own will and ability.

7. We believe that sinners are justified in the sight of God only by

the imputed righteousness of Christ.

8. We believe that God's elect will be called, converted, regenerated, and sanctified by the Holy Spirit.

9. We believe the saints will persevere in grace and never finally

fall away.

10. We believe that baptism and the Lord's Supper are ordinances of Jesus Christ and that true believers are the only proper subjects of the ordinances, and that the true mode of baptism is by immersion.

11. We believe in the resurrection of the dead, and a general

judgment.

- 12. We believe the punishment of the wicked will be eternal and the joys of the righteous everlasting.
- 13. We believe that no minister has the right to administer the ordinances, only such as are regularly called and have come under the imposition of the hands of the presbytery.

- 9. The names of the members composing the Association shall be enrolled by the Clerk and called over as often as the Association requires.
- 10. The Moderator shall not speak on any question before the Association until all the other messengers are through speaking, he may give his views, after any messenger, having a right to speak, may reply to any new matter introduced by the Moderator.
- 11. Any member who shall violate any of the rules of the Association shall be dealt with by the Association as it deems proper.

#### ARTICLES OF FAITH

- 1. We believe in only one true and living God, who rules all things after His own will, and that He, who created all things, is infinite in power, wisdom, knowledge, and goodness, eternal, immortal, invisible, and unchangeable and that this God has revealed Himself in His word under the character of Father, Son, and Holy Ghost, and that there are three that bear witness in earth: the Spirit, the water and the blood, and that these three agree in one.
- 2. We believe that the Holy Scriptures of the Old and New Testaments are the written word of God and are sufficient rule of faith and practice. They are given by inspiration of God and are profitable for doctrine, for reproof, for correction, and for instruction in righteousness that the man of God may be perfect, thoroughly furnished unto all good works.
- 3. We believe that Christ died and made a complete atonement for all who ever did, do now, or ever will believe on His name and that all who are finally saved were given to Christ in covenant of the Father before the world was, that they should show forth His praise.
- 4. We believe that all whom God did foreknow He did also predestinate to be conformed to the image of His Son; that God elected according to His foreknowledge through the sanctification of the Spirit unto obedience and sprinkling of the blood of Jesus Christ, all who are finally saved to an inheritance incorruptible and undefiled and that fadeth not away, reserved in heaven for all true saints, and that none come to Christ only those whom He loved with an everlasting love and in due time calls to everlasting glory.
  - 5. We believe in the doctrine of original sin.

- 6. We believe in man's impotency to recover himself from the fallen state he is in by his own will and ability.
- 7. We believe that sinners are justified in the sight of God only by the imputed righteousness of Christ.
- 8. We believe that God's elect will be called, converted, regenerated, and sanctified by the Holy Spirit.
- 9. We believe the saints will persevere in grace and never finally fall away.

- 13. We believe that no minister has the right to administer the ordinances, only such as are regularly called and have come under the imposition of the hands of the presbytery.

#### RULES OF DECORUM

1. The Association shall be opened and closed by prayer.

2. Only one person shall speak at a time, who shall rise from his seat and address the Moderator in the beginning of his speech.

3. Every brother speaking shall adhere strictly to the subject under

consideration, and shall in no way reflect on any brother.

4. No messenger shall absent himself from the Association while in conference without permission.

5. No messenger shall speak more than three times on the same subject without permission from the Association.

6. Messengers shall keep strict order while the business of the Association is being transacted.

7. No messenger shall be interrupted while speaking unless he violates the Rules of Decorum.

8. No messenger shall address another in any other term or appellation other than the title of brother.

9. The names of the members composing the Association shall be enrolled by the Clerk and called over as often as the Association requires.

10. The Moderator shall not speak on any question before the Association until all the messengers are through speaking, he may give his views, after any messenger, having a right to speak, may reply to any new matter introduced by the Moderator.

11. Any member who shall violate any of the rules of the Association

shall be dealt with by the Association as it deems proper.

#### ARTICLES OF FAITH

1. We believe in only one true and living God, who rules all things after His own will, and that He, who created all things, is infinite in power, wisdom, knowledge, and goodness, eternal, immortal, invisible, and unchangeable and that this God has revealed Himself in His word under the character of Father, Son, and Holy Ghost, and that there are three that bear witness in earth; the Spirit, the water and the blood and that these three agree in one.

2. We believe that the Holy Scriptures of the Old and New Testaments are the written word of God and are sufficient rule of faith and practice. They are given by inspiration of God and are profitable for doct-

rine, for reproof, for correction, and for instruction in righteousness that the man of God may be perfect, thoroughly furnished unto all good works.

3. We believe that Christ died and made a complete atonement for all who ever did, do now, or ever will believe on His name and that all who are finally saved were given to Christ in covenant of the Father

before the world was, that they should show forth His praise.

4. We believe that all whom God did foreknow He did also predestinate to be conformed to the image of His Son; that God elected according to His foreknowledge through the sanctification of the Spirit unto obedience and sprinkling of the blood of Jesus Christ, all who are finally saved to an inheritance incorruptible and undefiled and that fadeth not away, reserved in heaven for all true saints, and that none come to Christ only those whom He loved with an everlasting love and in due time calls to everlasting glory.

5. We believe in the doctrine of original sin.

6. We believe in man's impotency to recover himself from the fallen state he is in by his own will and ability.

7. We believe that sinners are justified in the sight of God only by the imputed righteousness of Christ.

8. We believe that God's elect will be called, converted, regenerated, and sanctified by the Holy Spirit.

 We believe the saints will persevere in grace and never finally fall away.

- 10. We believe that baptism and the Lord's Supper are ordinances of Jesus Christ and that true believers are the only proper subjects of the ordinances, and that the true mode of baptism is by immersion.
  - 11. We believe in the resurrection of the dead, and a general judgment.

12. We believe the punishment of the wicked will be eternal and the joys of the righteous everlasting.

13. We believe that no minister has the right to administer the ordinances, only such as are regularly called and have come under the imposition of the hands of the presbytery.

#### RULES OF DECORUM

1. The Association shall be opened and closed by prayer.

2. Only one person shall speak at a time, who shall rise from his seat and address the Moderator in the beginning of his speech.

3. Every brother speaking shall adhere strictly to the subject under consider-

ation, and shall in no way reflect on any brother.

- 4. No messenger shall absent himself from the Association while in conference without permission.
- 5. No messenger shall speak more than three times on the same subject without permission from the Association.
- 6. Messengers shall keep strict order while the business of the Association is being transacted.
- 7. No messenger shall be interrupted while speaking unless he violates the Rules of Decorum.
- 8. No messenger shall address another in any other term or appellation other than the title of brother.
- 9. The names of the members composing the Association shall be enrolled by the Clerk and called over as often as the Association requires.
- 10. The Moderator shall not speak on any question before the Association until all the messengers are through speaking, he may give his views, after which any messenger, having the right to speak, may reply to any new matter introduced by the Moderator.
- 11. Any member who shall violate any of the rules of the Association shall be dealt with by the Association as it deems proper.

#### ARTICLES OF FAITH

1. We believe in only one true and living God, who rules all things after His own will, and that He, who created all things, is infinite in power, wisdom, knowledge, and goodness, eternal, immortal, invisible, and unchangeable and that this God has revealed Himself in His word under the character of Father, Son, and Holy Ghost, and that there are three that bear witness in earth; the Spirit, the water and the blood and that these three agree in one.

2. We believe that the Holy Scripture of the Old and New Testaments are the written word of God and are sufficient rule of faith and practice. They are given by inspiration of God and are profitable for doctrine, for reproof, for correction, and for instruction in righteousness that the men of God may be perfect, thor-

oughly furnished unto all good works.

3. We believe that Christ died and made a complete atonement for all who ver did, do now, or ever will believe on His name and that all who are finally aved were given to Christ in covenant of the Father before the world was, that

hey should show forth His praise.

4. We believe that all whom God did foreknow He did also predestinate to be onformed to the image of His Son; that God elected according to His foreknowedge through the sanctification of the Spirit unto obedience and sprinkling of he blood of Jesus Christ, all who are finally saved to an inheritance incorruptle and undefiled and that fadeth not away, reserved in heaven for all true

saints and that none come to Christ only those whom He loved with an everlasting love and in due time calls to everlasting glory.

5. We believe in the doctrine of original sin.

6. We believe in man's impotency to recover himself from the fallen state he is in by his own will and ability.

7. We believe that sinners are justified in the sight of God only by the imput-

ed righteousness of Christ.

8. We believe that God's elect will be called, converted, regenerated, and sanctified by the Holy Spirit.

9. We believe the saints will persevere in grace and never finally fall away.

10. We believe that baptism and the Lord's Supper are ordinances of Jesus Christ and that true believers are the only proper subjects of the ordinances, and that the true mode of baptism is by immersion.

11. We believe in the resurrection of the dead, and a general judgment.

12. We believe the punishment of the wicked will be eternal and the joys of the righteous everlasting.

13. We believe that no minister has the right to administer the ordinances, only such as are regularly called and have come under the imposition of the hands of the presbytery.

RULES OF DECORUM

1. The Association shall be opened and closed by prayer.

2. Only one person shall speak at a time, who shall rise from his seat and address the Moderator in the beginning of his speesh.

shall in no way reflect on any brother,

4. No messenger shall absent himself from the Association while in conference without permission. 5. No messenger shall speak more than three times on the same subject without per-

mission from the Association.

6. Messengers shall keep strict order while the business of the Association isbeing

- transacted. 7. No messenger shall be interrupted while speaking unless he violates the Rules of Decorum.
- 8. No messenger shall address another in any appellation other than the title of brother.

9. The names of the members composing the Association shall be enrolled by the

Clerk and called over as often as the Association requires. 10. The Moderator shall not speak on any question before the Association until all the messengers are through speaking, he may give his views, after which any messenger having the right to speak, may reply to any new matter introduced by the Moderator.

11. Any member who shall violate any of the rules of the Association shall be dealt

with by the Association as it deems proper.

#### ARTICLES OF FAITH

1. We believe in only one true and living God, who rules all things after His own will, and that He, who created all things, is infinite in power, wisdom, knowledge, and goodness, eternal, immortal, invisible, and unchangeable and that this God has revealed Himself in His word under the character of Father, Son, and Holy Ghost, and that there are three that bear witness in earth; the Spirit, the water and the blood and that these three agree in one.

2. We believe that the Holy Scripture of the Old and New Testaments are the written word of God and are sufficient rule of faith and practice. They are given by inspiration of God and are profitable for doctrine, for reproof, for correction, and for instruction in righteousness that the men of God may be perfect, thoroughly furnished unto all good

works.

3. We believe that Christ died and made a complete atonement for all who ever did do now, or ever will believe on His name and that all who are finally saved were given to Christ in covenant of the Father before the world was, that they should show forth

His praise.

4. We believe that all whom God did foreknow He did also predestinate to be conformed to the image of His Son; that God elected according to His foreknowledge through the sanctification of the Spirit unto obedience and sprinkling of the blood of Jesus Christ, all of who are finally saved to an inheritance incorruptible and undefiled and that fadeth not away, reserved in heaven for all true saints and that none come to Christ only those whom He loved with an everlasting love and in due time calls to everlasting glory.

5. We believe in the doctrine of original sin.

6. We believe in man's impotency to recover himself from the fallen state he is in by his own will an ability.

7. We believe that sinners are justified in the sight of God only be the imputed

righteousness of Christ.

8. We believe that God's elect will be called, converted, regenerated, and sanctified by the Holy Spirit.

9. We believe the saints will persevere in grace and never finally fall away.

10. We believe that baptism and the Lord's Supper are ordinances of Jesus Christ and

that true believers are the only proper subjects of the ordinances, and that the true mode of baptism is by immersion.

11. We believe in the resurrection of the dead, and a general judgement.

12. We believe the punishment of the wicked will be eternal and the joys of the right-

eous everlasting.

13. We believe that no minister has the right to administer the ordinances, only such as are regularly called and have come under the imposition of the hands of the presbytery.

#### RULES OF DECORUM

1. The Association shall be opened and closed by prayer.

2. Only one person shall speak at a time, who shall rise from his seat and address the Moderator in the beginning of his speech.

3. Every brother speaking shall adhere strictly to the subject under

consideration, and shall in no way reflect on any brother.

4. No messenger shall absent himself from the Association while in conference without permission.

5. No messenger shall speak more than three times on the same sub-

ject without permission from the Association.

6. Messengers shall keep strict order while the business of the Association is being transacted.

7. No messenger shall be interrupted while speaking unless he violates the Rules of Decorum.

- 8. No messenger shall address another in any appellation other than the title of brother.
- 9. The names of the members composing the Association shall be enrolled by the clerk and called over as often as the Association reauires.
- 10. The Moderator shall not speak on any question before the Association until all the messengers are through speaking, when he may give his views, after which any messenger having the right to speak, may reply to any new matter introduced by the Moderator.

11. Any member who shall violate any of the rules of the Association shall be dealt with by the Association as it deems proper.

#### ARTICLES OF FAITH

1. We believe in only one true and living God, who rules all things after His own will, and that He, who created all things, is infinite in power, wisdom, knowledge, and goodness, eternal, immortal, invisible, and unchangeable and that this God has revealed Himself in His word under the character of Father, Son, and Holy Ghost, and that there are three that bear witness in earth; the Spirit, the water and the blood and that these three agree in one.

2. We believe that the Holy Scripture of the Old and New

Testaments are the written word of God and are sufficient rule of faith and practice. They are given by inspiration of God and are profitable for doctrine, for reproof, for correction, and for instruction in righteousness that the men of God may be perfect, thoroughly furnished unto all good works.

3. We believe that Christ died and made a complete atonement for all who ever did, do now, or ever will believe on His name and that all who are finally saved were given to Christ in covenant of the Father before the world was, that they should show forth His praise.

4. We believe that all whom God did foreknow, He did also predestinate to be conformed to the image of His Son, that God elected according to His foreknowledge through the sanctification of the Spirit unto obedience and sprinkling of the blood of Jesus Christ, all of who are finally saved to an inheritance incorruptible and undefiled and that fadeth not away, reserved in heaven for all true saints and that none come to Christ only those whom He loved with an everlasting love and in due time calls to everlasting glory.

5. We believe in the doctrine of original sin.

6. We believe in man's impotency to recover himself from the fallen state he is in by his own will and ability.

7. We believe that sinners are justified in the sight of God only by

the imputed righteousness of Christ.

8. We believe that God's elect will be called, converted, regenerated, and sanctified by the Holy Spirit.

9. We believe the saints will persevere in grace and never finally fall

away.

10. We believe that baptism and the Lord's Supper are ordinances of Jesus Christ and that true believers are the only proper subjects of the ordinances, and that the true mode of baptism is by immersion.

11. We believe in the resurrection of the dead, and a general judge-

ment.

12. We believe the punishment of the wicked will be eternal and the

joys of the righteous everlasting.

13. We believe that no minister has the right to administer the ordinances, only such as are regularly called and have come under the imposition of the hands of the presbytery.

- 9. The names of the members composing the Association shall be enrolled by the Clerk and called over as often as the Association requires.
- 10. The Moderator shall not speak on any question before the Association until all the other messengers are through speaking, he may give his views, after any messenger, having a right to speak, may reply to any new matter introduced by the Moderator.
- 11. Any member who shall violate any of the rules of the Association shall be dealt with by the Association as it deems proper.

#### ARTICLES OF FAITH

- 1. We believe in only one true and living God, who rules all things after His own will, and that He, who created all things, is infinite in power, wisdom, knowledge, and goodness, eternal, immortal, invisible, and unchangeable and that this God has revealed Himself in His word under the character of Father, Son, and Holy Ghost, and that there are three that bear witness in earth: the Spirit, the water and the blood, and that these three agree in one.
- 2. We believe that the Holy Scriptures of the Old and New Testaments are the written word of God and are sufficient rule of faith and practice. They are given by inspiration of God and are profitable for doctrine, for reproof, for correction, and for instruction in righteousness that the man of God may be perfect, thoroughly furnished unto all good works.
- 3. We believe that Christ died and made a complete atonement for all who ever did, do now, or ever will believe on His name and that all who are finally saved were given to Christ in covenant of the Father before the world was, that they should show forth His praise.

#### RULES OF DECORUM

1. The Association shall be opened and closed by prayer.

2. Only one person shall speak at a time, who shall rise from his seat and address the Moderator in the beginning of his speech.

3. Every brother speaking shall adhere strictly to the subject under consideration, and shall in no way reflect on any brother.

4. No messenger shall absent himself from the Association while in conference without permission.

5. No messenger shall speak more than three times on the same subject without permission from the Association.

6. Messengers shall keep strict order while the business of the Association is being transacted.

7. No messenger shall be interrupted while speaking unless he violates the Rules of Decorum.

8. No messenger shall address another in any other term or appellation other than the title of brother.

9. The names of the members composing the Association shall be enrolled by the Clerk and called over as often as the Association requires.

10. The Moderator shall not speak on any question before the Association until all the other messengers are through speaking, he may give his views, after any messenger, having a right to speak, may reply to any new matter introduced by the Moderator.

11. Any member who shall violate any of the rules of the Association

shall be dealt with by the Association as it deems proper.

#### ARTICLES OF FAITH

1. We believe in only one true and living God, who rules all things after His own will, and that He, who created all things, is infinite in

power, wisdom, knowledge, and goodness, eternal, immortal, invisible, and unchangeable and that this God has revealed Himself in His word under the character of Father, Son, and Holy Ghost, and that there are three that bear witness in earth: the Spirit, the water and the blood, and that these three agree in one.

2. We believe that the Holy Scriptures of the Old and New Testaments are the written word of God and are sufficient rule of faith and practice. They are given by inspiration of God and are profitable for doctrine, for reproof, for correction, and for instruction in righteousness that the man of God may be perfect, thoroughly furnished unto all good works.

3. We believe that Christ died and made a complete atonement for all who ever did, do now, or ever will believe on His name and that all who are finally saved were given to Christ in covenant of the Father before

the world was, that they should show forth His praise.

4. We believe that all whom God did foreknow He did also predestinate to be conformed to the image of His Son; that God elected according to His foreknowledge through the sanctification of the Spirit unto obedience and sprinkling of the blood of Jesus Christ, all who are finally saved to an inheritance incorruptible and undefiled and that fadeth not away, reserved in heaven for all true saints, and that none come to Christ only those whom He loved with an everlasting love and in due time calls to everlasting glory.

5. We believe in the doctrine of original sin.

6. We believe in man's impotency to recover himself from the fallen state he is in by his own will and ability.

7. We believe that sinners are justified in the sight of God only by the

imputed righteousness of Christ.

8. We believe that God's elect will be called, converted, regenerated, and sanctified by the Holy Spirit.

9. We believe the saints will persevere in grace and never finally fall

away.

- 10. We believe that baptism and the Lord's Supper are ordinances of Jesus Christ and that true believers are the only proper subjects of the ordinances, and that the true mode of baptism is by immersion.
  - 11. We believe in the resurrection of the dead, and a general judgment.

12. We believe the punishment of the wicked will be eternal and the joys of the righteous everlasting.

13. We believe that no minister has the right to administer the ordinances, only such as are regularly called and have come under the imposition of the hands of the presbytery.
