MID-SUMMER ADJOURNED SESSION

Presbyterian Church, Falkland, N. C.

July 15, 1941, 10:30 A. M.

Albemarle Presbytery met in mid-summer adjourned session at the Presbyterian Church, Falkland, N. C., at 10:30 A. M., July 15, 1941, and was called to order by the Moderator, Rev. J. Norton Dendy, and constituted with prayer by Rev. R. S. Boyd, D.D.

After a devotional conducted by the Moderator, the roll was called and a quorum found present, as follows:

Rev. I. S. McElroy, of Kings Mountain Presbytery, was introduced and invited to sit as a visiting brother. Mr. Monroe Wicker, assisting in the work at New Bern for the summer, a candidate of Mecklenburg was present as a visitor.

Rev. R. E. McClure presented a bulletin on Home Missions which was received as information.

Mr. McClure also made a summary report of the Young People's Conference held at Peace College July 7-12, 1941. The report was received as information and the Presbytery by a rising vote expressed appreciation for the work of Mr. McClure at the Conference. Rev. Hugh E. Powel succeeds Mr. McClure as director of the Conference for 1942.

Rev. Chester Alexander, Chairman of the Presbytery's Committee on Home Missions, made a verbal report for that committee which was received as information.

Rev. I. S. McElroy, representing the American Bible Society, made an inspirational address on the work of that agency of our church.

Rev. L. R. Scott, D.D., commissioner to the General Assembly, made an oral report and called special attention to some of the actions of the Assembly.

Rev. J. Norton Dendy and Ruling Elder J. C. Corbett, also commissioners, made oral reports of their attendance.

Rev. R. S. Boyd, D.D., made an oral report for the Committee on Evangelism and Spiritual Life which was received as information. Upon vote it was ordered that this committee arrange a special conference on Evangelism and Spiritual Life at some convenient time and place in the fall.

The time of the Fall meeting was set for 11 A. M., Tuesday, October 14th.

Rev. H. R. McFadyen, pastor of the Pinetops Church, extended an invitation to hold the Fall meeting there, and the invitation was accepted, subject to it being possible to use the new church building. Rev. L. R. Scott, D.D., pastor of the Goldsboro Church extended an invitation conditioned upon the inability of the Pinetops Church to entertain the Presbytery at this time.

Presbytery took recess until 2:15, and was dismissed with prayer by Rev. H. R. McFadyen.

2:15 P. M.

Presbytery reconvened for the afternoon session and was opened with prayer by Rev. L. R. Scott, D.D.

Rev. Chester Alexander made a further report for the Home Mission Committee, which was received as information, and the following recommendation was adopted as presented:

Commission On Morton Church

That Presbytery appoint a commission to visit the Morton Church to confer with said church regarding the immediately needed repairs to their building and the future of the church.

That said commission be given power to act in the matter of repairs and make a report with recommendations touching any other matters deemed wise.

The Commission appointed was: Rev. R. S. Boyd, D.D., Chairman, Rev. L. R. Scott, D.D., and Rev. H. R. McFadyen, Ministers, with Ruling Elder W. A. Dees. Rev. Norman Johnson and Ruling Elder J. Nat Harrison were named alternates.

Rev. J. A. Satterfield made a report for the Committee on Thanks.

The minutes were read and approved and Presbytery adjourned with prayer led by Rev. L. W. Kessler.

ORDERED MEETING

Albemarle Presbytery, Barium Springs, N. C.
September 22, 1941

Albemarle Presbytery met at the order of the Synod of North Carolina, upon a request of two Ministers and two Ruling Elders, upon adjournment of the evening session on Tuesday, September 22, 1941, at Barium Springs, N. C.

Enrollment

Rev. J. Norton Dendy called the meeting to order, as the last moderator present, and opened the session with prayer.

The Order of Synod was read, as follows:

1. To consider matters relative to the building of the manse at Leggett's, and take such action as may be deemed wise.
2. To consider the advisability of changing the time of the Fall Meeting and take appropriate action thereon.

The Presbytery voted to take up the second item first.

The matter was discussed, but the apparent conflicts were not deemed sufficient to change the time fixed earlier in the summer, and no motion was made. Hence the item was passed over without action.

On the second item, Presbytery was advised by Rev. Chester Alexander that it had been found impossible to build the type house deemed wise at Leggetts for a manse for that field on the initial sum designated (\$4,500, of which \$1,500 was to be borrowed. See Printed Minutes, 1940-1941, page 27).

After full discussion, upon motion duly seconded and carried, the Presbytery authorized a loan not to exceed \$2,400 (instead of the original \$1,500) against this new manse property at Leggetts, to be executed by the Trustees of Presbytery.

There being no further business, the Presbytery adjourned and was dismissed with prayer.

105TH STATED SESSION

First Presbyterian Church, Goldsboro, N. C.

October 7, 8, 1941

The 105th semi-annual sessions of Albemarle Presbytery convened in the First Presbyterian Church, Goldsboro, N. C., at 11 A. M., October 7, 1941, and was opened with a sermon by the retiring moderator, Rev. J. Norton Dendy, on the text, "The Sabbath was made for man."

The Presbyterian communion was administered by Rev. L. R. Scott, D.D., and the Session of the host church, after which Rev. L. W. Kessler constituted the Presbytery with prayer.

Rev. R. S. Boyd, D.D., was elected moderator.

Rev. C. C. Crawford was elected Permanent Clerk, pro tem.

Rev. L. R. Scott, D.D., presented the report of the Steering Committee which included the docket and other local details of arrangement and the same was adopted and followed.

Candidate Clyde Carter, of Holston Presbytery, was present. The Stated Clerk presented a certificate of transfer from this Presbytery dismissing him to Albemarle Presbytery. Upon motion Mr. Carter was received as a Candidate under the care of Albemarle Presbytery and Rev. R. E. McClure, chairman of the Examining Committee was authorized to assign parts for subsequent examinations for ordination.

The minutes of the Commission to visit the Morton Church were admitted to record and are as follows:

Commission On Morton Church

The Commission appointed by Albemarle Presbytery to visit the Morton Church met with the congregation on Sunday afternoon, July 20th, 1941 at 3:30.

The Commission was called to order by Rev. R. S. Boyd, D.D., and was constituted with prayer. Dr. Boyd was elected Moderator and Rev. H. R. McFadyen, Clerk.

Present: Rev. R. S. Boyd, D.D., Rev. L. R. Scott, D.D., Rev. H. R. McFadyen, and Elder J. N. Harrison.

The Moderator stated the objectives of the Commission as stated in a resolution passed by Presbytery: namely, "That Presbytery appoint a Commission to visit the Morton Church to confer with said church regarding the immediately needed repairs to their building and the future of the church, That said Commission be given power to act in the matter of repairs, and make a report with recommendations touching any other matters deemed wise."

The Commission looked over the building and grounds, had free discussion with the congregation on needed repairs. It was found that the congregation and friends had raised in cash and pledges something near \$122. A new roof is needed, plaster must be put on in some places and paint inside and out. The Commission agreed to give now \$50 toward the estimated cost of a new roof and in addition agreed to give one dollar for every two raised by the congregation, over the \$200 for the roof, toward putting the house in good order.

A conference was held, led by Rev. H. R. McFadyen, with the congregation on the general subject of support of the church and Benevolent causes. All members of the commission participated.

After prayer, the Commission adjourned.

Presbytery accepted the invitation to hold its Mid-winter Adjourned Session at Jason Presbyterian Church and the time to be 10:30 A. M., January 19, 1942.

After announcements, Presbytery took recess until 2 P. M.

Presbytery reconvened at 2 P. M. and was led in prayer by Ruling Elder Henry A. Walker.

The minutes of the ad-interim called meeting at Synod were read for information.

The following standing committees were appointed by the Moderator:

The matter docketed for this meeting regarding the Celebration of the Communion of the Lord's Supper and the preaching of an appointed sermon at each stated meeting was considered.

By vote it was ordered that the Communion be celebrated at each regular Spring and Fall meeting.

By similar action the matter of requiring a special sermon was rejected.

Presbytery proceeded to consider the matters sent down by the General Assembly touching amendments to the Confession of Faith and the Book of Church Order.

Presbytery gave formal votes, taken on each item separately, approving the changes proposed by the Assembly, to wit:

The additions to the paragraphs 142 and 149 of the Book of Church Order, as quoted on pages 110, and 43 of the 1941 Minutes of the General Assembly.

The additions of the Chapters "OF THE HOLY SPIRIT" and "OF THE GOSPEL" with proof texts, as recorded on pages 111-113 of the 1941 Minutes of the General Assembly.

The Stated Clerk presented a Certificate of Dismissal of Rev. A. G. Courtenay from the Presbytery of Knoxville to the Presbytery of Albemarle. Mr. Courtenay was examined on experimental religion, on his views touching theology and church government. These were sustained severally and as a whole as satisfactory, and he was admitted to the membership of the Presbytery, subject to his signing the obligations of same.

Mr. Courtenay's resignation as Chairman of the Committee on Educational Institutions was accepted and the vacancy was referred to the Committee on Nominations.

Presbytery noted the approaching visit of Rev. C. G. Vardell, D.D., in connection with the historical celebration of the Kinston Church, and voted to send him greetings. He was ordained by this Presbytery on June 21, 1891, just fifty years ago.

Presbytery noted the illness of Ruling Elder J. B. Sparrow of the Washington church and sent greetings to him through his pastor, expressing the sincere wish for his speedy recovery.

Rev. R. S. Boyd, D.D., was instructed to convene the Home Mission Committee in the absence of the Chairman, Rev. Chester Alexander.

The report of Synod's and Assembly's Home Mission Committee was presented and received as information.

Presbytery took recess at 3:35 P. M., to allow time for committee meetings, and voted to reconvene at 8 P. M., according to the docket.

8 P. M.

Albemarle Presbytery reconvened at 8 P. M. and was led in a popular meeting on Home Missions and Evangelism by Rev. R. S. Boyd, D.D., Chairman of the permanent committee on Evangelism and Spiritual Life.

Rev. J. Norton Dendy and Rev. C. C. Crawford were heard regarding the work in their fields and Ruling Elder A. E. Gibson, of Greenville, spoke on personal evangelism.

Albemarle Presbytery met at Jason Presbyterian Church at 10:30 A. M., January 19, 1942, in Mid-Winter Adjourned Session, and was opened with prayer.

Rev. R. S. Boyd, D.D., moderator, presided over the session and the following were present:

Candidate Clyde Carter of this Presbytery was present and requested licensure and ordination. By previous arrangement Mr. Carter preached his trial sermon at 11 A. M., from the text Romans 8:18, and the Presbytery proceeded to other parts of the examination after the sermon was approved by a formal vote.

The following examinations were held in the presence of the entire Presbytery, each being sustained as satisfactory:

Rev. Chester Alexander on Theology, Rev. Z. T. Piephoff on the Sacraments, Rev. E. C. Lynch on Church Government, and Rev. R. E. McClure on the English Bible.

Rev. L. R. Scott, D.D., reported that the written parts of the examination had been placed in his hands and found to be satisfactory. These parts were:

Popular Lecture on the Second Commandment.

Thesis: Theories of the Atonement.

The Moderator had opened the examination with questions on experimental religion and motives for seeking the Gospel Ministry.

Each of the above having been sustained separately, the examination as a whole was sustained as satisfactory.

Presbytery took recess until 1:30 P. M. and was dismissed with prayer by Dr. Boyd.

1:30 P. M.

Presbytery re-convened and was opened with prayer.

The Stated Clerk read a communication from Rev. T. L. Harnesberger, now serving as supply pastor of the First Presbyterian Church of Brunswick, Ga. The letter stated that that church had called Mr. Harnesberger as permanent pastor, and that he desired Albemarle Presbytery to grant him a certificate of dismissal to Savannah Presbytery.

Mr. Harnesberger had formerly been a missionary to China as a member of this Presbytery. Upon his request he was dismissed to Savannah Presbytery, effective January 19, 1942.

Presbytery re-convened at 8:00 P. M., with Rev. Z. T. Piephoff as moderator, and was opened with prayer by Ruling Elder J. B. Sparrow.

Rev. Chester Alexander, Chairman of the Home Mission Committee, presented his report, and pending the adoption of it the Presbytery engaged in a popular meeting in the interest of this cause.

Rev. E. E. Gillespie, D.D., of Orange Presbytery, Superintendent of the Synod's Committee, was present and illustrated the work with slides showing pictures of home mission churches of the Presbytery. Men from the field spoke of their work.

Rev. R. E. McClure, Stated Clerk, announced as information the tabulation of statistics concerning the membership of the churches of the Presbytery.

The report of the Home Mission Committee was received but final action thereon was docketed for tomorrow.

The Presbytery adjourned to meet at 9 A. M., tomorrow, and was dismissed with prayer by Rev. Mr. McClure.

Presbytery re-convened at 9:15 A. M., Wednesday, with Rev. Z. T. Piephoff in the moderator's chair, in the absence of Rev. Hugh E. Powel.

Devotional exercises were conducted by Rev. H. N. McDiarmid.

Rev. J. O. Mann, D.D., of Wilmington Presbytery, and Rev. E. E. Gillespie, D.D., of Orange Presbytery, were introduced and invited to sit as visiting brethren.

Presbytery took up the unfinished business of the report of the Home Mission Committee. In connection with this report Rev. H. R. McFadyen presented his report as the treasurer of this committee.

The report and the recommendations was adopted, and is as follows:

Presbytery's Home Missions

Your committee on Home Missions submits the following report for the year ending March 31, 1942:

Under the blessing of God our home mission work has shown gratifying progress during the past year. With the exception of three fields which were vacant during the year we have splendid reports from our home mission churches and pastors.

The Hyde County field was vacant during the year. Evangelistic meetings and vacation Bible schools were held in the two churches on this field. The committee has not been able to find a suitable supply for the field so far. The Wilson County field was also vacant during the year, however, quite a bit of interest was manifested in this field under the leadership of Rev. E. C. Lynch of the Wilson church. The Ahoskie field was supplied during the year by students from Union Seminary, Richmond, Va. Efforts are being made to supply all of these vacant fields.

An outstanding piece of work was done at Elizabeth City this year under Rev. C. C. Crawford. This church is to be selfsupporting as of April 1, 1942. The money formerly allotted to pastor's salary by Assembly's, Synod's and Presbytery's Home Mission Committees is being allocated for the next four years to complete the church building, the Assembly's Home Mission Committee advancing the money. The building will be completed within a few weeks. A substantial growth in population, due to defense projects, has added quite a few members to the Elizabeth City congregation.

The Edenton church is being supplied by Mr. David Crawford of Union Seminary. He will continue his work through the summer and, with the help of another student, will carry on through next winter. Mr. W. H. Belk, of Charlotte, has made a special gift toward the work at Edenton. Mr. Crawford has also visited Plymouth and will investigate the opportunities for the establishment of a mission there. Mr. Crawford is enthusiastic over the prospects for the development of this work at Edenton and Plymouth.

The Martin County work has been faithfully carried on through the year by Rev. Z. T. Piephoff. Miss Strange, our educational worker, resigned her work in this field because of ill health. During this emergency Mrs. Piephoff has been employed as educational worker by the committee. The Bear Grass and Roberson Chapel churches are adding to their physical equipment during the year. The Community house in the Bear Grass neighborhood is now free of debt.

The La Grange-Jason field has had a good year under Rev. F. E. Manning. The auditorium of the Jason church has been completed and well furnished. A few Sunday school rooms remain to be finished. The exterior presents a handsome appearance. Mr. Manning conducted two Bible schools at prospective outposts near his churches. We regret to report that Mr. Manning is accepting work in King's Mountain Presbytery. The present plans of the committee are to group the Snow Hill church with the Jason-La Grange field.

The Nahalah-Johnson Memorial-Runnymede field suffered the loss of Rev. J. N. Dendy, who moved to Birmingham Presbytery on February 1st. On November 9, 1941 the Johnson Chapel Mission was organized into the Johnson Memorial Presbyterian Church. 108 members were dismissed to

this church by the Howard Memorial Presbyterian church of Tarboro. This church has already accepted a budget and made a canvass for this church year. Extensive repairs are now under way at the Runnymede Mission. Rev. Chester Alexander is seeking a successor to Mr. Dendy in this field.

A new grouping has placed the Nahalah and Wm. and Mary Hart churches together. Rev. L. W. Kessler has taken over the work at Nahalah along with his work at Leggett. Substantial progress has been made in the Wm. and Mary Hart Church at Leggett during the year. The new Presbytery's manse is near completion at this place. The congregation gave the committee a spacious lot for this building. They also built a garage on the lot, which becomes the property of the Presbytery.

The Pinetops-Macclesfield group has experienced a happy year under the leadership of Rev. H. R. McFadyen. The Pinetops congregation has completed its new church building without debt. This is an outstanding achievement for Mr. McFadyen and the Pinetops congregation. Mr. McFadyen has given his leadership to the Grace Chapel outpost and the Macclesfield congregation, both of which continue to grow.

Rev. A. G. Courtenay reports splendid progress in the Fountain-Snow Hill group. Substantial increases to pastor's support and to benevolences have been made during the year. The Fountain church has added to its physical equipment. Mr. Courtenay will take over the pastorate of the Falkland Church along with the Fountain Church, as a new group. The Snow Hill Church, now served by Mr. Courtenay, will be grouped with the work at Jason and La Grange.

The work at Bethlehem and Morton Churches was carried on until January 15th by Rev. J. A. Satterfield, who resigned to accept work in Concord Presbytery. Improvements in the church building at Morton were made during the year. The Bethlehem Church is being supplied by Rev. R. L. Forbis. The Morton Church is being supplied by the Men's Club of the First Presbyterian Church, Rocky Mount. Tentative plans have been made to have a summer worker in the Morton Community.

Rev. R. L. Forbis reports splendid progress in the work of the Second Presbyterian Church, Rocky Mount. This pastor has conducted the largest Bible School in the Presbytery and has led his people in making a splendid contribution to their new Educational Building. This church gave more to benevolences last year than it had ever given before.

Rev. H. M. Wilson has reported fine progress in the Farmville Church and the missions at Ballards and Carraways. In Mr. Wilson's acceptance of work in Concord, N. C., April 1st, the Presbytery has lost one of its most faithful workers.

The Committee is grateful for the loyal cooperation and sacrificial service of our home mission pastors. They have set a high standard of achievement through their labors during the past year. The Chairman was proud to present a report of their achievements to the Synod's Home Mission Committee at its meeting in Greensboro. Due to the progress made this year we were able to secure slight increases in appropriations from both the Synod's and Assembly's Committees.

The Chairman wishes to thank the churches of Presbytery for cooperating with the committee by paying the new 30% of benevolent funds into the Home Mission Treasury. This enabled us to close the year with a few hundred dollars in hand. On February 1st, Rev. H. N. McDiarmid of Kings Mountain Presbytery took up his new duties as Promotional Secretary of Home Missions in the Presbytery. Mr. McDiarmid has been busily occupied supplying vacant churches and holding conferences in regard to finances in these churches. We welcome him into our home mission fellowship. His wide experience in home mission work, especially fits him to work with the committee in the advancement of our Home Mission program. The committee, along with the Commission on the Minister and His Work, is trying to secure pastors for the vacant fields of the Presbytery.

Recommendations:

1st. That all churches of the Presbytery be asked to remit the full 305 of benevolent funds to Presbytery's Home Missions.

2nd. That the re-grouping of mission churches be approved as follows: Nahalah with Wm. and Mary Hart; Snow Hill with Jason and La Grange; Fountain with Falkland; Johnson Memorial with Runnymede Mission; Farmville with Ballard and Carraways Missions; Edenton and Plymouth; and Hyde County.

3rd. That Presbytery authorize the Home Mission Committee to investigate the La Grange work, with a view to consolidating this work with Jason and closing the La Grange Church.

4th. That all pastors cooperate with the Promotional Secretary in his efforts to present the cause of Presbytery's Home Missions to their congregations.

Rev. Chester Alexander took the moderator's chair as Rev. Z. T. Piephoff presented the following motion which was adopted:

Bear Grass Church

That Albemarle Presbytery authorize Rev. Chester Alexander Chairman of Home Missions to sign a note, along with the Trustees of the Williamston Church for \$500.00 in favor of the Home Mission Committee of the Synod of North Carolina, said money to pay for pews in Bear Grass Church, and secured by a deed of trust on the Community House at Bear Grass.

Rev. E. E. Gillespie, D.D., made an address in the interest of the Soldier's Work Committee of the Synod.

Rev. T. H. Hamilton, Presbytery's Chairman of Soldier's Work presented an appeal to Presbytery to raise their full quota for this work.

Rev. Hugh E. Powel, moderator, took the chair.

Rev. L. R. Scott, D.D., made his report as chairman of the committee on Religious Education, and pending its adoption the Presbytery heard an address by Rev. J. O. Mann, D.D., Synod's Director of Religious Education.

The report was received as information and the following recommendations adopted:

Religious Education

1. That the Presbytery's Committee on Religious Education be authorized and directed to proceed with formation of the United Religious Education Advance in accordance with the churchwide schedule.

2. That all churches be urged to observe the annual Rally Day in October, with an offering for Assembly's Religious Education.

Rev. E. C. Lynch presented the report of the Committee on

Assembly's and Synod's Home Missions

which was received as information and the following recommendations adopted:

Whereas Synod's Home Mission Committee has shown its disposition to be increasingly generous in its aid to the home mission work of Albemarle Presbytery, we recommend

1. That all pastors and churches of the Presbytery resolve to give and give the full 9 % of benevolences to Synod's Committee for its work.

2. That churches and sub-organizations of the churches donate all surplus monies possible in their treasuries, after usual objectives for the year have been met, to this special work of Synod.

3. That all sessions be urged when determining their benevolent budgets to consider the responsibility of the Assembly's Home Mission Committee to provide adequate salaries for the home mission workers in this time of increasing living costs and its obligation to pay its share of the dues of the home mission pastors who participate in the Ministers' Annuity Fund.

4. That the period, October 5-November 8, 1942, be set apart by the Presbytery as a special season for home mission study, and the week of November 1-8 be designated as the Week of Prayer and Self-Denial for Assembly's Home Missions with a general offering in all churches for this cause.

5. That the book "While It Is Day" be commended for use as the study book for the home mission period in all organizations of the church.

Rev. L. W. Kessler presented the report of the Committee on

Foreign Missions

which was adopted as a whole, and in connection with the action of the Presbytery Mr. Kessler led the body in a special prayer for our Foreign Missionaries.

Since the Fall Meetings of Presbyteries epoch making events have taken place in the world. War between the United States and the Axis powers has affected our missionary work in many ways.

The actual disabilities suffered by Foreign Missions has not been as drastic as some have supposed. Far from contemplating any contractions in our work, wherever possible, we are determined to make this a period of expansion. The present emergency offers us an opportunity in those fields where we are not restricted by circumstances of war.

Our work in Africa has suffered small disruption. The Belgian Congo remains under the control of the free Belgian government. Fifty-one of our African missionaries are now on the field and twenty-six on furlough. All branches of our work in the Congo are carrying full programs of activity. 3,125 new communicants received on profession of faith compares favorably with the most fruitful years in the history of our African work. The enrollment in the African schools under the direction of our mission has reached the amazing total of 36,866 pupils. New fields have been opened to us in Africa by recent withdrawal of another mission which has been maintaining a work in a territory adjoining our. The area thus vacated has been assigned to our mission by the Belgian authorities and this new challenge is now laid before our church. The challenge of Africa now sounds louder than before.

In Brazil new buildings and equipment were added to several of our schools greatly increasing their efficiency and attracting a larger number of students. The year witnessed the largest number of students ever enrolled in our mission schools. A board of National Missions has been organized in which the Brazilian Presbyterian Church and the missions of the Presbyterian Church U. S. and U. S. A. are cooperating on an equal basis. The Womans Auxiliary birthday gift, the largest birthday offering ever given, has been used for pioneer evangelism in Brazil. The sum of \$25,000 has been contributed to the Campinas Theological Seminary. All our missions in Brazil are asking for increases of appropriations to enable them to take advantages of opportunities now open to them. During the year we have had forty-six missionaries on the field in Brazil and six on furlough.

The present administration in Mexico is known to be friendly to the United States. The protestant church is gaining increasing recognition, to wit., there is an increasing number of candidates for the ministry, and the organization of the church is greatly improving. Our Mexico mission is calling for reinforcements and substantial increases of appropriations to meet this new time of opportunity. During the year there have been twenty-five missionaries on the field and two on furlough.

As regards China, Japan, and Korea, we have entered an entirely new era, since December and the attack on Pearl Harbor. Out of a total of 205 missionaries, 60 are still left in the Pacific area at the time of the outbreak of war. In free China, 2; In occupied China, 36; In Japan, 6; In Korea, 4; In the Philippines, 7; and in Hawaii, 5. Of these 60 missionaries, all may be regarded as interned except two in free China, and the five in the Hawaiian Islands. All communication with the missionaries in occupied China, Japan, Korea and the Philippine Islands is now cut off. Their interests are being looked after by the Swiss diplomatic corps and our state department, through the Swiss Foreign Office and the American Legation in Bern. The native churches in China, Japan and Korea are carrying on under their own leaders. The missionaries themselves are meeting their own plight with the greatest courage and faith.

While the treasurer has not been able to complete the detailed receipts and expenditures for the year, we are able to give a statement of the financial condition. Our receipts were \$771,000, a decrease of \$23,000 from last year. We have been able to meet all expenses of the year's work and to pay \$85,000 on our indebtedness. This will leave less than \$40,000 remaining.

Above all we must remain alert and sensitive to the call of a new day. We cannot tell how or where the new opportunity may come to us, but we shall expect no contraction of the missionary work of the church.

We would recommend:

1. That the Presbytery affirm anew its unwavering faith in the Gospel of Jesus Christ as the one hope of the world, and the unparalleled need for the preaching of that Gospel with all its saving power to a world at war.

2. That the attention of all congregations be called to the Foreign Mission Conference at Montreat, August 13-19, 1942.

3. That every effort be made to inform the membership of our churches of the great new opportunities that confront us in our foreign fields.

2. That Presbytery recognize that again the amount received by these beneficiaries (\$2,285.82) is in excess of the receipts from this Presbytery (\$1,600.45) by over 33 %.

3. That the churches be urged to remember this cause generously at the Christmas season.

Assembly's and Synod's Religious Education

which was received as information and the following recommendations adopted:

1. That in this critical hour every session be reminded of the urgency of the priority of the claims of Christ for a consecrated and intelligent congregational leadership to replace men now in the service, and to complete fully the increasing local and national defense demands now being made upon Presbyterian men and women.

2. That every effort be put forth to maintain the high level of Presbyterian leadership already established, by seeing that our superintendents, leaders, elders, deacons, teachers, young people and others attend summer conferences and gatherings especially arranged for them during 1942, so that there may be no flagging of their interest or effectiveness in our Church's teaching program.

3. That men's groups and young people's groups be urged to consider especially the increasing need of their services in newly organized or congested industrial centers, camp areas, and defense localities where demands for constructive Christian leadership are so pressing.

4. That every congregation be asked to hold at least one Vacation Bible School this summer, making a supreme effort to find unchurched children who may be brought into a church relationship in these days of increasing spiritual peril.

5. That congregations be urged to pray for and cooperate fully with our Executive Committee of Religious Education as it tries to meet our emergency needs in these days of chaotic business changes, and that our people be asked to direct all business possible to this Agency, remembering that all profits earned are turned back immediately into our Church's program of Christian teaching, and form the only source of income for this work.

6. That recognizing the growing number of church groups that must be helped with free materials or supplies at greatly reduced prices, every church write into its benevolent budget the full apportionment assigned by Presbytery to the Executive Committee of Religious Education and Publication, and that a substantial Rally Day offering be secured in connection with the Rally Day Program, October 4, 1942.

7. That this Presbytery take this occasion to enlist itself in the United Religious Educational Advance and empower its Committee of Religious Education to take such additional steps as may be necessary to keep our Presbytery in the forefront of this great Christian Movement.

The Woman's Auxilliary has had an exceptionally fine year under the efficient leadership of Mrs. J. C. Gardner, the Presbyterial President. This organization continues to serve with great effectiveness within and without the bounds of this Presbytery.

The following facts have been obtained from the statistical report of the Recording Secretary of the Presbyterial:

There are 26 local auxiliaries with a total membership of 1,823, and of this number 1,223 women have been enlisted in some study or service. There are 72 general circles, and 10 business women's circles. During the past year there have been 612 Bible readers, and 826 studying the Bible in some class. There are 405 members of prayer groups, with 243 members having family worship and 577 who use the "Day by Day." This is an increase over last year.
