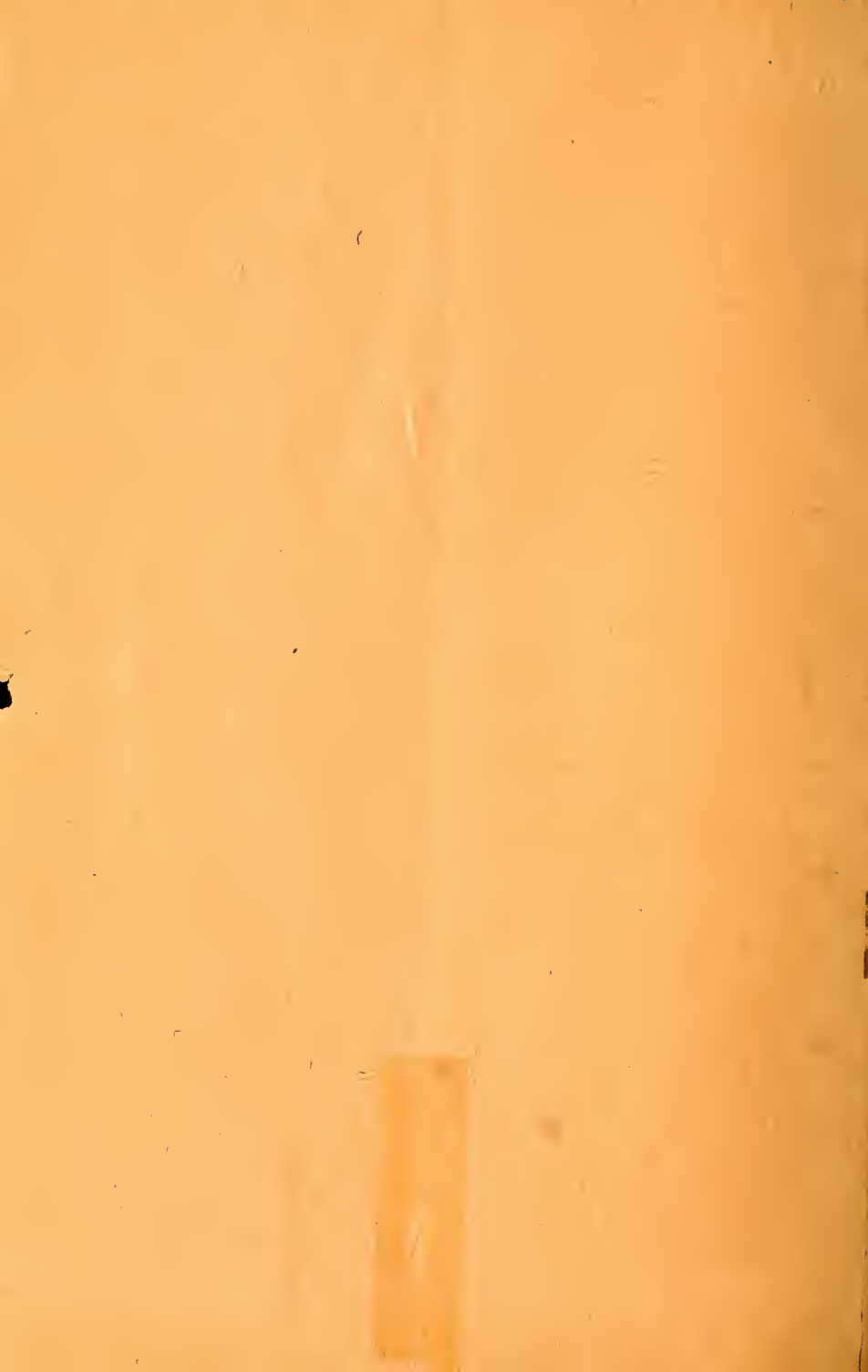

PROCEEDINGS.

The First Session of the Mitchels River Baptist Association convened with Friendship Church Dec. 11th, 12th, and 13th 1903.

The introductory sermon was delivered by Elder M. E. Pool of the Little River Association. Text, 1st Corinthians. 3:11. "For other foundation Can no man lay than that is laid which is Jesus Christ.

1 After short intermission the following Churches from the Primitive Baptist Association, to wit, Friendship, Elkin Valley, Union Cross, Oak Grove which have been recently constituted, came forward with letters and their Delegates met in Convention with Friendship Church Dec. 11, 1903.

2 Elder A. McKnight explained the cause of this convention and brother J. M. Gentry read the Church letters.

3 On motion Elders J. O. Wood and M. E. Pool acted as tellers who reported Elder W. F. Gregory, Moderator and J. M. Gentry, Clerk.

4 A motion invited the Presbytery from the Little River and Primitive Baptist Associations to especially take part in our organization when Elders A. McKnight and M. E. Pool from the Little River and Elder J. O. Wood from the Primitive took seats with us.

5. On motion to invite visiting brethren of the same faith and order when Brethren Jackson Key, Willey Hull, Henry Cook and John Law came forward and accepted seats.

6. On motion the Moderator was authorized to make all temporary appointments during the session.

7. Committee on arrangements: E. F. Cane, B. Woodruff, W. A. Melton, B. A. Freeman, J. H. Norton, with the Moderator and Clerk and visiting Brethren with them.

8. J. W. McCaw, W. A. Gentry, A. B. Woodruff Com. on finance.

9. Abram Ayers, J. F. Cooper with the delegates of this church, Com. on the ministry who reported for to-morrow, Elder A. McKnight.

10. Appointed Brethren to visit sister associations: E. F. Cain to the Mountain Union and Blue Ridge, Abram Ayers to the Little River, B. Woodruff to the Primitive.

11. On motion adjourn until to-morrow morning 9 o'clock prayer by Elder W. A. Melton benediction by Elder A. McKnight.

SATURDAY MORNING, DEC. 12, 1903.

After spending some time in devotional services, Convention lead by Elder J. O. Wood.

1. Called on the Clerk to call the roll of Delegates a quorum being present.

2. On motion the Com. of arrangement reported and was discharged.

3. On motion to take up the items as they appear on bill.

4. The clerk then read the Constitution, Rules of Decorum and Articles of faith of the Primitive Baptist Association.

5. On motion to adopt the Constitution, Rules of decorum and Articles of faith of the Primitive Baptist Association only insert the name Mitchels River in lieu of Primitive.

6. Invited visitors of the same faith and order to seat with us, none present.

7. Called on Finance Com. to report, he reported \$8.45 from the different churches.

8. Time and place for the next Association to convene with Oak Grove church two miles North of Hay Stacks on Friday before the second Sunday in November 1904. Elder W. A. Melton to preach the introduction, Elder E. F. Cain, alternate.

9. The Clerk was instructed to buy an Association book and allow him \$1-50 for his services and the remainder spent for minutes.

10. The brethren who were appointed to write correspondent letters and read them reported.

11. Appoint correspondents to Mountain Union, W. A. Melton, E. F. Cain; Blue Ridge, J. A. Norton, B. W. Snow; Little River, J. M. Gentry, B. A. Freeman, Abram Ayers, W. F. Gregory, W. A. Melton; Primitive, J. M. Gentry, W. A. Gentry, Henry Cook, A. B. Woodruff, Abram Ayers, B. A. Freeman, W. F. Gregory and J. H. Norton.

12. To return thanks to God and Brethren and sisters and kind friends of this community for their hospitality to us during this session.

13. Committee on the ministry report for to-night, first Elder E. F. Cain, second Elder W. F. Gregory, to-morrow first Elder M. E. Pool, second Elder A. McKnight.

14. The Clerk read the proceedings of this Convention and received by the body.

15. Adjourn to time and place appointed for the first session of the Mitchels River Baptist Association, song and payer by Elder A. McKnight of the Little River Association, Benediction by W. A. Melton.

SUNDAY MORNING, DEC. 13, 1903.

Services opened by singing, and prayer by the Moderator. First sermon by Elder M. E. Pool, text Revelations 3:18. Second sermon by Elder A. McKnight, text the Acts. 10:36, after which there was a hearty hand shaking and praising God and some gave their hands to be prayed for after prayer was offered by Elder B. Woodruff benediction.

Constitution.

Art. 1. This Association shall be known by the name of Mitchels River Association, and shall be composed of members chosen by the different churches in our union and duly sent to represent in the Association; who on producing letters from their respective churches, certifying their appointment, shall be entitled to their seats. Each church shall be entitled to five delegates. In their letters is to be expressed their number in full fellowship, baptized, received by letter, by application and good recommendation, dismissed by letter, excluded, and dead since the last association.

2. The number thus chosen and convened shall have no power to Lord it over God's heritage, nor shall they have any ecclesiastical power over the churches, nor shall they infringe any internal right over any church in her union.

3 The Association when convened shall be governed by a regular decorum.

4 The association shall have a Moderator and Secretary, who shall be chosen annually, by a majority of the votes of the members present, a majority of the churches being represented.

5. New churches or any regular Baptist church of Jesus Christ of our Faith and order in good standing either dismissed by letter from Sister Associations, or by applications and good recommendation, by sending up letters and delegates shall be admitted into the union.

6 Every church in the union shall be entitled to representation in the Association.

7 Every motion made and seconded shall come under the consideration of the association except it be withdrawn by the member who made it.

8 The Association shall endeavor to furnish the churches with the minutes of its proceedings, the best method for accomplishing this purpose shall be at the discretion of the future Association.

9 We think it necessary to have an Association fund to defray the expenses of the Association, and it is the duty of each church in the union to contribute such sums as they think proper to the association, and those moneys shall be deposited in the hands of a Treasurer who shall be accountable to the Association for the same and the Association shall appropriate the money thus contribute to any purpose they may think proper.

10 There shall be an association book wherein the proceedings of the Association shall be recorded by a Secretary appointed by the Association shall receive a reasonable compensation for his services.

11 The minutes of the Association shall be read and corrected, if necessary, and signed by the Moderator and Clerk before the Association adjourns,

12 Amendment to this form of Government may be made at any time by a majority of the Association, when they may deem it expedient by giving the churches twelve months notice.

13 The Association shall act as an advisory council and shall endeavor to preserve a general union of the churches, also preserve a chain of communion among the churches and give advice in matters of difficulty.

14 The Association shall inquire into the causes if any church fails to represent at any time in the Association.

15. The Association shall have power to withdraw from any church in her union that shall violate the rules of this Constitution or deviate from the orthodox principles of the Gospel.

16 The Association may correspond with Sister Associations and invite any brother in the ministry in good standing or that can bring a good recommendation of his standing, who may be of our faith and order to a seat in the Association, who may be present at the time of its sitting.

17 The Association shall have power to adjourn to any future time or place it may think proper.

18 The benevolent institutions of the day shall be no bar nor test to fellowship, but all shall be free to sustain the same as they may choose

Rules of Decorum.

1 This Association shall be opened and closed by prayer.

2 Only one person shall speak at the same time, who shall rise from his seat and address the Moderator when he is about to make his speech

3 The person thus speaking shall not be interrupted in his speech by any, except the Moderator, until he is done speaking.

4 He shall strictly adhere to his subject, and in no wise reflect on the person who speaks before, by making remarks on his slips, failings or imperfections, but shall fairly state the matter as nearly as he can, so as to convey his light or idea.

5 No person shall abruptly break off or absent himself from the Association, without liberty obtained from the body, for his absence.

6 No person shall speak more than three times on one subject; without liberty obtained from the Association.

7 No member of the Association shall have liberty of laughing during the sitting of the same nor whispering in the time of public speech.

8 No member of the Association shall address another by an other appellation than that of Brother.

9 The Moderator shall not interrupt any member, nor prohibit him from speaking until he gives his light on the subject, except he violates the Rules of Decorum

10 The names of the several members of the Association shall be enrolled by the Secretary and called over as often as the Association requires.

11 The Moderator shall be entitled to the same privilege of speech as any other member, provided the chair be filled, but he shall not vote unless the association be equally divided, then he may give the casting vote.

12 Any member who shall wilfully and knowingly break any of these rules shall be approved by the Association as shall be deemed proper.

Articles of Faith.

1 We believe in one only true and living God, Father, Son and Holy Ghost, and these three are one.

2 We believe that the Scriptures of the Old and New Testaments are the word of God, and the only rule of Faith and Practice.

3 We believe in the doctrine of Election by Grace,

4 We believe in the doctrine of Original Sin, and in man's impotency to recover himself from the fallen state he is in by nature, by his own free will and ability.

5 We believe that sinners are called, converted, regenerated and sanctified by the Holy Spirit, and all who are thus regenerated and born again by the Spirit of God, shall never fall finally again.

6 We believe that sinners are justified in the sight of God, only by the imputed righteousness of Jesus Christ.

7 We believe that Baptism, the Lord's Supper and Feet Washing are ordinances of Jesus Christ, and that true believers are the only subjects of those ordinances, and we believe the only true mode of Baptism is by immersion.

8 We believe in the resurrection of the dead and a general judgment, and that the joys of the righteous and the punishment of the wicked will be eternal.

9 We believe that no minister has the right to administer the ordinances of the Gospel, except such as are regularly called, and come under the imposition of hands by the Presbytery.

The next session will meet with Bear Creek Church, four miles north of Crutchfield, Surry county, N. C., on Friday before the second Sunday in November, 1908.

PROCEEDINGS.

1. The Fourth Annual Session of the Mitchells River Baptist Association met pursuant to adjournment of last year with Covenant Church on Friday morning, November 8th, 1907. Elder J. H. Haynes, read the 51 Psalm. Singing and prayer by Elder A. McKnight, from the Little River Association. The Introductory Sermon was delivered by Elder J. H. Norton, Text: Matt. 2 Chapter and 2 verse.

2. After a short intermission Elder W. F. Gregory opened the Association by singing and prayer.

3. Called for Associational letters, when 6 were handed in and read by the Clerk.

4. On motion published an open door for newly constituted churches, when Center View came forward and joined by letter and recommendation, and delegates were seated with the Body.

5. On motion proceeded to elect Moderator and Clerk, with Elders A. McKnight, J. N. Calloway and Bro. John Crab, from the Little River and Mountain Union Associations as tellers who reported. Elder W. F. Gregory, Moderator; J. H. Haynes, Clerk.

6. On motion invited Brethren from Corresponding Associations of the same faith and order to seats with us, when Elder A. McKnight, C. Doby, J. D. Johnson, H. Bartley, and J. M. Todd from the Little River Association came forward and was seated with the Body. From the Mountain Union, Elder J. N. Calloway; from the Primitive, John Crab and L. C. Parden.

7. On motion Correspondents and Letters were received in love and were invited to aid in counsel.

8. On motion they were seated with the Body.

9. On motion to authorize the Moderator to make all temporary appointments during the session.

A. On the Ministry, C. A. Cooper, W. A. Gentry, G. T. Butcher with the Delegates of Covenant Church.

B. On arrangements C. A. Cooper, E. F. Caine, J. W. McCraw, W. H. Melton and W. E. Norman.

C. Brethren to write Correspondent Letters: C. C. Hollyfield to the Little River. H. D. Woodruff to the Primitive. E. F. Caine to Mountain Union. J. H. Haynes, to Blue Ridge.

D. On Finance: F. W. Norman, J. M. Coe and S. L. Edmunds.

E. On Sabbath Schools: J. H. Haynes, J. H. Norton and W. A. Gentry.

F. Resolutions: Sexton Stanley, J. M. Coe and E. F. Caine.

G. Temperance: C. C. Hollyfield, F. W. Norman and W. H. Melton.

10. Committee on Ministry reported for Saturday. 1st. Elder J. N. Calloway. 2nd. Elder A. McKnight.

11. On motion adjourned till Saturday morning half past nine. Prayer by Elder J. N. Calloway. Benediction by Elder A. McKnight.

SATURDAY MORNING, NOVEMBER, 9th, 1907.

1. Met pursuant to adjournment of yesterday. After spending some time in devotional services the Association was opened by prayer by Elder E. F. Caine.

2. Clerk called roll of delegates and marked absentees.

3. Called on Committee on Arrangements to report. Report handed in and received, the items being taken up as they appeared on bill.

4. Clerk read Rules of Decorum.

5. Clerk read Minutes of yesterday which were received by the Body.

6. Committee on Temperance reported, after some remarks by W. H. Melton, J. N. Calloway, J. H. Haynes and others. Report received and Brethren discharged.

7. Committee on Sabbath Schools reported and after some remarks by the Brethren; Reports received and Committee discharged.

8. Called Committee on finance to report. Committee reported received from the different churches \$11.12. Report received and Committee discharged.

9. Called on Correspondents to report. These reported that they were received in love by sister Associations.

10. Called on Committee on Obituaries. Report received and Committee discharged.

11. Called on those who were appointed to write correspondent letters to report. Letters received and Committee discharged.

12. Committee on Ministry rerorted for Sunday 1st, Elder J. N. Calloway; 2nd, Elder A. McKnight.

13. Appointed Correspondents to Sister Associations, W. F. Gregory, W. H. Melton to Mountain Union; C. C. Hollyfield, J. M. Coe and W. F. Gregory to Little River; J. H. Norton and W. H. Melton to Blue Ridge; E. F. Caine and F. W. Norman to the Primitive.

14. On motion that we give Bro. E. F. Caine a letter of Reccommendation to the Primeville District Association in Virginia and West Virginia. Letter was granted.

15. Called on Committee on Resolutions. Report received and Brethren discharged.

16. That we grant the request of Bear Creek Church

that the next session be held with that church. The request granted.

17. Appointed Clerk treasurer and that he have 300 copies of these Minutes printed, and allow him the remainder of the money for his service.

18. The next session to be held with Bear Creek Church. Elder J. H. Haynes to preach the Introductory, and W. H. Melton, Alternate.

19. On motion that the Clerk read Minutes of to-day. Read and received.

20. On motion adjourned till time and place of next Session. Singing and prayer by the Moderator.
