PROCEEDINGS

The Radicue Primitive Baptist Association met in session with the Seven-Springs Church, Rocky Mount, N. C., commencing on Friday before the first Sunday in October 1919. Elder H. Black introduced the services by singing hymn on page 350. Elder J. H. Sones invoked the blessings of God upon the association, after which Elder H. Black preached the Introductory sermon from Isaiah 53:1.

Elder J. R. Barnes alternated, subject Isaiah 53:1.

Elder J. H. Jones preached from the same subject, after which he sang hymn on page 250 and pronounced the benediction. Elder H. Smith dismissed the association for a short recess.

Howard and Charlie Cooper be appointed committee on Agreed on motion Elder H. M. Smith, Bro. S. B. Howard and Bro. Hosea Dicken be appointed committee on Arrangement of Preaching from day to day. MINUTES

Abstracts of Principles.

We believe in one true and living God the Father, and the Holy Ghost.

We believe that the Scriptures of the Old and New Testaments

are the words of God and the only rule of faith and practice.

We believe in one Superior Eternal God the Creator and upholder of all beings and the disposer of all events for there are three that bear record in heaven; the Father, the Word, and the Holy Ghost, and these three are one. 1 John 1:5.

We believe in the total depravity and just condemnation of all

the falien race of Adam.

We believe in original sin and that the punishment of the wicked shall be everlasting and the joys of the righteous eternal. We believe that God's elect shall be called, converted, regenerated, sanctified by the Holy Ghost.

We believe that the saints shall always preserve in grace and

never finally fall away.

We believe that baptism, the Lord's supper, and the washing of the Saint's feet are ordinances of Jesus Christ and that the true believers in Jesus Christ are the only subjects entitled to these privileges.

We believe the mode of baptism is by immersing in water.

We believe that God chose his people in Christ Jesus before the

world began.

We believe that no minister has a right to the administration of ordinances only such as are regularly baptized, called and come under the imposition of the hands presbyter.

We believe that none but regularly baptized members have the

right to commune at the Lord's table.

Rules of Decorum of Church Government.

AGREED TO AND ADOPTED BY THE CHURCH OF GOD AT RADICUE MEETING HOUSE, FRIDAY BEFORE THE FIRST SUNDAY IN AUG. 1876.

Being dismissed by letters from Otter's Creek, Sparta, Tyson's Meeting House; having spent the day in fasting and prayer, give ourselves to Christ and to one another.

Article 1. That members comprising the church shall assemble themselves together at Radicue Meeting House the first Sunday in every month and the Saturday before, unless prevented by unavoidable necessity. Heb. 10:10. "And not to forsake the assembling of ourselves together as the manner of some is."

2. The members of the church shall meet in conference on every Saturday before the first Sunday in each month. Acts 15:6, "And the Apostles and Elders come together to consider of this matter."

3. Conference shall be opened and closed with prayer, or praise to Almighty God. 1 Tim. 2:1. "I exhort, therefore, that first of all prayer and intercession and giving of thanks be made for all men." 1 Thes. 1:17, 18. "Pray without ceasing, and everything give thanks, for this the Will of God in Christ Jesus concerning you."

4. The pastor of the church shall be moderator or nominate one who is present, when absent the conference shall appoint one, and after the conference shall be agreed, on motion, visiting brethren

from sister churches may be invited to take seats with us. Psalm 133:1. "Behold how good and how pleasant it is for brethren to dwell in unity."

5. It shall be the duty of the moderator to preserve order and harmony in the conference according to these rules or others which may be subsequently adopted. He shall fairly state every question, ascertain the majority and report accordingly. 1 Cor. 14:40, "Let everything be done decently and in order."

6. The conference shall appoint a clerk whose duty it shall be to record faithfully in a well bound book (purchased by the conference) all of their proceedings and to do and to perform all such other things

as usually devolves upon such officers.

7. The members' names shall be enrolled distinctly, called over and a significant mark attached to their names which may be absent. Acts 1:15. "The number of their names together were about 120." When any member shall be absent three conferences, it shall be the duty of the clerk to give notice thereof to the church who thereupon. shall order notice to be issued to the delinquent, to be served by one of the deacons, and upon which the conference may take such measures as to them may appear consonant with brotherly love and Gospel order. Heb. 10:25. "Not forsake the assembling together."

8. A door shall be opened for the admission of new members, who before admission shall verbally relate their experience, and when unanimous satisfaction is offered the church in conference that God has wrought a work of grace in their souls, it shall be the duty of the moderator to give them the right hand of fellowship in behalf of the church, and said candidate, shall after being baptized by immersion become a member of the church and not before. Peter 3:15, "Be ready always to give an answe; to every man thatasks you the reason of hope that is in you with meekness and 'fear." Mat. 28:19, "Baptizing them in the name of the Father, and of the Son and of the

9. If any member of this church shall bring a complaint of a private trespass having been committed upon him by one of his brethren, before he shall have complied with the requisition of the great head of the church, prescribed in the 8th chapter of Matthew, the church shall disregard it and shall be deemed disorder. "Whereof

if thy brother trespass against thee," etc.

10. It shall be deemed disorder if any member of the church who shall speak illiberally of one of his brethren or otherwise than is laid down in the word before the recited chapter (18th of Matthew) and who may join the world calumniating or traducing their character. Rom. 1:39, "Let love be without dissimulation." Gal. 6:12, "Brethren if a man be overtaken in fault, ye which are spiritual, restore such a one in the spirit of meekness, considering thyself, lest thou also be tempted." "Bear ye one another's burdens, and so fulfill the law of Christ."

11. All public offences against morality shall be noted by the church publicity and the offenders dealt with according to Gospel order. Matt. 5:16, "Let your light so shine before men, that they may see your good works and glorify your Father which is in Heaven."

12. Every motion made and seconded, shall be taken under consideration of the conference, unless withdrawn by the mover and making it open for discussion or delege, but one person shall speak at a time, who shall arise from his seat and address the moderator by the appealeation of brother moderator, and when two or more rise at the same time he shall decide without argument between t 1 Cor. 14:40, Let everything be done decently and in order."

13. Every query presented shall be thrice read before it is for debate, and it shall not be received unless a majority of t present concur in its reception and its decision a majority s

govern.

14. In all cases, except in the admission of members into the church, a majority of those present shall govern whose decisions shall be final; except two-thirds of the members at the next conference agree to consider the matter and two-thirds shall so agree, the subject matter shall again come before the conference and this decision shall be final.

15. Implicit obedience shall be yielded to the decision of the conference, but every member that is dissatisfied with the proceedings of the conference shall express themselves before adjourning of the conference and not thereafter. Rom. 13:1, "Let every soul be sub-

ject to the higher power."

16. The minutes of the conference shall be read before it adjourns,

and all errors corrected.

17. The following are prohibited, whispering or laughing during time of public speaking, with the appearance of wrath, or in a degrading manner, speaking more than three times without leeave.

18. It shall be deemed disorderly in any member who openly and avowedly denies the fundamental doctrine contained in the church covenant and they shall be dealt with accordingly. Jude 1:3, "Earnestly contend for the faith which was once delivered unto the saints." Be of one mind. How can two talk together except they be agreed?

19. As intemperance is one of the worst evils which can effect the members of any society, either civil or religious, and more especially the latter, it being in direct violation, the word of God, wounding the cause of Jesus Christ, hurting the Delings of the sober brethren and exposing the individual to commission of sin of the most abominable cast of character, we do declare and agree that when any member of this church shall so far forget what he owes to the great head of the church, to himself, the feelings of his brethren and to mortals and to well being of society generally, as to get drunk and become known to the church, he shall be notified to attend our church conference, and on failing to render entire satisfaction, to be considered as an excommunicant and not entitled to any privilege thereafter until such offender shall bring forth fruits meet for 'repentance. Matt. 5:16, "Let your light so shine before men," etc. The following amendment to the above article was adopted in conference and read thus:-"And we further agree and declare to be the duty of every member of this church, that when he knows of a member of this church getting drunk as above stated in this article, to make it known to the church."

20. If upon issuing a notice to any delinquent member as is required by the 7th Article of this Decorum, the Deacon returns, "not to be found within the limits of the church," that the conference

shall then proceed as if the notice had been served.

21. A majority of the members of this church in conference shall have power to alter or amend any of the rules of this Decorum, which they have adopted for their governmentor to add any new rules which said majority may deem necessary.

Motion made, seconded and and agreed that no church shall hold

any member who will not pay an honest debt.

Motion made and seconded that we will not have nor hold members with us belonging to secret societies, Odd Fellows, Masons, or Sunday School.

Rules of Decorum of Church Government

Agreed to and Adopted by the Church of God at Radicue Meeting House, Friday before the First Sunday in August, 1876

Being dismissed by letters from Otter's Creek, Sparta, Tyson's Meeting House; having spent the day in fasting and prayer, give ourselves to Christ and to one another

ARTICLE I. That members comprising this church shall assemble themselves together at Radicue Meeting House the first Sunday in every month and the Saturday before, unless prevented by unavoidable necessity. Heb. 10:10. "And not forsake the assembling of ourselves together as the manner of some is."

- 2. The members of the church shall meet in conference on every Saturday before the first Sunday in each month. Acts 15:6. "And the Apostles and Elders came together to consider of this matter."
- 3. Conference shall be opened and closed with prayer, or praise to Almighty God. 1 Tim. 2:1. "I exhort, therefore, that first of all prayer and intercession and giving of thanks be made for all men." 1 Thes. 1:17-18. "Pray without ceasing, and everything give thanks for this the will of God in Christ Jesus concerning you.
- 4. The pastor of the church shall be moderator or nominate one who is present, when absent the Conference shall appoint one, and after the conference shall be agreed, on motion, visiting brethren from sister churches may be invited to take seats with us. Psalm 133:1. "Behold how good and how pleasant it is for brethren to dwell together in unity."
- 5. It shall be the duty of the moderator to preserve order and harmony in the conference according to these rules or others which may be subsequently adopted. Be shall fairly state every question, ascertain the majority and report accordingly. 1 Cor. 16:10. "Let everything be done decently and in order."
- 6. The conference shall appoint a clerk, whose duty it shall be to record faithfully in a well bound book (purchased by the conference) all of their proceedings and to do and to perform all other such things as usually devolves upon such officers.
- 7. The members' names shall be enrolled distinctly, called over and a significant mark attached to their names which may be absent. Acts 1:15. "The number of their names together were about 120." When any member shall be absent three conference, it shall be the duty of the clerk to give notice thereof to the church, who

thereupon, shall order notice to be issued to the delinquent to be served by one of the deacons, and upon which the conference may take such measures as to them may appear consonant with brotherly love and gospel order. Heb. 10:25. "Not forsake the assembling together."

- 8. A door shall be opened for the admission of new members who before admission shall verbally relate their experience and when unanimous satisfaction is offered the church in conference that God has wrought a work of grace in their souls, it shall be the duty of the moderator to give them the right hand of fellowship in behalf of the church, and said candidate, shall after being baptized by immersion, become a member of the church, and not before. Peter 3:15. "Be ready always to give an answer to every man that ask you the reason of the hope that is in you with meekness and fear." Mat. 28:19. Baptizing them in the name of the Father, and of the Son and of the Holy Ghost."
- 9. If any member of this church shall bring a complaint of a private trespass having been committed upon him by one of his brethren, before he shall have complied with the requisition of the great head of the church, prescribed in the 8th chapter of Matthew, the church shall disregard it and shall be deemed disorder. - 11. All public offences against morality shall be noted by the church publicly and the offenders dealt with according to gospel order. Mat. 5:16. "Let your light so shine before men that they May see your good works and glorify your Father which is in Heaven."
- 12. Every motion made and seconded, shall be taken under consideration of the conference. unless withdrawn by the mover and making it open for discussion or debate, but one person shall speak at a time, who shall arise from his seat and address the Moderator by the appellation of Brother Moderator, and when two or more shall rise at the same time he shall decide without argument between them." 1 Cor. 14:40. "Let everything be done decently and in order."
 - 13. Every query presented shall be thrice read before it is open

for debate and it shall not be received unless a majority of those present concur in its reception and its decision a majority shall govern.

- 14. In all cases, except in the admission of members into the church a majority of those present shall govern whose decisions shall be final; except two-thirds of the members at the next conference agree to consider the matter and two-thirds shall so agree the subject matter shall again come before the conference and this decision shall be final.
- 15. Implicit obedience shall be yielded to the decision of the conference, but every member that is dissatisfied with the proceedings of the conference shall express themselves before adjourning of the conference and not thereafter. Rom. 13:1. "Let every soul be subject to a higher power."
- 16. The minutes of the conference shall be read before it adjourns and all errors corrected.
- 17. The following are prohibited: Whispering or laughing during time of public speaking, with the appearance of wrath, or in a degrading manner, speaking more than three times without leave.
- 18. It shall be deemed disorderly in any member who openly and avowedly denies the fundamental doctrine contained in the church covenant and they shall be dealt with accordingly. Jude 1:3. "Earnestly contend for the faith which was once delivered unto the saints." Be of one mind. How can two walk together except they be agreed?
- 19. As intemperance is one of the worst evils which can effect the members of any society, either civil or religious, and more especially the latter, it being in direct violation of the word of God. wounding the cause of Jesus Christ, hurting the feelings of the sober brethren and exposing the individual to commission of sin of the most abominable cast of character, we do declare and agree that when any member of this church shall so far forget what he owes to the great head of the church, to himself, the feeling of his brethren and to mortals and to well being of society generally, as to get drunk and become known to the church, he shall be notified to attend our church conference, and on failing to render entire satisfaction, to be considered as an excommunicant and not entitled to any privilege thereafter until such offender shall bring forth fruits meet for repentance. That members comprising this church shall assemble themselves together at Radioue Meeting House the first Sunday in every month and the Saturday before unless prevented by unavoidable necessity. Heb. 10:13. "And not for ake the assembling of ourselves together as the manner of some is."
- 2. The members of the church shall meet in conference on Saturday before the first Sunday in each month. Acts 15:6. "And the Apostles and Elders came together to consider of this matter.
- 3. Conference shall be opened and closed with prayer or praise to Almfghty God. 1 Tim. 2:1. "I exhort, therefore, that first of all prayer and intercession and giving of thanks be made for all men. 1 Thes. 1:17-18. Pray without ceasing, and everything give thanks for this the will of God in Christ Jesus concerning you."
- 4. The pastor of the church shall be Moderator or nominate one who is present, when absent the Conference shall appoint one, and after the Conference shall be agreed. On motion visiting brethren from sister churches may be invited to take seats with us. Psalm 133:1. 'Behold how good and how pleasant it is for brethren to dwell together in unity.
- 5. It shall be the duty of the Moderator to preserve order and harmony in the Conference according to these rules or others which may be subsequently adopted. When any member shall be absent three Conference, it shall be the duty of the clerk to give notice thereof to the church, who thereupon shall order notice to be issued to the delinquent to be served by one the deacons, and upon which the Conference may take such measures as to them may appear consonant with brotherly love and gospel order. 8. A door shall be opened for the admission ot new members who before admission shall verbally relate their experience and when unanimous satisfaction is offered the church in Conference, that God has wrought a work of grace in their souls, it shall be the

duty of the Moderator to give them the right hand of fellowship in behalf of the church, and said candidate, shall after being baptized by immersion, become a member of the church, and not before. Peter 3:15. "Be ready always to give an answer to every man that ask you the reason of the hope that is in you with meekness and fear." Mat. 28:19. Baptizing them in the name of the Father, and of the Son, and of the Holy Ghost

- 9. If any member of this church shall bring a complaint of a private trespass having been committed upon him by one of his brethren, before he shall have complied with requisition of the great head of the church, prescribed in the 8th. chapter of Matthew. The church shall disregard it and shall be deemed disorders. "Whereof if thy brother trespass against thee, etc.
- 10. It shall be deemed disorder in any member of the church who shall speak illiberally of one of his brethren or otherwise than is laid down in the word before the recited chapter, 18th. of Matthew. "And who may join the world caluminating or traducing their character." Rom.1:39. "Let love be without dissimulation." Gal. 6:12. "Brethren if a man be overtaken in fault, ye which are spiritual, restore such a one in the spirit of meekness, considering thyself less thou also be tempted." "Bear ye one another's burden and so fulfill the law of Christ."
- 11. All public offences against morality shall be noted by the church publicly and the offenders dealt with according to gospel order. Mat. 5:16. 'Let your light so shine before men that they may see your good works and glorify your Father which is in Heaven.
- 12. Every motion made and seconded, shall be taken under consideration of the Conference, unless withdrawn by the mover and making it open for discussion or debate, but one person shall speak at a time, who shall arise from his seat and address the Moderator by the appellation of Brother Moderator, and when two or more shall rise at the same time he shall decide without argument between them. 1 Cor. 14:40. "Let everything be done decently and in order."
- 13. Every query presented shall be thrice read before it is open for debate and it shall not be received unless a majority of those present concur in its reception and its decision a majority shall govern.
- 14. In all cases, except in the admission of members into the church a majority of those present shall govern whose decisions shall be final, except two-thirds of the members at the next Conference agree to consider the matter and two-thirds shall so agree the subject matter shall again come before the Conference and this decision shall be final.

- 19. As intemperance is one of the worst evils which can effect the members of any society, either civil or religious, and more especially the latter, it being in direct violation of the word of God, wounding the cause of Jesus Christ, hurting the feelings of the sober brethren and exposing the individual to commission of sin of the most abominable cast of character, we do declare and agree that when any member of this church shall so far forget what he owes to the great head of the church, to himself, the feeling of his brethren and to mortals and to well being of society generally, as to get drunk and become known to the church, he shall be notified to attend our church Conference, and on failing to render entire satisfaction, to be considered as an excommunicant and not entitled to any privilege thereafter until such offender shall bring forth fruits meet for repentance. "Let your lights so shine before men", The following amendment to the above article was adopted in Conference and read thus-"And we further agree and declare to be the duty of every member of this church, that when he knows or a member of this church getting drunk as above stated in this article to make it known to the church.

Every motion made and seconded, shall be taken under consideration of the Conference, unless withdrawn by the mover and making it open for discussion or debate, but one person shall speak at a time, who shall arise from his seat and address the Moderator by the appellation of Brother Moderator, and when two or more shall rise at the same time, he shall decide without argument be tween them. 1 Cor. 14:40. "Let everything be done decently and in order."
- 13. Every query presented shall be thrice read before it is open for debate and it shall not be received unless a majority of those present concur in its reception and its decision a majority shall govern.
- 14. In all cases, except in the admission of members into the church, a majority of those present shall govern whose decisions shall be final, except two-thirds of the members at the next Conference agree to consider the matter and two-thirds shall so agree the subject matter shall again come before the Conference and this decision shall be final.

- 15. Implicit obedience shall be yielded to the decision of the Conference, but every member that is dissatisfied with the proceedings of the Conference shall express themselves before adjourning of the Conference and not ther after, Rom. 13:1, "Let every soul be subject to a higher power."
- 16. The minutes of, the Conference shall be read before it adjourns and all errors corrected.
- 17 The following are prohibited: Whispering or laughing during time of public speaking, with the appearance of wrath, or in a degrading manner, speaking more than three times without leave.
- 18. It shall be deemed disorderly in any member who openly and avowedly denies the fundamental doctrine contained in the church covenant and they shall be dealt with accordingly. Jude 1:3 "Earnestly contend for the faith which was once delivered unto the saints." Be of one mind, how can two walk together except they be agreed.
- 19. As intemperence is one of the worst evils which can affect the memb rs of any society, either civil or religious, and more especially the latter it being in direct violation of the word of God, wounding the cause of Jesus Christ, hurting the feelings of the so ber brethren and exposing the individual to commission of sin of the most abominable cast of character, we do declare and agree that when any member of this church shall so far forget what he owes to the great head of the church, to himself, the feeling of his brethren and to mortals and to well being of society generally, as to get drunk and become known to the church, he shall be notified to attend our church Conference, and on failing to render entire satisfaction, to be considered as an excommunicant and not entitled to any privilege thereafter until such offender shall bring forth fruits mees for repentance. Mat. 5:16. 'Let your lights so shine before men", etc. The following amendment to the above article was adopted in Conference and read thus-'And we further agree and declare to be the duty of every member of this church. that when he knows of a member of this church getting drunk as above stated in this article to make it known to the church.
- 20. If upon issuing a notice to any delinquent member as is required by the 7th. Article of this Decorum, the Deacon returns "Not to be found within the limits of the church", that the Conference shall then proceed as if the notice had been served.
- 21. A majority of the members of this church in Conference shall have power to alter or to amend any of the rules of this Decorum, which they have adopted for their government or to add any uew rules which said majority may deem necessary.

Motion made and seconded and agreed that no church shall hold any member who will not pay an honest debt,

Motion made and seconded that we will not have nor hold members with us belonging to secret societies, Odd Fellows, Masons or Sunday School.



RULES OF DECORUM OF CHURCH GOVERNMENT

Being dismissed by letter from Otter's Creek, Sparta, Tyson's Meeting House, having spent the day in fasting and prayer, give ourselves to Christ and to one another.

1. That members comprising this church shall assemble themselves together at Radicue Meeting House the first Sunday in every month and the Saturday before unless prevented by unavoidable necessity. Heb. 10:12. "And not forsake the assembling of ourselves together as the manner of some is."

2. The members of the church shall meet in conference on Saturday before the first Sunday in each month, Acts 15:6. "And the Apostles

and Elders came together to consider this matter."

3. Conference shall be opened and closed with prayer or praise to Almighty God. 1 Tim. 2:1. "I exhort therefore, that first of all prayer and intercession and giving of thanks be made for all men." 1 Thess. 1:17, 18. "Pray without ceasing, and in everything give thanks for this is the will of God in Christ Jesus concerning you."

4. The pastor of the church shall be Moderator or nominate one who is present, when absent the Conference shall appoint and and after the Conference shall be agreed. On motion visiting brethren from sister churches may be invited to take seats with us. Psa. 133:1. "Behold how good and how pleasant it is for brethren to dwell together in unity."

5. It shall be the duty of the Moderator to preserve order and harmony in the Conference according to these rules or others which may be subsequently adopted. He shall fairly state every question, ascertain the majority and report accordingly. 1 Cor. 16:10. "Let every-

thing be done decently and in order."

5. The Cenference shall appoint a Clerk, whose duty it shall be to record faithfully in a well bound book (purchased by the conference) all of their proceedings and to do and perform all other such things

15. Implicit obedience shall be yielded to the decision of the Conference, but every member that is dissatisfied with the proceedings of the Conference shall express themselves before adjourning of the Conference and not thereafter. Rom. 13:1. "Let every soul be subject unto the higher powers."

16. The minutes of the Conference shall be read before it adjourns

and all errors corrected.

17. The following are prohibited: Whispering or laughing during time of public speaking, with the appearance of wrath, or in a degrading manner, speaking more than three times without leave.

18. It shall be deemed disorderly in any member who openly and avowedly denies the fundamental doctrine contained in the church covenant and they shall be dealt with accordingly. Jude 1:3: "Earnestly contend for the faith which was once delivered unto the saints." "Be of one mind, how can two walk together except they be agreed."

19. As intemperance is one of the worst evils which can affect the members of any society, either civil or religious, and more especially the latter in direct violation of the word of God, wounding the cause of Jesus generally, as to get drunk and become known to the church, he shall be notified to attend our church Conference, and on failing to render entire satisfaction, to be considered as an excommunicant and not entitled to any privilege thereafter until such offender shall bring forth fruit meet for repentance. Matt. 5:16. "Let your light so shine before men," etc. The following amendment to the above article was adopted in Conference and read thus:—"And we further

agree and declare to be the duty of every member of this church, that when he knows of a member of this church getting drunk as above stated in this article to make it known to the church."

20. If upon issuing a notice to any delinquent member as is required by the 7th Article of the Decorum, the Deacon return "Not to be found within the limits of the church," that the Conference shall then

proceed as if the notice had been served.

21. A majority of the members of this church in Conference shall have power to alter or to amend any of the rules of this Decorum, which they have adopted for their government or to add any new rules which said majority may deem necessary.

Motion made and seconded and agreed that no church shall hold

any member who will not pay an honest debt.

Motion made and seconded that we will not have nor hold members

with us belonging to secret societies, Odd Fellows, or Masons.

Moved and seconded that we will not establish a church within five miles of any church in the Radicue Association, nor any with which we correspond.

ABSTRACT OF PRINCIPLES

1. We believe in one true and living God, the Father, the Word and the Holy Ghost.

2. We believe that the Scriptures of the Old and New Testaments

are the words of God and the only rule of faith and practice.

3. We believe in one Superior Eternal God, the creator and upholder of all beings and the disposer of all events, for there are three that bear record in Heaven, the Father, the Word and the Holy Ghost, and these three are one. John 2:5.

4. We believe in the total depravity and just condemnation of all

the fallen race of Adam.

5. We believe in original sin and that the punishment of the wicked shall be everlasting and the joys of the righteous eternal. We believe that God's elect shall be called, converted, regenerated, sanctified by the Holy Ghost.

6. We believe that the saints shall always persevere in grace and

never finally fall away.

7. We believe that baptism, the Lord's Supper and the washing of the saint's feet are ordinances of Jesus Christ and that true believers in Jesus Christ are the only subjects entitled to these privileges.

8. We believe the mode of baptism is by immersing in water.

9. We believe that God chose His people in Christ Jesus before the world began.

10. We believe that no minister has a right to the administration of ordinances only such as are regularly baptised, called and come under the imposition of the hands of the presbytery.

11. We believe that none but regularly baptised members have the

right to commune at the Lord's Table.
