We, your Committee on Education, beg to submit the following report: We find that the Committee appointed at our last Conference to inspect sites and purchase school property have purchased building, lands, &c., at Beulah, N. C., three miles South-west of Clinton for the purpose of running a school for and in the interest of the Cape Fear Conference, and others who may give us their support.

The Directors have secured the services of Prof. J. E. B. Davis. The school begun in August and is progressing finely, has an excellent corps of teachers, but is greatly in need of the patronage of the Church and its financial aid without which it cannot thrive. Your Committee begs further to state that the patronage upon the part of our churches has been very discouraging and not what the Churches should make it in order to secure success. As a part of this report your committee appends a brief report from the management covering the first three months work:

Z. Taylor tendered his resignation as Committee on Department and Work of the Ministry. His resignation was accepted and J. H. Pope was elected in his stead.

#### REPORT OF BOARD OF DIRECTORS FOR SCHOOL.

We, the Board report the following: We met at Beulah, N. C., on Dec. 17, 1901. Present: H. W. Jernigan, R. C. Jackson, O. B. Garriss, W. P. Collier, W. J. Powell. The Secretary being absent Rev. E. L. Parker was chosen Secretary pro. tem. On motion of W. P. Collier, W. J. Powell, R. C. Jackson and C. F. Collins were elected a Committee to hold and defend the title to the property and give title to parcels sold and said named persons shall hold office until their successors are elected. On motion by O. B. Garriss, the school shall open on Monday after the third Lord's Day in August, 1902, and continue ten months; giving holiday vacation. The Chairman appointed R. C. Jackson and W. J. Powell, Lookout Committee to solicit applications for Principal of the school and report to the Board of Directors.

On motion by R. C. Jackson the treasurer was ordered to pay at once to A. J. Cooper the sum of \$45.00 to make payment on piano. On motion by O. B. Garriss, the Board of Trustees accepted the title to the property from the former Board; and gave them their note for the amount.

#### DUNN MEETING.

On motion, a quorum being present at this meeting, we make the report of the meeting at Beulah legal.

On motion the resolution offered by O. W. Gregory was adopted as follows:

Resolved, That the Board of Directors positively refuse to run a sectarian school at Beulah, N. C. That while the school is owned and controlled by the Cape Fear Free Will Baptist Conference, yet it shall be run upon union principles and strictly non sectarian and undenominational. On motion we guarantee the school at Beulah to pay and obligate to hire for ten months Prof. J. E. B. Davis at \$50 per month and furnish an assistant teacher. On motion Prof. Davis shall be required to report the proceedings of the school at the close of the session. On motion the Treasurer shall pay to R. C. Jackson, \$18.35 that he may apply it to the discharge of debt on Piano. On motion the meeting adjourned subject to the call of the President.

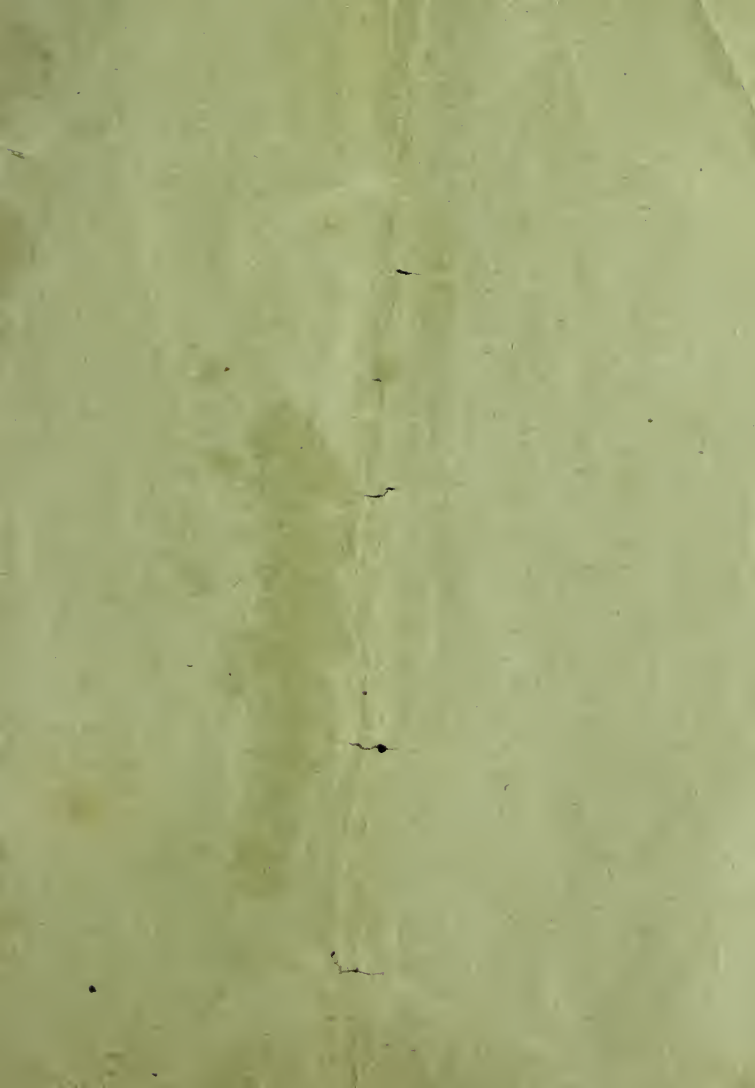
