# MINUTES OF WILMINGTON PRESBYTERY

## STATED MEETING

October 21, 1958

The Presbytery of Wilmington met in the 204th stated session in the Winter Park Church, Wilmington, N. C., on Tuesday, October 21, 1958, at 10:00 a.m. A service of worship was conducted and a sermon preached by the retiring moderator, Rev. Horace H. Hilton. A quorum was declared present and the Presbytery was constituted in prayer, led by the retiring moderator. Mr. Mac F. Jones, a Ruling Elder in the Woodburn Church, was elected moderator.

Visiting Ministers, and Ruling Elders representing their Sessions at Presbytery for the first time, were introduced. The Visiting Ministers were:

William P. Burns, Albemarle Presbytery; Edward F. Torsch, Brooklyn-Nassau Presbytery; L. C. LaMotte, Fayetteville Presbytery; John S. Cook, Concord Presbytery.

The Ruling Elders introduced were:

O. A. Marrow; Needham Sloan; Roy Jessup; Charles Farrior.

The pastor of the host church, Rev. Horace H. Hilton, welcomes the Presbytery to the Winter Park Church, and made helpful announcements.

Communications were read and referred as follows: From the Stated Clerk of the General Assembly, Dr. E. C. Scott, copies of the Proposed Amendments to the Confession of Faith and the Book of Church Order, regarding Remarriage of Divorced Persons, referred to the Committee on Marriage and Divorce and report docketed for the January meeting of Presbytery, (2) Report of an ad-interim committee of the General Assembly on the subject of "United", or "Federated" churches, referred to a special committee appointed by the Moderator to study and report docketed for the January meeting of Presbytery. At a later hour the Moderator announced the appointment of the following persons to serve on this committee: Rev. John R. MacKinnon, Rev. Richard K. Johnson, Rev. Harry B. Mitchell, and Ruling Elder Jordan Sloan.

A proposed docket was amended and adopted as the docket of the Presbytery.

Rev. M. J. McChesney, Chairman of the Commission on the Minister and His Work, presented Certificates of Dismissal for Rev. Edward F. Torsch, from the Presbytery of Brooklyn-Nassau, and for Rev. William P. Burns from the Presbytery of Albemarle. These men were admitted to examination. Dr. B. Frank Hall led the examination on Views in Theology. This was sustained as satisfactory. Rev. P. L. Clark led the examination in Experimental Religion. This was sustained as satisfactory. Rev. Edward G. Connette led the examination in Views in Church Government and Sacraments. This was sustained as satisfactory. The examinations as a whole were sustained as satisfactory and the men ordered enrolled as members of Presbytery upon the signing of the "obligations".

Dr. L. C. Lamotte, President of the Presbyterian Junior College, reported that Rev. Edward F. Torsch had been called by the College to serve as Chaplain and Instructor in Bible. This call was approved by the Presbytery. A call from the Little

Chapel on the Boardwalk, Wrightsville Beach, N. C., for the services of Rev. William P. Burns was read and approved and placed in his hands. Upon his acceptance of the call a Commission was appointed for his Installation as follows: Ministers—L. A. Taylor, B. Frank Hall, Edward G. Connette; Ruling Elders—Dr. W. C. Mebane, Mr. Leslie N. Boney, Jr. The date for the Installation was fixed for November 2, 1958 in the Little Chapel on the Boardwalk.

Rev. Walter H. Goodman, Chairman of the sub-committee on Candidates, introduced Mr. Hugh S. Evans, a member of the St. Andrews-Covenant Church, Wilmington, and Mr. Leon J. Simmons, Jr., a member of the Mt. Olive Church. He reported to the Presbytery that these men had been examined by the sub-committee on Candidates and approved for recommendation to the Presbytery. They were admitted to examination. Rev. P. L. Clark led the examination on Experimental Religion and Motives for seeking the Ministry. This was sustained as satisfactory. The Moderator propounded the Constitutional Questions. When these had been answered in the affirmative, Rev. W. H. Goodman delivered Charge to the candidates and led the Presbytery in prayer in their behalf. Mr. Hugh S. Evans and Mr. Leon J. Simmons, Jr., were enrolled as Candidates for the Gospel Ministry under the care of Wilmington Presbytery.

Candidate Eugene Baughman Davis, a member of the Mt. Olive church and a Candidate for the Gospel Ministry under the care of the Presbytery, was introduced by Rev. W. H. Goodman who also moved that Mr. Davis be admitted to examination for Ordination at the hands of the Presbytery. He reported that Mr. Davis is a graduate of Union Theological Seminary, Richmond, with the degree of Bachelor of Divinity, he has been approved for recommendation to the Presbytery by the sub-committee on Candidates, His Thesis: "The State of the Saved" and his Exegesis of Philippians 4:10-13 have been approved. Mr. Davis was admitted to examination. Dr. B. Frank Hall led the examination in Theology. This was sustained as satisfactory. Rev. M. C. MacQueen led the examination in Experimental Religion. This was sustained as satisfactory. Rev. James A. Marrow led the examination in the English Bible. This was sustained as satisfactory. Rev. Edward G. Connette led the examination in the Sacraments and Church Government. A sermon was preached from Matthew 28:16-20; and was sustained as satisfactory. The examination as a whole was sustained as satisfactory for Ordination. Mr. Davis stated to the Presbytery that he had the strong feeling of being called to serve the Military forces

of the country as a Chaplain and requested Ordination as an Evangelist. The Executive Secretary of the Presbytery stated that Mr. Davis had been called by the Sessions of the Grove and Hallsville churches to serve them as Stated Supply while awaiting appointment by the Military forces. This was approved and a Commission was appointed to Ordain Mr. Davis as follows: Ministers—Rev. L. A. Taylor, Rev. Wade H. Allison, Rev. Norman H. Flowers; Ruling Elders—Samuel M. Davis, the father of the candidate, and alternates Rev. Reid H. Erwin and Ruling Elder William Patterson. The date was fixed as October 26, 1958, at 7:30 p.m. in the Grove church.

Mr. John Talbert, Chairman of Stewardship on the Council of Presbytery, spoke to the Presbytery on the subject of the Every Member Canvass and announced area meetings on this subject to be held in Wilmington, Wallace and Whiteville.

Dr. B. Frank Hall, Chairman, made the annual report for the Committee on Church Extension. The report was adopted.

### REPORT OF THE COMMITTEE ON CHURCH EXTENSION

The Committee on Church Extension is organized for work into five sub-committees: Home Missions, Negro Work, Christian Relations, Evangelism, Radio and Television.

#### HOME MISSIONS

This committee is fortunate in having a membership of men who are deeply devoted to this important cause, and who give of their time and talents to this without stint.

The two principle lines of work have been continued throughout the year. These are salary supplements to many of the smaller churches made in order that the pastors may receive at least the minimum salary determined by the Presbytery, and grants-in-aid for building of churches, Sunday school rooms and manses. Funds for all this come from regular and special offerings for Church Extension from the churches of the Presbytery, from grants made to the Presbytery by the Synod and General Assembly agencies, gifts made by individuals and business firms, and from the Church and Manse Assistance Fellowship. The Home Mission Committee gives careful consideration to the groupings of churches into pastorates, to mergers of congregations and to the relocations of churches. The final decisions in these matters are made by the local churches and the Presbytery, but both look to this Committee for guidance and recommendations. We continue to be blessed by a group of dedicated, capable, attractive and energetic pastors in our aid-receiving churches. Reports of the work of this committee will come to the Presbytery in greater details in the annual report of the Treasurer of the Committee. The committee wishes to record its appreciation to the Executive Secretary, Dr. L. A. Taylor for his untiring efforts and wise counsel to the committee and to all the churches involved.

#### NEGRO WORK

This sub-committee would remind the Presbytery that we have no work whatsoever among the people of this great segment of our popula-

tion. This should be a matter for sincere repentance on our part, and for an increased sense of responsibility. The only thing resembling Negro Work in our Presbytery is the work of the Women of the Church in sending Women to the Negro Conferences. No new work was undertaken in the Synod during the year, however a survey looking toward a Negro church was made in the city of Asheville.

### CHRISTIAN RELATIONS

This committee calls attention of the Presbytery to the serious crisis in human relations, not only in the Southland, but also in the nation and throughout the world. These are times that test the genuineness of our Christian Profession and try the souls of men. Your committee urges upon the Presbytery the obligation of self-examination in the light of the teachings of the scriptures, prayer for the guidance of the Holy Spirit in facing our prejudices, fears and pre-conceptions, and our submission to the messengers of reconciliation in this critical hour. We refer the Presbytery to the reports of the General Assembly's Council on Christian Relations (Minutes of the General Assembly of 1958, page 88) and also to the reports of Synod's committee made at the 1958 meeting of Synod and recorded in the printed Minutes of that meeting.

We are deeply disturbed by the increase in the number of irresponsible hate movements in the Southland and their violations of the basic rights of individual citizens and their destruction of homes, churches and schools. We recommend that Presbytery affirm its condemnation of these atrocities and urge upon its members the recognition of their duty as Christian citizens to uphold the legal authorities in combatting them.

We invite your prayers and sympathy for Christian brothers who have suffered for their convictions and are persecuted for righteousness sake.

### EVANGELISM

We are happy to report that many of the ministers of Wilmington Presbytery attended the pre-Assembly Conference on Evangelism, First Presbyterian Church, Charlotte, N. C. It was the largest number that has attended any Pre-Assembly Conference on Evangelism. We were very proud and happy to have one of our own beloved ministers of Wilmington Presbytery, Dr. B. Frank Hall, to be one of the guest speakers. Dr. Hall spoke on "Preaching for a Decision."

At Synod this past summer at Davidson College, Dr. James Fogartie, minister at Myers Park Presbyterian Church, requested the ministers of our Synod to remember the Billy Graham Crusade to be held in Charlotte in our prayers and attendance. Many of our ministers have attended the meeting. Some of our churches have chartered busses to attend this Crusade.

We have encouraged the churches of Wilmington Presbytery to set aside a special time for Evangelistic Services. The majority of our churches have or will have a special time for evangelistic meetings.

We are asking and encouraging the ministers to develop several ways and means for the promotion of evangelism in their local churches. First of all to have before them constantly a prospect list; to remember that every person who moves in their area is a prospect for their church; to remember them by name each day in prayer; to visit in their homes with the invitation to church; to explain the program of your church for spiritual growth. With this prospect list, remembering them in prayer, contacting them, it should create a concern and a tie with the prospect of your community.

We have encouraged each local pastor to have a "working" Committee on Evangelism. This committee should be composed of various age levels, in order to meet the new prospects on their own level. The churches have been encouraged to have periodical meetings of the Committee on Evangelism in order that they might have instructions on their duties.

We still stress the importance of Visitation Evangelism. It has been tried by most of our churches and when it has really been planned with a genuine spirit of concern it has been very profitable.

This committee hopes that as the ministers of Wilmington Presbytery prepare, develop, and follow-up their prospect list that as these prospects become members of the local churches, they will be pleasantly placed in the worship, program and fellowship of the church.

Your Committee on Evangelism is grateful to each of you for your help and cooperation in promoting evangelism in our Presbytery. We hope, with your prayers, concern, cooperation, to reach a higher goal than we have ever done before.

Rev. Charles W. Worth reminded the Presbytery that it has long held title to a piece of land in the town of Roseboro, N. C. The Home Mission Committee has no plans for the use of this land now or in the foreseeable future. Recently a resident of Roseboro expressed interest in the purchase of this land. He made the motion, which was duly seconded that the Home Mission Committee be given permission to sell this land if an offer were made that was suitable to the Committee and that the Trustees of the Presbytery: James H. Clark, J. K. Bannerman, E. Walker Stevens be authorized and empowered to grant title to this property upon the recommendation of the Home Mission Committee. The motion was passed.

Ruling Elder, R. C. Platt, Jr., reported for the Committee on Audits that Presbytery Treasurer's books were audited by the firm of "Brand and Perdeu" according to accepted auditing practices; that the said audits have been accepted and approved by the Council of Presbytery and are on file at Presbytery's office.

The following standing Committees were appointed:

Leave of absence: I. H. Rawles, W. E. Pauley and M. J. Jackson.

Place of next meeting: L. W. Kessler, Herbert Lewis and Charles Farrior.

Thanks: Harry Mitchell, Will Terry and J. G. Murdock.

Presbytery recessed for lunch with prayer offered by the Moderator. Presbytery reconvened with the singing of a hymn. The prayer was offered by the Rev. F. A. Elliott.

Ruling Elder George L. Mitchell presented a report in behalf of Synod's Special Committee on the Study of Minister's salaries. The recommendations were adopted as follows:

1. That all salaries of ministers be considered in the future on a net basis.
2. That all expenses of ministers be taken care of by the churches they serve through the current expense budget.

3. That steps be taken by Presbytery to reimburse the Home Mission Minister for his professional expenses in the conduct of his ministry.
  - (a) That it would take approximately \$1,100.00 a year, on an average to reimburse the Home Mission Minister for professional expenses.
  - (b) That a start be made immediately on this undertaking.
  - (c) Because of the large sum involved, the Presbytery be given three years to work this out. With one-third of the professional expenses be assumed the first year, two-thirds the second year, and the whole by the third year.
4. That each minister in the Presbytery be allowed by the church or Presbytery the sum of \$75.00 as a minimum allowance for books and periodicals for the purpose of continued study and improvement.
5. That each minister in the Presbytery be provided with hospitalization, insurance for themselves and their families at Church or Presbytery expense.
6. That a deeper understanding on the part of church members of the work of the minister is basic to the study of Minister's salaries. Each Presbyterian be urged to understand that our ministers are entitled to be reasonably free from worldly care and that our churches immediately take steps necessary to accomplish this requirement as outlined in our "Book of Church Order."

Mr. Richard Short spoke regarding the Presbyterian Home at High Point.

The report of the Committee on Homes was presented by the Rev. J. S. Russell. It was adopted as follows:

Your Committee on Homes directs your attention to the reports of the Board of Trustees of Barium Springs Orphanage, Presbyterian Home, Inc., and the William Black Home which were presented to the Synod of N. C. at its 1958 meeting at Davidson, N. C., with special attention being called to the campaign for funds for the Presbyterian Home, Inc., authorized for this winter.

The Committee recommends:

1. That the Churches of the Presbytery be urged to receive at this Thanksgiving Season an offering for Barium Springs Orphanage.
2. That the churches of the Presbytery be urged to cooperate in full in the campaign for Presbyterian Homes, Inc., and that they receive a special offering for the Presbyterian Homes, Inc., on Mother's Day, 1959.
3. That the ministers of Presbytery and the Sessions of our churches pray, and encourage the prayers of all of our people, for our Homes, those in positions of leadership and those cared for in our Homes.

The report of the Committee on Nominations was presented by Dr. B. Frank Hall. It was adopted as follows:

1. Trustees of Flora Macdonald College—Class of 1958 to become the Class of 1961.
2. Church Extension—Class of 1958 to become the Class of 1961.

The recommendation was adopted and the Trustees of Presbytery—James H. Clark, J. K. Bannerman, E. Walker Stevens were authorized and empowered to effect this change in the title.

### ADJOURNMENT

Jenkins was named Chairman, with two additional persons, appointed by the Moderator, to constitute the committee.

The docket was amended and adopted.

Rev. J. M. McChesney, Chairman of the Commission on the Minister and His Work, presented Certificates of Dismissal, for Rev. William M. Schotanus from the Presbytery of Holston and Rev. Joseph C. Wagner from the Presbytery of Kings Mountain. Upon this evidence these men were admitted to examination. Rev. John M. Irvine led the examination touching upon "Views in Theology", Rev. Edward G. F. Group Life Health Insurance, \$400.00 per year for utilities, use of the manse, and an annual vacation of one month were stated in the call. The call was approved and ordered placed in his hands. A Commission was appointed to Install him as pastor of the Jacksonville church on Sunday, February 15, 1959. Members of the Commission are: Ministers—John R. MacKinnon, Joseph C. Wagner, L. A. Taylor; Ruling Elder Royden Caulk. Rev. Walter H. Goodman was appointed alternate for the ministers and John N. Bender for the Ruling Elder.

The call from the Trinity church for the ministerial services of Rev. Joseph C. Wagner was read, approved and ordered placed into his hands. The terms of the call include an annual salary of \$4800.00, with manse and participation in the M.A.F. The Presbytery added an annual vacation of one month to the terms of the call. A Commission, composed of Rev. Horace H. Hilton, Rev. William M. Schotanus, Rev. L. A. Taylor, Ruling Elder W. E. Baird, and alternate Ruling Elders James Shank and L. H. Brandon was appointed to Install Mr. Wagner as Pastor of the Trinity church, on February 22, 1959.

A call for the ministerial services of Rev. Charles L. Kirby from the Church of Morehead City was read, approved and ordered placed in his hands. Terms of the call include an annual salary of \$5000.00, with manse, participation in the M.A.F. and Group Life and Health Insurance, and \$300.00 per year for traveling expenses. Presbytery added to the terms of the Call an annual vacation of one month. A Commission was appointed to Install Mr. Kirby as pastor of the church of Morehead City on February 1, 1959. The following persons composed the Commission: Ministers Alvis M. Daniel, Norman P. Farrior, Joseph C. Wagner; Ruling Elders Ashley Murphy with alternate Lee A. Murdock.

Rev. Horace H. Hilton, chairman of a special committee appointed to study the report of a special Committee of the General Assembly on Divorce and Remarriage, reported for the committee, and moved that the report of the Committee of the General Assembly be approved by the Presbytery.

At this point in the docket further discussion of the report was postponed until the annual report of the Women of the Church could be heard.

### ANNUAL REPORT OF THE WOMEN OF THE CHURCH OF WILMINGTON PRESBYTERY

The Women of the Church of Wilmington Presbytery have, in the study of "The Nature and Mission of The Church" realized that we have a significant responsibility as we are a part of Christ's Church, a part of His body on earth and a part of His plan for the world. We have studied our beliefs, attitudes and actions through our Circle Bible Study, Special Bible Study, reading the New Testament through this year, reading Presbyterian Women, Survey, and the General Programs as recommended by the Board of Women's Work. This being 'a part of the Church' is a business of giving and receiving. We must contribute to the flow of Christ's work and by doing so we ourselves are carried along by the current and kept from remaining stagnant.

We have 4,868 members in 76 groups divided into 230 Circles. We welcome one new organization this year, Salem Church. The Women of the Church have felt a responsibility for worship, teaching and services of their church. Our women serve on local, Presbytery's and Synod's Committees, Councils and Boards. The Every Family Plan for the Survey has been stressed. The Women have prepared themselves for leadership and service by attending the Officer's Training Classes conducted by Miss Ruth Hillhouse, of the Atlanta office, The Synodical Training School in Charlotte and the Montreat Conferences and Area Lab. Schools. Two visited the Chinese Church in New Orleans. 26 Negro women were sent to the Interdenominational Christian Conference at Winston-Salem. Clothes and money were sent to the migrants in Florida last winter. One church held a clinic for the children migrant workers in this Presbytery. All White Cross work asked for and more was gladly done. Hundreds of pounds of warm clothing was given for Overseas Relief. Dental supplies for Dr. Sandy Marks in Africa and many supplies for the T. B. hospital in Korea were given by several churches. Missionaries visited a large number of our churches. Foreign students have been entertained. Our Birthday Offering amounted to \$2,102.19, \$400.00 less than 1957, a per-capita giving of .43. \$450.50 to the Alice Johnson Scholarship at Assembly's Training School. The Lucy Steele Memorial Fund has been completed. The interest on this \$100,000.00 will be used by Peace College until the Consolidated College is ready to open. \$1,447.50 was given to Barium Springs as a Love Gift for repairing two of the cottages. \$300.00 for our Presbytery's Camp. May we continue to support the Camp project with our prayers and contributions. Much has been accomplished this year and we are grateful to God and give Him the glory. May we each be willing to give of our time and talents and accept leadership in our Local and Presbytery organizations. It is necessary for us to accept responsibility if we wish to grow. "For why are we here on earth except to Grow?" May we strive to give a better stewardship as we plan for the special emphasis in 1959, *World-Wide Witness*. May we become and help others to become conscious of the church throughout the world and may we understand the role of the church through an acceptance of our responsibility in the *World-Wide Witness*.

The Annual Report of World Missions was presented by Rev. Norman P. Fariior. Pending the adoption of the report Presbytery heard Mrs. R. T. Sinclair and Mr. D. M. Calhoun. The report was adopted.

### REPORT OF THE COMMITTEE ON WORLD MISSIONS

Our largest field for church extension and for medical work, and a most fruitful one in education and evangelism continues to be our mission beyond the borders of our own country, World Missions.

In this field we have work which is our own responsibility in Africa, Brazil, Taiwan, Korea, Japan, and Mexico, and share with other missions in work in Ecuador, Iraq, and Portugal.

In the fields for which we are solely responsible, there is a population totaling 36,000,000, and in those in which we are partially responsible, a reported population of 16,000,000.

While the number of our missionaries in these fields has gradually grown, it is not sufficient to meet the pressing needs for taking advantage of many strategic opportunities.

We cannot in this brief report bring much detailed information about this phase of our Church's work. The mention of just a few facts must suffice.

*Africa.* This is a place of rapid change, as western industry and culture and the white man's sins are racing with the mission of the Gospel of Christ to claim the hearts of the black men. If the achievement of sixty-odd years in mission work has not brought the high degree of general Christian culture and nationwide evangelism for which we might hope, after all, sixty years is a short time to change men from savagery, with no written language to a people of culture and ethics becoming a truly Christian people.

The year 1957 saw 8 features of advance in the Congo:

1. First year of a Central School of Missionaries' Children, a cooperative venture of Baptists, Methodists, and Presbyterians, finish its first year.

2. First official representative of the Congo Church to visit the mother Church in the U.S.A.

3. First member of the cannibalistic Basala tribe was ordained by Momba Presbytery.

4. First conference of Congo Council, representing 46 Protestant Missions.

5. First central benevolence treasury established by Presbyteries of the Congo Church.

6. Christian Medical Institute graduate its first class, and send them to larger hospitals for further training.

7. The Dental School at Lobondai graduated its first class.

8. First nurses training class began work in the McKownr Hospital at Loebo.

*Brazil.* The establishment of Brasilia, the new capital of the nation, within the boundaries of one of our missions there, opens a new and unique opportunity. In the present temporary city of some 15,000 to 20,000, who are building the capital, there is already a Presbyterian Church of fifty members, with a Sunday School of 125. The first observance of the Lord's Supper in the new capital was in 1957.

One of our missions (we have three) in Brazil turned over an entire Presbytery, consisting of seven churches and their pastors, to the native Brazilian Church. This meant that our mission force will proceed in pioneer work.

Evangelistic fervor is characteristic of the Brazilian Church. Our missionaries share the same zeal.

*Taiwan.* We have been at work in this island for 9 years. There is a native church of eight Presbyteries, being composed of 183 churches with a membership of 53,000.

This field seems to be peculiarly a field of response to the Presbyterian Church. Other Presbyterian missions had worked there before we entered. We were invited to join them when our missionaries had to leave China. Several distinct racial groups live on the island, and our own work has important distinct features, as among hill tribesmen, Chinese from the mainland, contacts with military people, and in publication work. Two of our missionaries lead in of the China Sunday School

Association, an interdenominational work that supplies literature in Taiwan and among Chinese on Southeast Asian countries.

*Japan.* This is one of our most difficult fields. It seems that in any country of high literacy, with most of its people firmly indoctrinated with their own religious beliefs, or thoroughly committed to doubt and criticism of any religious dogma, is a hard field for the Gospel. In Japan there seems under way a revival of all the old religions and the introduction of new ones. Her religions now number 377, each loudly presenting its tenets and demanding loyalty.

In this situation, so much like that in which Christianity began, the Christian Church has lost none of its zeal, zeal for introducing men to Christ. Through the old standard method on propagating the Gospel by conversation, by preaching, and by literature, and through use of newer facilities in this field, including the radio, the hospital, and through the I.C.U. we are still winning people for Christ.

*Korea.* The year was one of many hardships, struggles, and of suffering, but one of progress of the Church in Korea. Korea has a native General Assembly. We work closely with that Church and with the Presbyterian Church, U.S.A. (recently united with the United Presbyterians) and with the Australian Presbyterian Church.

Medical work, especially with people threatened with tuberculosis and with leprosy, is a strong field of service paralleling the Gospel. Much educational work, from kindergarten to seminary is carried on. The Seminary at Seoul had 550 students in 1957.

*Mexico.* The report from the mission in Mexico is keynoted by the word "Advance". The rapid growth of Mexico City in the last decades, and the world-wide acquaintance of the world with Acapulco, illustrate the national progress. That of the Christian Church is likewise on the forward trend.

The major problem of our mission in facing its task is personnel. Our two hospitals are doing a great work, the one at Ometepe, with Dr. Boyce at its head, and flying his plane to make calls in many places, is winning the friendship of many people in this new mission point, and the "Hospital de la Luz", in Morelia is truly a great light in its ministry to both the bodies and souls of people. To illustrate need for workers, we are told that only one man is available as a minister to fifteen churches in a large area of the Balsas River Valley, and inhospitable place because of its bad, hot climate and its inaccessibility, but said to contain more Presbyterians than all the rest of the Presbytery.

The Bible schools, and the hostels which give a Christian home life to students attending government schools, are contribution of their important part of the advance of the Church in Mexico.

We have no missionaries at this time in the fields on Ecuador, Iraq, and Portugal. These are all difficult fields. From Ecuador and Iraq our Board had no report in 1957. Portugal has a vital work in its evangelistic activity, its hospital, and its seminary, from which graduates go out to other portugese-speaking countries.

In addition to this part of our World Mission Committee's report to Presbytery, Mrs. R. T. Sinclair will present some suggestions for the effective use of literature that is provided for the World Mission emphasis season, and Mr. D. M. Calhoun will present another important factor that should engage our interest in this work.

### RECOMMENDATIONS:

1. That the churches of the Presbytery observe the season of world Mission study, Feb. 1st to March 1st, and the week of Prayer and self-denial with appropriate exercises.
2. That prayer be earnestly made for more men and women to fill the needs of all the aspects of the work, and in this, that ministers and Elders call attention of the Board to qualified young people in their churches or acquaintance.
3. That the Presbytery request the Presbytery's Council to investigate the feasibility of increasing the percentage of benevolences apportioned for World Missions in its distribution of undesignated benevolences.

N. P. FARRIOR, *Chairman of World Mission Comm.*

The Report of a Special Committee of the General Assembly dealing with "United" or "Federated" churches was reported to the Presbytery by Rev. Richard K. Johnson, who served as chairman of a special committee of the Presbytery to study this report. The Presbytery approved the Assembly's Report dealing with "United" Churches, but disapproved the report dealing with "Federated" churches.

Rev. Alvis M. Daniel presented the Annual Report of the Committee on Records. The report was adopted as follows:

1. The following churches failed to submit Sessional Records for examination: Ashwood, Croatan, Currie, Elkton, Harmony, South River, Stafford Memorial. Sessional Records were approved with exceptions, noted in the books, for the following churches: Acme, Antioch, Burgaw, Clarkton, Harper-Southerland, Hebron, Hopewell, Mt. Horeb, New Hope, Oakdale, Pike, Pink Hill, Pleasant View, Rocky Point, Southport, White Plains. Sessional Records were approved for all the remaining churches of the Presbytery.

2. We recommend that all Sessions conform more closely to the Book of Church Order in: (a) bi-annual reading and approving of the Minutes of the Board of Deacons, (b) affording opportunity for the representatives to higher courts of the church to report their attendance, (c) copying the annual statistical reports into the Session Records.

Dr. L. A. Taylor presented reports of the Treasurer of funds of the Presbytery: The Contingency Fund, Presbytery's Office, Home Mission Committee, General Benevolences, and Church and Manse Assistance Fellowship. The report was received as information and ordered printed in the Minutes of the Presbytery. The annual report of the committee on audits, to be made at the July meeting of Presbytery to be the official treasurer's report.

It was suggested to the executive secretary that in the future pertinent information for the churches be mailed to Clerks of Sessions as well as to Pastors.

The Minutes of the Commission on the Minister and His Work were admitted to record as follows:

### MINUTES OF COMMISSION ON MINISTER AND HIS WORK

The Commission on the Minister and His Work met in the office of the Presbytery on Monday, December 15, 1958. Members present: Rev. J. M. McChesney, Rev. J. W. Miller, Rev. Charles W. Worth, Rev. W. J. Wilkins, Mr. W. C. Scoggins. The meeting was opened with prayer by J. W. Miller.

Rev. Hubert J. Kaylor appeared before the Commission with the request for dissolution of the pastoral relationship between himself and the Westminster (Wil.) church, and the granting of a letter of dismissal to the Presbytery of Concord. Ruling Elder W. E. Starnes, representing the congregation, reported that the congregation had concurred in this request at a meeting called for this purpose. On motion by W. C. Scoggins, seconded by Charles W. Worth, the request was granted effective December 31, 1958. The Stated Clerk was ordered to forward the letter of dismissal to the Stated Clerk of Concord Presbytery.

Lake Waccamaw Church to increase the annual salary of the pastor by \$400.00. White Plains Church to increase the annual salary of the pastor by \$400.00. Mt. Zion Church to increase the annual salary of the pastor by \$600.00. Woodburn Church to increase the annual salary of the pastor by \$300.00. Bethany Church to increase the annual salary of the pastor by \$300.00. Wildwood Church to increase the annual salary of the pastor by \$100.00.

These requests were granted.

Rev. James A. Marrow requested the dissolution of the pastoral relationship between himself and the Cape Fear Church, and the granting of certificate of dismissal to the Presbytery of Concord. Ruling Elder J. M. Coley, representing the congregation, reported that the congregation had joined with Mr. Marrow in this request with great reluctance and regret. ### RESOLUTION

Whereas there is a need to maintain an account for donors who are interested in supporting some certain worthy non-budgeted cause and beneficiary, and

Whereas the donors to this account may wish to remain anonymous, and

Whereas certain donors may wish to make donations of real estate, stocks, bonds, securities, or assets other than cash, and

Whereas Wilmington Presbytery does not wish to hold such assets or speculate in the market value of such assets, and therefore, a simple and quick procedure is desired to dispose of such assets upon their receipt.

Now Be It Resolved That:

1. An account be maintained under the name of Laymen's Christian Mission of Wilmington Presbytery.

2. The Executive Secretary of Wilmington Presbytery shall act as Treasurer and Administrator for the account.

3. The purpose of the account is to receive special gifts, not provided for in the budget of Wilmington Presbytery, from donors,

(a) Who may wish to designate a specific cause or beneficiary of their gifts in so far as these gifts are for religious, charitable, educational, hospital or literary purposes, and

(b) Who may not wish to designate any specific beneficiary.

4. The donation shall be disbursed by the Treasurer

(a) In accordance with the wishes of the donor, or

(b) Where no specific beneficiary is named by the donor, for any needs within the discretion of the Treasurer.

5. Where such donations are received in the form of real estate, stocks, bonds, or securities other than cash, that the treasurer is empowered to receive such assets for Wilmington Presbytery and to sell, transfer, or assign such assets without further approval of Presbytery or its Trustees.

6. The Treasurer shall have full power to accept or reject any such gifts within his discretion.

7. The Treasurer shall maintain a record of all such receipts and disbursements which shall be available for inspection by the Presbytery but shall not be required to be reported to the Presbytery.

8. The account so maintained by the Treasurer, Dr. L. A. Taylor, since March 17, 1950 and all actions by the Treasurer in connection therewith and within the scope and powers authorized above, are hereby ratified.
