





Pastor's Report Rev. Mark W. Wethington Charge Conference November 9, 1997

I begin by expressing thanksgiving to God for the privilege of ordained ministry, its functions, challenges and joys. Ministry here at Duke Memorial continues to be both intriguing and encouraging. In recent days I spoke with a church member who was struggling with a question of how to be a disciple of Jesus in the midst of a troubling work situation. The very fact that she was asking the question was a joy to behold, knowing that there are indeed church people "out there" who are struggling with being faithful followers of Christ in their places of association outside of "Sunday presence." The ministry to which I continue to be called to give leadership is one which I steadily lift up as being guided by the ministry and teachings of Jesus through acts of worship, devotion, compassion and justice, under the guidance of the Holy Spirit.

While my ministry in this place continues to bring much joy and affirmation, this year's report by me is written with more of a dampened spirit than in the five years past. I say this with honesty mingled with seasoned hope. The dampened spirit arises from the presence of some in the congregation who have raised issues surrounding my leadership, while the seasoned hope arises from my own experience of how conflict, when handled in the Spirit of Christ, is an opportunity for Christian growth.

Duke Memorial has a history of conflict. Many who have weathered such experiences have shared them with me over the years I have served here. Some of those issues of conflict over many years have not been resolved, and, among some there is still lack of forgiveness. Those who have known such conflict have unfortunately also been witness and party to unhealthy "keeping of the peace." I have discovered more and more that healthy and open dialogue is difficult for many to engage in, as all of us are caught in a North American disposition that being Christian is about being nice rather than honest.

1997 has brought to my attention some deep concerns among church members, including one who resigned as Administrative Board chair and withdrew her membership from the church, that "due process" is not always seen to be followed, that proper communication has been lacking, and that true intentions have been questioned. These issues lead to questions of trust and honesty, causing some concerns to be seemingly unresolvable. The question of my study leave from January to May 1997 and how that was approved and handled is among these issues.

In conversation with the Staff-Parish Committee of this congregation it has been mutually acknowledged that this committee has not functioned well in recent years. While it has been "nice" to the staff, the committee has not provided the important critique of staff/parish relationships, etc. which is critical for shared ministry. As pastor, I have often been the last to know about things, even in recent months I have come to know about things which had not been shared with me before. In the five years that Bob Irvine has been here as our minister of music, in the years in which Jan Irvine was employed, as well as our financial secretary, our assistant in ministry, our receptionist, etc. these persons have rarely met with the Staff-Parish Relations Committee. Often I have felt the burden of being the committee on their behalf, and I now acknowledge that such was unwise on my part. I have grown in my own understanding of these things, remain discouraged about them, and hope and pray that this committee, by the grace of

God and with the help of all the congregation, can be conformed to give the strength of leadership to which it has been appointed. The fault lies with no one person, nor with the committee alone. As pastor, I acknowledge my own responsibility and am open to finding a better way in relationship with this committee and in support of the very difficult, challenging and privileged task which they have.

Our recently made video entitled "Christ's Ministry Through Us" has turned out to be a wonderful depiction of the many and varied aspects of ministry in this congregation. It will be used as an evangelism instrument to introduce the church to visitors. The key to this presentation is the understanding that this is not our ministry, but Christ's through us. Ministry becomes antithetical to the gospel when we assume it is something which we primarily create or carry out. The mission is God's and not ours; and yet we are at the mercy of human opinions, human prejudices, human committees, etc. which can both foster and hinder the missio Dei. This video depicts Christ's strong presence among us and working through us despite ourselves.

I am extremely grateful for the study leave which I had in the early part of this year. While at Wesley Seminary in Washington DC, I studied, meditated, and wrote, taught one course and was active at Casa del Pueblo, an innercity congregation in a community which was transitioning from being predominantly African-American to Hispanic. It was a very productive time for me intellectually and spiritually, and, in addition, I have been able to contribute something to the wider church. I regret that my study leave was met with some resistance by members of this congregation. Nevertheless, I am grateful for having been given the opportunity.

Since my return in mid-May, ministry in this place has been constant and demanding, as it has been ever since I was appointed here. The demands are unceasing, the time given costly, and the vision for this congregation's future remains very promising. It is my prayer that we will continue to learn from one another, grow in unity, and maintain a spirit of reconciling hope and love. In all of this may we steadily affirm that this is Christ's ministry and not ours. As the Wesleyan Covenant Prayer reminds us: "May we be used by thee, or laid aside by thee."

In addition to my pastoral responsibilities, I remain active ecumenically in the Durham community through Durham Congregations in Action, through the Durham Minister's Association, etc. I am active in various other ecumenical ministries including those related to the Durham Hispanic mission. I continue to be invited by Duke Divinity School to teach, as well as the continuing education office. I am chair of the Durham District Committee on Ordained Ministry, serve on the Conference Taskforce on Hispanic Ministry, and, chair the Conference Peru Taskforce. I have had a major essay published this year as part of a series entitled *United Methodism and American Culture*, and, it is my hope to complete a book entitled *Rise and Walk* by early 1998. In November of this year I will be representing the NC Conference at the National Holy Boldness Urban Convocation in San Francisco. I have performed five weddings this year and numerous funerals and baptisms (report included). Pastoral care and counseling is constant and demanding. Worship preparation, committee and board meetings, administrative responsibilities, staff oversight, etc. are steady and without end. But in all these things I rejoice in the constant presence of Christ and the strength and courage of his Spirit.
