

PROCEEDINGS.

The Presbytery, Revs. T. M. Duncan, E. Tucker, and R. L. Shoaf appointed by the Ashe and Alleghany Association, to organize the churches in Alleghany county in an association met this day with Sparta church.

Elder E. Tucker preached the introductory sermon from 1st Chor. 3rd chapter, 11 verse, "For other foundations can no man lay than that is laid which is Jesus

Christ."

The convention took a recess of one hour.

AFTERNOON SESSION.

The convention was called to order and on motion Elder T. M. Duncan was elected Moderator, pro tem and by request J. M. Wagoner acted as secretary, pro

By request of Moderator, Bro. W. C: Fields explained the object of the meeting.

The following letter was read from the Ashe and Al-

leghany association:

FOREST HOME BAPTIST CHURCH, Ashe Co., N. C., Sept. 28, 29, 30, 1897.

The Ashe and Alleghany Association, now in its eleventh annual session, and whereas, the churches of our union situated in Alleghany county, N. C., having a year ago asked for a committee to consider the propriety of dividing our churches, and upon hearing the reports of said committee and the minds of our brethren upon this matter it was unanimously agreed that this association be divided with the line separating Ashe and Alleghany counties, and that the following named churches in Alleghany county, now members of this body, be granted letters of dismission from our union for the purpose of forming another association, with other churches, of same faith and order, and they will be dismissed from us when such organization is accomplished, viz: New Hope, Liberty, (of Alleghany), Sparta, Laurelsprings, Belleview, Calloway's Chapel, Chest-

nut Grove. These are members in good and regular standing with us and are separated from us at their own request. We pray that the blessings of God may attend their efforts and that great good may result from this action,

Then letters from these churches, together with a letter from Brush Creek church, dismissed from the New River association in good standing, and Toliver School House a newly constituted church were read, brethren W. C. Fields and R. L. Shoaf acting as reading clerks.

The following visiting brethren reported themselves and took seats with the body, W. G. Young, New River association; Isom Burchett and J. N. Burchett, Elkin association; A. C. Hamby and D. W. Lee, Stony Fork association.

CONSTITUTION, RULES OF ORDER AND ABSTRACT OF PRINCIPLES.

On motion the Constitution (except Art. 1), Rules of Order and Abstract of Principles of the Ashe and Alleghany association were adopted.

NAME.

The Moderator appointed W. C. Fields, J. H. Doughton, T. R Windsor as a committee to name the association. They reported the name, "Alleghany and Grayson" which was adopted.

OFFICERS.

The Association was now declared organized by T. M. Duncan, Moderator of Presbytery. Bro. J. H. Doughton was elected Moderator and Bro.J. M. Wagoner, Clerk of the Association.

GALENA CHURCH.

On motion the Moderator appointed a committee to investigate the letter from Galena church, viz: Jas. Vaughan, F. B. Cheek, R. K. Johnson. The committee

reported favorably and the church was received.

ORDER OF BUSINESS AND FORM OF CHURCH LETTER TO ASSOCIATION.

On motion this Association adopt the form of Church Letter to association and Order of Business as that of the Ashe and Alleghany Association.

CONSTITUTION.

ART. 1. This body shall be called "The Alleghany

and Grayson Association."

2. The object of this Association shall be an organized effort to unite the churches in more efficient work for the spread of the gospel in our bounds, and in all the world, and in this work the association will be co operate with the Baptist State Convention of North Carolina.

3. The members of this body shall be all the ordained ministers of the churches composing the as ociation, and three delegates from each, who shall bring a letter certifying their appointment and giving statistics of the membership and work of the churches.

4. At each annual cession of the body there shall be elected a Moderator, a Clerk, and a Treasurer, in such way as the association may direct. The last two offices

may be held by the same brother.

5. The moderator shall preside at the meetings, preserve order, appoint committees and perform such other duties as are usually required of presiding officers.

6. The clark shall keep a correct record of the proceedings of the body, and superintend printing and dis-

tributing to the churches these proceedings

7. The Treasurer shall have charge of all funds sent up to the association, pay them out as the association may direct, and make report at each annual session.

8. The association shall hold annual meetings at such

times and places as may be agreed upon.

- 9. At each annual meeting there shall be appointed an Executive Committee of five brethren who shall look after the destitution in the bounds of this association and co operate with the State Mission board of the Baptist State convention, making to the next session a report of the work done, and of the general state of mission work.
- 10. At each annual session there shall be appointed committees to make reports at the subsequent session on the following subjects: Foreign Missions, Home Missions, State Missions, Ministerial Education, Bap-

tist Orphanage, Periodicals and Temperance.

11. Each annual session shall be introduced by a ser-

mon by some brother previously appointed.

22. The association will not receive or retain in per manent fellowship any church that retains in its fellowship any member who is disorderly in doctrine or practice, or who makes, sells or in any way deals in ardent spirits as a beverage.

13. This constitution may be amended by a vote of two-thirds of the members present at any annual ses-

sion.

ABSTRACT OF PRINCIPLES.

1. We believe in one only true and living God; and that there are three persons in the God head, the Father Son and Holy Ghost, and that these three are one.

2. We believe that the Bible—the Old and New Testament-is the word of God and only rule of faith and

practice.

3. We believe in the impotency of man and the sov-

ereingty of God.

4. We believe that salvation is by Grace, through faith in our Lord Jesus Christ.

5. We believe that Baptism and the Lotd's Supper are ordinances institued by Jesus Christ, to be prac-

ticed only by believers in their scriptural order.

6. We believe that baptism is the immersion of believer in water by a qualified administrator. And that only those who are thus baptized are in fellowship with the Church in feeling and doctrine should take the Lord's Supper.

7. We believe in the final perseverance of the Saints

in Grace to Glory.

8. We believe in the resurrection of the dead and a

General judgment.

9. We believe that the existence of the righteous and of the wicked will both be of eternal duration and that the happiness of the righteous and the punishment of the wicked will both be eternal.

1. Every session shall be opened and closed by prayer.

2. When the Moderator calls the association to order, every member shall at once take his seat.

3. When a member wishes to speak he shall arise and address

the Moderator and not proceed until he has been recognized.

4. No member shall speak more than twice on any subject except by permission of the body, and not over fifteen minutes at a time. 5. No member shall leave the body during its session without

permission of the Moderator.

6. It will be counted disorder for any member to stand up, leave the house or hold private conversation while the Moderator or any member is speaking.
