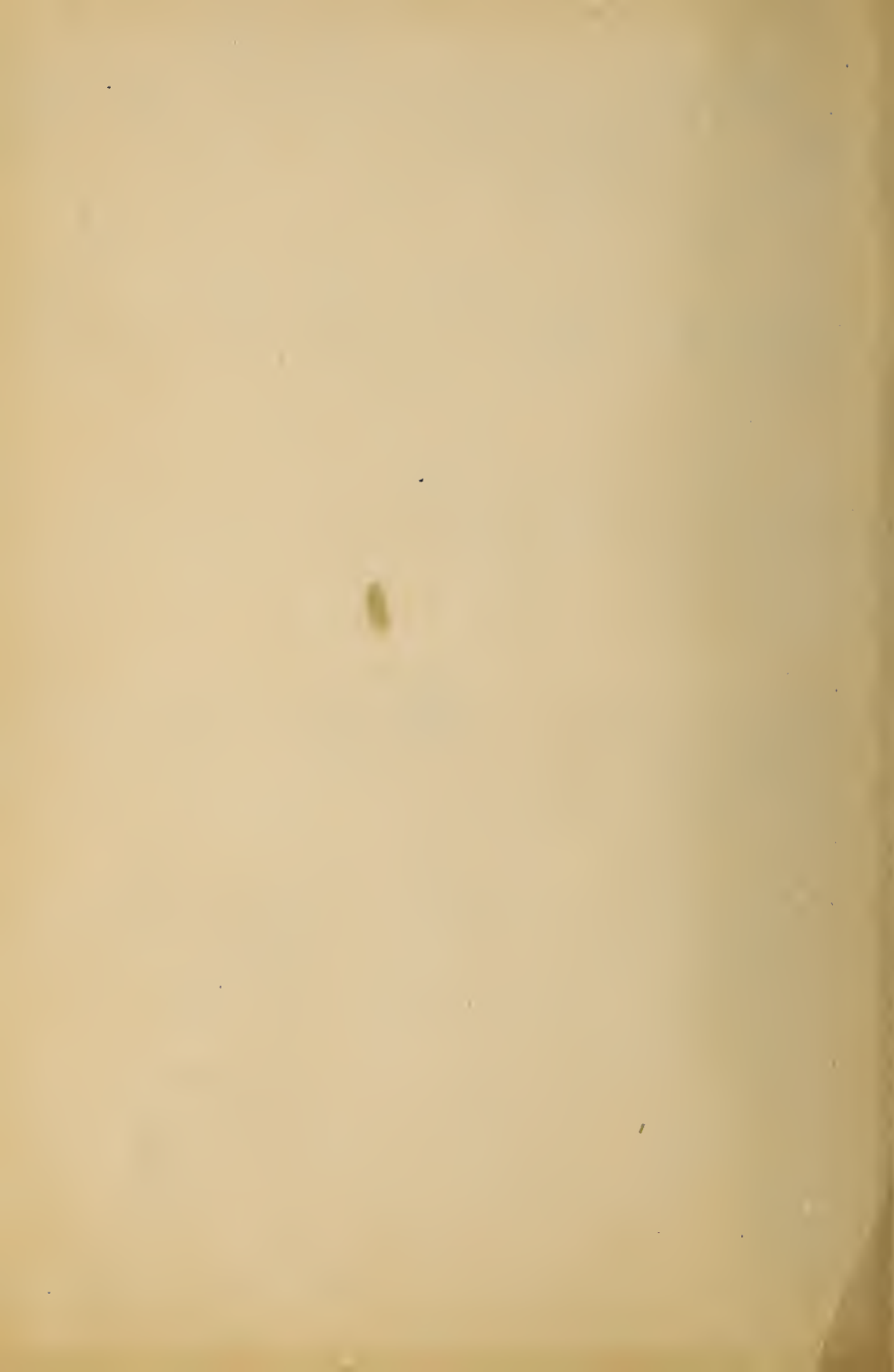

PROCEEDINGS

FRIDAY OCTOBER 4, 1940

The Lower Mayo Primitive Baptist Association met with the church at Snow Creek, Stokes County, N. C. After songs and prayer by Elder L. A. Harris. The Introductory sermon was preached by Elder W. H. Freeman from a portion of the 8 chapter of Romans.

After an intermission of an hour the Messengers composing The Lower Mayo Association together with Messengers from Sisiter Associations met in the house. The Association was opened with song and prayer by Elder Emmitt Stone:

ARTICLES OF FAITH

We believe in the Being of God Almighty, eternal unchangable of infinite wisdom, power, justice, holiness, goodness, mercy and truth; and this God has revealed Himself in His word under the characters of The Father, Son and Holy Ghost.

We believe that Almighty God has made known His mind and will to the children of men in His word; which Word we believe to be of Devine Authority and contains all things necessary to be known for the salvation of men and women. The same is comprehended as contained in The Books of the Old and New Testament as are commonly received.

We believe that God, before the Foundation of the World for a purpose of His own glory did elect a certain number of men and angels to eternal life, and that this election is particularly eternal and unconditional on the part of the creature.

We believe that Adam fell from this state of recitude and he involved himself and all his natural offsprings in the state of death; and for that original transgression, we all are both Filthy and Guilty in the sight of a Holy God.

We also believe that it is utterly out of the power of men, as fallen creatures, to keep the Law of God perfectly and repent of their sins, truly as we believe in Christ, except that man be drawn by the Holy Spirit.

We believe in God's own appointed time and way by means

which He has ordained. The elect shall be called justified, pardoned and sanctified; and that it is impossible that we can utterly refuse the call, but shall be made willing by divine grace to receive the offers of mercy.

We believe that Justification in the sight of God is only by the imputed Righteousness of Jesus Christ; received and applied by Faith alone.

We believe in like manner, that God's elect shall not only be called and justified, but that they shall be converted, born again and changed by the effectual working of God's Holy Spirit.

We believe that such as are converted, justified and called by His Grace shall preserve in Holiness and never fall finally away.

We believe it to be a duty incumbent on all of God's people to work religiously in God's work, not in the old covert way of seeking life and favor of the Lord, by it but only as a duty from a principal of Love.

We believe baptism and the Lord's Supper are Gospel ordinances both belonging to the True Believers: and that persons who were sprinkled or dipped while in unbelief were not regularly baptised according to God's word, and that such ought to be baptised after they are savingly converted into the faith of Christ.

We believe that every church is independent in matters of discipline, and that associations, councils and conferences of several ministers of churches are not to impose on the churches, the keeping or maintaining of any principal or practice contrary to the church's judgment.

We believe in the Resurrection of the dead, both of the just and unjust and a general judgment.

We believe the punishment of the wicked is everlasting and the joys of the righteous eternal.

We believe that no ministers have a right to the administration of the ordinances only such as are regularly called and come under imposition of hands by the Presbytery.

We do believe for the mutual comfort, union and satisfaction of the several churches of the aforesaid faith and order, we ought to meet in an association way, wherein each church is to represent their case by their delegates, and attend as often as necessary to advise in such matters in such associations are not to be imposed or in any wise binding on churches without their consent, but only to sit and act as advisory council.

ARTICLES 1 AND 7, CHAPTERS 3, LONDON

ARTICLES OF FAITH:

God has (Isa. XLVI:10; Eph. 1:11; Heb. VI:17; Rom. IX: 15-18) decreed in Himself from all Eternity, by the most wise and holy counsel of His own will, freely, unchangeably. All things whatsoever come to pass; yet so as thereby is God neither the

author of sin (James 1:15-17; I John 1:5) nor hath fellowship with any therein nor is violence offered to the will of the creature nor yet is liberty to continency of second cause taken but rather (Acts IV:27, 18; John XIX:11) established in which appears His wisdom in dispairing all things and power and faithfulness (Numbers XXIII: 19; Eph. 1:3, 53) in accomplishing His decree.

The doctrine of this high mystery of predestination is to be handled with special prudence and care, that men attending the will of God revealed in His word and yielding obedience thereunto, may from the certainty of their effectual vocation be assured of their (I Thes. 1:45; II Peter 1:10) Eternal election so shall his doctrine afford matter (Eph. 1:7; Rom. XI:33) of praise, reverence and admiration of God and (Rom. XI:5-6) of humiliation, diligence and abundant (Luke X:20) consolation to all that sincerely obey the Gospel.

RULES OF DECORUM

The Association shall be opened and closed by prayer.

Only one person may speak at a time, who shall rise from his seat and address the Moderator in the beginning of his speech.

Every brother speaking shall adhere strictly to the subject under consideration and in no way reflect on any other Brother.

No Messenger shall absent himself from the Association while in conference without permission.

No Messenger shall speak more than three times on the same subject without permission from the Association.

Messengers shall keep strict order while the business of the Association is being transacted.

No Messenger shall be interrupted while speaking unless he violates the rules of this decorum.

No Messenger shall address another in any other term or appellation other than the title of Brother.

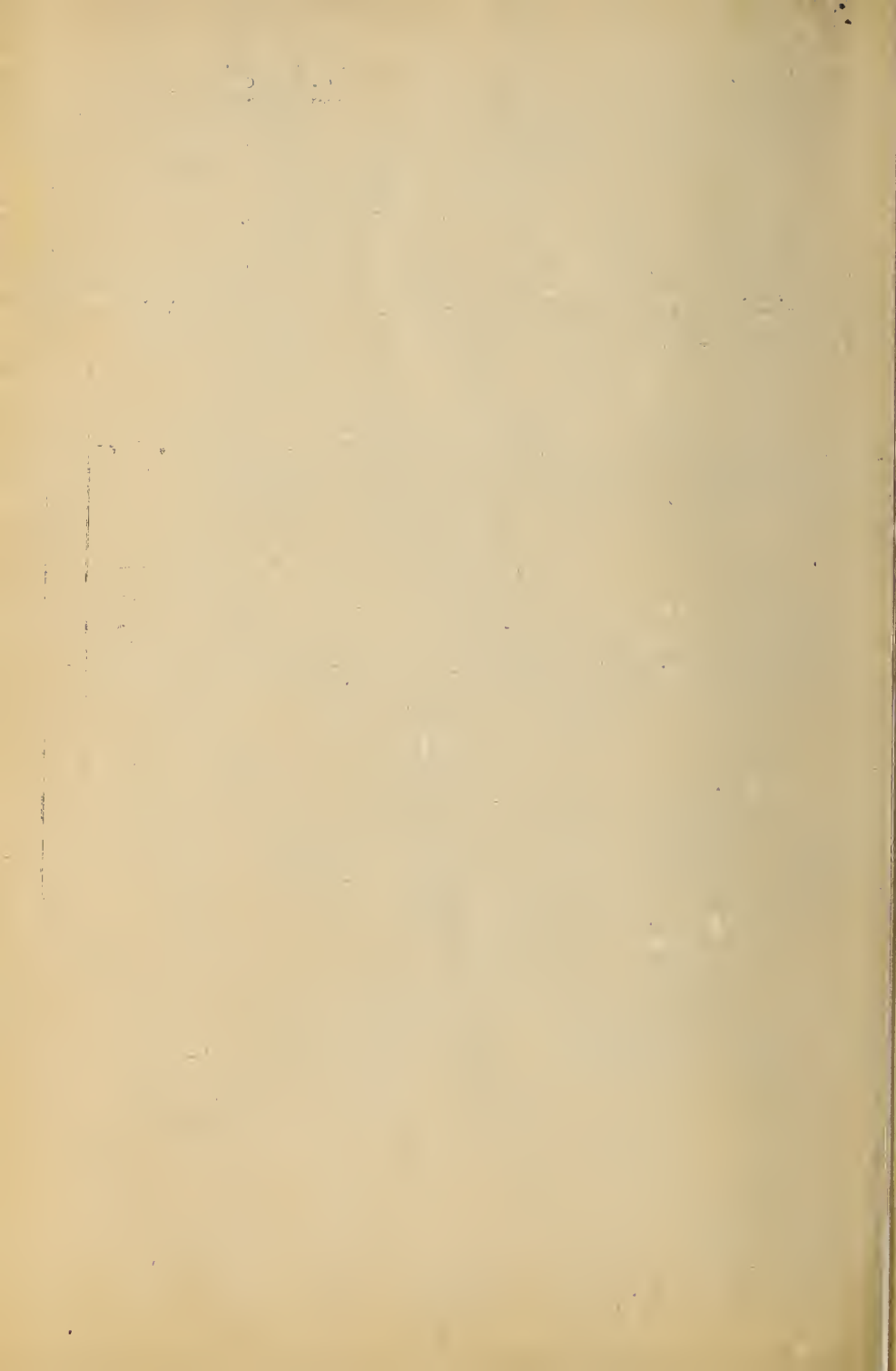
The names of the members composing the Association shall be enrolled by the Clerk and called over as often as the Association desires.

The Moderator shall not speak on any question before the Association until all the other Messengers are through speaking, when he may give his views. After any messenger having a right to speak may reply to any matter introduced by the Moderator.

Any member who violates any of the Rules of the Association shall be dealt with by the association as it deems proper.

Dear Mrs. Bridges:

I am sending you under separate cover the minutes requested, except 1933 thru 1939. Also I do not have 1942.

In October 1932, the Mayo Association disbanded; and was then re-organized into two separate bodies. Being known as the Upper Mayo Association and the lower Mayo Association. This was supposed to have been a friendly division. But was later resolved into two separate and distinct bodies of Baptist. Having no ~~correspondence~~ correspondence one with the other. Since I have personally been identified with Lower Mayo, I have very little knowledge as pertaining to the Upper Mayo. The Churches composing the Lower Mayo Association Met in January 1933, and Organized into the Lower Mayo Association. The first association under the name Lower Mayo Association, was held July 1933. There is now no Upper Mayo association, it is now know as the Piney Grove association. I understand that three or four churches, Just a short time back re-organized into the old Mayo association.

If you wish you can contact Mr J. B. Young, Danbury, N.C., and he may be able to give you further information concerning the Old Mayo Association. However he is not a member of that body of Churches.

I personally am trying to locate the minutes of the Lower Mayo Association From 1933 to 1938. I will endeavor to try to find them also for your Library. From 1932 to sometime around 1950, there was no Mayo association.

The above information is given to the best of my knowledge.

If I can be of any further ^{Assistance} ~~assistance~~ please feel free to contact me at any time. I would like and do sincere desire that I could give you further my feelings regarding the preservation of old records especially, of the religious body that is known as the Old School Predestinarians. In their behalf, and in the name of Christ the Saviour, I extend to you and those connected with you, my humble thanks, for your interest and efforts in our behalf.
